Testimony in Support of HB 3310  
June 3, 2019 at 1pm, Hearing Room C  
Senate Committee on Rules

Chair Burdick, Vice-Chair House Baertschiger Jr., and Senators Boquist, Dembrow, and Roblan:

The Oregon Commission for Women and the Oregon Commissions on Black Affairs, Asian and Pacific Islander Affairs, and Hispanic Affairs, strongly support HB 3310. HB 3310 provides school districts, education service districts (ESD), and community colleges a community-driven process to address election structures that align to the National Voting Rights Act.

"One person One vote" is a core American belief. It is a distinctively American clarion call for equality and individual empowerment through the right to vote. This bill establishes that signature right as it applies to the local governing institutions of our system of public education, our school districts. Representation in public education is core to our American ideals of Equal Protection under the law. The Supreme Court of the United States has written that public education is at the foundation of democratic government and cited that as its reason for rejecting the doctrine of segregation in public education. *Brown v. Board of Education* 347 U.S. 493 (1954). Without proper structural mechanisms in place, public schools are frequently targeted as avenues for abuses that perpetuate inequality against underrepresented minorities. *Goss v. Board of Education* (1963); *Griffin v. County School Board* (1964); *Green v. County School Board* (1969). Exempting school districts from the requirements of representative government undermines our democratic institutions of government and leaves the rights of women and minorities vulnerable.

The Oregon Advocacy Commissions remain deeply concerned about the effects of disproportionate discipline and opportunities within our educational systems for women and people of color. The right to equal representation in our school systems of local governance is an essential first priority in ensuring a fair and successful education for all of Oregon's people.

We strongly support HB 3310, and urge its immediate implementation to help our state achieve its educational goals.
