Subject: SB 973 A – Relating to behavioral health

This bill establishes the Improving People’s Access to Community-based Treatment, Supports and Services program within the Criminal Justice Commission. The grant program will provide funding to counties, tribal nations, and regional consortiums to strengthen local and regional supports and services for people with serious mental illnesses and substance addictions with the goal of reducing arrests, jail bookings, emergency department visits, and state hospital admissions.

Within the Criminal Justice Commission, the amendment creates a committee to identify the target population; methodology for review and approval of grant applications; process for evaluating programs; establishing criteria for alternative grant fund usage; and outcome requirements. The committee and Oregon Health Authority may work together to provide technical assistance and performance incentives to Coordinated Care Organizations.

The -A6 amendment makes some technical changes, including changing the name of the program, making the pilot program with the Oregon Health plan optional, and requiring the Committee to make recommendations to the next Legislature.

The -A6 amendment provides \$10 million General Fund for grant awards and other related activities. The amendment also requires that three percent of the \$10 million, or \$300,000, be used for research.

The -A6 amendment provides \$639,462 General Fund to the Criminal Justice Commission (CJC) for 3 positions (2.38 FTE) for the 2019-21 biennium. CJC is also allocated \$10 million in Other Funds limitation for dispersing grant awards and research contracts.

Recommended Changes

LFO recommends adoption of the -A6 amendment.
