Dear Chair Holvey and Members of the House Rules Committee,

## Please Support House Bill 3448 – Enhanced Wine Labeling and Content Standards

The wine industry is an extremely competitive business. Oregon wine only represents 1% of all the wine produced in the United States. To succeed, we need to find ways to stand out from the crowd.

Willamette Valley wine has gained a national and international reputation for its high quality. That reputation was earned by producing authentic wines reflecting the unique qualities of Willamette Valley soil, climate and terrain. The Willamette Valley is a special place and arguably the best place on earth to produce Pinot noir.

To preserve this reputation, the 239-member Willamette Valley Wineries Association is seeking legislation to enhance the labeling and content standards for wines produced in this special place. In short, we want standards that ensure **what's on the label is what's in the bottle**.

Our legislation is all about promoting high standards and integrity, not harming other wine-producing regions in Oregon. Unfortunately, the bills originally introduced and approved in the Senate by 26-4 margins stalled in a House committee. This was largely as a result of misinformation about the bills. Even so, the bills would have passed out of committee by the deadline except for the excused absence of one of our supporters. That led Rep. Ken Helm to use a priority bill to keep our legislation alive this session.

The new bill incorporates all of the provisions of the previous bills relating to varietal and wine grape content, with a few revisions. The new bill extends the phase-in period for the viticultural area content provision from 10 to 15 years. The new bill clarifies membership of the OLCC regulatory advisory committee that will work out implementation details. The new bill eliminates exemption language.

Competition never ceases. Our reputation is never secure. That's why it is essential to move forward on legislation that addresses the labeling and content standards of Willamette Valley wine. The hard work of the last 50 years has put Oregon Pinot noir on the world map. Now we need to take action to keep it on that map as a special place with the world's highest standards of authenticity and integrity. As leaders of Oregon's wine industry, we ask for your support House Bill 3448.
