## **Measure Description:**

Prohibits sale of mattress or children's product that incorporates or bears specified chemicals unless person affixes or attaches warning to mattress or children's product.

## **Government Unit(s) Affected:**

Oregon Health Authority (OHA), Oregon Judicial Department (OJD)

## **Summary of Fiscal Impact:**

#### **Analysis:**

HB 3055 prohibits a retailer from selling or offering for sale in Oregon a mattress or children's product that incorporates or bears a fire-retardant chemical in concentrations of more than one-tenth of one percent by mass. The measure allows the Director of OHA to petition a circuit court for an injunction restraining further violations.

# Oregon Health Authority (OHA)

OHA estimates the fiscal impact of this measure to be \$577,039 General Fund and 3 positions (2.00 FTE) for the 2019-21 biennium; and \$634,763 General Fund and 3 positions (3.00 FTE) for the 2021-23 biennium. To comply with the requirements of the measure, OHA would need to procure equipment, establish a data system, and hire additional staffing to administer this new regulatory program. Staffing costs reflect:

- One Program Analyst 2 position to coordinate all program activities including outreach, communication, rule writing, and data analysis.
- One Administrative Specialist 2 to perform all support functions for the program including mailings, phone and communication support, appointments and supply ordering.
- One Compliance Specialist 2 position to carry out investigations of violations, random merchandise purchasing for testing, case review coordination, and civil penalty coordination.

Included in the 2019-21 services and supplies amount are Office of Information Services expenses to establish the database and Attorney General expenses.

The measure authorizes OHA to impose a civil penalty of \$1,000 for a first violation and \$2,500 for each subsequent violation. Revenues from penalties are indeterminate, at this time.
