Summary of Revenue Changes

Senate Bill 488 appropriates \$114,182 General Fund to the Department of Corrections (DOC) for the purpose of providing influenza (flu) vaccinations to adults in custody.

Summary of Public Safety Subcommittee Action

Currently, DOC offers immunization for the flu virus on an "opt-in" basis – meaning adults in custody must proactively request a vaccination. Senate Bill 488 directs DOC to offer each adult in custody an appointment to receive a flu vaccination during the medically accepted standard timing for immunization against the flu virus, at no cost. The adult in custody may decline the offer.

The bill appropriates \$114,181 General Fund to DOC to purchase a sufficient supply of flu vaccinations.
