## **Summary of Revenue Changes**

For the 2019-21 biennium, the Psychiatric Security Review Board (PSRB) is fully supported by General Fund. In previous biennia, the Board carried a small balance of Other Funds, originally received as a \$10,000 grant from the American Psychiatric Association in 1994. The grant funds have been used sparingly for training purposes only. In the 2017-19 biennium, the remaining \$2,000 balance was spent and the Other Funds expenditure limitation was phased-out for 2019-21.

## **Summary of Human Services Subcommittee Action**

PSRB has jurisdiction over adults in Oregon who successfully assert the “guilty except for insanity” defense in criminal proceedings, as well as juveniles who assert the youth insanity defense “responsible except for insanity.” The Department is also responsible for processing relief petitions and hearings for persons barred from possessing a firearm due to a mental health determination.

The Department’s primary purpose is to protect the public through the on-going review of the progress made by clients under its jurisdiction and to determine the appropriate placement for each client. Administrative hearings are conducted to determine appropriate placement of both juvenile and adult clients. The Department oversees treatment outcomes for certain clients who are committed to the Oregon State Hospital; coordinates treatment and case management for clients under conditional release; revokes conditional release and orders the return of clients to the Oregon State Hospital, if appropriate; and discharges clients from the Board’s jurisdiction.

The Subcommittee approved a budget for PSRB of \$3,229,021 General Fund and 11 positions (11.00 FTE). The budget funds the Board at current service level, discontinues Other Funds expenditure limitation and provides General Fund at 6.0 percent higher than the 2017-19 Legislatively Approved Budget.

**LFO Recommendation:**

Approve the Key Performance Measures (KPMs) and targets as proposed.

Direct the Psychiatric Security Review Board (PSRB) to review existing KPMs and propose changes for the 2021-23 biennium as needed or based on legislative feedback. This recommendation is consistent with the intent of new agency leadership who want to evaluate the current measures and targets for possible improvements and potentially develop new measures more in line with evolving programs. The PSRB will provide a progress update to the Legislative Fiscal Office by February 1, 2020 and may be requested to present that work to the Subcommittee during the 2020 legislative session or at an interim meeting.

**SubCommittee Action:**

The Human Services Subcommittee approved the Legislative Fiscal Office recommendations.
