# **Summary of Revenue Changes**

House Bill 2515 appropriates \$102,108 General Fund to the Department of Corrections (DOC) for the purpose of providing a range of sanitary products to adults in custody at no cost to the individual.

## **Summary of Public Safety Subcommittee Action**

House Bill 2515 directs local correctional facilities, lockup facilities, regional correctional facilities, DOC, Oregon Youth Authority (OYA) and juvenile detention facilities to provide tampons, sanitary pads, postpartum pads, and panty liners at specified and varying absorbency to those in custody at no cost. This practice is already in place at OYA, however, DOC does not currently provide all of the specified products free of charge.

The bill appropriates \$102,108 General Fund to DOC to purchase a sufficient supply of sanitary supplies to store and make available as needed.
