Summary of Revenue Changes

House Bill 2998 increases Other Funds expenditure limitation by \$50,000 to allow the Secretary of State to translate 70 business filing forms into five specified languages.

Summary of Education Subcommittee Action

House Bill 2998 removes the requirement for business filing forms to be only in the English language. The bill requires the Secretary of State to make business filing forms available in Spanish, Chinese, Vietnamese, Russian, and Korean by July 1, 2021. The Subcommittee recommended an Other Funds expenditure limitation increase of \$50,000 to the Secretary of State to translate business filing forms into five specified languages.
