

# House Bill 2047

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of Governor Kate Brown for Oregon State Police)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires sex offender to report within 10 days of legal change of name. Punishes failure to report change of name by maximum of 364 days' imprisonment, \$6,250 fine, or both. If sex crime requiring reporting is felony, punishes failure to report change of name by maximum of five years' imprisonment, \$125,000 fine, or both.

2 Relating to sex offender reporting; creating new provisions; and amending ORS 163A.010, 163A.015,  
3 163A.020, 163A.025 and 163A.040.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 163A.010 is amended to read:

6 163A.010. (1) The agency to which a person reports under subsection (3) of this section shall  
7 complete a sex offender registration form concerning the person when the person reports under  
8 subsection (3) of this section.

9 (2) Subsection (3) of this section applies to a person who:

10 (a) Is discharged, paroled or released on any form of supervised or conditional release from a  
11 jail, prison or other correctional facility or detention facility in this state at which the person was  
12 confined as a result of:

13 (A) Conviction of a sex crime or a crime for which the person would have to register as a sex  
14 offender under federal law; or

15 (B) Having been found guilty except for insanity of a sex crime;

16 (b) Is paroled to this state under ORS 144.610 after being convicted in another United States  
17 court of a crime:

18 (A) That would constitute a sex crime if committed in this state; or

19 (B) For which the person would have to register as a sex offender in that court's jurisdiction,  
20 or as required under federal law, regardless of whether the crime would constitute a sex crime in  
21 this state; or

22 (c) Is discharged by the court under ORS 161.329 after having been found guilty except for in-  
23 sanity of a sex crime.

24 (3)(a) A person described in subsection (2) of this section shall report, in person, to the Depart-  
25 ment of State Police, a city police department or a county sheriff's office, in the county to which the  
26 person was discharged, paroled or released or in which the person was otherwise placed:

27 (A) Within 10 days following discharge, release on parole, post-prison supervision or other  
28 supervised or conditional release;

29 (B) Within 10 days of a change of residence;

30 **(C) Within 10 days of a legal change of name;**

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 [(C)] (D) Once each year within 10 days of the person's birth date, regardless of whether the  
2 person changed residence;

3 [(D)] (E) Within 10 days of the first day the person works at, carries on a vocation at or attends  
4 an institution of higher education; and

5 [(E)] (F) Within 10 days of a change in work, vocation or attendance status at an institution of  
6 higher education.

7 (b) If a person required to report under this subsection has complied with the initial reporting  
8 requirement under paragraph (a)(A) of this subsection, the person shall subsequently report, in per-  
9 son, in the circumstances specified in paragraph (a) of this subsection, as applicable, to the De-  
10 partment of State Police, a city police department or a county sheriff's office, in the county of the  
11 person's last reported residence.

12 (c) Notwithstanding paragraphs (a) and (b) of this subsection, during the period of supervision  
13 or custody authorized by law, the Oregon Youth Authority may authorize a youth offender commit-  
14 ted to its supervision and custody by order of the juvenile court or a person placed in its physical  
15 custody under ORS 137.124 or any other provision of law to report to the authority regardless of the  
16 youth offender's or the person's last reported residence.

17 (d) In the event that a person reports to the authority under this subsection, the authority shall  
18 register the person.

19 (e) The obligation to report under this subsection terminates if the conviction or adjudication  
20 that gave rise to the obligation is reversed or vacated or if the registrant is pardoned.

21 (4) As part of the registration and reporting requirements of this section:

22 (a) The person required to report shall:

23 (A) Provide the information necessary to complete the sex offender registration form and sign  
24 the form as required; and

25 (B) Submit to the requirements described in paragraph (b) of this subsection.

26 (b) The Department of State Police, Oregon Youth Authority, city police department or county  
27 sheriff's office:

28 (A) Shall photograph the person when the person initially reports under this section and each  
29 time the person reports annually under this section;

30 (B) May photograph the person or any identifying scars, marks or tattoos located on the person  
31 when the person reports under any of the circumstances described in this section; and

32 (C) Shall fingerprint the person if the person's fingerprints are not included in the record file  
33 of the Department of State Police.

34 **SECTION 2.** ORS 163A.015 is amended to read:

35 163A.015. (1) The agency to which a person reports under subsection (4) of this section shall  
36 complete a sex offender registration form concerning the person when the person reports under  
37 subsection (4) of this section.

38 (2) Subsection (4) of this section applies to a person who is discharged, released or placed on  
39 probation:

40 (a) By the court after being convicted in this state of a sex crime;

41 (b) By a federal court after being convicted of a crime for which the person would have to  
42 register as a sex offender under federal law, regardless of whether the crime would constitute a sex  
43 crime in this state; or

44 (c) To or in this state under ORS 144.610 after being convicted in another United States court  
45 of a crime:

1 (A) That would constitute a sex crime if committed in this state; or

2 (B) For which the person would have to register as a sex offender in that court's jurisdiction,  
3 regardless of whether the crime would constitute a sex crime in this state.

4 (3) The court shall ensure that the person completes a form that documents the person's obli-  
5 gation to report under ORS 163A.010 or this section. No later than three working days after the  
6 person completes the form required by this subsection, the court shall ensure that the form is sent  
7 to the Department of State Police.

8 (4)(a) A person described in subsection (2) of this section shall report, in person, to the Depart-  
9 ment of State Police, a city police department or a county sheriff's office, in the county to which the  
10 person was discharged or released or in which the person was placed on probation:

11 (A) Within 10 days following discharge, release or placement on probation;

12 (B) Within 10 days of a change of residence;

13 **(C) Within 10 days of a legal change of name;**

14 [(C)] **(D)** Once each year within 10 days of the person's birth date, regardless of whether the  
15 person changed residence;

16 [(D)] **(E)** Within 10 days of the first day the person works at, carries on a vocation at or attends  
17 an institution of higher education; and

18 [(E)] **(F)** Within 10 days of a change in work, vocation or attendance status at an institution of  
19 higher education.

20 (b) If a person required to report under this subsection has complied with the initial reporting  
21 requirement under paragraph (a)(A) of this subsection, the person shall subsequently report, in per-  
22 son, in the circumstances specified in paragraph (a) of this subsection, as applicable, to the De-  
23 partment of State Police, a city police department or a county sheriff's office, in the county of the  
24 person's last reported residence.

25 (c) The obligation to report under this subsection terminates if the conviction or adjudication  
26 that gave rise to the obligation is reversed or vacated or if the registrant is pardoned.

27 (5) As part of the registration and reporting requirements of this section:

28 (a) The person required to report shall:

31 (B) Submit to the requirements described in paragraph (b) of this subsection.

39 **SECTION 3.** ORS 163A.020 is amended to read:

40 163A.020. (1)(a) When a person described in subsection (6) of this section moves into this state  
41 and is not otherwise required by ORS 163A.010, 163A.015 or 163A.025 to report, the person shall  
42 report, in person, to the Department of State Police, a city police department or a county sheriff's  
43 office, in the county of the person's residence:

44 (A) No later than 10 days after moving into this state;

45 (B) Within 10 days of a change of residence;

1       **(C) Within 10 days of a legal change of name;**

2       [(C)] **(D)** Once each year within 10 days of the person’s birth date, regardless of whether the  
3 person changed residence;

4       [(D)] **(E)** Within 10 days of the first day the person works at, carries on a vocation at or attends  
5 an institution of higher education; and

6       [(E)] **(F)** Within 10 days of a change in work, vocation or attendance status at an institution of  
7 higher education.

8       (b) If a person required to report under this subsection has complied with the initial reporting  
9 requirement under paragraph (a)(A) of this subsection, the person shall subsequently report, in per-  
10 son, in the circumstances specified in paragraph (a) of this subsection, as applicable, to the De-  
11 partment of State Police, a city police department or a county sheriff’s office, in the county of the  
12 person’s last reported residence.

13       (2)(a) When a person described in ORS 163A.010 (2) or 163A.015 (2) or subsection (6) of this  
14 section attends school or works in this state, resides in another state and is not otherwise required  
15 by ORS 163A.010, 163A.015 or 163A.025 to report, the person shall report, in person, to the Depart-  
16 ment of State Police, a city police department or a county sheriff’s office, in the county in which the  
17 school or place of work is located, no later than 10 days after:

18       (A) The first day of school attendance or the 14th day of employment in this state; [and]

19       (B) A change in school enrollment or employment[.]; **and**

20       **(C) A legal change of name.**

21       (b) As used in this subsection, “attends school” means enrollment in any type of school on a  
22 full-time or part-time basis.

23       (3)(a) When a person described in subsection (6) of this section resides in this state at the time  
24 of the conviction or adjudication giving rise to the obligation to report, continues to reside in this  
25 state following the conviction or adjudication and is not otherwise required by ORS 163A.010,  
26 163A.015 or 163A.025 to report, the person shall report, in person, to the Department of State Police,  
27 a city police department or a county sheriff’s office, in the county of the person’s residence:

28       (A) Within 10 days following:

29       (i) Discharge, release on parole or release on any form of supervised or conditional release, from  
30 a jail, prison or other correctional facility or detention facility; or

31       (ii) Discharge, release or placement on probation, by another United States court;

32       (B) Within 10 days of a change of residence;

33       **(C) Within 10 days of a legal change of name;**

34       [(C)] **(D)** Once each year within 10 days of the person’s birth date, regardless of whether the  
35 person has changed residence;

36       [(D)] **(E)** Within 10 days of the first day the person works at, carries on a vocation at or attends  
37 an institution of higher education; and

38       [(E)] **(F)** Within 10 days of a change in work, vocation or attendance status at an institution of  
39 higher education.

40       (b) If a person required to report under this subsection has complied with the applicable initial  
41 reporting requirement under paragraph (a)(A) of this subsection, the person shall subsequently re-  
42 port, in person, in the circumstances specified in paragraph (a) of this subsection, as applicable, to  
43 the Department of State Police, a city police department or a county sheriff’s office, in the county  
44 of the person’s last reported residence.

45       (4) When a person reports under this section, the agency to which the person reports shall

1 complete a sex offender registration form concerning the person.

2 (5) The obligation to report under this section terminates if the conviction or adjudication that  
 3 gave rise to the obligation is reversed or vacated or if the registrant is pardoned.

4 (6) Subsections (1) to (5) of this section apply to a person convicted in another United States  
 5 court of a crime:

6 (a) That would constitute a sex crime if committed in this state; or

7 (b) For which the person would have to register as a sex offender in that court's jurisdiction,  
 8 or as required under federal law, regardless of whether the crime would constitute a sex crime in  
 9 this state.

10 (7) As part of the registration and reporting requirements of this section:

11 (a) The person required to report shall:

12 (A) Provide the information necessary to complete the sex offender registration form and sign  
 13 the form as required; and

14 (B) Submit to the requirements described in paragraph (b) of this subsection.

15 (b) The Department of State Police, the city police department or the county sheriff's office:

16 (A) Shall photograph the person when the person initially reports under this section, each time  
 17 the person reports annually under subsection [(1)(a)(C) or (3)(a)(C)] **(1)(a)(D) or (3)(a)(D)** of this  
 18 section and each time the person reports under subsection (2)(a)(B) of this section;

19 (B) May photograph the person or any identifying scars, marks or tattoos located on the person  
 20 when the person reports under any of the circumstances described in this section; and

21 (C) Shall fingerprint the person if the person's fingerprints are not included in the record file  
 22 of the Department of State Police.

23 **SECTION 4.** ORS 163A.025 is amended to read:

24 163A.025. (1) A person found to be within the jurisdiction of the juvenile court under ORS  
 25 419C.005, or found by the juvenile court to be responsible except for insanity under ORS 419C.411,  
 26 for having committed an act that, if committed by an adult, would constitute a felony sex crime shall  
 27 report as a sex offender as described in subsections (2) to (4) of this section, unless the juvenile  
 28 court enters an order under ORS 163A.130 or 163A.135 relieving the person of the obligation to re-  
 29 port, if:

30 (a) The person has been ordered under ORS 163A.030 to report as a sex offender;

31 (b) The person was adjudicated, and the jurisdiction of the juvenile court or the Psychiatric  
 32 Security Review Board over the person ended, prior to August 12, 2015;

33 (c) The person was adjudicated prior to August 12, 2015, and the jurisdiction of the juvenile  
 34 court or the Psychiatric Security Review Board over the person ended after August 12, 2015, and  
 35 before April 4, 2016; or

36 (d) The person has been found in a juvenile adjudication in another United States court to have  
 37 committed an act while the person was under 18 years of age that would constitute a felony sex  
 38 crime if committed in this state by an adult.

39 (2) A person described in subsection (1)(a) or (d) of this section, or a person described in sub-  
 40 section (1)(c) of this section who did not make an initial report prior to April 4, 2016, who resides  
 41 in this state shall make an initial report, in person, to the Department of State Police, a city police  
 42 department or a county sheriff's office as follows:

43 (a) The person shall report no later than 10 days after the date of the court order requiring the  
 44 person to report under ORS 163A.030;

45 (b) If the person is adjudicated for the act giving rise to the obligation to report in another

1 United States court and the person is found to have committed an act that if committed by an adult  
 2 in this state would constitute:

3 (A) A Class A or Class B felony sex crime:

4 (i) If the person is not a resident of this state at the time of the adjudication, the person shall  
 5 make the initial report to the Department of State Police, a city police department or a county  
 6 sheriff's office, in the county of the person's residence, no later than 10 days after the date the  
 7 person moves into this state; or

8 (ii) If the person is a resident of this state at the time of the adjudication, the person shall make  
 9 the initial report to the Department of State Police, a city police department or a county sheriff's  
 10 office, in the county of the person's residence, no later than 10 days after the date the person is  
 11 discharged, released or placed on probation or any other form of supervised or conditional release  
 12 by the other United States court or, if the person is confined in a correctional facility by the other  
 13 United States court, no later than 10 days after the date the person is discharged or otherwise re-  
 14 leased from the facility.

15 (B) A Class C felony sex crime:

16 (i) If the person is not a resident of this state at the time of the adjudication, the person shall  
 17 make the initial report to the Department of State Police, a city police department or a county  
 18 sheriff's office, in the county of the person's residence, no later than six months after the date the  
 19 person moves into this state; or

20 (ii) If the person is a resident of this state at the time of the adjudication, the person shall make  
 21 the initial report to the Department of State Police, a city police department or a county sheriff's  
 22 office, in the county of the person's residence, no later than 10 days after the date the person is  
 23 discharged, released or placed on probation or any other form of supervised or conditional release  
 24 by the other United States court or, if the person is confined in a correctional facility by the other  
 25 United States court, no later than 10 days after the date the person is discharged or otherwise re-  
 26 leased from the facility; or

27 (c) For persons described in subsection (1)(c) of this section who did not make an initial report  
 28 prior to April 4, 2016, the person shall report no later than 120 days after April 4, 2016.

29 (3) After making the initial report described in subsection (2) of this section or, for a person  
 30 described in subsection (1)(c) of this section who made an initial report prior to April 4, 2016, or a  
 31 person described in subsection (1)(b) of this section, beginning after April 4, 2016, the person shall  
 32 report, in person, to the Department of State Police, a city police department or a county sheriff's  
 33 office, in the county of the person's last reported residence:

34 (a) Within 10 days of a change of residence;

 44 section or ORS 163A.010, 163A.015 or 163A.020, the person shall report, in person, to the Depart-  
 45 ment of State Police, a city police department or a county sheriff's office, in the county in which the

1 person attends school or works, no later than 10 days after:

2 (a) The first day of school attendance or the 14th day of employment in this state; *[and]*

3 (b) A change in school enrollment or employment~~].~~; **and**

4 (c) **A legal change of name.**

5 (5) The agency to which a person reports under this section shall complete a sex offender reg-  
6 istration form concerning the person when the person reports under this section.

7 (6) As part of the registration and reporting requirements of this section:

8 (a) The person required to report shall:

9 (A) Provide the information necessary to complete the sex offender registration form and sign  
10 the form as required; and

11 (B) Submit to the requirements described in paragraph (b) of this subsection.

12 (b) The Department of State Police, Oregon Youth Authority, county juvenile department, city

14 (A) Shall photograph the person when the person initially reports under this section and each  
15 time the person reports annually under this section;

21 to the obligation is reversed or vacated.

22 (8) Notwithstanding subsections (2) and (3) of this section:

23 (a) The Oregon Youth Authority may authorize a youth offender committed to its custody and  
24 supervision by order of the juvenile court, or a person placed in its physical custody under ORS  
25 137.124 or any other provision of law, to report to the authority regardless of the youth offender's  
26 or the person's last reported residence.

27 (b) A county juvenile department may authorize a youth offender or young person, as those  
28 terms are defined in ORS 419A.004, to report to the department, regardless of the county of the  
29 youth offender's or the young person's last reported residence.

30 (c) In the event that a person reports to the authority or the department under this subsection,  
31 the authority or the department shall register the person.

32 **SECTION 5.** ORS 163A.040 is amended to read:

33 163A.040. (1) A person who is required to report as a sex offender in accordance with the ap-  
34 plicable provisions of ORS 163A.010, 163A.015, 163A.020 or 163A.025 and who has knowledge of the  
35 reporting requirement commits the crime of failure to report as a sex offender if the person:

36 (a) Fails to make the initial report to an agency;

37 (b) Fails to report when the person works at, carries on a vocation at or attends an institution  
38 of higher education;

39 (c) Fails to report following a change of school enrollment or employment status, including en-  
40 rollment, employment or vocation status at an institution of higher education;

41 (d) Fails to report following a change of residence;

42 (e) **Fails to report a legal change of name;**

43 ~~[(e)]~~ (f) Fails to make an annual report;

44 ~~[(f)]~~ (g) Fails to provide complete and accurate information;

 8 (3)(a) that the person reported, in person, within 10 days of a change of residence to the Department  
 9 of State Police, a city police department or a county sheriff's office, in the county of the person's  
 10 new residence, if the person otherwise complied with all reporting requirements.

11        (b) It is an affirmative defense to a charge of failure to report under subsection (1)(a) of this  
 12 section by a person required to report under ORS 163A.025 (2)(b)(A)(i) that the person reported, in  
 13 person, to the Department of State Police in Marion County, Oregon, within 10 days of moving into  
 14 this state.

15        (c) It is an affirmative defense to a charge of failure to report under subsection (1)(a) of this  
 16 section by a person required to report under ORS 163A.025 (2)(b)(B)(i) that the person reported, in  
 17 person, to the Department of State Police in Marion County, Oregon, within six months of moving

19        (d) It is an affirmative defense to a charge of failure to report under subsection (1) of this sec-  
 20 tion by a person required to report under ORS 163A.025 (2)(b)(A)(ii) or (B)(ii) that the person re-  
 21 ported, in person, to the Department of State Police in Marion County, Oregon, if the person  
 22 otherwise complied with all reporting requirements.

31        (g) It is an affirmative defense to a charge of failure to report under subsection (1) of this sec-  
 32 tion by a person required to report under ORS 163A.025 (2) or (3) that the person reported to the  
 33 Oregon Youth Authority or a county juvenile department if the person establishes that the authority  
 34 or department registered the person under ORS 163A.025 (8).

35        (3)(a) Except as otherwise provided in paragraph (b) of this subsection, failure to report as a sex  
 36 offender is a Class A misdemeanor.

37        (b) Failure to report as a sex offender is a Class C felony if the person violates:

38        (A) Subsection (1)(a) of this section; or

39        (B) Subsection (1)(b), (c), (d), (e) or [(g)] (h) of this section and the crime for which the person  
 40 is required to report is a felony.

41        (4) A person who fails to sign and return an address verification form as required by ORS  
 42 163A.035 (4) commits a violation.

 25 person, to the Department of State Police in Marion County, Oregon, within 10 days of moving into  
 26 this state.

27 (c) It is an affirmative defense to a charge of failure to report under subsection (1)(a) of this  
 28 section by a person required to report under ORS 163A.025 (2)(b)(B)(i) that the person reported, in  
 29 person, to the Department of State Police in Marion County, Oregon, within six months of moving  
 30 into this state.

31 (d) It is an affirmative defense to a charge of failure to report under subsection (1) of this sec-  
 32 tion by a person required to report under ORS 163A.025 (2)(b)(A)(ii) or (B)(ii) that the person re-  
 33 ported, in person, to the Department of State Police in Marion County, Oregon, if the person  
 34 otherwise complied with all reporting requirements.

35 (e) It is an affirmative defense to a charge of failure to report under subsection (1) of this sec-  
 36 tion by a person required to report under ORS 163A.025 (3) that the person reported, in person, to  
 37 the Department of State Police, a city police department or a county sheriff's office, in the county  
 38 of the person's residence, if the person otherwise complied with all reporting requirements.

39 (f) It is an affirmative defense to a charge of failure to report under subsection (1) of this section  
 40 by a person required to report under ORS 163A.010 (3) that the person reported to the Oregon Youth  
 41 Authority if the person establishes that the authority registered the person under ORS 163A.010  
 42 (3)(c).

43 (g) It is an affirmative defense to a charge of failure to report under subsection (1) of this sec-  
 44 tion by a person required to report under ORS 163A.025 (2) or (3) that the person reported to the  
 45 Oregon Youth Authority or a county juvenile department if the person establishes that the authority

1 or department registered the person under ORS 163A.025 (8).

2 (3)(a) Except as otherwise provided in paragraph (b) of this subsection, failure to report as a sex  
3 offender is a Class A misdemeanor.

4 (b) Failure to report as a sex offender is a Class C felony if the person violates:

5 (A) Subsection (1)(a) of this section; or

6 (B) Subsection (1)(b), (c), (d), (e) or [(g)] (h) of this section and the crime for which the person  
7 is required to report is a felony.

8 (4) A person who fails to sign and return an address verification form as required by ORS  
9 163A.035 (4) commits a violation.

10 **SECTION 7. The amendments to ORS 163A.040 by sections 5 and 6 of this 2019 Act apply**  
11 **to legal changes of name occurring on or after the effective date of this 2019 Act.**
