3	"INCORPORATION INTO CHAPTER
4	
5	" <u>SECTION 1.</u> Sections 2 to 19 of this 2019 Act are added to and made a part of ORS
6	chapter 540.
7	
8	"DEFINITIONS
9	
10	" <u>SECTION 2.</u> As used in sections 2 to 18 of this 2019 Act:
11	"(1) 'Construct' means:
12	"(a) To build a new dam;
13	"(b) To modify dam height; or
14	"(c) To make modifications to a dam that:
15	"(A) Do not include modifying dam height, performing maintenance actions or removing
16	a dam;
17	"(B) Have a potential impact on the safe functioning of the dam; and
18	"(C) Are to an extent that the modified dam structures no longer conform to the original
19	design.
20	"(2) 'Dam' means:
21	"(a) A hydraulic structure built above the natural ground gradeline that is used to
22	impound water or wastewater; and
23	"(b) Appurtenant structures on or adjacent to hydraulic structures described in para-
24	graph (a) of this subsection that affect the stability of, or the control of water through or
25	away from, the hydraulic structure.
26	"(3) 'Dam failure' means a rapid, sudden and uncontrolled release of water or
27	wastewater.
28	"(4) 'Emergency action plan' means a plan that assists a dam owner or operator, and
29	local emergency management personnel, to perform actions to ensure human safety in the
30	event of a potential or actual dam failure.
31	"(5) 'High hazard rating' means that the department expects loss of human life to occur
32	if a dam fails.
33	"(6) 'Maintenance action' means measures that are necessary to address a condition that,
34	if left unaddressed, may cause a dam to become unsafe or potentially unsafe.
35	"(7) 'Potentially unsafe' means that, based on an inspection or analysis:

1	"(a) It is probable that a dam cannot withstand an extreme flood or earthquake; or
2	"(b) The dam has a high risk of internal erosion.
3	"(8) 'Significant hazard rating' means the department does not expect loss of life to occur
4	if a dam fails, but does expect extensive damage to property or public infrastructure.
5	"(9) 'Unsafe' means that, based on an inspection or analysis:
6	"(a) It is probable that a dam cannot be depended upon to retain or pass water or
7	wastewater as designed or operated; and
8	"(b) Inability of the dam to retain or pass water or wastewater as designed or operated
9	could result in dam failure.
10	
11	"SCOPE OF DEPARTMENT PROGRAM
12	
13	"SECTION 3. (1) Sections 2 to 18 of this 2019 Act do not apply to:
14	"(a) A dam that is less than 10 feet in height; or
15	"(b) A dam that impounds less than 3 million gallons of water or wastewater.
16	"(2) Except as provided in this subsection, sections 2 to 18 of this 2019 Act do not apply
17	to dams regulated under a federal dam safety program. If there is a potential or actual risk
18	of dam failure at a dam regulated under a federal dam safety program, the Water Resources
	Department may aid in the inspection of the dam and may provide advice and assistance to
19	
20	prevent, mitigate or respond to a potential or actual dam failure.

22	"CONSTRUCTION PLAN APPROVAL
23	"SECTION 4 (1) A noncon more not construct a dam unloss the Water Decourses De
24	" <u>SECTION 4.</u> (1) A person may not construct a dam unless the Water Resources De-
25	partment has examined the site, plans and specifications, features and other supporting in-
26	formation regarding the construction and operation of the dam and has approved them in
27	writing.
28	"(2) Except as provided in this subsection, a dam may not be used to impound water or
29	wastewater until final documentation for the site, plans and specifications, features and
30	other supporting information of the dam has been submitted to and accepted by the depart-
31	ment after completion of construction. The Water Resources Commission may adopt rules
32	to allow all or a portion of a previously authorized impoundment during construction work
33	on a dam that is undergoing modification.
34	"(3) The department may charge a fee for an examination under subsection (1) of this
35	section of information regarding construction of a new dam or modification of a dam. The
36	fee may not exceed the lesser of the costs of providing the examination or:
37	"(a) \$1,750 for a dam that has a low hazard rating;
38	"(b) \$3,500 for a dam that has a significant hazard rating; or
39	"(c) \$8,500 for a dam that has a high hazard rating.
40	"(4) The department may waive the requirements in subsections (1) and (2) of this section
41	as necessary to address an actual or potential dam failure that poses an imminent risk to
42	life, property or public infrastructure, including but not limited to waiving the requirements
43	for actions identified in an emergency action plan.
44	
45	"REMOVAL OF DAM

"SECTION 5. (1) An owner seeking to remove a dam that has a significant hazard rating 1 2 or high hazard rating must notify the Water Resources Department and follow Water Resources Commission standards for safe dam removal. The owner shall provide the depart-3 4 ment with a removal plan sufficiently in advance of the removal to allow the department reasonable time for evaluating the plan. The department may evaluate the removal plan to 5 ensure that the plan includes appropriate safety precautions to protect life, property and 6 7 public infrastructure from temporary inundation in the area below the dam during dam re-8 moval. The department may require modification of the removal plan or require that the work performed under the plan be supervised by an engineer to the extent the department 9 concludes is necessary to protect life, property or public infrastructure from temporary 10 11 inundation during dam removal. If the department requires modification of a dam removal plan or requires that the work be supervised by an engineer, the department shall provide 1213the owner with an opportunity to meet with the department. "(2) A person may not perform removal work on a dam that has a significant hazard 14 rating or high hazard rating except as provided in subsection (1) of this section. 15

"INSPECTIONS

19 "SECTION 6. (1) The Water Resources Department, or agents or representatives of the department, may inspect a dam and the site, plans and specifications, features and other 2021supporting information regarding the construction, maintenance and operation of a dam. If 22a dam has a high hazard rating, the department shall ensure that the dam is inspected an-23nually unless the department determines that a different inspection schedule is appropriate. 24 "(2) In addition to inspections described in subsection (1) of this section, the department 25may, upon a written request from a person residing near a dam, conduct or order an in-26spection of a dam at any time during or after completion of construction.

"(3) The department shall provide the dam owner with an inspection document describing
the condition of the dam and specific maintenance actions recommended by the department.

"CORRECTIVE ACTION FOR UNSAFE OR POTENTIALLY UNSAFE CONDITIONS

33 "<u>SECTION 7.</u> (1) If, as the result of an inspection or analysis of a dam that has a high 34 hazard rating or significant hazard rating, the Water Resources Department concludes that 35 corrective action is necessary to address a condition allegedly rendering the dam unsafe or 36 potentially unsafe, the department shall notify the dam owner regarding:

"(a) Why the inspection or analysis of information and conditions causes the department
 to conclude that the dam is unsafe or potentially unsafe;

"(b) The action the department concludes is necessary to address the alleged unsafe or
 potentially unsafe condition;

41 "(c) The opportunity for the dam owner to meet with the department; and

42 "(d) The opportunity for the dam owner to provide information to challenge the
43 department's conclusion alleging that the dam is unsafe or potentially unsafe.

44 "(2) The department shall notify a dam owner under subsection (1) of this section by:

45 "(a) Registered mail; or

1 "(b) Certified mail with return receipt requested.

2 "SECTION 8. (1) If the Water Resources Department provides notification to a dam owner under section 7 of this 2019 Act stating that the department has concluded that a dam 3 4 having a significant hazard rating or high hazard rating is unsafe or potentially unsafe, the department may cooperate with dam owner efforts to develop a plan and time frame for 5 corrective action that is agreeable to the department. When determining whether a plan and 6 7 time frame for corrective action developed by a dam owner is agreeable to the department, the department may consider any relevant information, including, but not limited to, infor-8 mation regarding: 9

10 "(a) The specific dam;

11 "(b) The efforts and resources of the dam owner; and

12 "(c) The impacts associated with dam failure.

"(2) In addition to any other available remedies, the Water Resources Director may issue
a proposed final order containing one or more of the provisions described in subsection (3)
of this section if:

16 "(a) The department and the dam owner do not agree on a plan and time frame under 17 subsection (1) of this section for corrective action to resolve a condition identified in a no-18 tification that was sent by mail under section 7 of this 2019 Act;

19 "(b) The dam owner has failed to comply with a plan or time frame agreed to under 20 subsection (1) of this section; or

21

"(c) The department concludes, based on inspection or analysis, that the dam is unsafe.

22 "(3) If the director issues a proposed final order under subsection (2) of this section, the 23 director shall provide the dam owner with notice and opportunity for hearing under ORS 24 183.413 to 183.470. If the notice is provided by mail, the director shall use a form of mail de-25 scribed in section 7 of this 2019 Act. The proposed final order shall include the specific in-26 formation and conditions that have caused the department to conclude that the dam is 27 unsafe or potentially unsafe. The proposed final order may also include, but need not be 28 limited to, provisions:

29 "(a) Notifying the dam owner as described in section 7 of this 2019 Act why specific in-30 formation and conditions have caused the department to conclude that the dam is unsafe, if 31 that notification has not been provided.

32 "(b) Requiring that the dam owner consult with an engineer to assess the nature and 33 extent of the conditions specified by the department allegedly indicating that the dam is un-34 safe or potentially unsafe and, as necessary, to identify specific corrective action.

"(c) Specifying commencement and completion dates for any corrective action the de partment deems necessary to remedy the unsafe or potentially unsafe condition.

"(d) Restricting the maximum reservoir level until corrective action has been completed
 to the satisfaction of the department.

39 "(e) Directing that the dam may not be used for the storage, restraint or conveyance of 40 water until corrective action has been completed to the satisfaction of the department.

41 "(f) If the department concludes that monitoring is necessary to protect life, property 42 or public infrastructure, requiring the installation and use of monitoring equipment at a dam 43 to monitor unsafe or potentially unsafe conditions. If the department requires monitoring, 44 the department shall allow the use of the most economical monitoring equipment sufficient 45 to protect life, property and public infrastructure. 1 "(4) After issuing a proposed final order and allowing an opportunity for hearing, the di-2 rector may issue a final order as provided under ORS chapter 183.

"(5) The department and a dam owner may at any time use informal or alternative means, including but not limited to stipulation, agreed settlement or consent orders, to resolve a matter for which the department has notified the dam owner as described in section 7 of this 2019 Act.

SECTION 9. The Water Resources Department may accept the reports of consulting engineers, geologists or other specialists employed by the dam owner. If the department concludes that the reports are insufficient, the department may employ consulting engineers, geologists or other specialists as agents or representatives of the department to make special examinations and inspections and to prepare reports for the department. The cost of such special examinations, inspections and reports shall be paid by the department or, upon mutual agreement, may be divided between the department and the dam owner.

"MAINTENANCE ACTIONS

17 "<u>SECTION 10.</u> (1) If, as the result of an inspection under section 6 of this 2019 Act of a 18 dam that has a significant hazard rating or high hazard rating, the Water Resources De-19 partment concludes that maintenance actions are needed, the department shall inform the 20 dam owner of the need for maintenance actions. The department shall provide the infor-21 mation by inclusion in the inspection document and provide the dam owner with the oppor-22 tunity to meet with the department concerning the information.

"(2) If the department or its agent or representative conducts an inspection and the department determines that the dam owner has failed to take needed maintenance actions identified in a prior inspection document, in addition to any other available remedies, the Water Resources Director may issue a proposed final order under subsection (3) of this section. A proposed final order under subsection (3) of this section shall include notice and opportunity for hearing under ORS 183.413 to 183.470.

29 "(3) Subject to subsection (2) of this section, the director may issue a proposed final or-30 der that includes, but need not be limited to, provisions:

"(a) Requiring the dam owner to perform the needed maintenance actions by a specified
 date; and

33 "(b) Imposing a civil penalty under section 19 of this 2019 Act, not to exceed an amount 34 established by the Water Resources Commission by rule, for failing to address the needed 35 maintenance actions identified in the proposed final order or failing to comply with a resol-36 ution reached through informal or alternative means.

37 "(4) If the dam owner performs needed maintenance actions required by a proposed final 38 order issued under subsection (3) of this section to the satisfaction of the department by the 39 date specified in the proposed final order, the director may not impose any civil penalty that 40 was described in the proposed final order.

41 "(5) After issuing a proposed final order and allowing an opportunity for hearing, the di42 rector may issue a final order as provided under ORS chapter 183.

43 "(6) The department and a dam owner may at any time use informal or alternative 44 means, including but not limited to stipulation, agreed settlement or consent orders, to re-45 solve a matter for which the department has notified the dam owner as described in this 1 section.

"ENFORCEMENT

⁵ "<u>SECTION 11.</u> If the Water Resources Director issues a proposed final order under section 8 of this 2019 Act, regarding a dam that the Water Resources Department has concluded is unsafe, and the director requests that the scheduling of any contested case hearing on the proposed final order be expedited, the Office of Administrative Hearings shall expedite the date of the contested case hearing to the extent that the office considers is practicable and will give the dam owner reasonable time to prepare.

SECTION 12. In addition to any other available remedies, if the Water Resources Department has information that a person is violating or intends to violate a final order issued under section 8 of this 2019 Act, or concludes that a dam poses an imminent risk to life, property or public infrastructure, the department may apply to the circuit court for Marion County or to the circuit court for any county where all or part of the dam is located for a temporary or permanent injunction requiring the person to:

"(1) Refrain from violation of the order; or

"(2) Take any actions necessary to remedy an imminent risk to life, property or public
 infrastructure.

20 "<u>SECTION 13.</u> In addition to any other available remedies, if an order issued under section 8 (4) of this 2019 Act becomes final by operation of law or on appeal, and the dam owner fails to comply with the order, the Water Resources Department may request that the Attorney General or the district attorney of any county where all or part of the dam is located bring an action to have the dam declared a public nuisance that must be removed at the dam owner's expense.

"EMERGENCY PLANNING; EMERGENCIES

"<u>SECTION 14.</u> (1) The owner of record of a dam shall: "(a) Provide the Water Resources Department with contact information in an emergency

action plan, or in writing if no emergency action plan exists, for:

32 "(A) The dam owner;

33 "(B) The operator of the dam, if other than the owner; and

34 "(C) The individual in immediate charge of the dam;

"(b) Notify the department of any changes in the contact information provided under this
 subsection; and

"(c) Provide the department with notice, in a form acceptable to the department, after
 completing a transfer of title for the dam.

39 "(2) The dam owner shall review and evaluate the conditions at the dam as necessary to:

40 "(a) Keep the dam in good repair and properly maintained; and

41 "(b) Address any detected conditions that may pose a risk of dam failure.

42 "<u>SECTION 15.</u> (1) The Water Resources Department shall require the owner of a dam 43 that has a high hazard rating to develop an emergency action plan for the dam.

44 "(2) An emergency action plan required under this section must include, but need not be
45 limited to:

1 "(a) Means for emergency condition detection;

2 "(b) Means for emergency level determination;

"(c) Identification of, and information necessary for, notifications and communications
to be made at each level of emergency condition;

5 "(d) A description of actions expected to be undertaken to prevent dam failure or reduce
6 the effects of dam failure;

"(e) A map of dam failure inundation zones for varying conditions, including, but not
limited to, dry weather conditions and high flood conditions; and

"(f) Procedures to be followed at the termination of an emergency.

"(3) A dam owner that develops an emergency action plan required under this section shall file copies of the plan with the department, the Office of Emergency Management and the local emergency services agency for the county where the dam is located. The department, in consultation with the office and local emergency services agency, shall periodically review the emergency action plan and may require updates to the plan.

"(4) The department, in consultation with the office and local emergency services agency,
 shall determine the appropriate frequency for conducting emergency response exercises at
 a dam that has a high hazard rating.

18 "<u>SECTION 16.</u> (1) If an actual or potential dam failure creates an imminent risk to life, 19 property or public infrastructure, and an emergency action plan exists for the dam, the dam 20 owner shall immediately implement the actions specified in the plan.

"(2) If an actual or potential dam failure creates an imminent risk to life, property or
 public infrastructure, and no emergency action plan exists for the dam, the dam owner shall
 immediately:

"(a) Notify by telephone or other method that ensures immediate notification:

25 "(A) If the dam has a significant hazard rating, the local emergency services agency for 26 the county where the dam is located;

27 "(B) The Water Resources Department; and

28 "(C) To the extent practicable, persons in areas where the potential for dam failure cre-29 ates a risk to life, property or public infrastructure; and

"(b) Take all practicable actions to prevent dam failure.

31 "(3) If the department is aware of conditions that indicate the need for immediate action 32 to prevent dam failure, the department may advise the owner or operator of the dam or the 33 individual in immediate charge of the dam regarding the actions necessary to prevent the 34 dam failure.

³⁵ "(4) The department may communicate and coordinate actions necessary to reduce the ³⁶ risk of dam failure. If there is a rapidly increasing leakage or risk of overtopping at a dam ³⁷ that has a significant hazard rating or high hazard rating, the department may open gates ³⁸ or valves and may siphon or pump water to reduce the water level in the reservoir. Activities ³⁹ under this subsection by the department do not relieve the owner, the operator or an indi-⁴⁰ vidual in immediate charge of a dam from the responsibility to prevent the dam failure.

41 "(5) If a dam that has a significant hazard rating or high hazard rating presents an im-42 minent risk of dam failure, the department or its agent or representative may enter without 43 notice or permission upon any property that affords access to the dam to the extent entry 44 is reasonable or necessary to allow evaluation of the condition or risk or to undertake 45 actions described in subsection (4) of this section.

27	"EFFECT ON RESPONSIBILITIES AND LIABILITY
28	
29	" <u>SECTION 18.</u> (1) Compliance with sections 2 to 18 of this 2019 Act does not relieve the
30	owner or operator of a dam or an individual in immediate charge of a dam from any duty,
31	obligation or liability regarding the ownership, maintenance or operation of the dam.
32	"(2) Water Resources Department actions and services under sections 2 to 18 of this 2019
33	Act do not relieve the owner or operator of a dam or an individual in immediate charge of
34	a dam from any duty, obligation or liability regarding the ownership, maintenance or opera-
35	tion of the dam.

37	"CIVIL PENALTIES
38	
39	" <u>SECTION 19.</u> (1) The Water Resources Director may impose a civil penalty of not more
40	than \$2,000 per occurrence for a violation of sections 4, 5 or 15 of this 2019 Act.
