

House Bill 2118

Introduced and printed pursuant to House Rule 12.00. Pre-session filed (at the request of House Interim Committee on Revenue)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Standardizes use of consumer price index for purposes of indexing values in statutes and session law.

Be It Enacted by the People of the State of Oregon:

7 **SECTION 1.** Section 3, chapter 390, Oregon Laws 2017, is amended to read:

9 **Sec. 3.** (1) On January 1, 2021, the Oregon Department of Administrative Services shall deter-
10 mine the cumulative percentage increase or decrease in the cost of living for the previous four
11 years, based on changes in the [*Portland-Salem, OR-WA, Consumer Price Index for All Urban Con-*
12 *sumers for All Items*] **Consumer Price Index for All Urban Consumers, West Region (All**
13 **Items)**, as published by the Bureau of Labor Statistics of the United States Department of Labor.
14 The Oregon Department of Administrative Services shall adjust the fees under ORS 21.300 (1) and
15 (4) as follows:

16 (a) If the cost of living has increased, the department shall adjust the fees by multiplying the fee
17 amounts by the percentage amount determined under this subsection. The department shall round
18 the adjusted fees up to the nearest \$1. The adjusted fees become effective on July 1, 2021, and apply
19 to all fees incurred on or after July 1, 2021.

20 (b) If the cost of living has not increased, the department may not change the fees.

21 (2) After the department adjusts the fees under ORS 21.300 (1) and (4) as provided in subsection
22 (1) of this section, the department shall promptly notify the Oregon State Sheriffs' Association of the
23 adjusted fees.

24 **SECTION 2.** ORS 30.271 is amended to read:

25 30.271. (1) The limitations imposed by this section apply to claims that:

26 (a) Are subject to ORS 30.260 to 30.300;

27 (b) Are made against the state, or against an officer, employee or agent of the state acting

30 (d) Are not claims for damage to or destruction of property.

4 and agents acting within the scope of their employment or duties, to any single claimant for claims

45 (b) Are made against a public body, or against a public body's officers, employees and agents

1 acting within the scope of their employment or duties;

2 (c) Arise out of a single accident or occurrence; and

3 (d) Are claims for damage to or destruction of property, including consequential damages.

4 (2) The liability of a public body, and the liability of the public body's officers, employees and
5 agents acting within the scope of their employment or duties, for claims described in subsection (1)
6 of this section may not exceed:

7 (a) \$100,000, or the adjusted limitation provided by subsection (3) of this section, to any single
8 claimant.

9 (b) \$500,000, or the adjusted limitation provided by subsection (3) of this section, to all claim-
10 ants.

11 (3) Beginning in 2010, and every year thereafter, the State Court Administrator shall determine
12 the percentage increase or decrease in the cost of living for the previous calendar year, based on
13 changes in the [*Portland-Salem, OR-WA Consumer Price Index for All Urban Consumers for All*
14 *Items*] **Consumer Price Index for All Urban Consumers, West Region (All Items)**, as published
15 by the Bureau of Labor Statistics of the United States Department of Labor. On or before July 1

17 section, the State Court Administrator shall adjust the limitations imposed under subsection (2) of

27 58.187. (1) For the purpose of revising the amounts of the limitation on joint and several liability
28 described in ORS 58.185 (5) and (8) to reflect the effects of inflation or deflation, the Secretary of
29 State shall multiply the amounts under ORS 58.185 (5) and (8) by the inflation factor described in
30 this section every six years. The six-year cycle shall begin January 1, 1994. The Secretary of State
31 shall round the amount to the nearest \$50,000 and publish the revised amount as a rule not later
32 than February 1 following the end of the six-year cycle. The revised limitation shall take effect
33 February 1 and apply for the next six years.

34 (2) For purposes of this section[:],

35 [(a)] the inflation factor shall be a number determined by dividing the [*June 30*] Consumer Price
36 **Index for All Urban Consumers, West Region (All Items), as published by the Bureau of La-**

41 [(b)] *The "Consumer Price Index" is the Portland Consumer Price Index for All Urban Consumers*

43 *United States Department of Labor. If the index is discontinued or no longer published at least semi-*
44 *annually, the Secretary of State shall select an alternative index that, in the discretion of the Secretary*
45 *of State, reasonably approximates changes in consumer spending power in the Portland, Oregon, met-*

2 **SECTION 6.** ORS 90.490 is amended to read:

3 90.490. (1) A tenant may bring an action against a building landlord if for the purpose of
4 avoiding, or assisting a declarant of a conversion condominium in avoiding, the requirements under
5 ORS 100.301 to 100.320:

6 (a) Within one year before the declarant records the declaration under ORS 100.100, the landlord
7 gives a tenant a 30-day notice without stated cause; or

8 (b) Within one year before the declarant records the declaration under ORS 100.100, the landlord
9 increases the rent in excess of the percentage increase in the [*Portland-Salem Consumer Price Index*
10 *for All Urban Consumers for All Items as reported by the United States Bureau of Labor Statistics*]
11 **Consumer Price Index for All Urban Consumers, West Region (All Items), as published by**
12 **the Bureau of Labor Statistics of the United States Department of Labor.**

13 (2) If a court finds that a landlord has taken an action described in subsection (1) of this section
14 for the purpose of avoiding, or assisting a declarant of a conversion condominium in avoiding, the
15 requirements under ORS 100.301 to 100.320, the court may award the tenant the greater of:

16 (a) Six times the monthly rent for the dwelling unit; or

17 (b) Twice the actual damages to the tenant arising out of the termination or rent increase.

18 (3) The time allowed under ORS 12.125 to commence an action under this section begins on the
19 date the declarant records the declaration under ORS 100.100.

20 **SECTION 7.** ORS 90.493 is amended to read:

21 90.493. (1) The landlord of a building for which a declarant of a conversion condominium has
22 issued the tenant a notice of conversion under ORS 100.305 may not:

23 (a) Give the tenant a 30-day notice without stated cause that causes the tenancy to terminate
24 on a date that is prior to the end of the 120-day period described in ORS 100.305 or the 60-day period
25 described in ORS 100.310; or

26 (b) Increase the rent for the dwelling unit in excess of:

27 (A) Any scheduled increase provided for in a written rental agreement; or

28 (B) A percentage equal to the percentage increase in the [*Portland-Salem Consumer Price Index*
29 *for All Urban Consumers for All Items as reported by the United States Bureau of Labor Statistics*]
30 **Consumer Price Index for All Urban Consumers, West Region (All Items), as published by**
31 **the Bureau of Labor Statistics of the United States Department of Labor.**

32 (2) A tenant may bring an action against a landlord that violates subsection (1) of this section
33 to recover the greater of:

34 (a) Six times the monthly rent for the dwelling unit; or

35 (b) Twice the actual damages to the tenant arising out of the termination.

36 **SECTION 8.** ORS 100.305 is amended to read:

37 100.305. (1) A declarant of a conversion condominium shall give each of the existing tenants of
38 any building which the declarant intends to submit to the provisions of this chapter notice of the
39 conversion at least 120 days before the conversion condominium is submitted to the provisions of
40 this chapter. Thereafter, until the property is submitted to the provisions of this chapter, the
41 declarant shall provide a copy of such notice to any new tenant before the commencement of the
42 tenancy. The notice of conversion shall:

43 (a) State that the declarant intends to create a conversion condominium and include general
44 information relating to the nature of condominium ownership.

45 (b) State that the notice does not constitute a notice to terminate the tenancy.

1 (c) State whether there will be a substantial alteration of the physical layout of the unit.

2 (d) State whether the declarant intends to offer the unit for sale and, if so:

3 (A) Set forth the rights of the tenant under ORS 100.310 (1) to (3), including the time available
4 for the declarant to make an offer to sell and for the tenant to respond;

5 (B) Set forth a good faith estimate of the approximate price range for which the unit will be
6 offered for sale to the tenant under ORS 100.310 (1) and (2);

7 (C) Set forth a good faith estimate of the monthly operational, maintenance and any other
8 common expenses or assessments appertaining to the unit;

9 (D) State that financial assistance for purchasing the unit may be available from a local gov-
10 erning body, the Housing and Community Services Department or a regional housing center;

11 (E) Give contact information for the local regional housing center or, if no regional housing
12 center exists, for the Housing and Community Services Department; and

13 (F) State that the landlord may not terminate the tenancy without cause if the termination
14 would take effect before the end of the 120-day period described in this subsection or the 60-day
15 period described in ORS 100.310.

22 During the 120 days following the receipt of this notice, your landlord may increase your rent
23 only as follows:

24 If your rental agreement says that your rent will increase on a particular date and by a definite
25 amount, the landlord may increase the rent as provided in your rental agreement.

26 If your rental agreement allows rent increases but does not say that your rent will increase on
27 a particular date and by a definite amount, the landlord may not increase your rent by a percentage
28 that is more than the percentage increase in the general cost of living. An increase in the general
29 cost of living is measured by the percentage increase in the [*Portland-Salem Consumer Price Index*
30 *for All Urban Consumers for All Items as reported by the United States Bureau of Labor Statistics*]
31 **Consumer Price Index for All Urban Consumers, West Region (All Items), as published by**
32 **the Bureau of Labor Statistics of the United States Department of Labor.**

35 (f) Be hand delivered to the dwelling unit of the tenant or sent to the tenant at the address of
36 the dwelling unit by certified mail, return receipt requested.

37 (2) A notice of conversion given under subsection (1) of this section:

38 (a) Shall be for the sole purpose of providing the tenant with general information regarding the
39 anticipated cost of acquisition of the unit and estimated monthly expenses.

40 (b) Does not obligate the declarant to submit the property to the provisions of this chapter.

41 (c) Does not constitute an offer to sell the unit to the tenant or an offer to sell at a particular
42 price.

43 (d) Is not a limitation on monthly common expenses or assessments.

44 (3) The notice of conversion given under subsection (1) of this section must be delivered to the
45 tenant at least 30 days prior to the presentation of an offer to sell under ORS 100.310 (1) and (2).

1 (4) The declarant shall send a copy of the notice of conversion to the mayor of the city in which
 2 the conversion condominium is located or, if the conversion condominium is not located in a city,
 3 to the county commission or county court.

4 (5) A notice of conversion that does not contain the information required by subsection (1)(a)
 5 to (e) of this section, or that is not sent to the mayor, county commission or county court as re-
 6 quired by subsection (4) of this section, does not begin the 120-day period required by subsection (1)
 7 of this section. Notwithstanding any prior delivery of a deficient notice of conversion, the 120-day
 8 period required by subsection (1) of this section does not begin until the date a valid notice is de-
 9 livered. A tenant, mayor, county commission or county court entitled to notice may bring an action
 10 for injunctive relief to prevent the conversion until the declarant has complied with the notice re-
 11 quirement.

12 (6) The declaration may be recorded prior to the end of the 120-day period required under sub-
 13 section (1) of this section with the written consent of all tenants who received the notice of con-
 14 version less than 120 days before the date of such consent.

15 (7) The requirement under subsection (1) of this section to provide a copy of the notice of con-
 16 version to new tenants shall not extend the 120-day period nor shall such tenant's consent be re-
 17 quired to record the declaration prior to the end of the 120-day period as provided for under
 18 subsection (6) of this section.

19 (8) A notice of conversion does not constitute a notice to terminate the tenancy.

20 **SECTION 9.** ORS 196.815 is amended to read:

21 196.815. (1) A person who is required to have a permit to remove material from the bed or banks
 22 or fill any waters of this state shall file a written application with the Director of the Department
 23 of State Lands for each individual project before performing any removal or fill.

24 (2)(a) Except as otherwise may be provided by the rules of the Department of State Lands for
 25 removal or fill permits related to ocean renewable energy facilities as defined in ORS 274.870, each
 26 application under subsection (1) of this section must be accompanied by a base fee in accordance
 27 with the following schedule:

28 (A) For a removal by a private operator, or a person contracting to perform services for a pri-
 29 vate operator, \$85.

30 (B) For a removal by a public body, \$250.

31 (C) For a removal by a commercial operator, \$250.

32 (D) For a fill by a private operator, or a person contracting to perform services for a private
 33 operator, \$250.

34 (E) For a fill by a public body, \$620.

35 (F) For a fill by a commercial operator, \$620.

36 (G) For erosion-flood repair, including riprap, no fee.

37 (b) In addition to the base fee for removal established under paragraph (a) of this subsection,
 38 each applicant shall also pay as part of the application fee the following fee based on the volume
 39 of removal material:

40 (A) Less than 500 cubic yards, no volume fee.

41 (B) 500 to less than 5,000 cubic yards, \$125.

42 (C) 5,000 to less than or equal to 50,000 cubic yards, \$250.

43 (D) Over 50,000 cubic yards, \$375.

44 (c) In addition to the base fee for fill established under paragraph (a) of this subsection, each
 45 applicant shall also pay as part of the application fee the following fee based on the volume of fill

1 material:

2 (A) Less than 500 cubic yards, no volume fee.

3 (B) 500 to less than 3,000 cubic yards, \$125.

4 (C) 3,000 to less than or equal to 10,000 cubic yards, \$250.

5 (D) Over 10,000 cubic yards, \$375.

6 (d) The department may establish by rule a volume-based fee for the commercial removal of sand
7 and gravel from the waters of this state for use in administering the provisions of the fill and re-
8 moval law in this state.

9 (e) For the purposes of this subsection:

10 (A) "Private operator" means any person undertaking a project for exclusively a nonincome-
11 producing and nonprofit purpose;

12 (B) "Public body" means federal, state, and local governmental bodies, unless specifically ex-
13 empted by law, engaged in projects for the purpose of providing free public services;

14 (C) "Commercial operator" means any person undertaking a project having financial profit as
15 a goal;

16 (D) "Riprap" means the facing of a streambank with rock or similar substance to control erosion
17 in accordance with rules adopted by the department; and

18 (E) "Erosion-flood repair" means riprap or any other work necessary to preserve existing facil-
19 ities and land from flood and high streamflows, in accordance with regulations promulgated by the
20 department.

21 (3) For each application that involves both removal and filling, the application fee assessed shall
22 be either for removal or filling, whichever is higher according to the fee schedule in subsection (2)
23 of this section.

24 (4) The department may waive the fees specified in subsection (2) of this section for a permit
25 that will be used to perform a voluntary habitat restoration project.

26 (5) A person who receives an emergency authorization under ORS 196.810 to remove material
27 from the beds or banks of any waters of this state or to fill any waters of this state shall, within
28 45 days after receiving the authorization, submit a fee to the department calculated in the manner
29 provided under this section for permit applications.

30 (6) Each holder of a material removal or fill permit shall pay a fee during the term of the permit
31 in accordance with the schedule set forth in subsection (2) of this section, except that the applicant
32 shall pay only the base fee. For multiyear permits valid over a period of more than one year, the
33 department may assess a one-time fee that covers all fees due under subsection (2) of this section
34 for the period of the permit. The permit shall be suspended during any period of delinquency of
35 payment as though no permit was applied for. Notwithstanding this subsection the director may,
36 before granting a renewal of the permit, require the permittee to show that the continued exercise
37 of the permit is consistent with the protection, conservation and best use of the water resources of
38 this state.

39 (7) Fees received under this section shall be credited to the Common School Fund for use by the
40 department in administration of ORS 196.600 to 196.905.

41 (8) The director shall issue an order revising the fees specified in this section on January 1 of
42 each year, beginning in 2009, based on changes in the [*Portland-Salem, OR-WA Consumer Price In-*
43 *dex for All Urban Consumers for All Items*] **Consumer Price Index for All Urban Consumers,**
44 **West Region (All Items)**, as published by the Bureau of Labor Statistics of the United States De-
45 partment of Labor. The director shall round the amount of each fee to the nearest dollar. The re-

1 revised fees shall take effect January 1 and apply for that calendar year.

2 **SECTION 10.** ORS 196.818 is amended to read:

45 (3) The holder of a full on-premises sales license shall allow a patron to remove a partially

1 consumed bottle of wine from the licensed premises if the wine is served in conjunction with the
 2 patron's meal, the patron is not a minor and the patron is not visibly intoxicated.

3 (4) The holder of a full on-premises sales license is entitled to purchase any distilled liquor from
 4 an agent of the commission appointed pursuant to ORS 471.750 at a discount of not more than five
 5 percent off the regular listed price fixed by the commission, together with all taxes, in a manner
 6 prescribed by commission rule. For purposes of compensation by the commission, the appointed
 7 agent shall be credited with such sales at full retail cost. The commission may not require the

35 (17) Adopt rules necessary to carry out and enforce the provisions of ORS 830.950 and 830.955.
 36 The rules shall include but need not be limited to:

37 (a) The kinds of protective covering or physical barriers that are acceptable to be used between
 38 a submersible polystyrene device and the water.

39 (b) Guidelines for the use of submersible polystyrene devices for the repair or maintenance of
 40 existing docks or floats.

41 (18) Adopt rules providing for establishment of a Safe Boating Education Course to be made
 42 available to courts and law enforcement agencies within this state for use as a sentencing option
 43 for those individuals convicted of boating offenses. The board shall specify the content of the Safe
 44 Boating Education Course and shall prescribe procedures for making the course available to local
 45 courts and law enforcement agencies, including procedures for promptly notifying such courts

1 whether individuals required to enroll in the course have taken and successfully passed the course.
2 Such rules may provide for administration of the course through nonprofit organizations, such as the
3 United States Coast Guard Auxiliary, United States Power Squadrons or similar groups.

4 (19) For purposes of ORS 830.175, 830.180, 830.185, 830.187 and 830.195, in cooperation with the
5 State Aviation Board, regulate boats that are seaplanes as provided in ORS 830.605 and 835.200.

6 **SECTION 39. The amendments to statutes and session law by sections 1 to 38 of this 2019**
7 **Act apply to computations required under the statutes and session law made on or after the**
8 **effective date of this 2019 Act. The amendments to statutes and session law by sections 1 to**
9 **38 of this 2019 Act do not require the recomputation of any computation made under the**
10 **statutes and session law before the effective date of this 2019 Act.**
