SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires that transfer of tax credit follow uniform transfer procedures. Authorizes Department of Revenue to prescribe additional procedural requirements for transfer of credits. Requires certifying agencies to provide information about certification of tax credits to Department of Revenue. Authorizes director of certifying agency to suspend or revoke tax credit certification in certain circumstances. Allows Department of Revenue to collect unpaid taxes in case of suspension or revocation of transferable credit.

Applies to tax credits that are transferred on or after January 1, 2020.
Takes effect on 91st day following adjournment sine die.

Be It Enacted by the People of the State of Oregon:

ADMINISTRATION OF TAX CREDIT PROVISIONS

SECTION 1. Sections 2 to 4 of this 2019 Act are added to and made a part of ORS chapter 315.

SECTION 2. (1) Transfer of any transferable tax credit that is allowed under this chapter or ORS chapter 316 or 317 and that is transferred on or after January 1, 2020, is conditioned upon compliance with this section and ORS 315.052 and 315.053.

(2) The Department of Revenue may require that the person that has earned the credit and the taxpayer that intends to claim the credit jointly file a notice of tax credit transfer with the department on or before the earliest of the following dates:

- (a) A date 30 days after the transfer of the credit;**
 - (b) The date on which the transferee files a return; or**
 - (c) The due date, including extensions, of the transferee's return.**
- (3) The notice shall be given on a form prescribed by the department that contains:**
- (a) The name and address of the transferor and of the transferee;**
 - (b) The taxpayer identification number of the transferor and of the transferee;**
 - (c) The dates on which the person earning the credit received certifications for the**

1 credit;

2 (d) The amount of the credit that is certified, the amount that is being transferred and
3 the amount that is being retained by the transferor; and

4 (e) Any other information required by the department.

5 (4)(a) If a tax credit must be claimed over multiple tax years, a transferor may separately
6 transfer the entirety of that portion corresponding to each tax year to one or more
7 transferees, subject to subsection (5) of this subsection.

8 (b) Any amount of credit that would be allowed due only to a carryforward provision may
9 not be transferred.

10 (5) Any transfer of a tax credit or a portion of a tax credit must be completed no later
11 than the earliest of the following dates in relation to the tax return on which it is claimed:

12 (a) The original due date, including extensions, of the transferor's return;

13 (b) The date on which the transferor's return is actually filed;

14 (c) The original due date, including extensions, of the transferee's return; or

15 (d) The date on which the transferee's return is actually filed.

16 (6) Notwithstanding subsection (5) of this section, if the transferor is a tax-exempt entity,
17 the transfer must be completed on or before a date one year after the close of the tax year
18 for which the credit receives final certification. As used in this subsection "tax-exempt
19 entity" means a government agency or an organization that is recognized as exempt under
20 section 501(c)(3) of the Internal Revenue Code.

21 (7) The transferee shall claim the credit in accordance with the credit provisions for the
22 tax years in which the credit is allowed.

23 (8) The department by rule may establish policies and procedures for the implementation
24 of this section.

25 **SECTION 3.** (1) For any tax credit that is allowed under this chapter or ORS chapter 316
26 or 317 and for which certification, determination of eligibility or other approval from an
27 agency other than the Department of Revenue is required and was issued on or after January
28 1, 2019, the department may require that the other agency provide information about the
29 certification, determination of eligibility or other approval, including the name and taxpayer
30 identification number of the taxpayer or other person receiving approval, the date the ap-
31 proval was issued in its final form, the approved amount of credit and the first tax year for
32 which the credit may be claimed.

33 (2) Within two months after the close of the tax year in which the approval was issued,
34 a taxpayer that is a pass-through entity that has received approval shall provide to the de-
35 partment, in the manner prescribed by the department, the name and taxpayer identification
36 number of each owner receiving a distributive share of the credit and any other information
37 required by the department pertaining to an owner receiving a distributive share.

38 **SECTION 4.** (1) Under the procedures for a contested case under ORS chapter 183, the
39 director of the agency responsible for certifying or otherwise determining eligibility or
40 granting approval for a tax credit allowed under this chapter or ORS chapter 316 or 317 may
41 order the suspension, revocation or forfeiture of the tax credit approval or of a portion
42 thereof if the director finds that:

43 (a) The approval was obtained by fraud or misrepresentation;

44 (b) The approval was obtained by mistake or miscalculation; or

45 (c) The taxpayer otherwise violates or has violated a condition or requirement for eligi-

1 **bility for the tax credit.**

2 (2) **As soon as an order of revocation under this section becomes final, the director shall**
3 **notify the Department of Revenue and the person that received the tax credit certification,**
4 **or other approval, of the order of revocation. Upon notification, the Department of Revenue**
5 **immediately shall proceed to collect:**

6 (a) **If no portion of a credit has been transferred, those taxes not paid by the holder of**
7 **the certificate or other approval as a result of the tax credits provided to the holder under**
8 **the revoked approval, from the holder or a successor in interest to the business interests**
9 **of the holder. All tax credits provided to the holder and attributable to the fraudulently or**
10 **mistakenly obtained approval or portion of the approval shall be forfeited.**

11 (b) **If all of a credit has been transferred, an amount equal to the amount of the tax**
12 **credits allowable to the transferee under the revoked approval, from the transferor.**

13 (c) **If a portion of a tax credit has been transferred, those taxes not paid by the**
14 **transferor as a result of the tax credits provided to the transferor pursuant to the revoked**
15 **approval, from the transferor or a successor in interest to the business interests of the**
16 **transferor, and an amount equal to the amount of the tax credits allowable to the transferee**
17 **pursuant to the revoked approval, from the transferor.**

18 (3)(a) **The Department of Revenue shall have the benefit of all laws of the state pertain-**
19 **ing to the collection of income and excise taxes and may proceed to collect the amounts de-**
20 **scribed in subsection (2) of this section from the person that obtained approval or a**
21 **successor in interest to the business interests of that person. An assessment of tax is not**
22 **necessary and the collection of taxes described in this subsection is not precluded by any**
23 **statute of limitations.**

24 (b) **For purposes of this subsection, a lender, bankruptcy trustee or other person that**
25 **acquires an interest through bankruptcy or through foreclosure of a security interest is not**
26 **considered to be a successor in interest to the business interests of the person that obtained**
27 **approval.**

28 (4) **If the approval is ordered revoked pursuant to this section, the holder of the certif-**
29 **icate or other approval shall be denied any further relief in connection with the credit from**
30 **and after the date that the order of revocation becomes final.**

31 (5) **Notwithstanding subsections (1) to (4) of this section, a certificate or portion of a**
32 **certificate held by a transferee may not be considered revoked for purposes of the**
33 **transferee, the tax credit allowable to the transferee may not be reduced and a transferee**
34 **is not liable under this section.**

35 (6) **Interest under this section shall accrue at the rate established in ORS 305.220 begin-**
36 **ning the day after the due date of the return on which the credit may first be claimed.**

37 (7) **The Department of Revenue may collect amounts owed under this section by a part-**
38 **nership from the partnership.**

39 **SECTION 5.** ORS 315.053 is amended to read:

40 315.053. An income tax credit allowed under [ORS 315.141, 315.331, 315.336, 315.341 or 315.354
41 or section 12, chapter 855, Oregon Laws 2007,] **this chapter or ORS chapter 316 or 317 that is**
42 **transferable** may be transferred or sold only to one or more of the following:

- 43 (1) A C corporation.
- 44 (2) An S corporation.
- 45 (3) A personal income taxpayer.

TRANSFERABLE TAX CREDIT PROVISIONS

SECTION 6. ORS 315.141 is amended to read:

315.141. (1) As used in this section:

(a) "Agricultural producer" means a person that produces biomass in Oregon that is used, in Oregon, as biofuel or to produce biofuel.

(b) "Biofuel" means liquid, gaseous or solid fuels, derived from biomass, that have been converted into a processed fuel ready for use as energy by a biofuel producer's customers or for direct biomass energy use at the biofuel producer's site.

(c) "Biofuel producer" means a person that through activities in Oregon:

(A) Alters the physical makeup of biomass to convert it into biofuel;

(B) Changes one biofuel into another type of biofuel; or

(C) Uses biomass in Oregon to produce energy.

(d) "Biomass" means organic matter that is available on a renewable or recurring basis and that is derived from:

(A) Forest or rangeland woody debris from harvesting or thinning conducted to improve forest or rangeland ecological health and reduce uncharacteristic stand replacing wildfire risk;

(B) Wood material from hardwood timber described in ORS 321.267 (3);

(C) Agricultural residues;

(D) Offal and tallow from animal rendering;

(E) Food wastes collected as provided under ORS chapter 459 or 459A;

(F) Wood debris collected as provided under ORS chapter 459 or 459A;

(G) Wastewater solids; or

(H) Crops grown solely to be used for energy.

(e) "Biomass" does not mean wood that has been treated with creosote, pentachlorophenol, inorganic arsenic or other inorganic chemical compounds or waste, other than matter described in paragraph (d) of this subsection.

(f) "Biomass collector" means a person that collects biomass in Oregon to be used, in Oregon, as biofuel or to produce biofuel.

(g) "Canola" means plants of the genus Brassica:

(A) In which seeds having a high oil content are the primary economically valuable product; and

(B) That have a high erucic acid content suitable for industrial uses or a low erucic acid content suitable for edible oils.

(h) "Oilseed processor" means a person that receives agricultural oilseeds and separates them into meal and oil by mechanical or chemical means.

(i) "Willamette Valley" means Clackamas, Linn, Marion, Multnomah, Polk, Washington and Yamhill Counties and the portion of Benton and Lane Counties lying east of the summit of the Coast Range.

(2) The Director of the State Department of Energy may adopt rules to define criteria, only as the criteria apply to organic biomass, to determine additional characteristics of biomass for purposes of this section.

(3)(a) An agricultural producer or biomass collector shall be allowed a credit against the taxes that would otherwise be due under ORS chapter 316 or, if the taxpayer is a corporation, under ORS chapter 317 or 318 for:

(A) The production of biomass in Oregon that is used, in Oregon, as biofuel or to produce

1 biofuel; or

2 (B) The collection of biomass in Oregon that is used, in Oregon, as biofuel or to produce biofuel.

3 (b) A credit under this section may be claimed in the tax year in which the credit is certified
4 under subsection (5) of this section.

5 (c) A taxpayer may be allowed a credit under this section for more than one of the roles defined
6 in subsection (1) of this section, but a biofuel producer that is not also an agricultural producer or
7 a biomass collector may not claim a credit under this section.

8 (d) A credit under this section may be claimed only once for each unit of biomass.

9 (e) Notwithstanding paragraph (a) of this subsection, a tax credit:

10 (A) Is not allowed for canola grown, collected or produced in the Willamette Valley; and

11 (B) Is not allowed for grain corn, but a tax credit shall be allowed for other corn material.

12 (4) The amount of the credit shall equal the amount certified under subsection (5) of this section.

13 (5)(a) The State Department of Energy may establish by rule procedures and criteria for deter-
14 mining the amount of the tax credit to be certified under this section, consistent with ORS 469B.403.
15 The department shall provide written certification to taxpayers that are eligible to claim the credit
16 under this section.

17 (b) The State Department of Energy may charge and collect a fee from taxpayers for certifica-
18 tion of credits under this section. The fee may not exceed the cost to the department of determining
19 the amount of certified cost.

20 *[(c) The State Department of Energy shall provide to the Department of Revenue a list, by tax year,*
21 *of taxpayers for which a credit is certified under this section, upon request of the Department of Re-*
22 *venue.]*

23 (6) The amount of the credit claimed under this section for any tax year may not exceed the tax
24 liability of the taxpayer.

25 (7) Each agricultural producer or biomass collector shall maintain the written documentation
26 of the amount certified for tax credit under this section in its records for a period of at least five
27 years after the tax year in which the credit is claimed and provide the written documentation to the
28 Department of Revenue upon request.

29 (8) The credit shall be claimed on a form prescribed by the Department of Revenue that contains
30 the information required by the department.

31 (9) Any tax credit otherwise allowable under this section that is not used by the taxpayer in a
32 particular tax year may be carried forward and offset against the taxpayer's tax liability for the next
33 succeeding tax year. Any credit remaining unused in the next succeeding tax year may be carried
34 forward and used in the second succeeding tax year, and likewise any credit not used in that second
35 succeeding tax year may be carried forward and used in the third succeeding tax year, and any
36 credit not used in that third succeeding tax year may be carried forward and used in the fourth
37 succeeding tax year, but may not be carried forward for any tax year thereafter.

38 (10) In the case of a credit allowed under this section:

39 (a) A nonresident shall be allowed the credit under this section in the proportion provided in
40 ORS 316.117.

41 (b) If a change in the status of the taxpayer from resident to nonresident or from nonresident
42 to resident occurs, the credit allowed by this section shall be determined in a manner consistent
43 with ORS 316.117.

44 (c) If a change in the *[taxable]* tax year of the taxpayer occurs as described in ORS 314.085, or
45 if the department terminates the taxpayer's *[taxable]* tax year under ORS 314.440, the credit allowed

1 under this section shall be prorated or computed in a manner consistent with ORS 314.085.

2 **(11) The Director of the State Department of Energy may order the suspension or revo-**
3 **cation of a certification issued under this section, as provided in section 4 of this 2019 Act.**

4 **SECTION 7.** ORS 315.164 is amended to read:

5 315.164. (1) A taxpayer who is the owner or operator of agriculture workforce housing is allowed
6 a credit against the taxes otherwise due under ORS chapter 316, if the taxpayer is a resident indi-
7 vidual, or against the taxes otherwise due under ORS chapter 317, if the taxpayer is a corporation.
8 The total amount of the credit shall be equal to 50 percent of the eligible costs actually paid or
9 incurred by the taxpayer to complete an agriculture workforce housing project, to the extent the
10 eligible costs actually paid or incurred by the taxpayer do not exceed the estimate of eligible costs
11 approved by the Housing and Community Services Department under ORS 315.167.

12 (2) A taxpayer who is otherwise eligible to claim a credit under this section may elect to
13 transfer all or a portion of the credit to a contributor in the manner provided in ORS 315.169.

14 (3)(a) The credit allowed under this section may be taken for the tax year in which the agri-
15 culture workforce housing project is completed or in any of the nine tax years succeeding the tax
16 year in which the project is completed.

17 (b) The credit allowed in any one tax year may not exceed 20 percent of the amount determined
18 under subsection (1) of this section.

19 (4)(a) To claim a credit under this section, a taxpayer must show in each year following the
20 completion of an agriculture workforce housing project that the housing continues to be operated
21 as agriculture workforce housing.

22 (b) A taxpayer need not make the showing required in paragraph (a) of this subsection if the
23 Housing and Community Services Department waives the requirement after the taxpayer has suc-
24 cessfully met the requirement for the first five years after completion of the agriculture workforce
25 housing project.

26 (c) The Housing and Community Services Department shall determine by rule the factors nec-
27 essary to grant a waiver. Such factors may include a documented decline in a particular area for
28 agriculture workforce housing.

29 (5) The credit shall apply only to an agriculture workforce housing project that is located within
30 this state and physically begun on or after January 1, 1990.

31 (6)(a) A credit may not be allowed under this section unless the taxpayer claiming credit under
32 this section:

33 (A) Obtains a letter of credit approval from the Housing and Community Services Department
34 pursuant to ORS 315.167; and

35 (B) Files with the [*Department of Revenue*] **Housing and Community Services Department** an
36 annual certification providing that all occupied units for which credit is being claimed are occupied
37 by agricultural workers, including agricultural workers who are retired or disabled, and their im-
38 mediate families.

39 (b) The certification described under this subsection shall be made on the form and in the time
40 and manner prescribed by the [*Department of Revenue*] **Housing and Community Services De-**
41 **partment.**

42 (7) Except as provided under subsection (8) of this section, the credit allowed in any one year
43 may not exceed the tax liability of the taxpayer.

44 (8) Any tax credit otherwise allowable under this section that is not used by the taxpayer in a
45 particular tax year may be carried forward and offset against the taxpayer's tax liability for the next

1 succeeding tax year. Any credit remaining unused in the next succeeding tax year may be carried
2 forward and used in the second succeeding tax year, and likewise any credit not used in that second
3 succeeding tax year may be carried forward and used in the third succeeding tax year, and any
4 credit not used in that third succeeding tax year may be carried forward and used in the fourth
5 succeeding tax year, and any credit not used in that fourth succeeding tax year may be carried
6 forward and used in the fifth succeeding tax year, and any credit not used in that fifth succeeding
7 tax year may be carried forward and used in the sixth succeeding tax year, and any credit not used
8 in that sixth succeeding tax year may be carried forward and used in the seventh succeeding tax
9 year, and any credit not used in that seventh succeeding tax year may be carried forward and used
10 in the eighth succeeding tax year, and any credit not used in that eighth succeeding tax year may
11 be carried forward and used in the ninth succeeding tax year, but may not be carried forward for
12 any tax year thereafter.

13 (9)(a) The credit provided by this section is not in lieu of any depreciation or amortization de-
14 duction for the agriculture workforce housing project to which the taxpayer otherwise may be en-
15 titled under ORS chapter 316 or 317 for the year.

16 (b) The taxpayer's adjusted basis for determining gain or loss may not be further decreased by
17 any tax credits allowed under this section.

18 (10) For a taxpayer to receive a credit under this section, the agriculture workforce housing
19 must:

20 (a) Comply with all occupational safety or health laws, rules, regulations and standards;

21 (b) If registration is required, be registered as a farmworker camp with the Department of
22 Consumer and Business Services under ORS 658.750;

23 (c) Upon occupancy and if an indorsement is required, be operated by a person who holds a valid
24 indorsement as a farmworker camp operator under ORS 658.730; and

25 (d) Continue to be operated as agriculture workforce housing for a period of at least 10 years
26 after the completion of the agriculture workforce housing project, unless a waiver has been granted
27 under subsection (4) of this section.

28 [(11)(a) Pursuant to the procedures for a contested case under ORS chapter 183, the Department
29 of Revenue may order the disallowance of the credit allowed under this section if it finds, by order,
30 that:]

31 [(A) The credit was obtained by fraud or misrepresentation; or]

32 **(11) The Director of the Housing and Community Services Department may order the**
33 **suspension or revocation of a letter of credit approval issued under ORS 315.167 or the dis-**
34 **allowance of a credit allowed under this section, as provided in section 4 of this 2019 Act:**

35 **(a) For the reasons set forth in section 4 of this 2019 Act; or**

36 [(B)] **(b) In the event that an owner or operator claims or claimed the credit, if the director**
37 **finds that:**

38 [(i)] **(A)** The taxpayer has failed to continue to substantially comply with the occupational safety
39 or health laws, rules, regulations or standards;

40 [(ii)] **(B)** After occupancy and if registration is required, the agriculture workforce housing is
41 not registered as a farmworker camp with the Department of Consumer and Business Services under
42 ORS 658.750;

43 [(iii)] **(C)** After occupancy and if an indorsement is required, the agriculture workforce housing
44 is not operated by a person who holds a valid indorsement as a farmworker camp operator under
45 ORS 658.730; or

1 *[(iv)]* **(D)** The taxpayer has failed to make a showing that the housing continues to be operated
2 as agriculture workforce housing as required under subsection (4)(a) of this section and the taxpayer
3 has not been granted a waiver by the Housing and Community Services Department under sub-
4 section (4)(b) of this section.

5 *[(b) If the tax credit is disallowed pursuant to this subsection, notwithstanding ORS 314.410 or*
6 *other law, all prior tax relief provided to the taxpayer shall be forfeited and the Department of Revenue*
7 *shall proceed to collect those taxes not paid by the taxpayer as a result of the prior granting of the*
8 *credit.]*

9 *[(c) If the tax credit is disallowed pursuant to this subsection, the taxpayer shall be denied any*
10 *further credit provided under this section, in connection with the agriculture workforce housing project,*
11 *as the case may be, from and after the date that the order of disallowance becomes final.]*

12 (12) In the event that the agriculture workforce housing is destroyed by fire, flood, natural dis-
13 aster or act of God before all of the credit has been used, the taxpayer may nevertheless claim the
14 credit as if no destruction had taken place. In the event of fire, if the fire chief of the fire protection
15 district or unit determines that the fire was caused by arson, as defined in ORS 164.315 and 164.325,
16 by the taxpayer or by another at the taxpayer's direction, then the fire chief shall notify the [*De-*
17 *partment of Revenue*] **Housing and Community Services Department**. Upon conviction of arson,
18 the department [*of Revenue*] shall disallow the credit in accordance with subsection (11) of this
19 section.

20 (13)(a) A nonresident individual shall be allowed the credit computed in the same manner and
21 subject to the same limitations as the credit allowed a resident by this section. However, the credit
22 shall be prorated using the proportion provided in ORS 316.117.

23 (b) If a change in the [*taxable*] **tax** year of a taxpayer occurs as described in ORS 314.085, or
24 if the Department of Revenue terminates the taxpayer's [*taxable*] **tax** year under ORS 314.440, the
25 credit allowed by this section shall be prorated or computed in a manner consistent with ORS
26 314.085.

27 (c) If a change in the status of a taxpayer from resident to nonresident or from nonresident to
28 resident occurs, the credit allowed by this section shall be determined in a manner consistent with
29 ORS 316.117.

30 (14)(a) The Department of Revenue may adopt rules for carrying out the provisions of this sec-
31 tion.

32 **(b) The Housing and Community Services Department may adopt rules for providing let-**
33 **ters of credit approval and granting certification and for monitoring taxpayer compliance**
34 **with this section.**

35 **(15) The Housing and Community Services Department shall provide information to the**
36 **Department of Revenue about all letters of credit approval and certifications granted under**
37 **this section, if required by section 3 of this 2019 Act.**

38 **SECTION 8.** ORS 315.169 is amended to read:

39 315.169. (1) A taxpayer that is a contributor is allowed a credit against the taxes otherwise due
40 under ORS chapter 316, if the taxpayer is a resident individual, or ORS chapter 317, if the taxpayer
41 is a corporation, to the extent the owner or operator of agriculture workforce housing transferred
42 all or a portion of the credit allowed to the owner or operator under ORS 315.164.

43 (2) An owner or operator of agriculture workforce housing may transfer all or a portion of the
44 credit allowed to the owner or operator under ORS 315.164 to one or more contributors but the
45 amount transferred may not total more than the total credit the owner or operator may claim. **The**

1 **transfer must comply with section 2 of this 2019 Act.**

2 (3) To receive a credit under this section:

3 (a) The contributor must obtain a letter of credit approval from the Housing and Community
4 Services Department under ORS 315.167; or

5 (b) If the owner or operator of agriculture workforce housing elects to transfer all or a portion
6 of the credit allowed under ORS 315.164 after the date that a letter of credit approval has been is-
7 sued to the owner or operator, the owner or operator and the contributor must [*jointly file a state-*
8 *ment with the Department of Revenue stating the portion of the credit the contributor is allowed to*
9 *claim and any other information the department may require by rule*] **comply with section 2 of this**
10 **2019 Act.**

11 (4) A contributor remains eligible to receive a credit under this section even if the owner or
12 operator of the agriculture workforce housing becomes ineligible for the credit as a result of:

13 (a) Failure to file the annual certification under ORS 315.164 (6);

14 (b) Failure to continue to substantially comply with occupational safety or health laws, rules,
15 regulations or standards under ORS 315.164 (10);

16 (c) Failure to register as a farmworker camp with the Department of Consumer and Business
17 Services under ORS 658.750;

18 (d) Failure of the operator to hold a valid indorsement as a farmworker camp operator under
19 ORS 658.730; or

20 (e) Failure to comply with any other rules or provisions relating to the operation or mainte-
21 nance of the agriculture workforce housing after work on the agriculture workforce housing project
22 has been completed.

23 [(5)(a) *A contributor does not remain eligible to receive a credit under this section if the Depart-*

31 *collect those taxes not paid by the taxpayer as a result of the prior granting of the credit.*]

32 [(c) *If the credit is disallowed pursuant to this subsection, the taxpayer shall be denied any further*
33 *credit provided under this section, in connection with the agriculture workforce housing project, as the*
34 *case may be, from and after the date that the order of disallowance becomes final.*]

26 (a) "Annual rate" means the yearly interest rate specified on the note, and not the annual per-

 29 by the lending institution, and other charges related to the cost of obtaining credit.

 31 any mortgage banking company that maintains an office in this state or any community development
 32 corporation that is organized under the Oregon Nonprofit Corporation Law.

33 (d) "Manufactured dwelling park" has the meaning given that term in ORS 446.003.

34 (e) "Nonprofit corporation" means a corporation that is exempt from income taxes under section
 35 501(c)(3) or (4) of the Internal Revenue Code as amended and in effect on December 31, 2017.

36 (f) "Preservation project" means housing that was previously developed as affordable housing
 37 with a contract for rent assistance from the United States Department of Housing and Urban De-
 38 velopment or the United States Department of Agriculture and that is being acquired by a spon-
 39 soring entity.

40 (g) "Qualified assignee" means any investor participating in the secondary market for real estate
 41 loans.

42 (h) "Qualified borrower" means any borrower that is a sponsoring entity that has a controlling
 43 interest in the real property that is financed by a qualified loan. A controlling interest includes a
 44 controlling interest in the general partner of a limited partnership that owns the real property.

45 (i) "Qualified loan" means:

1 (A) A loan that meets the criteria stated in subsection (5) of this section or that is made to re-
2 finance a loan that meets the criteria described in subsection (5) of this section; or

3 (B) The purchase by a lending institution of bonds, as defined in ORS 286A.001, issued on behalf
4 of the Housing and Community Services Department, the proceeds of which are used to finance or
5 refinance a loan that meets the criteria described in subsection (5) of this section.

6 (j) "Sponsoring entity" means a nonprofit corporation, nonprofit cooperative, state governmental
7 entity, local unit of government as defined in ORS 466.706, housing authority or any other person,

3 458.690. (1) Notwithstanding ORS 315.271, a fiduciary organization selected under ORS 458.695
4 may qualify as the recipient of account contributions that qualify the contributor for a tax credit
5 under ORS 315.271 only if the fiduciary organization structures the accounts to have the following
6 features:

7 (a) The fiduciary organization matches amounts deposited by the account holder according to a
8 formula established by the fiduciary organization. The fiduciary organization shall maintain on de-
9 posit in the account not less than \$1 nor more than \$5 for each \$1 deposited by the account holder.

10 (b) The matching deposits by the fiduciary organization to the individual development account
11 are placed in:

12 (A) A savings account jointly held by the account holder and the fiduciary organization and
13 requiring the signatures of both for withdrawals;

14 (B) A savings account that is controlled by the fiduciary organization and is separate from the
