7	<b>"ADMINISTRATION OF TAX CREDIT PROVISIONS</b>
8	
9	"SECTION 1. Sections 2 to 4 of this 2019 Act are added to and made a part of ORS
10	chapter 315.
11	"SECTION 2. (1) Transfer of any transferable tax credit that is allowed under this chap-
12	ter or ORS chapter 316 or 317 and that is transferred on or after January 1, 2020, is condi-
13	tioned upon compliance with this section and ORS 315.052 and 315.053.
14	"(2) The Department of Revenue may require that the person that has earned the credit
15	and the taxpayer that intends to claim the credit jointly file a notice of tax credit transfer
16	with the department on or before the earliest of the following dates:
17	"(a) A date 30 days after the transfer of the credit;
18	"(b) The date on which the transferee files a return; or
19	"(c) The due date, including extensions, of the transferee's return.
20	"(3) The notice shall be given on a form prescribed by the department that contains:
21	"(a) The name and address of the transferor and of the transferee;
22	"(b) The taxpayer identification number of the transferor and of the transferee;
23	"(c) The dates on which the person earning the credit received certifications for the
24	credit;
25	"(d) The amount of the credit that is certified, the amount that is being transferred and
26	the amount that is being retained by the transferor; and
27	"(e) Any other information required by the department.
28	"(4)(a) If a tax credit must be claimed over multiple tax years, a transferor may sepa-
29	rately transfer the entirety of that portion corresponding to each tax year to one or more
30	transferees, subject to subsection (5) of this subsection.
31	"(b) Any amount of credit that would be allowed due only to a carryforward provision
32	may not be transferred.
33	"(5) Any transfer of a tax credit or a portion of a tax credit must be completed no later
34	than the earliest of the following dates in relation to the tax return on which it is claimed:
35	"(a) The original due date, including extensions, of the transferor's return;

1 "(b) The date on which the transferor's return is actually filed;

2 "(c) The original due date, including extensions, of the transferee's return; or

3 "(d) The date on which the transferee's return is actually filed.

4 "(6) Notwithstanding subsection (5) of this section, if the transferor is a tax-exempt en-5 tity, the transfer must be completed on or before a date one year after the close of the tax 6 year for which the credit receives final certification. As used in this subsection 'tax-exempt 7 entity' means a government agency or an organization that is recognized as exempt under 8 section 501(c)(3) of the Internal Revenue Code.

9 "(7) The transferee shall claim the credit in accordance with the credit provisions for the
 10 tax years in which the credit is allowed.

"(8) The department by rule may establish policies and procedures for the implementation of this section.

"SECTION 3. (1) For any tax credit that is allowed under this chapter or ORS chapter 13316 or 317 and for which certification, determination of eligibility or other approval from an 14 15agency other than the Department of Revenue is required and was issued on or after January 16 1, 2019, the department may require that the other agency provide information about the certification, determination of eligibility or other approval, including the name and taxpayer 1718 identification number of the taxpayer or other person receiving approval, the date the ap-19 proval was issued in its final form, the approved amount of credit and the first tax year for 20which the credit may be claimed.

"(2) Within two months after the close of the tax year in which the approval was issued, a taxpayer that is a pass-through entity that has received approval shall provide to the department, in the manner prescribed by the department, the name and taxpayer identification number of each owner receiving a distributive share of the credit and any other information required by the department pertaining to an owner receiving a distributive share.

26 "<u>SECTION 4.</u> (1) Under the procedures for a contested case under ORS chapter 183, the 27 director of the agency responsible for certifying or otherwise determining eligibility or 28 granting approval for a tax credit allowed under this chapter or ORS chapter 316 or 317 may 29 order the suspension, revocation or forfeiture of the tax credit approval or of a portion 30 thereof if the director finds that:

31 32 "(a) The approval was obtained by fraud or misrepresentation;

"(b) The approval was obtained by mistake or miscalculation; or

33 "(c) The taxpayer otherwise violates or has violated a condition or requirement for el-34 igibility for the tax credit.

35 "(2) As soon as an order of revocation under this section becomes final, the director shall 36 notify the Department of Revenue and the person that received the tax credit certification, 37 or other approval, of the order of revocation. Upon notification, the Department of Revenue 38 immediately shall proceed to collect:

(a) If no portion of a credit has been transferred, those taxes not paid by the holder of the certificate or other approval as a result of the tax credits provided to the holder under the revoked approval, from the holder or a successor in interest to the business interests of the holder. All tax credits provided to the holder and attributable to the fraudulently or mistakenly obtained approval or portion of the approval shall be forfeited.

"(b) If all of a credit has been transferred, an amount equal to the amount of the tax
 credits allowable to the transferee under the revoked approval, from the transferor.

"(c) If a portion of a tax credit has been transferred, those taxes not paid by the transferor as a result of the tax credits provided to the transferor pursuant to the revoked approval, from the transferor or a successor in interest to the business interests of the transferor, and an amount equal to the amount of the tax credits allowable to the transferee pursuant to the revoked approval, from the transferor.

6 "(3)(a) The Department of Revenue shall have the benefit of all laws of the state per-7 taining to the collection of income and excise taxes and may proceed to collect the amounts 8 described in subsection (2) of this section from the person that obtained approval or a suc-9 cessor in interest to the business interests of that person. An assessment of tax is not nec-10 essary and the collection of taxes described in this subsection is not precluded by any statute 11 of limitations.

12 "(b) For purposes of this subsection, a lender, bankruptcy trustee or other person that 13 acquires an interest through bankruptcy or through foreclosure of a security interest is not 14 considered to be a successor in interest to the business interests of the person that obtained 15 approval.

16 "(4) If the approval is ordered revoked pursuant to this section, the holder of the certif-17 icate or other approval shall be denied any further relief in connection with the credit from 18 and after the date that the order of revocation becomes final.

19 "(5) Notwithstanding subsections (1) to (4) of this section, a certificate or portion of a 20 certificate held by a transferee may not be considered revoked for purposes of the 21 transferee, the tax credit allowable to the transferee may not be reduced and a transferee 22 is not liable under this section.

23 "(6) Interest under this section shall accrue at the rate established in ORS 305.220 be-24 ginning the day after the due date of the return on which the credit may first be claimed.

25 "(7) The Department of Revenue may collect amounts owed under this section by a 26 partnership from the partnership.

## **"TRANSFERABLE TAX CREDIT PROVISIONS**

37 "SECTION 6. ORS 315.141 is amended to read:

38 "315.141. (1) As used in this section:

"(a) 'Agricultural producer' means a person that produces biomass in Oregon that is used, in
Oregon, as biofuel or to produce biofuel.

"(b) 'Biofuel' means liquid, gaseous or solid fuels, derived from biomass, that have been converted into a processed fuel ready for use as energy by a biofuel producer's customers or for direct
biomass energy use at the biofuel producer's site.

44 "(c) 'Biofuel producer' means a person that through activities in Oregon:

45 "(A) Alters the physical makeup of biomass to convert it into biofuel;

1 "(B) Changes one biofuel into another type of biofuel; or

2 "(C) Uses biomass in Oregon to produce energy.

- 3 "(d) 'Biomass' means organic matter that is available on a renewable or recurring basis and that 4 is derived from:
- 5 "(A) Forest or rangeland woody debris from harvesting or thinning conducted to improve forest 6 or rangeland ecological health and reduce uncharacteristic stand replacing wildfire risk;
  - "(B) Wood material from hardwood timber described in ORS 321.267 (3);
- 8 "(C) Agricultural residues;

- 9 "(D) Offal and tallow from animal rendering;
- 10 "(E) Food wastes collected as provided under ORS chapter 459 or 459A;
- 11 "(F) Wood debris collected as provided under ORS chapter 459 or 459A;
- 12 "(G) Wastewater solids; or
- 13 "(H) Crops grown solely to be used for energy.

"(e) 'Biomass' does not mean wood that has been treated with creosote, pentachlorophenol, inorganic arsenic or other inorganic chemical compounds or waste, other than matter described in paragraph (d) of this subsection.

"(f) 'Biomass collector' means a person that collects biomass in Oregon to be used, in Oregon,as biofuel or to produce biofuel.

- 19 "(g) 'Canola' means plants of the genus Brassica:
- 20 "(A) In which seeds having a high oil content are the primary economically valuable product; 21 and
- "(B) That have a high erucic acid content suitable for industrial uses or a low erucic acid content suitable for edible oils.

24 "(h) 'Oilseed processor' means a person that receives agricultural oilseeds and separates them 25 into meal and oil by mechanical or chemical means.

"(i) 'Willamette Valley' means Clackamas, Linn, Marion, Multnomah, Polk, Washington and
Yamhill Counties and the portion of Benton and Lane Counties lying east of the summit of the Coast
Range.

"(2) The Director of the State Department of Energy may adopt rules to define criteria, only as the criteria apply to organic biomass, to determine additional characteristics of biomass for purposes of this section.

"(3)(a) An agricultural producer or biomass collector shall be allowed a credit against the taxes
that would otherwise be due under ORS chapter 316 or, if the taxpayer is a corporation, under ORS
chapter 317 or 318 for:

35 "(A) The production of biomass in Oregon that is used, in Oregon, as biofuel or to produce 36 biofuel; or

"(B) The collection of biomass in Oregon that is used, in Oregon, as biofuel or to produce biofuel.

39 "(b) A credit under this section may be claimed in the tax year in which the credit is certified 40 under subsection (5) of this section.

41 "(c) A taxpayer may be allowed a credit under this section for more than one of the roles de-42 fined in subsection (1) of this section, but a biofuel producer that is not also an agricultural pro-43 ducer or a biomass collector may not claim a credit under this section.

44 "(d) A credit under this section may be claimed only once for each unit of biomass.

45 "(e) Notwithstanding paragraph (a) of this subsection, a tax credit:

1 "(A) Is not allowed for canola grown, collected or produced in the Willamette Valley; and

2 "(B) Is not allowed for grain corn, but a tax credit shall be allowed for other corn material.

3 "(4) The amount of the credit shall equal the amount certified under subsection (5) of this sec-4 tion.

5 "(5)(a) The State Department of Energy may establish by rule procedures and criteria for de-6 termining the amount of the tax credit to be certified under this section, consistent with ORS 7 469B.403. The department shall provide written certification to taxpayers that are eligible to claim 8 the credit under this section.

9 "(b) The State Department of Energy may charge and collect a fee from taxpayers for certi-10 fication of credits under this section. The fee may not exceed the cost to the department of deter-11 mining the amount of certified cost.

12 "[(c) The State Department of Energy shall provide to the Department of Revenue a list, by tax 13 year, of taxpayers for which a credit is certified under this section, upon request of the Department of 14 Revenue.]

15 "(6) The amount of the credit claimed under this section for any tax year may not exceed the 16 tax liability of the taxpayer.

"(7) Each agricultural producer or biomass collector shall maintain the written documentation of the amount certified for tax credit under this section in its records for a period of at least five years after the tax year in which the credit is claimed and provide the written documentation to the Department of Revenue upon request.

"(8) The credit shall be claimed on a form prescribed by the Department of Revenue that contains the information required by the department.

"(9) Any tax credit otherwise allowable under this section that is not used by the taxpayer in a particular tax year may be carried forward and offset against the taxpayer's tax liability for the next succeeding tax year. Any credit remaining unused in the next succeeding tax year may be carried forward and used in the second succeeding tax year, and likewise any credit not used in that second succeeding tax year may be carried forward and used in the third succeeding tax year, and any credit not used in that third succeeding tax year may be carried forward and used in the fourth succeeding tax year, but may not be carried forward for any tax year thereafter.

"(10) In the case of a credit allowed under this section:

"(a) A nonresident shall be allowed the credit under this section in the proportion provided in
 ORS 316.117.

33 "(b) If a change in the status of the taxpayer from resident to nonresident or from nonresident 34 to resident occurs, the credit allowed by this section shall be determined in a manner consistent 35 with ORS 316.117.

"(c) If a change in the [*taxable*] **tax** year of the taxpayer occurs as described in ORS 314.085, or if the department terminates the taxpayer's [*taxable*] **tax** year under ORS 314.440, the credit allowed under this section shall be prorated or computed in a manner consistent with ORS 314.085.

"(11) The Director of the State Department of Energy may order the suspension or revocation of a certification issued under this section, as provided in section 4 of this 2019 Act.
"SECTION 7. ORS 315.164 is amended to read:

42 "315.164. (1) A taxpayer who is the owner or operator of agriculture workforce housing is al-43 lowed a credit against the taxes otherwise due under ORS chapter 316, if the taxpayer is a resident 44 individual, or against the taxes otherwise due under ORS chapter 317, if the taxpayer is a corpo-45 ration. The total amount of the credit shall be equal to 50 percent of the eligible costs actually paid or incurred by the taxpayer to complete an agriculture workforce housing project, to the extent the
 eligible costs actually paid or incurred by the taxpayer do not exceed the estimate of eligible costs
 approved by the Housing and Community Services Department under ORS 315.167.

4 "(2) A taxpayer who is otherwise eligible to claim a credit under this section may elect to 5 transfer all or a portion of the credit to a contributor in the manner provided in ORS 315.169.

6 "(3)(a) The credit allowed under this section may be taken for the tax year in which the agri-7 culture workforce housing project is completed or in any of the nine tax years succeeding the tax 8 year in which the project is completed.

9 "(b) The credit allowed in any one tax year may not exceed 20 percent of the amount determined 10 under subsection (1) of this section.

"(4)(a) To claim a credit under this section, a taxpayer must show in each year following the completion of an agriculture workforce housing project that the housing continues to be operated as agriculture workforce housing.

"(b) A taxpayer need not make the showing required in paragraph (a) of this subsection if the Housing and Community Services Department waives the requirement after the taxpayer has successfully met the requirement for the first five years after completion of the agriculture workforce housing project.

18 "(c) The Housing and Community Services Department shall determine by rule the factors nec-19 essary to grant a waiver. Such factors may include a documented decline in a particular area for 20 agriculture workforce housing.

"(5) The credit shall apply only to an agriculture workforce housing project that is located within this state and physically begun on or after January 1, 1990.

"(6)(a) A credit may not be allowed under this section unless the taxpayer claiming credit under
 this section:

25 "(A) Obtains a letter of credit approval from the Housing and Community Services Department 26 pursuant to ORS 315.167; and

"(B) Files with the [Department of Revenue] Housing and Community Services Department an annual certification providing that all occupied units for which credit is being claimed are occupied by agricultural workers, including agricultural workers who are retired or disabled, and their immediate families.

31 "(b) The certification described under this subsection shall be made on the form and in the time 32 and manner prescribed by the [Department of Revenue] Housing and Community Services De-33 partment.

34 "(7) Except as provided under subsection (8) of this section, the credit allowed in any one year 35 may not exceed the tax liability of the taxpayer.

36 "(8) Any tax credit otherwise allowable under this section that is not used by the taxpayer in 37 a particular tax year may be carried forward and offset against the taxpayer's tax liability for the 38 next succeeding tax year. Any credit remaining unused in the next succeeding tax year may be 39 carried forward and used in the second succeeding tax year, and likewise any credit not used in that 40 second succeeding tax year may be carried forward and used in the third succeeding tax year, and 41 any credit not used in that third succeeding tax year may be carried forward and used in the fourth 42succeeding tax year, and any credit not used in that fourth succeeding tax year may be carried 43 forward and used in the fifth succeeding tax year, and any credit not used in that fifth succeeding 44 tax year may be carried forward and used in the sixth succeeding tax year, and any credit not used 45 in that sixth succeeding tax year may be carried forward and used in the seventh succeeding tax

year, and any credit not used in that seventh succeeding tax year may be carried forward and used
in the eighth succeeding tax year, and any credit not used in that eighth succeeding tax year may
be carried forward and used in the ninth succeeding tax year, but may not be carried forward for
any tax year thereafter.

5 "(9)(a) The credit provided by this section is not in lieu of any depreciation or amortization de-6 duction for the agriculture workforce housing project to which the taxpayer otherwise may be en-7 titled under ORS chapter 316 or 317 for the year.

8 "(b) The taxpayer's adjusted basis for determining gain or loss may not be further decreased by 9 any tax credits allowed under this section.

10 "(10) For a taxpayer to receive a credit under this section, the agriculture workforce housing 11 must:

12 "(a) Comply with all occupational safety or health laws, rules, regulations and standards;

"(b) If registration is required, be registered as a farmworker camp with the Department of
 Consumer and Business Services under ORS 658.750;

15 "(c) Upon occupancy and if an indorsement is required, be operated by a person who holds a 16 valid indorsement as a farmworker camp operator under ORS 658.730; and

"(d) Continue to be operated as agriculture workforce housing for a period of at least 10 years after the completion of the agriculture workforce housing project, unless a waiver has been granted under subsection (4) of this section.

20 "[(11)(a) Pursuant to the procedures for a contested case under ORS chapter 183, the Department 21 of Revenue may order the disallowance of the credit allowed under this section if it finds, by order, 22 that:]

38 "[(*iv*)] (**D**) The taxpayer has failed to make a showing that the housing continues to be operated 39 as agriculture workforce housing as required under subsection (4)(a) of this section and the taxpayer 40 has not been granted a waiver by the Housing and Community Services Department under sub-41 section (4)(b) of this section.

42 "[(b) If the tax credit is disallowed pursuant to this subsection, notwithstanding ORS 314.410 or 43 other law, all prior tax relief provided to the taxpayer shall be forfeited and the Department of Revenue 44 shall proceed to collect those taxes not paid by the taxpayer as a result of the prior granting of the 45 credit.] 1 "[(c) If the tax credit is disallowed pursuant to this subsection, the taxpayer shall be denied any 2 further credit provided under this section, in connection with the agriculture workforce housing project, 3 as the case may be, from and after the date that the order of disallowance becomes final.]

4 "(12) In the event that the agriculture workforce housing is destroyed by fire, flood, natural disaster or act of God before all of the credit has been used, the taxpayer may nevertheless claim 5 the credit as if no destruction had taken place. In the event of fire, if the fire chief of the fire pro-6 tection district or unit determines that the fire was caused by arson, as defined in ORS 164.315 and 7 8 164.325, by the taxpayer or by another at the taxpayer's direction, then the fire chief shall notify the [Department of Revenue] Housing and Community Services Department. Upon conviction of 9 arson, the department [of Revenue] shall disallow the credit in accordance with subsection (11) of 10 11 this section.

"(13)(a) A nonresident individual shall be allowed the credit computed in the same manner and subject to the same limitations as the credit allowed a resident by this section. However, the credit shall be prorated using the proportion provided in ORS 316.117.

"(b) If a change in the [taxable] tax year of a taxpayer occurs as described in ORS 314.085, or if the Department of Revenue terminates the taxpayer's [taxable] tax year under ORS 314.440, the credit allowed by this section shall be prorated or computed in a manner consistent with ORS 314.085.

"(c) If a change in the status of a taxpayer from resident to nonresident or from nonresident to resident occurs, the credit allowed by this section shall be determined in a manner consistent with ORS 316.117.

"(14)(a) The Department of Revenue may adopt rules for carrying out the provisions of this section.

"(b) The Housing and Community Services Department may adopt rules for providing
letters of credit approval and granting certification and for monitoring taxpayer compliance
with this section.

"(15) The Housing and Community Services Department shall provide information to the
 Department of Revenue about all letters of credit approval and certifications granted under
 this section, if required by section 3 of this 2019 Act.

"<u>SECTION 8.</u> ORS 315.169 is amended to read:

31 "315.169. (1) A taxpayer that is a contributor is allowed a credit against the taxes otherwise due 32 under ORS chapter 316, if the taxpayer is a resident individual, or ORS chapter 317, if the taxpayer 33 is a corporation, to the extent the owner or operator of agriculture workforce housing transferred 34 all or a portion of the credit allowed to the owner or operator under ORS 315.164.

35 "(2) An owner or operator of agriculture workforce housing may transfer all or a portion of the 36 credit allowed to the owner or operator under ORS 315.164 to one or more contributors but the 37 amount transferred may not total more than the total credit the owner or operator may claim. The 38 transfer must comply with section 2 of this 2019 Act.

39

"(3) To receive a credit under this section:

40 "(a) The contributor must obtain a letter of credit approval from the Housing and Community
41 Services Department under ORS 315.167; or

 ORS 658.730; or

"(e) Failure to comply with any other rules or provisions relating to the operation or maintenance of the agriculture workforce housing after work on the agriculture workforce housing project has been completed.

"(2) Account holders may not accrue more than \$3,000 of matching funds under subsection (1) of this section from state-directed moneys in any 12-month period. A fiduciary organization may designate a lower amount as a limit on annual matching funds. A fiduciary organization shall maintain on deposit sufficient funds to cover the matching deposit agreements for all individual development accounts managed by the organization.

"(3) The Housing and Community Services Department shall adopt rules to establish a maximum total amount of state-directed moneys that may be deposited as matching funds into an individual development account.

"(4) The Housing and Community Services Department shall provide information to the
Department of Revenue about all individual development account contributors that are
qualified for a tax credit under ORS 315.271, if required by section 3 of this 2019 Act.
