House Bill 2144

Introduced and printed pursuant to House Rule 12.00. Presession filed (at the request of House Interim Committee on Revenue)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Requires addition to federal taxable income of amounts deducted as gain attributable to investment in federal qualified opportunity zone. Allows subtraction in later tax year if gain is temporarily deferred at federal level.

Applies to tax years beginning on or after January 1, 2019.

Takes effect on 91st day following adjournment sine die.

SECTION 1. Section 2 of this 2019 Act is added to and made a part of ORS chapter 316.

SECTION 2. (1) There shall be added to federal taxable income for Oregon tax purposes 6

7 any gain that is allowable as a deduction under section 1400Z-2 of the Internal Revenue Code 8 for the tax year.

9 (2) Any amount added to federal taxable income for Oregon tax purposes under subsection (1) of this section that under section 1400Z of the Internal Revenue Code is tempo-10 rarily deferred gain may thereafter be subtracted from federal taxable income for Oregon tax 11 12 purposes for the year in which the amount is includible in federal taxable income under section 1400Z-2 (b) of the Internal Revenue Code. 13

(3) Any adjustment in basis of opportunity zone property allowed under section 1400Z of 14 the Internal Revenue Code for federal tax purposes shall be disregarded for Oregon tax pur-1516 poses.

SECTION 3. Section 4 of this 2019 Act is added to and made a part of ORS chapter 317. 17

SECTION 4. (1) There shall be added to federal taxable income for Oregon tax purposes 18 any gain that is allowable as a deduction under section 1400Z-2 of the Internal Revenue Code 19 20 for the tax year.

(2) Any amount added to federal taxable income for Oregon tax purposes under sub-2122 section (1) of this section that under section 1400Z of the Internal Revenue Code is temporarily deferred gain may thereafter be subtracted from federal taxable income for Oregon tax 2324 purposes for the year in which the amount is includible in federal taxable income under 25section 1400Z-2 (b) of the Internal Revenue Code.

26 (3) Any adjustment in basis of opportunity zone property allowed under section 1400Z of 27the Internal Revenue Code for federal tax purposes shall be disregarded for Oregon tax pur-28poses.
