House Bill 2238

Introduced and printed pursuant to House Rule 12.00. Presession filed (at the request of Chief Justice Martha L. Walters for Judicial Department and Oregon Circuit Court Judges Association)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Modifies annual salaries of judges of Supreme Court, Court of Appeals, circuit courts and Oregon Tax Court. Provides that, beginning on July 1, 2021, annual salaries of judges may not be less than specified percentage of annual salary of judge of United States District Court. Declares emergency, effective on passage.
