House Bill 2255

Introduced and printed pursuant to House Rule 12.00. Presession filed (at the request of Governor Kate Brown for Office of the Governor)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Restricts limitation on award of noneconomic damages to claims in actions for wrongful death. Corrects inaccurate reference for definition. Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to damages; creating new provisions; amending ORS 30.298, 30.650, 31.360, 31.705, 31.710,

31.715, 124.100, 137.103 and 260.532; and declaring an emergency.

4 Be It Enacted by the People of the State of Oregon:

5 **SECTION 1.** ORS 31.710 is amended to read:

6 31.710. (1) Except for claims subject to ORS 30.260 to 30.300 and ORS chapter 656, in any civil 7 action [seeking damages arising out of bodily injury, including emotional injury or distress, death or

8 property damage] for the wrongful death of any one person including claims for loss of care, com-9 fort, companionship and society and loss of consortium, the amount awarded for noneconomic dam-

10 ages, as defined in ORS 31.705, shall not exceed \$500,000.

11 [(2) As used in this section:]

[(a) "Economic damages" means objectively verifiable monetary losses including but not limited to reasonable charges necessarily incurred for medical, hospital, nursing and rehabilitative services and other health care services, burial and memorial expenses, loss of income and past and future impairment of earning capacity, reasonable and necessary expenses incurred for substitute domestic services, recurring loss to an estate, damage to reputation that is economically verifiable, reasonable and necessarily incurred costs due to loss of use of property and reasonable costs incurred for repair or for replacement of damaged property, whichever is less.]

19 [(b) "Noneconomic damages" means subjective, nonmonetary losses, including but not limited to 20 pain, mental suffering, emotional distress, humiliation, injury to reputation, loss of care, comfort, 21 companionship and society, loss of consortium, inconvenience and interference with normal and usual 22 activities apart from gainful employment.]

23 [(3)] (2) This section does not apply to punitive damages.

24 [(4)] (3) The jury shall not be advised of the limitation set forth in this section.

<u>SECTION 2.</u> (1) Except as provided in subsection (2) of this section, the amendments to
 ORS 31.710 by section 1 of this 2019 Act apply to all causes of action, whether arising before,
 on or after the effective date of this 2019 Act.

(2)(a) The amendments to ORS 31.710 by section 1 of this 2019 Act do not apply to any
 award of noneconomic damages for which a final judgment has been entered before the ef-

30 fective date of this 2019 Act.

1 (b) As used in this subsection, "final judgment" means a judgment for which the time to

appeal has expired without any party filing an appeal or that is not subject to further appeal
 or review.

(b) "Noneconomic damages" means subjective, nonmonetary losses, including but not

(a) A foster home that is maintained by the foster parents and that has been certified by the
 department under the provisions of ORS 418.625 to 418.645;

(b) An approved home that is maintained by the foster parents and that is receiving payment
from the department under the provisions of ORS 418.027 or under the provisions of ORS 420.810
and 420.815; or

(c) A developmental disability child foster home that has been certified by the department under
 the provisions of ORS 443.830 and 443.835.

(a) The defendant in the civil action was also in violation of ORS 806.010 or 813.010 at the time
the act or omission causing the death or injury occurred;

(c) The defendant was engaged in conduct that would constitute a violation of ORS 811.140 at
 the time the act or omission causing the death or injury occurred; or

17 260.532. (1) No person shall cause to be written, printed, published, posted, communicated or 18 circulated, any letter, circular, bill, placard, poster, photograph or other publication, or cause any 19 advertisement to be placed in a publication, or singly or with others pay for any advertisement, with 20 knowledge or with reckless disregard that the letter, circular, bill, placard, poster, photograph, 21 publication or advertisement contains a false statement of material fact relating to any candidate, 22 political committee or measure.

(2) As used in subsection (1) of this section, "cause" does not include the broadcast of an advertisement by a radio or television station or cable television company unless the advertisement
is for:

26 (a) The candidacy of the owner, licensee or operator of the station or company; or

(b) A ballot measure of which a chief petitioner is the owner, licensee or operator of the stationor company.

(3) A candidate who knows of and consents to a publication or advertisement prohibited by this
section with knowledge or with reckless disregard that it contains a false statement of material fact,
violates this section regardless of whether the candidate has participated directly in the publication
or advertisement.

(4) There is a rebuttable presumption that a candidate knows of and consents to any publication
 or advertisement prohibited by this section caused by a political committee over which the candi date exercises any direction and control.

(5) Any candidate or political committee aggrieved by a violation of this section shall have a right of action against the person alleged to have committed the violation. The aggrieved party may file the action in the circuit court for any county in this state in which a defendant resides or can be found or, if the defendant is a nonresident of this state, in the circuit court for any county in which the publication occurred. To prevail in such an action, the plaintiff must show by clear and convincing evidence that the defendant violated subsection (1) of this section.

(6) A plaintiff who prevails in an action provided by subsection (5) of this section may recover
economic and noneconomic damages, as defined in ORS [31.710] 31.705, or \$2,500, whichever is
greater. The court may award such additional equitable relief as it considers necessary or proper.
The equitable relief may include, but is not limited to, a requirement that a retraction of the false

statement be disseminated in the manner directed by the court. Proof of entitlement to economic and
 noneconomic damages must be by a preponderance of evidence. The court shall award the prevailing
 party reasonable attorney fees at trial and on appeal.

4 (7) A political committee has standing to bring an action provided by subsection (5) of this sec-5 tion as plaintiff in its own name, if its purpose as evidenced by its preelection activities, solicitations 6 and publications has been injured by the violation and if it has fully complied with the provisions 7 of this chapter. In an action brought by a political committee as provided by subsection (5) of this 8 section, the plaintiff may recover economic and noneconomic damages for all injury to the purpose 9 of the committee as provided in subsection (6) of this section.

10 (8) If a judgment is rendered in an action under this section against a defendant who has been 11 nominated to public office or elected to a public office other than state Senator or state Represen-12 tative, and it is established by clear and convincing evidence that the false statement was delib-13 erately made or caused to be made by the defendant, the finder of fact shall determine whether the 14 false statement reversed the outcome of the election. If the finder of fact finds by clear and con-15 vincing evidence that the false statement reversed the outcome of the election, the defendant shall 16 be deprived of the nomination or election and the nomination or office shall be declared vacant.

(9) An action under this section must be filed not later than the 30th day after the election relating to which a publication or advertisement in violation of this section was made. Proceedings
on a complaint filed under this section shall have precedence over all other business on the docket.
The courts shall proceed in a manner which will ensure that:

(a) Final judgment on a complaint which relates to a primary election or nominating election is
 rendered before the 30th day before the general election; and

(b) Final judgment on a complaint which relates to an election to an office is rendered beforethe term of that office begins.

25 (10) The remedy provided by this section is the exclusive remedy for a violation of this section.

26 <u>SECTION 11.</u> This 2019 Act being necessary for the immediate preservation of the public 27 peace, health and safety, an emergency is declared to exist, and this 2019 Act takes effect 28 on its passage.
