SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Authorizes Department of State Lands to perform work to acquire and restore operation of Willamette Falls navigation canal and locks.

A BILL FOR AN ACT

2 Relating to Willamette Falls navigation infrastructure.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) It is the intent of the Legislative Assembly that the State of Oregon**
5 **should work to acquire the Willamette Falls navigation canal and locks from the United**
6 **States Army Corps of Engineers and work to restore the navigation canal and locks to an**
7 **operational state.**

8 **(2) For the purposes expressed in subsection (1) of this section, the Department of State**
9 **Lands may:**

10 **(a) Acquire any and all interests in property, real or personal, constituting the navigation**
11 **canal and locks;**

12 **(b) Repair, maintain and operate the navigation canal and locks, including by contracting**
13 **with public or private entities for repairs, maintenance or operation;**

14 **(c) Enter into agreements with the United States Army Corps of Engineers for repair or**
15 **maintenance of the navigation canal and locks, which may include transfers of moneys to**
16 **or from the corps;**

17 **(d) Lease or transfer any portion of the navigation canal and locks to any public or pri-**
18 **vate entity for purposes of maintenance, repair or operation;**

19 **(e) Perform any work, or contract for the performance of work, that is necessary for or**
20 **incident to a transfer of ownership of the navigation canal and locks from the United States**
21 **Army Corps of Engineers; and**

22 **(f) Perform any work, or contract for the performance of work, related to seismic sta-**
23 **bilization or rehabilitation of the navigation canal and locks.**

24 **(3) The powers granted to the Department of State Lands by this section are in addition**
25 **to, and do not limit, powers otherwise granted to the department under any other provision**
26 **of law.**

27 **(4) The Oregon Business Development Department, the Department of Transportation**
28 **and the State Parks and Recreation Department shall consult with and render assistance to**
29 **the Department of State Lands as necessary to accomplish the purposes expressed in sub-**
30 **section (1) of this section.**
