

House Bill 2370

Sponsored by Representative SMITH DB (Pre-session filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Allows electors of county to approve measure allowing use of dogs for hunting, pursuing or taking cougars within county. Authorizes State Department of Fish and Wildlife to issue resident of approving county special cougar tag that allows use of dogs for hunting, pursuing or taking cougars within county.

2 Relating to cougars; creating new provisions; and amending ORS 498.164.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. Section 2 of this 2019 Act is added to and made a part of ORS chapter 497.**

5 **SECTION 2. The electors of a county may, at any county-wide election, approve a meas-**
6 **ure to allow the use of one or more dogs to hunt, pursue or take cougars. If the electors of**
7 **a county approve a measure described in this section, the State Department of Fish and**
8 **Wildlife may issue a person residing within the county a special cougar tag that allows the**
9 **person to use one or more dogs for the purpose of hunting, pursuing or taking cougars**
10 **within the county.**

11 **SECTION 3. ORS 498.164, as amended by section 3, chapter 376, Oregon Laws 2013, is amended**
12 **to read:**

13 498.164. (1) Except as provided in [*subsections (2) and (3)*] **subsection (2)** of this section, a per-
14 son may not use bait to attract or take black bears or use one or more dogs to hunt or pursue black
15 bears or cougars.

16 (2) [*Nothing in*] Subsection (1) of this section [*prohibits*] **does not apply to:**

17 (a) The use of bait or one or more dogs by employees or agents of county, state or federal
18 agencies while acting in their official capacities.

19 [(3)] (b) [*Nothing in subsection (1) of this section prohibits*] The use of bait or dogs by persons for
20 the taking of black bears or cougars in accordance with the provisions of ORS 498.012 relating to
21 taking wildlife that is causing damage.

22 (c) **The use of dogs for the purpose of hunting, pursuing or taking cougars under a spe-**
23 **cial cougar tag issued under section 2 of this 2019 Act.**

24 [(4)] (3) Any person who violates subsection (1) of this section commits a Class A misdemeanor
25 and, upon conviction, shall in addition to appropriate criminal penalties have his or her privilege
26 to apply for any hunting license suspended for a period of five years for a first offense and perma-
27 nently suspended for any subsequent offense.

28 [(5)] (4) For the purposes of this section, "bait" means any material placed for the purpose of
29 attracting or attempting to attract bears.
