

HOUSE AMENDMENTS TO HOUSE BILL 2393

1 On page 1 of the printed bill, line 3, after “163.472” delete the rest of the line and insert “,
2 166.065 and 659A.270.”

3 On page 2, line 23, after “\$5,000” insert “per plaintiff”.

4 In line 29, after “(4)” insert “An emancipated minor, or” and before “shall” insert a comma.

5 After line 33, insert:

6 “(6) An award of statutory damages described in subsection (2) of this section is not evidence
7 of the existence or the amount of economic damages for purposes of restitution under ORS
8 137.106.”

9 On page 4, after line 1, insert:

10 “**SECTION 4.** ORS 659A.270 is amended to read:

11 “659A.270. As used in ORS 659A.270 to 659A.285:

12 “(1) ‘Covered employer’ means an employer who employs six or more individuals in the State
13 of Oregon for each working day during each of 20 or more calendar workweeks in the year in which
14 an eligible employee takes leave to address domestic violence, harassment, sexual assault or stalk-
15 ing, or in the year immediately preceding the year in which an eligible employee takes leave to
16 address domestic violence, harassment, sexual assault or stalking.

17 “(2) ‘Eligible employee’ means an employee who is a victim of domestic violence, harassment,
18 sexual assault or stalking or is the parent or guardian of a minor child or dependent who is a victim
19 of domestic violence, harassment, sexual assault or stalking.

20 “(3) ‘Protective order’ means an order authorized by ORS 30.866, 107.095 (1)(c), 107.700 to
21 107.735, 124.005 to 124.040, 163.730 to 163.750 or 163.760 to 163.777 or any other order that restrains
22 an individual from contact with an eligible employee or the employee’s minor child or dependent.

23 “(4) ‘Victim of domestic violence’ means:

24 “(a) An individual who has been a victim of abuse, as defined in ORS 107.705; or

25 “(b) Any other individual designated as a victim of domestic violence by rule adopted under ORS
26 659A.805.

27 “(5) ‘Victim of harassment’ means:

28 “(a) An individual against whom harassment has been committed as described in ORS 166.065.

29 “(b) Any other individual designated as a victim of harassment by rule adopted under ORS
30 659A.805.

31 “(6) ‘Victim of sexual assault’ means:

32 “(a) An individual against whom a sexual offense has been committed as described in ORS
33 163.305 to 163.467, **163.472** or 163.525; or

34 “(b) Any other individual designated as a victim of sexual assault by rule adopted under ORS
35 659A.805.

1 “(7) ‘Victim of stalking’ means:

2 “(a) An individual against whom stalking has been committed as described in ORS 163.732;

3 “(b) An individual designated as a victim of stalking by rule adopted under ORS 659A.805; or

4 “(c) An individual who has obtained a court’s stalking protective order or a temporary court’s
5 stalking protective order under ORS 30.866.

6 “(8) ‘Victim services provider’ means a prosecutor-based victim assistance program or a
7 nonprofit program offering safety planning, counseling, support or advocacy related to domestic vi-
8 olence, harassment, sexual assault or stalking.”.
