SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[*Directs*] **Authorizes** Health Licensing Office to [*register*] **certify** qualified applicant as sexual offense therapist intern. **Establishes qualifications for certification.** Renames Sex Offender Treatment Board to Sexual Offense Treatment Board.

Becomes operative January 1, 2020.

Takes effect on 91st day following adjournment sine die.

5 an effective date.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 675.365 is amended to read:

8 675.365. As used in ORS 675.360 to 675.410:

9 (1) "Certified associate [*sex offender*] **sexual offense** therapist" means a person who is certified
10 under ORS 675.375 or 675.380 to provide services for the treatment and rehabilitation of persons
11 described in ORS 675.368 while under the direct supervision of a certified clinical [*sex offender*]
12 **sexual offense** therapist.

13 (2) "Certified clinical [*sex offender*] **sexual offense** therapist" means a person who is certified
14 under ORS 675.375 or 675.380 to provide services for the treatment and rehabilitation of persons
15 described in ORS 675.368 and who may supervise certified associate [*sex offender*] **sexual offense**
16 therapists, **certified secondary clinical sexual offense therapists and certified sexual offense**
17 **therapist interns.**

18 (3) "Certified secondary [*associate sex offender*] **clinical sexual offense** therapist" means a per-
19 son who is certified under ORS 675.375 or 675.380 to provide limited services for the treatment and
20 rehabilitation of persons described in ORS 675.368 under the direct supervision of a certified clinical
21 [*sex offender*] **sexual offense** therapist.

22 (4) "Certified [*sex offender*] **sexual offense** therapist" means a certified clinical [*sex offender*]
23 **sexual offense** therapist, a certified associate [*sex offender*] **sexual offense** therapist, [*or*] a certi-
24 fied secondary [*associate sex offender*] **clinical sexual offense** therapist **or a certified sexual of-**
25 **fense therapist intern.**

26 (5) "Certified sexual offense therapist intern" means a person who:

1 (a) **Has not completed the supervised clinical experience and training required to be a**
2 **certified associate sexual offense therapist; and**

3 (b) **Is certified under ORS 675.375 to provide services for the treatment and rehabilitation**
4 **of persons described in ORS 675.368 while under the direct supervision of a certified clinical**
5 **sexual offense therapist.**

6 [(5)] (6) “Direct supervision” means a minimum **number** of [two] hours of supervision by a cer-
7 tified clinical [sex offender] **sexual offense** therapist [for each:] **required under ORS 675.375.**

8 [(a) 45 hours of direct clinical contact with a person described in ORS 675.368, if the individual
9 being supervised is a certified associate sex offender therapist; or]

10 [(b) 10 hours of direct clinical contact with a person described in ORS 675.368, if the individual
11 being supervised is a certified secondary associate sex offender therapist.]

12 [(6)] (7) “Professional disclosure statement” means a statement about an applicant for certifica-
13 tion under ORS 675.375 or 675.380 that includes the following information:

14 (a) Name, business address and telephone number;

15 (b) Philosophy and approach to treatment and rehabilitation of persons described in ORS
16 675.368;

17 (c) Formal education and training;

18 (d) Continuing education experience and name of supervisor, if any;

19 (e) Fee schedules for sexual abuse specific treatment services; and

20 (f) The name, address and telephone number of the [Sex Offender] **Sexual Offense** Treatment
21 Board.

22 [(7)] (8) “Sexual abuse specific treatment” means the process of evaluation, assessment and re-
23 formation of persons described in ORS 675.368.

24 **SECTION 2.** ORS 675.370 is amended to read:

25 675.370. (1) A person may not:

26 (a) Engage in the practice of sexual abuse specific treatment or assume or use any title, words
27 or abbreviations, including the title or designation “certified clinical [sex offender] **sexual offense**
28 therapist,” “certified associate [sex offender] **sexual offense** therapist,” [or] “certified secondary
29 [associate sex offender] **clinical sexual offense** therapist[,]” or “**certified sexual offense therapist**
30 **intern,**” that indicate that the person is authorized to engage in the practice of sexual abuse spe-
31 cific treatment unless the person holds a certificate issued under ORS 675.375 or 675.380.

32 (b) Attempt to obtain a certificate or renewal of a certificate under ORS 675.360 to 675.380 by
33 bribery or fraudulent representation.

34 [(2) Subsection (1) of this section does not prohibit a person who is authorized to practice a mental
35 health profession other than sexual abuse specific treatment under the laws of this state:]

36 [(a) From practicing the person’s mental health profession; or]

37 [(b) From providing sexual abuse specific treatment if the provision of sexual abuse specific treat-
38 ment is within the person’s scope of practice.]

39 [(3)] (2) Each violation of subsection (1) of this section is a separate violation.

40 **SECTION 3.** ORS 675.375 is amended to read:

41 675.375. (1) To obtain certification as a clinical [sex offender] **sexual offense** therapist, associate
42 [sex offender] **sexual offense** therapist, [or] secondary [associate sex offender] **clinical sexual of-**
43 **fense** therapist or **sexual offense therapist intern,** an applicant must complete an application de-
44 veloped and prescribed by the [Sex Offender] **Sexual Offense** Treatment Board and file a
45 professional disclosure statement with the Health Licensing Office. The documents must be accom-

1 panied by the applicable fees established under ORS 676.576.

2 (2) Subject to the provisions of ORS 676.612, the office may issue [*three*] **four** types of certi-
3 fication to qualified applicants under this section:

4 (a) Clinical [*sex offender*] **sexual offense** therapist;

5 (b) Associate [*sex offender*] **sexual offense** therapist; [*and*]

6 (c) Secondary [*associate sex offender*] **clinical sexual offense** therapist; **and**

7 **(d) Sexual offense therapist intern.**

8 (3) To qualify as a certified clinical [*sex offender*] **sexual offense** therapist, the applicant must:

9 (a) Be in compliance with applicable provisions and rules adopted by the office;

10 (b) Have at least a master's degree in the behavioral sciences;

11 (c) Have an active Oregon mental health professional license or equivalent license as determined
12 by the office;

13 (d) Within not [*less than three years nor*] more than six years prior to application, have had a
14 minimum of 2,000 hours of direct clinical contact with persons described in ORS 675.368, including:

15 (A) 1,000 hours of direct treatment services; and

16 (B) 500 hours of evaluations; and

17 (e) Have a minimum of 60 hours of formal training applicable to sexual abuse specific treatment
18 and evaluation, achieved within the [*three*] **six** years prior to application.

19 (4) To qualify as a certified associate [*sex offender*] **sexual offense** therapist, the applicant must:

20 (a) Be in compliance with applicable provisions and rules adopted by the office;

21 (b) Have at least a bachelor's degree in the behavioral sciences;

22 (c) Have had a minimum of 1,000 hours of direct clinical contact with persons described in ORS
23 675.368;

24 (d) Have a minimum of 30 hours of formal training applicable to sexual abuse specific treatment
25 and evaluation, achieved within the three years prior to application; and

26 (e) Be under the direct supervision of a certified clinical [*sex offender*] **sexual offense** therapist.

27 (5) To qualify as a certified secondary [*associate sex offender*] **clinical sexual offense** therapist,
28 the applicant must:

29 (a) Be in compliance with applicable provisions and rules adopted by the office;

30 (b) Have at least a master's degree in the behavioral sciences;

31 (c) Have an active Oregon mental health professional license or equivalent license as determined
32 by the office or be a registered intern for a mental health professional licensed in Oregon;

33 (d) Have a minimum of 15 hours of formal training applicable to sexual abuse specific treatment
34 and evaluation, achieved within the three years prior to application;

35 (e) Be under the direct supervision of a certified clinical [*sex offender*] **sexual offense** therapist;
36 and

37 (f) Provide sexual abuse specific treatment services to not more than nine clients in a calendar
38 month, unless the applicant is accruing hours to qualify for application as a certified associate [*sex*
39 *offender*] **sexual offense** therapist.

40 **(6) To qualify as a certified sexual offense therapist intern, the applicant must:**

41 **(a) Be in compliance with applicable provisions and rules adopted by the office;**

42 **(b) Have at least a bachelor's degree in the behavioral sciences; and**

43 **(c) Be under the direct supervision of a certified clinical sexual offense therapist.**

44 **(7)(a) A certified associate sexual offense therapist and a certified sexual offense thera-
45 pist intern must obtain:**

1 (A) A minimum of two hours of direct supervision, at least one hour of which must be
2 individual supervision, in a month if the certified associate sexual offense therapist or cer-
3 tified sexual offense therapist intern has 45 or fewer hours in the month of direct clinical
4 contact with a person described in ORS 675.368.

5 (B) A minimum of three hours of direct supervision, at least 90 minutes of which must
6 be individual supervision, in a month if the certified associate sexual offense therapist or
7 certified sexual offense therapist intern has more than 45 hours in the month of direct clin-
8 ical contact with a person described in ORS 675.368.

9 (b) A certified secondary clinical sexual offense therapist must obtain at least two hours
10 of direct supervision for every 10 hours of direct clinical contact with a person described in
11 ORS 675.368.

12 **SECTION 4.** ORS 675.380 is amended to read:

13 675.380. Upon receipt of an application and the applicable fees established under ORS 676.576,
14 the Health Licensing Office shall certify a clinical [*sex offender*] **sexual offense** therapist, associate
15 [*sex offender*] **sexual offense** therapist or secondary [*associate sex offender*] **clinical sexual offense**
16 therapist if the applicant provides evidence to the satisfaction of the office that the applicant is
17 recognized as a clinical [*sex offender*] **sexual offense** therapist, associate [*sex offender*] **sexual of-**
18 **fense** therapist or secondary [*associate sex offender*] **clinical sexual offense** therapist in another
19 state in which the requirements for recognition are, in the judgment of the office, in consultation
20 with the [*Sex Offender*] **Sexual Offense** Treatment Board, at least equivalent to the requirements
21 of ORS 675.360 to 675.410 and rules of the office.

22 **SECTION 5.** ORS 675.382 is amended to read:

23 675.382. [(1)] ORS 675.360 to 675.410 do not apply to:

24 [(a)] (1) A student enrolled in an approved educational program who is pursuing a graduate de-
25 gree in a mental health field, if the student provides sexual abuse specific treatment services only
26 for academic credit as part of an organized and supervised training program.

27 [(b)] (2) A person employed by a local, state or federal government agency, community mental
28 health program or drug and alcohol treatment program licensed or certified in this state, if the
29 person's activities and services are performed and provided within the person's scope of employment.

30 [(c)] (3) A person who is a recognized member of the clergy, if the person is acting in the
31 person's capacity as a member of the clergy.

32 [(2) A person described in subsection (1) of this section may not use the title "certified clinical sex
33 offender therapist," "certified associate sex offender therapist," "certified secondary associate sex
34 offender therapist" or a similar title.]

35 **SECTION 6.** ORS 675.384 is amended to read:

36 675.384. A person who engages in the practice of sexual abuse specific treatment as a certified
37 clinical [*sex offender*] **sexual offense** therapist, and who did not hold an active Oregon mental
38 health professional license or equivalent license as determined by the Health Licensing Office as
39 of the date of the person's initial certification, may continue to engage in the practice of sexual
40 abuse specific treatment as a certified clinical [*sex offender*] **sexual offense** therapist only if the
41 person obtains an Oregon mental health professional license or equivalent license as determined by
42 the office not later than January 1, 2021.

43 **SECTION 7.** ORS 675.385 is amended to read:

44 675.385. (1) In the manner prescribed in ORS chapter 183 for contested cases, and at the direc-
45 tion of the [*Sex Offender*] **Sexual Offense** Treatment Board, the Health Licensing Office may impose

1 a form of discipline listed in ORS 676.612 against a certified clinical [*sex offender*] **sexual offense**
2 therapist, certified associate [*sex offender*] **sexual offense** therapist, [or] certified secondary [*asso-*
3 *ciate sex offender*] **clinical sexual offense** therapist **or certified sexual offense therapist intern**
4 for any of the grounds listed in ORS 676.612 and for any violation of the provisions of, or rules
5 adopted under, ORS 675.360 to 675.410.

6 (2) The office may impose disciplinary sanctions against a certified clinical [*sex offender*] **sexual**
7 **offense** therapist, certified associate [*sex offender*] **sexual offense** therapist, [or] certified secondary
8 [*associate sex offender*] **clinical sexual offense** therapist **or certified sexual offense therapist in-**
9 **tern** for any of the following reasons:

10 (a) The person was convicted of violating ORS 675.390, or of a felony or misdemeanor that
11 brings into question the person's competence or integrity as a certified clinical [*sex offender*] **sexual**
12 **offense** therapist, certified associate [*sex offender*] **sexual offense** therapist, [or] certified secondary
13 [*associate sex offender*] **clinical sexual offense** therapist **or certified sexual offense therapist in-**
14 **tern**.

15 (b) The person's mental health professional license, or equivalent license, has been revoked,
16 suspended or restricted by the issuing authority.

17 (c) The person has violated ORS 675.370 (1), or any rules adopted by the office pertaining to
18 certification.

19 (d) The person has failed to file or has filed a false, misleading or incomplete professional dis-
20 closure statement with the office.

21 (e) The person has practiced beyond the scope of the person's certification under ORS 675.380.

22 **SECTION 8.** Section 13, chapter 421, Oregon Laws 2017, is amended to read:

23 **Sec. 13.** (1) Not later than December 31, 2018, the Department of Corrections, the Oregon
24 Health Authority and the Oregon Youth Authority shall each submit a report to the interim com-
25 mittees of the Legislative Assembly related to the judiciary in the manner provided in ORS 192.245.
26 A report submitted under this section must include:

27 (a) A description of any complaints the submitting agency received against persons employed
28 by the agency who provide sexual abuse specific treatment as defined in ORS 675.365 and who are
29 not certified under ORS 675.375; and

30 (b) Any steps that the submitting agency would need to take to ensure that any of the agency's
31 employees to whom ORS 675.360 to 675.410 do not apply because of [*section 11 (1)(b) of this 2017*
32 *Act*] **ORS 675.382 (2)** become certified under ORS 675.375 if [*section 11 (1)(b) of this 2017 Act*] **ORS**
33 **675.382 (2)** were to be repealed.

34 (2) A local, state or federal governmental agency, community mental health program or drug and
35 alcohol treatment program licensed or certified by this state that employs a person to whom the
36 requirements of ORS 675.360 to 675.410 do not apply because of [*section 11 (1)(b) of this 2017 Act*]
37 **ORS 675.382 (2)** may submit the report described in subsection (1) of this section.

38 **SECTION 9.** ORS 675.390 is amended to read:

39 675.390. A certified [*sex offender*] **sexual offense** therapist, or any employee of a certified [*sex*
40 *offender*] **sexual offense** therapist, may not disclose any communication made by a client during the
41 course of noninvestigatory professional treatment or rehabilitation, except:

42 (1) When the client or a person authorized to act on behalf of the client gives consent to the
43 disclosure;

44 (2) When the client initiates legal action or makes a complaint against a [*sex offender*] **sexual**
45 **offense** therapist to the [*Sex Offender*] **Sexual Offense** Treatment Board;

1 (3) When the communication reveals the intent to commit a crime harmful to the client or oth-
2 ers;

3 (4) When the communication reveals that a minor may have been a victim of a crime or physical,
4 sexual or emotional abuse or neglect; or

5 (5) To juvenile and adult parole and probation officers supervising the client under a mandated
6 sex offender treatment condition imposed by a court or releasing authority.

7 **SECTION 10.** ORS 675.395 is amended to read:

8 675.395. (1) The [*Sex Offender*] **Sexual Offense** Treatment Board is established within the Health
9 Licensing Office. The board shall consist of seven members appointed by the Governor from lists of
10 recommended persons submitted as provided in subsection (2) of this section. All members of the
11 board must be residents of this state.

12 (2) Of the members appointed to the board:

13 (a) Two shall be from a list submitted by the Oregon Association for the Treatment of Sexual
14 Abusers;

15 (b) Two shall be from a list submitted by the Oregon Adolescent Sex Offending Treatment Net-
16 work or a successor organization;

17 (c) One shall be from a list submitted by the Oregon Association of Community Corrections Di-
18 rectors;

19 (d) One shall be from a list submitted by the Oregon Juvenile Department Directors Association;
20 and

21 (e) One shall be from a list submitted by a victims' advocacy organization.

22 (3) The term of office of each member is four years, but a member serves at the pleasure of the
23 Governor. Vacancies shall be filled by the Governor by appointment for the unexpired term. A
24 member shall hold the member's office until the appointment and qualification of a successor. A
25 member is eligible for reappointment. If a person serves two consecutive full terms, a period of at
26 least four years must elapse before the person is again eligible for appointment to serve on the
27 board.

28 (4) Members of the board are eligible for compensation and expenses as provided in ORS 292.495.

29 (5) The board shall select one of its members to serve as chair and another to serve as vice
30 chair, for those terms and with such duties and powers necessary for the performance of the func-
31 tions of those offices as the board determines.

32 (6) A majority of the board constitutes a quorum for the transaction of business.

33 (7) The board shall meet at times and places specified by the call of the chair or of a majority
34 of the members of the board. The board shall meet at least once each calendar year.

35 (8) A board member appointed under this section who is also a certified clinical [*sex offender*]
36 **sexual offense** therapist, certified associate [*sex offender*] **sexual offense** therapist or certified
37 secondary [*associate sex offender*] **clinical sexual offense** therapist must satisfy all requirements for
38 certification provided in ORS 675.375 and must obtain certification within 12 months of the member's
39 appointment.

40 **SECTION 11.** ORS 675.400 is amended to read:

41 675.400. The [*Sex Offender*] **Sexual Offense** Treatment Board shall:

42 (1) Determine the qualifications and fitness of applicants for certification as clinical [*sex*
43 *offender*] **sexual offense** therapists, [*or*] associate [*sex offender*] **sexual offense** therapists, **second-**
44 **ary clinical sexual offense therapists and sexual offense therapist interns** under ORS 675.360
45 to 675.380.

1 (2) Establish standards of practice and professional responsibility for persons certified by the
2 Health Licensing Office.

3 (3) Adopt standards for training, including but not limited to training related to the treatment
4 of distinct [*sex offender*] **sexual abuser** populations, including adults, juveniles, persons with devel-
5 opmental disabilities and others.

6 (4) Advise the office on all matters related to administering ORS 675.360 to 675.410 and recom-
7 mend rules, standards and guidelines necessary for the administration of ORS 675.360 to 675.380.

8 **SECTION 12.** ORS 675.410 is amended to read:

9 675.410. (1) The Health Licensing Office shall:

10 (a) Issue certifications to persons determined by the office to be qualified.

11 (b) Make all disbursements necessary to carry out the provisions of ORS 675.360 to 675.410.

12 (c) Maintain a registry of all current certified [*sex offender*] **sexual offense** therapists. The
13 registry shall be made available to the public online.

14 (d) Keep a record of its proceedings related to the issuance, refusal, suspension and revocation
15 of certifications issued under ORS 675.360 to 675.380.

16 (e) In consultation with the [*Sex Offender*] **Sexual Offense** Treatment Board, create a multidis-
17 ciplinary advisory committee within the board. Persons who are not board members may be ap-
18 pointed as nonvoting members to serve on the multidisciplinary advisory committee with the
19 approval of the board.

20 (2) The office may:

21 (a) Deny, suspend, revoke or refuse to issue or renew any certification issued under ORS 675.360
22 to 675.380.

23 (b) Provide for waivers of examinations, grandfathering requirements and temporary certif-
24 ications as considered appropriate.

25 (c) In consultation with the [*Sex Offender Treatment*] board, create any committees within the
26 board as deemed necessary. Persons who are not board members may be appointed as nonvoting
27 members to serve on the committees with the approval of the board.

31 **SECTION 13.** ORS 163A.030 is amended to read:

32 163A.030. (1)(a) Except as provided in subsection (6) of this section, the juvenile court shall hold
33 a hearing on the issue of reporting as a sex offender by a person who has been found to be within
34 the jurisdiction of the juvenile court under ORS 419C.005, or found by the juvenile court to be re-
35 sponsible except for insanity under ORS 419C.411, for having committed an act that if committed
36 by an adult would constitute a felony sex crime if:

37 (A) The person was adjudicated on or after August 12, 2015; or

38 (B) The person was adjudicated before August 12, 2015, and was still under the jurisdiction of
39 the juvenile court or the Psychiatric Security Review Board on April 4, 2016.

40 (b) Unless the court continues the hearing described in this section for good cause, the hearing
41 must be held:

42 (A) During the six-month period before the termination of juvenile court jurisdiction over the
43 person; or

44 (B) During the six-month period after the court receives the notice described in subsection (2)
45 of this section from the Psychiatric Security Review Board, if the person was placed under the ju-

1 jurisdiction of the board.

2 (c) The court shall notify the person of the person's right to a hearing under this section upon
3 finding the person within the jurisdiction of the juvenile court under ORS 419C.005.

4 (2)(a) The county or state agency responsible for supervising the person shall notify the person
5 and the juvenile court when the agency determines that termination of jurisdiction is likely to occur
6 within six months.

7 (b) If the Psychiatric Security Review Board discharges a person prior to the end of the board's
8 jurisdiction over the person, the board shall notify the juvenile court within three business days
9 after the discharge date.

10 (3) Upon receipt of the notice described in subsection (2) of this section, the court shall:

11 (a) Appoint an attorney for the person as described in subsection (4) of this section;

12 (b) Set an initial hearing date; and

13 (c) Notify the parties and the juvenile department or the Psychiatric Security Review Board, if
14 the department or board is supervising or has jurisdiction over the person, of the hearing at least
15 60 days before the hearing date.

16 (4)(a) A person who is the subject of a hearing under this section has the right to be represented
17 by a suitable attorney possessing skills and experience commensurate with the nature and com-
18 plexity of the case, to consult with the attorney prior to the hearing and, if financially eligible, to
19 have a suitable attorney appointed at state expense.

20 (b) In order to comply with the right to counsel under paragraph (a) of this subsection, the court
21 may:

22 (A) Continue the appointment of the attorney appointed under ORS 419C.200 at the time of dis-
23 position;

24 (B) Set a date prior to the hearing under this section in order to reappoint the attorney ap-
25 pointed under ORS 419C.200; or

26 (C) Appoint or reappoint an attorney at any time in response to a request by the person who
27 is the subject of a hearing under this section.

28 (5)(a) The district attorney shall notify the victim prior to the hearing of the right to appear and
29 the right to be heard under ORS 419C.273.

30 (b) If the person is under the jurisdiction of the Psychiatric Security Review Board, the board
31 shall notify the following of the hearing:

32 (A) The mental health agency providing services to the person, if any;

33 (B) The person's board defense attorney; and

34 (C) The assistant attorney general representing the state at board hearings.

35 (6)(a) A person may waive the right to the hearing described in this section after consultation
36 with the person's attorney. If the court finds that the person has knowingly waived the right to a
37 hearing, the court shall enter an order requiring the person to report as a sex offender under ORS
38 163A.025.

39 (b) If a person fails to appear at a hearing described in this section, the court may enter an
40 order requiring the person to report as a sex offender under ORS 163A.025.

41 (7) At the hearing described in subsection (1) of this section:

42 (a) The district attorney, the victim, the person and the juvenile department or a representative
43 of the Oregon Youth Authority shall have an opportunity to be heard.

44 (b) The person who is the subject of the hearing has the burden of proving by clear and con-
45 vincing evidence that the person is rehabilitated and does not pose a threat to the safety of the

1 public. If the court finds that the person has not met the burden of proof, the court shall enter an
2 order requiring the person to report as a sex offender under ORS 163A.025.

3 (8) In determining whether the person has met the burden of proof, the juvenile court may
4 consider but need not be limited to considering:

5 (a) The extent and impact of any physical or emotional injury to the victim;

6 (b) The nature of the act that subjected the person to the duty of reporting as a sex offender;

7 (c) Whether the person used or threatened to use force in committing the act;

8 (d) Whether the act was premeditated;

9 (e) Whether the person took advantage of a position of authority or trust in committing the act;

10 (f) The age of any victim at the time of the act, the age difference between any victim and the
11 person and the number of victims;

12 (g) The vulnerability of the victim;

13 (h) Other acts committed by the person that would be crimes if committed by an adult and
14 criminal activities engaged in by the person before and after the adjudication;

15 (i) Statements, documents and recommendations by or on behalf of the victim or the parents of
16 the victim;

17 (j) The person's willingness to accept personal responsibility for the act and personal account-
18 ability for the consequences of the act;

19 (k) The person's ability and efforts to pay the victim's expenses for counseling and other
20 trauma-related expenses or other efforts to mitigate the effects of the act;

21 (L) Whether the person has participated in and satisfactorily completed a sex offender treatment
22 program or any other intervention, and if so the juvenile court may also consider:

23 (A) The availability, duration and extent of the treatment activities;

24 (B) Reports and recommendations from the providers of the treatment;

25 (C) The person's compliance with court, board or supervision requirements regarding treatment;
26 and

27 (D) The quality and thoroughness of the treatment program;

28 (m) The person's academic and employment history;

29 (n) The person's use of drugs or alcohol before and after the adjudication;

30 (o) The person's history of public or private indecency;

31 (p) The person's compliance with and success in completing the terms of supervision;

32 (q) The results of psychological examinations of the person;

33 (r) The protection afforded the public by records of sex offender registration; and

34 (s) Any other relevant factors.

35 (9) In a hearing under this section, the juvenile court may receive testimony, reports and other
36 evidence, without regard to whether the evidence is admissible under ORS 40.010 to 40.210 and
37 40.310 to 40.585, if the evidence is relevant evidence related to the determination and findings re-
38 quired under this section. As used in this subsection, "relevant evidence" has the meaning given
39 that term in ORS 40.150.

40 (10)(a) In a hearing under this section, the Oregon Youth Authority or the juvenile department,
41 if either agency is supervising the person, or the Psychiatric Security Review Board, if the board
42 has jurisdiction over the person, shall file with the juvenile court the following records and mate-
43 rials in the possession of the agency or board at least 45 days prior to the hearing unless good cause
44 is shown:

45 (A) Evaluations and treatment records concerning the person conducted by a clinician or pro-

1 gram operating under the standards of practice for the evaluation and treatment of juvenile sex
2 offenders adopted by the [*Sex Offender*] **Sexual Offense** Treatment Board under ORS 675.400, and
3 recommendations contained therein regarding the need for the person to register in order to protect
4 the public from future sex crimes;

5 (B) All examination preparation material and examination records from polygraph examinations
6 conducted by or for the treatment provider, juvenile department or Oregon Youth Authority; and

7 (C) The Psychiatric Security Review Board exhibit file.

8 (b) Any records and materials filed with the court under this subsection shall be made available
9 to the parties in accordance with ORS 419A.255.

10 (11) When the juvenile court enters an order described in subsection (7)(b) of this section, the
11 court shall ensure that the person completes a form that documents the person's obligation to report
12 under ORS 163A.025. No later than three business days after the person completes the form required
13 by this subsection, the court shall ensure that the form is sent to the Department of State Police.

14 (12) Notwithstanding ORS 419C.005 (4)(c), (d) and (e), the juvenile court retains jurisdiction over
15 a person for purposes of this section.

16 (13) As used in this section, "parties" means the person, the state as represented by the district
17 attorney or the juvenile department, and the Oregon Youth Authority or other child care agency,
18 if the person is temporarily committed to the authority or agency.

20 (G) Respiratory care and polysomnography under ORS 688.800 to 688.840;
