SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Expands higher education tuition grants offered to qualified members of Oregon National Guard by permitting grant to be used for undergraduate degree program at **Oregon Health and Science University or** qualifying private post-secondary institutions or for program or curriculum designed to lead to certificate of completion at community college, public university, Oregon Health and Science University or qualifying private post-secondary institution.

other state or territory; 1 2 (E) Has completed and submitted the Free Application for Federal Student Aid for each academic year, if eligible to file the application; and 3 (F) Has accepted all state and federal aid grants available to the student, including but not 4 limited to federal grants offered by the United States Department of Education and the United 5 States Department of Defense. 6 (d) "Qualifying private institution" means a private post-secondary institution that meets 7 the criteria set forth in ORS 348.597 (2). 8 9 (2) A qualified student shall receive a grant under this section in an amount that equals, after the amount of resident tuition is reduced by any amounts received by the qualified student 10 in state and federal aid grants: 11 12 (a) The resident tuition charges at the community college [or public university listed in ORS 13 352.002] at which the qualified student is enrolled, after the amount of resident tuition is reduced by any amounts received by the qualified student in state and federal aid grants]; 14 15 (b) The resident tuition charges at the public university listed in ORS 352.002 at which the qualified student is enrolled; 16 (c) The average resident tuition charges to attend a public university listed in ORS 17 352.002 if the qualified student is enrolled at a qualifying private institution; or 18 (d) The resident tuition charges at Oregon Health and Science University if the qualified 19 student is enrolled at Oregon Health and Science University. 20(3) Grants provided under this section shall be awarded to a qualified student for up to: 21(a) 90 credit hours at a community college; [or] 22(b) 180 credit hours at a public university listed in ORS 352.002; 23(c) 180 credit hours at a qualifying private institution; or 94 (d) 180 credit hours at Oregon Health and Science University. 25[(3)] (4) The Higher Education Coordinating Commission shall adopt any rules necessary for the 2627administration of this section, including but not limited to any requirements related to: (a) Specifying the form and timelines for submitting an application for a grant under this section; 28(b) Determining whether a person is eligible for a grant under this section; and 2930 (c) Prescribing grant calculations for qualified students dually enrolled [in] at a community 31 college, [and] a public university, Oregon Health and Science University or a qualifying private institution. 32SECTION 2. The amendments to section 2, chapter 53, Oregon Laws 2018, by section 1 33 34 of this 2019 Act first apply to tuition assistance provided for the 2020-2021 academic year. 35
