

HOUSE AMENDMENTS TO A-ENGROSSED HOUSE BILL 2902

1 On page 1 of the printed A-engrossed bill, line 2, after the first semicolon delete the rest of the
2 line and insert “and declaring an”.

3 Delete lines 5 through 23 and delete page 2 and insert:

4 **“SECTION 1. (1) Each school district shall make an annual report on the number of in-**
5 **cidents that occurred during the previous school year during which the students of a class-**
6 **room were removed from the classroom because another student in the classroom was**
7 **acting in a manner that would threaten to:**

8 **“(a) Cause harm to the student;**

9 **“(b) Injure another person; or**

10 **“(c) Damage school property.**

11 **“(2) The report required under this section must be made to the Department of Educa-**
12 **tion no later than September 1 of each year for the previous school year.**

13 **“(3) The Department of Education shall make available the information received under**
14 **subsection (2) of this section on the department’s website no later than December 31 of each**
15 **year.**

16 **“(4) The State Board of Education shall adopt any rules necessary for the administration**
17 **of this section.**

18 **“SECTION 2. (1) Section 1 of this 2019 Act becomes operative on July 1, 2020.**

19 **“(2) Notwithstanding the operative date specified in subsection (1) of this section, the**
20 **first report required from a school district under section 1 of this 2019 Act must be made**
21 **to the Department of Education no later than September 1, 2021, for the 2020-2021 school**
22 **year.**

23 **“SECTION 3. (1) Section 1 of this 2019 Act is repealed on December 31, 2025.**

24 **“(2) No report is required from a school district under section 1 of this 2019 Act for the**
25 **2025-2026 school year or any subsequent school year.**

26 **“SECTION 4. (1) The Department of Education shall conduct a study to investigate**
27 **options for sharing best practices related to quiet rooms, positive behavioral management,**
28 **restorative justice, behavioral supports that are provided in the classroom and other meth-**
29 **ods of improving student behaviors.**

30 **“(2) The department shall report the results of the study, and may include recommen-**
31 **dations for legislation, to an interim committee of the Legislative Assembly related to edu-**
32 **cation no later than September 15, 2020.**

33 **“SECTION 5. Section 4 of this 2019 Act is repealed on December 31, 2020.**

34 **“SECTION 6. This 2019 Act being necessary for the immediate preservation of the public**
35 **peace, health and safety, an emergency is declared to exist, and this 2019 Act takes effect**

1 **July 1, 2019.”**
