SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires covered organizations that make political communications in excess of specified amount to file with Secretary of State donor identification list that identifies donors that made donations above \$10,000 during election cycle to covered organization. Requires covered organization to update list throughout election cycle. **Exempts from definition of "political communication" any communication reported as contribution, expenditure or independent expenditure on ORESTAR.**

Permits covered organization to exclude from donor list donations from specified charitable organizations and donations and grants received from foundations and other donors that may not be used for political communications.

Regulates covered organization acceptance and use of anonymous donations.

Establishes civil penalty for failure to comply with covered organization disclosure requirements.

Reduces amount of independent expenditure requiring disclosure in ORESTAR from \$750 to \$250.

[Expands electioneering communication period from 30 days before primary election and 60 days before general election to 60 days before primary election, 120 days before general election and 90 days before any other election.]

[Establishes procedures for certain election-related investigations.]

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to campaign finance; creating new provisions; amending ORS 260.005, 260.044, 260.055 and

3 260.402; and declaring an emergency.

4 Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> Sections 2 to 4 of this 2019 Act are added to and made a part of ORS chapter 6 260.

7 SECTION 2. As used in sections 2 to 4 of this 2019 Act:

8 (1) "Anonymous donation" means a donation for which the covered organization does not 9 possess the donor name or address that is required under section 3 of this 2019 Act.

10 (2) "Communication in support of or in opposition to a clearly identified candidate or 11 measure" has the meaning given that phrase in ORS 260.005 (10)(c).

12 (3) "Covered organization" means a combination of two or more individuals, or a person 13 other than an individual, political committee, petition committee or a not-for-profit corpo-

14 ration that is tax exempt under section 501(c)(3) of the Internal Revenue Code, that both 15 accepts donations and makes political communications.

16 (4)(a) "Donation" means the gift or transfer of moneys or any other item of value to a

covered organization, including any membership fees, dues or assessments. 1

2 (b) "Donation" does not include moneys or any other item of value received by a covered organization in the ordinary course of a trade or business conducted by the covered organ-3 ization. 4

 $\mathbf{5}$ (5) "Donor" means a person that makes a donation to a covered organization.

(6) "Election cycle" means the period of time starting on the day after the date of a 6 general election and ending on the date of the next general election. 7

(7) "Electioneering threshold for a legislative race" means political communications made 8 9 by a covered organization of less than \$25,000 for a particular seat of the Legislative As-10 sembly.

(8)(a) Except as provided in paragraphs (b) and (c) of this subsection, "electioneering 11 12 threshold for a measure" means political communications made by a covered organization of less than \$100,000 for a particular measure. 13

(b) For a city measure in a city with a population of less than 60,000, "electioneering 14 15 threshold for a measure" means political communications made by a covered organization of less than \$25,000 for a particular city measure. 16

(c) For a county measure in a county with a population of less than 60,000, 1718 "electioneering threshold for a measure" means political communications made by a covered organization of less than \$25,000 for a particular county measure. 19

(9) "Electioneering threshold for a political committee" means political communications 20made by a covered organization of less than \$100,000 for a particular political committee. 21

22(10) "Electioneering threshold for a statewide race" means political communications made by a covered organization of less than \$100,000 for a particular state office as defined 23in ORS 249.215. 24

(11)(a) "Political communication" means a communication in support of or in opposition 25to a clearly identified candidate or measure. 26

27

(b) "Political communication" does not include:

(A) A communication that is reported as a contribution, expenditure or independent ex-28penditure on a statement filed with the Secretary of State by using the electronic filing 2930 system adopted under ORS 260.057;

(B) A communication that constitutes lobbying as defined in ORS 171.725; or

(C) A communication excluded from the definition of "expenditure" under ORS 260.007.

SECTION 3. (1)(a) Except as provided in subsection (5) of this section, a covered organ-33 34 ization that during an election cycle exceeds the electioneering threshold for a legislative 35race, the electioneering threshold for a measure, the electioneering threshold for a political committee or the electioneering threshold for a statewide race shall file with the Secretary 36 37 of State an initial donor identification list containing the name, address and aggregate 38 amount donated of each donor that donated an aggregate amount of \$10,000 or more to the covered organization during that election cycle. 39

(b) A covered organization that is required to file an initial donor identification list under 40 this subsection shall file the list no later than seven calendar days after the covered organ-41 ization makes a political communication that requires the covered organization to make a 42 filing under paragraph (a) of this subsection. 43

(2)(a) A covered organization that filed an initial donor identification list under sub-44 section (1) of this section shall, during that election cycle, update the list by filing with the 45

Secretary of State: 1

2 (A) The name, address and aggregate amount donated of each subsequent donor that makes a donation or aggregate donations of \$10,000 or more to the covered organization 3 4 during that election cycle; and

(B) An updated amount of the aggregate donations the covered organization has received 5 during the election cycle from each donor that was previously listed on an initial donor 6 identification list or updated donor identification list filed under this section. 7

(b) An updated donor identification list filed under this subsection must be filed according 8 9 to the time frame for filing a statement of independent communications under ORS 260.044, except that the time frame for filing starts on the day that: 10

(A) The dollar amount received by the covered organization from a single donor not 11 12previously on the list, whether by single donation or aggregate donations, equals \$10,000 or 13 more; or

(B) The covered organization receives an additional donation from a donor that was 14 15 previously listed on an initial donor identification list or updated donor identification list filed under this section. 16

(3) Each initial donor identification list and updated donor identification list filed under 17this section must be signed and certified as true by an authorized representative of the 18 covered organization. Signatures must be supplied in the manner specified by the Secretary 19 20of State by rule.

(4) The Secretary of State shall, upon request, deliver to any person the initial donor 2122identification lists and updated donor identification lists filed under this section. If the Secretary of State receives a request under this subsection, the Secretary of State shall deliver 23the lists not later than five days after receiving the request. 24

(5) In identifying donors who have made aggregate donations of \$10,000 or more in the 25manner described in subsections (1) and (2) of this section, a covered organization may ex-2627clude:

(a) Donations received from an affiliated charitable organization that is tax exempt under 28section 501(c)(3) of the Internal Revenue Code; and 29

30 (b) Donations and grants received from foundations and other donors that may not be 31 used for political communications.

(6) A covered organization must consider an anonymous donation of \$1,000 or more from 32a single donor to be a donation that may not be used for political communications. 33

34

(7) The Secretary of State may enact rules necessary to implement this section.

35SECTION 4. (1) The Secretary of State may impose a civil penalty as provided in this 36 section, in addition to any other penalty that may be imposed, for failing to:

37 (a) Timely file an initial donor identification list required to be filed under section 3 of 38 this 2019 Act;

(b) Timely file an updated donor identification list required to be filed under section 3 of 39 this 2019 Act; or 40

(c) Include all donors or amounts donated that are required to be included in an initial 41 donor identification list or an updated donor identification list that is required to be filed 42 under section 3 of this 2019 Act. 43

(2)(a) For each failure to timely file an initial donor identification list that is required to 44 be filed under section 3 of this 2019 Act for exceeding the electioneering threshold for a leg-45

1 islative race, the Secretary of State may impose a civil penalty not to exceed the lesser of:

2 (A) 10 percent per day of the total cost for political communications made by the covered 3 organization for the applicable legislative race; or

4 (B) 150 percent of the total cost for political communications made by the covered or-5 ganization for the applicable legislative race.

6 (b) For each failure to timely file an initial donor identification list that is required to 7 be filed under section 3 of this 2019 Act for exceeding the electioneering threshold for a 8 measure, the Secretary of State may impose a civil penalty not to exceed the lesser of:

9 (A) 10 percent per day of the total cost for political communications made by the covered
 10 organization for the applicable measure; or

(B) 150 percent of the total cost for political communications made by the covered or ganization for the applicable measure.

(c) For each failure to timely file an initial donor identification list that is required to
 be filed under section 3 of this 2019 Act for exceeding the electioneering threshold for a pol itical committee, the Secretary of State may impose a civil penalty not to exceed the lesser
 of:

(A) 10 percent per day of the total cost for political communications made by the covered
 organization for the applicable political committee; or

(B) 150 percent of the total cost for political communications made by the covered or ganization for the applicable political committee.

(d) For each failure to timely file an initial donor identification list that is required to
be filed under section 3 of this 2019 Act for exceeding the electioneering threshold for a
statewide race, the Secretary of State may impose a civil penalty not to exceed the lesser
of:

(A) 10 percent per day of the total cost for political communications made by the covered
 organization for the applicable statewide race; or

(B) 150 percent of the total cost for political communications made by the covered or ganization for the applicable statewide race.

(3) For each failure to accurately include the name of a donor or the amount a donor donated to the covered organization in an initial donor identification list or an updated donor identification list that is required to be filed under section 3 of this 2019 Act, or for each failure to timely file an updated donor identification list that is required to be filed under section 3 of this 2019 Act, the Secretary of State may impose a civil penalty not to exceed 10 percent of the aggregate donations that were not properly identified.

(4) Except as otherwise provided by this section, civil penalties under this section shall
 be imposed as provided in ORS 183.745. In addition to the requirements for a notice of right
 to a hearing of ORS 183.745, the notice shall include:

(a) A statement of the authority and jurisdiction under which the hearing is to be held;
 and

(b) If the person is an agency, corporation or an unincorporated association, a statement
 that such person must be represented by an attorney licensed in Oregon.

42 (5) A hearing on whether to impose a civil penalty and to consider circumstances in
43 mitigation shall be held by the Secretary of State:

(a) Upon request of the person against whom the penalty may be assessed, if the request
 is made not later than the 20th day after the date the person received notice sent under

10 (2) "Committee director" means any person who directly and substantially participates in 11 decision-making on behalf of a political committee concerning the solicitation or expenditure of 12 funds and the support of or opposition to candidates or measures. The officers of a political party 13 shall be considered the directors of any political party committee of that party, unless otherwise 14 provided in the party's bylaws.

has been filed but that is not yet a measure.

(12) "Judge" means judge of the Supreme Court, Court of Appeals, circuit court or the Oregon
 Tax Court.

(13) "Mass mailing" means more than 200 substantially similar pieces of mail, but does not include a form letter or other mail that is sent in response to an unsolicited request, letter or other inquiry.

(14) "Measure" includes any of the following submitted to the people for their approval or re jection at an election:

29 (a) A proposed law.

30 (b) An Act or part of an Act of the Legislative Assembly.

31 (c) A revision of or amendment to the Oregon Constitution.

32 (d) Local, special or municipal legislation.

33 (e) A proposition or question.

34 (15) "Occupation" means:

35 (a) The nature of an individual's principal business; and

(16) "Person" means an individual, corporation, limited liability company, labor organization,
 association, firm, partnership, joint stock company, club, organization or other combination of indi viduals having collective capacity.

(17) "Petition committee" means an initiative, referendum or recall petition committee organized
 under ORS 260.118.

(18) "Political committee" means a combination of two or more individuals, or a person otherthan an individual, that has:

45 (a) Received a contribution for the purpose of supporting or opposing a candidate, measure or

1 political party; or

2 (b) Made an expenditure for the purpose of supporting or opposing a candidate, measure or 3 political party. For purposes of this paragraph, an expenditure does not include:

4 (A) A contribution to a candidate or political committee that is required to report the contri-5 bution on a statement filed under ORS 260.057 or 260.076 or a certificate filed under ORS 260.112; 6 or

(B) An independent expenditure for which a statement is required to be filed by a person under
 ORS 260.044.

9 (19) "Public office" means any national, state, county, district, city office or position, except a 10 political party office, that is filled by the electors.

(20) "Recall petition" means a petition to recall a public officer for which a prospective petition
 has been filed but that is not yet a measure.

(21) "Referendum petition" means a petition to refer a measure for which a prospective petition
has been filed but that is not yet a measure.

15 (22) "Regular district election" means the regular district election described in ORS 255.335.

(23) "State office" means the office of Governor, Secretary of State, State Treasurer, Attorney
 General, Commissioner of the Bureau of Labor and Industries, state Senator, state Representative,
 judge or district attorney.

19 <u>SECTION 7.</u> ORS 260.044, as amended by section 2, chapter 70, Oregon Laws 2018, is amended

(1) If a person makes independent expenditures in a total amount of more than [\$750] 22 **\$250** in a calendar year, the person shall use the electronic filing system adopted under ORS 260.057 23 to file with the Secretary of State a statement of independent expenditures not later than seven 24 calendar days after the total amount of independent expenditures exceeds [\$750] **\$250** in a calendar 25 year.

(2) A person who files a statement of independent expenditures under subsection (1) of this

(c) A person is not a political committee under subsection (6) of this section if all contributions

(1)(a) Each candidate, [other than a candidate for political party office,] the treasurer of 2122each political committee, [and] the treasurer of each petition committee and each person that 23makes independent expenditures in a total amount of more than \$250 in a calendar year shall keep detailed accounts. The accounts shall be current as of not later than the seventh business day 24 after the date of receiving a contribution or making an expenditure or independent expenditure 25with respect to all contributions received and all expenditures or independent expenditures made 2627by or on behalf of the candidate or committee that are required to be reported under ORS 260.044, 260.057, 260.076 or 260.078. Subject to ORS 260.085, the accounts shall list all information required 28 to be reported under ORS 260.083. 29

(b) This subsection does not apply to candidates for political party office.

31 (2) Accounts kept by a candidate [or the], a treasurer of a political committee, a treasurer of a petition committee or a person that makes independent expenditures in a total amount of 32more than \$250 in a calendar year may be inspected under reasonable circumstances at any time 33 34 before the election to which the accounts refer or during the period specified for retention of the 35accounts under subsection (3) of this section by any opposing candidate or the treasurer of any political committee for the same electoral contest. The right of inspection may be enforced by writ 36 37 of mandamus issued by any court of competent jurisdiction. The treasurers of political committees 38 supporting a candidate may be joined with the candidate as defendants in a mandamus proceeding.

(3) Accounts kept by a candidate [or treasurer], a treasurer of a political committee, a
treasurer of a petition committee or a person that makes independent expenditures in a total
amount of more than \$250 in a calendar year shall be preserved by the candidate, [or] treasurer
or person for at least two years after the date the statement of the contribution or expenditure is
filed under ORS 260.057 or the independent expenditure is made.

44 <u>SECTION 9.</u> It is the intent of the Legislative Assembly that all parts of this 2019 Act 45 are independent and that if any part of this 2019 Act is held unconstitutional, all remaining 1 parts shall remain in force.

2 <u>SECTION 10.</u> Sections 2 to 4 of this 2019 Act and the amendments to ORS 260.005, 260.044, 3 260.055 and 260.402 by sections 5 to 8 of this 2019 Act apply to:

4 (1) All independent expenditures and donations made on or after the effective date of this
 5 2019 Act; and

6 (2) All donations made or transferred, and investigations of donations conducted, on or 7 after the effective date of this 2019 Act.

8 <u>SECTION 11.</u> This 2019 Act being necessary for the immediate preservation of the public 9 peace, health and safety, an emergency is declared to exist, and this 2019 Act takes effect 10 on its passage.
