SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies laws related to ignition interlock devices.
Declares emergency, effective July 1, 2019.

A BILL FOR AN ACT

2 Relating to ignition interlock devices; creating new provisions; amending ORS 813.599, 813.602,
3 813.603, 813.630, 813.635, 813.645, 813.660, 813.665, 813.670 and 813.680; and declaring an emer-
4 gency.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 813.660 is amended to read:

7 813.660. (1) A [*person*] **service center or manufacturer's representative** may not [*establish*]
8 **operate** a service center [*without first obtaining*] **in Oregon unless both the service center and**
9 **the manufacturer's representative obtain** a certificate from the Department of Transportation.

10 (2) A [*person*] **service center and a manufacturer's representative** may apply to the depart-
11 ment for a [*service center*] certificate under this section. The application shall be in such form as
12 may be specified by the department.

13 (3) The department may issue a certificate **to a manufacturer's representative** if the
14 [*person*] **applicant:**

15 (a) Meets all of the requirements established by this section and the rules adopted by the de-
16 partment;

17 (b) Agrees to provide testimony relating to any aspect of the installation, service, [*repair,*]
18 monitoring, maintenance, calibration, use, removal or performance of the ignition interlock device
19 at any criminal proceeding or administrative hearing;

20 [*(c) Utilizes ignition interlock device technicians who meet the minimum standards for qualification*
21 *as a technician established by the department by rule and who undergo a criminal background check*
22 *under ORS 813.665;*]

23 [*(d)*] (c) Provides service centers statewide, as defined by the department by rule;

24 [*(e)*] (d) Provides 24-hour telephone assistance to customers; and

25 [*(f)*] (e) Pays all required fees.

26 (4) **The department may issue a certificate to a service center if the applicant:**

27 (a) **Meets all of the requirements established by this section and the rules adopted by the**
28 **department;**

1 **(b) Utilizes ignition interlock device technicians who meet the minimum standards for**
2 **qualification as a technician established by the department by rule and who undergo a**
3 **criminal background check under ORS 813.665; and**

4 **(c) Pays all required fees.**

5 [(4)] **(5)** The department may adopt rules establishing additional requirements for issuance and
6 renewal of certificates under this section.

7 [(5)] **(6)** The department may refuse to issue or renew or may suspend or revoke any certificate
8 issued under this section in any case where the department finds that the applicant or certificate
9 holder has violated or failed to comply with any rules adopted under this section.

10 [(6) *The department by rule shall establish fees for applications for and issuance and renewal of*
11 *certificates under this section.*]

12 **(7) A service center or manufacturer's representative shall pay fees to the department**
13 **in accordance with a fee schedule established by the department by rule.**

14 **(8)** The fees **charged under this section** shall be in an amount adequate to pay all adminis-
15 trative costs incurred by the department in administering ORS [813.599 and] 813.660 to 813.680.
16 [*The fees shall be designed to cover the costs to the department for issuing or renewing certificates*
17 *under this section.*]

18 [(7)] **(9)** Certificates issued under this section are subject to the following:

19 (a) A certificate shall expire [two years] **one year** from the date of issuance unless renewed
20 according to the rules of the department.

21 (b) The department may not issue or renew a certificate to a service center [until the fee for
22 issuance or renewal of the certificate under this section is paid] **or manufacturer's representative**
23 **unless the service center or manufacturer's representative has paid all required fees under**
24 **this section.**

25 (c) A fee for a certificate may not be refunded in the event any certificate is refused, suspended
26 or revoked.

27 [(8)] **(10)** The department may adopt rules for the implementation and administration of ORS
28 [813.599 and] 813.660 to 813.680.

29 **SECTION 2.** ORS 813.660, as amended by section 15, chapter 655, Oregon Laws 2017, is
30 amended to read:

31 813.660. (1) A [person] **service center or manufacturer's representative** may not [establish]
32 **operate** a service center [without first obtaining] **in Oregon unless both the service center and**
33 **the manufacturer's representative obtain** a certificate from the Department of State Police.

34 (2) A [person] **service center and a manufacturer's representative** may apply to the depart-
35 ment for a [service center] certificate under this section. The application shall be in such form as
36 may be specified by the department.

37 (3) The department may issue a certificate **to a manufacturer's representative** if the
38 [person] **applicant:**

39 (a) Meets all of the requirements established by this section and the rules adopted by the de-

42 monitoring, maintenance, calibration, use, removal or performance of the ignition interlock device

44 [(c) *Utilizes ignition interlock device technicians who meet the minimum standards for qualification*
45 *as a technician established by the department by rule and who undergo a criminal background check*

1 *under ORS 813.665;*

2 [(d)] (c) Provides service centers statewide, as defined by the department by rule;

3 [(e)] (d) Provides 24-hour telephone assistance to customers; and

4 [(f)] (e) Pays all required fees.

5 **(4) The department may issue a certificate to a service center if the applicant:**

6 (a) **Meets all of the requirements established by this section and the rules adopted by the**
7 **department;**

8 (b) **Utilizes ignition interlock device technicians who meet the minimum standards for**
9 **qualification as a technician established by the department by rule and who undergo a**
10 **criminal background check under ORS 813.665; and**

11 (c) **Pays all required fees.**

12 [(4)] (5) The department may adopt rules establishing additional requirements for issuance and
13 renewal of certificates under this section.

14 [(5)] (6) The department may refuse to issue or renew or may suspend or revoke any certificate
15 issued under this section in any case where the department finds that the applicant or certificate
16 holder has violated or failed to comply with any rules adopted under this section.

17 [(6) *The department by rule shall establish fees for applications for and issuance and renewal of*
18 *certificates under this section.*]

19 **(7) A service center or manufacturer's representative shall pay fees to the department**
20 **in accordance with a fee schedule established by the department by rule.**

21 (8) The fees **charged under this section** shall be in an amount adequate to pay all adminis-

36 **SECTION 3.** ORS 813.599 is amended to read:

37 813.599. As used in ORS chapter 813:

38 (1) "Ignition interlock device technician" means an individual employed by a service center to
39 install, service, [*repair, monitor,*] maintain, calibrate or remove ignition interlock devices.

40 (2) **"Manufacturer's representative" means a business entity:**

41 (a) **That is registered with or authorized by the Secretary of State to transact business**
42 **in this state;**

43 (b) **That is designated by an ignition interlock device manufacturer to sell, rent or lease**
44 **a specific ignition interlock device model in Oregon; and**

45 (c) **That provides statewide ignition interlock device service through the operation of a**

1 **network of service centers.**

2 [(2)] (3) "Negative report" includes a report of tampering with an ignition interlock device, un-
3 authorized removal of an ignition interlock device, lockout or a test violation recorded by an ig-
4 nition interlock device.

5 [(3)] (4) "Service center" means a private entity that installs, services, [*repairs, monitors,*]
6 maintains, calibrates and removes ignition interlock devices in this state.

7 [(4)] (5) "Test violation" means:

8 (a) For a person who is required to use an ignition interlock device as a condition of a driving
9 while under the influence of intoxicants diversion agreement:

10 (A) An attempt to start a vehicle while the person has a blood alcohol content higher than
11 [0.00] **0.02** percent by weight unless a subsequent test performed within 10 minutes registers a blood
12 alcohol content of [0.00] **0.02** percent by weight **or lower** and a digital image confirms that the same
13 person provided both samples; or

14 (B) Failure to pass a random retest due to a blood alcohol content [*of over 0.00*] **higher than**
15 **0.02** percent by weight unless a subsequent test performed within 10 minutes registers a blood al-
16cohol content of [0.00] **0.02 percent** by weight **or lower** and a digital image confirms that the same
17 person provided both samples;

18 (b) For a person who is required to use an ignition interlock device and is not subject to a
19 driving while under the influence of intoxicants diversion agreement:

20 (A) An attempt to start a vehicle while the person has a blood alcohol level [*of 0.04*] **higher**
21 **than 0.02** percent by weight [*or higher*] unless a subsequent test performed within 10 minutes reg-
22isters a blood alcohol content [*lower than 0.04*] **of 0.02** percent by weight **or lower** and a digital
23 image confirms that the same person provided both samples; or

24 (B) Failure to pass a random retest due to a blood alcohol content [*of*] **higher than** 0.02 percent
25 by weight [*or higher*] unless a subsequent test performed within 10 minutes registers a blood alcohol
26 content [*lower than*] **of** 0.02 percent by weight **or lower** and a digital image confirms that the same
27 person provided both samples; or

28 (c) For any person required to use an ignition interlock device, a failure to take a random retest.

29 **SECTION 4.** ORS 813.602 is amended to read:

30 813.602. (1) Subject to subsection (2) of this section, when a person is convicted of driving while
31 under the influence of intoxicants in violation of ORS 813.010 or of a municipal ordinance, the De-
32partment of Transportation, in addition to any other requirement, shall require that the person have
33 installed and be using an approved ignition interlock device in any vehicle operated by the person:

34 (a) Before the person is eligible for a hardship permit. The requirement is a condition of the
35 hardship permit for the duration of the hardship permit.

36 (b) For a first conviction, for one year after the ending date of the suspension or revocation
37 caused by the conviction. Violation of the condition imposed under this paragraph is a Class A
38 traffic violation.

39 (c) For a second or subsequent conviction, for two years after the ending date of the suspension
40 or revocation caused by the conviction. Violation of the condition imposed under this paragraph is
41 a Class A traffic violation.

42 (2) When a person is convicted of a crime or multiple crimes as described in this subsection, the
43 department, in addition to any other requirement, shall require that the person have installed and
44 be using an approved ignition interlock device in any vehicle operated by the person for five years
45 after the ending date of the longest running suspension or revocation caused by any of the con-

1 victions. Violation of the condition imposed under this subsection is a Class A traffic violation. A
2 person is subject to this subsection when the person is convicted of:

3 (a) Driving while under the influence of intoxicants in violation of ORS 813.010 or of a municipal
4 ordinance and any of the following crimes as part of the same criminal episode:

- 5 (A) Any degree of murder.
- 6 (B) Manslaughter in the first or second degree.
- 7 (C) Criminally negligent homicide.
- 8 (D) Assault in the first degree.

9 (b) Aggravated vehicular homicide.
10 (c) Driving while under the influence of intoxicants in violation of ORS 813.010 or of a municipal
11 ordinance and the person's driving privileges are revoked under ORS 809.235 (1)(b) and later ordered
12 restored under ORS 809.235 (4).

13 (3)(a) Except as provided in paragraph (c) of this subsection, as a condition of a driving while
14 under the influence of intoxicants diversion agreement:

15 (A) The court shall require that an approved ignition interlock device be installed and used in
16 any vehicle operated by the person during the period of the agreement when the person has driving
17 privileges if:

18 (i) The person submitted to a chemical test of the person's breath or blood as required under
19 ORS 813.100, **813.140 or 813.150** and the test disclosed a blood alcohol content of 0.08 percent or
20 more by weight;

21 (ii) The person refused to submit to a chemical test of the person's breath or blood; or

22 (iii) The person submitted to a chemical test of the person's breath, blood or urine as required
23 under ORS 813.100 or 813.131 and the test disclosed a blood alcohol content of more than 0.00 per-
24 cent by weight but less than 0.08 percent by weight and disclosed the presence of cannabis, a con-
25 trolled substance or an inhalant.

26 (B) The court may require that an approved ignition interlock device be installed and used in
27 any vehicle operated by the person during the period of the agreement when the person has driving
28 privileges if the person submitted to a chemical test of the person's breath, blood or urine as re-
29 quired under ORS 813.100 or 813.131 and the test disclosed a blood alcohol content below 0.08 per-
30 cent by weight.

31 (b) In addition to any action taken under ORS 813.255, violation of the condition imposed under
32 this subsection is a Class A traffic violation.

33 (c) A court may exempt a person from the condition in a diversion agreement to have installed
34 and be using an ignition interlock device if the court determines that the person meets the re-
35 quirements for a medical exemption in accordance with rules adopted by the department under this
36 section. A person granted a medical exemption under this paragraph shall carry proof of the medical
37 exemption with the person while operating any vehicle.

38 (4) The department shall adopt rules permitting medical exemptions from the requirements of
39 installation and use of an ignition interlock device under this section.

40 (5) When a person is required to install an ignition interlock device under subsection (2) of this
41 section, the *[service center]* **manufacturer's representative** providing the device shall provide no-
42 tice of any installation or removal of the device or any tampering with the device to:

43 (a) The supervising court or to the court's designee, including but not limited to an agency or
44 organization certified by the Oregon Health Authority under ORS 813.025; *[and]*

45 (b) The district attorney or the city prosecutor; **and**

1 **(c) The Oregon State Police.**

2 **SECTION 5.** ORS 813.665 is amended to read:

3 813.665. *[(1) A service center shall conduct a criminal background check before hiring or con-*
4 *tracting with an individual as an ignition interlock device technician to determine whether the indi-*
5 *vidual has been convicted of the following:]*

6 *[(a) Driving while under the influence of intoxicants in violation of ORS 813.010 or the statutory*
7 *counterpart in another jurisdiction; or]*

8 *[(b) A criminal offense involving fraud, forgery or theft in any jurisdiction.]*

9 **(1) A criminal background check is required to determine the eligibility of a person**
10 **seeking employment as an ignition interlock device technician in this state. A service center**
11 **shall conduct a fingerprint-based criminal background check before hiring or contracting**
12 **with an individual as an ignition interlock device technician. The service center shall request**
13 **that the Department of State Police conduct the fingerprint-based criminal background**
14 **check by reviewing state and federal databases including, but not limited to, the:**

15 **(a) Oregon computerized criminal history system;**

16 **(b) Law Enforcement Data System;**

17 **(c) Databases maintained by the Federal Bureau of Investigation; and**

18 **(d) National Crime Information Center.**

19 **(2) The purpose of a criminal background check is to preserve safety and prevent crimi-**
20 **nal acts by determining whether an individual is eligible to be employed as an ignition**
21 **interlock device technician. A person is ineligible if the person has been convicted of:**

22 **(a) Except as provided in paragraph (b) of this subsection, a misdemeanor in any juris-**
23 **isdiction within two years of the date of the criminal background check;**

31 **check.**

33 **obtaining a criminal background check by the Department of State Police or, if the Department**
34 **of State Police is unable to conduct the check, by the service center requesting the criminal**
35 **background check.**

36 ~~[(3)]~~ **(5) If the criminal background check conducted by the Department of State Police or a**
37 **service center reveals that the individual who is the subject of the criminal background check has**

41 amended to read:

42 813.665. *[(1) A service center shall conduct a criminal background check before hiring or con-*
43 *tracting with an individual as an ignition interlock device technician to determine whether the indi-*
44 *vidual has been convicted of the following:]*

45 *[(a) Driving while under the influence of intoxicants in violation of ORS 813.010 or the statutory*

1 counterpart in another jurisdiction; or]

2 [(b) A criminal offense involving fraud, forgery or theft in any jurisdiction.]

3 (1) A criminal background check is required to determine the eligibility of a person
4 seeking employment as an ignition interlock device technician in this state. A service center
5 shall conduct a fingerprint-based criminal background check before hiring or contracting
6 with an individual as an ignition interlock device technician. The service center shall request

28 conduct the check, by the service center requesting the criminal background check.

29 [(3)] (5) If the criminal background check conducted by the department or a service center
30 reveals that the individual who is the subject of the criminal background check has been convicted
31 of any of the crimes described in subsection [(1)] (2) of this section, the service center may not
32 employ the individual as an ignition interlock device technician.

33 **SECTION 7.** ORS 813.645 is amended to read:

34 813.645. (1) A defendant may apply by motion to the court in which a driving while under the
35 influence of intoxicants diversion agreement described in ORS 813.230 was entered for an order va-
36 cating the requirement to install and use an ignition interlock device if the defendant:

37 (a) Has complied with the condition of the diversion agreement described in ORS 813.602 (3) for
38 at least six consecutive months and provides a certificate to the court from the ignition interlock
39 device [service center] **manufacturer's representative** stating that the device has not recorded a
40 negative report; and

41 (b) The defendant has entered into and is in compliance with any treatment program that the
42 person is required to participate in as a condition of diversion.

43 (2) The defendant shall cause to be served on the district attorney or city prosecutor a copy of
44 the motion for an order vacating the requirement to install and use an ignition interlock device
45 under ORS 813.602 (3). The copy of the motion shall be served on the district attorney or city

1 prosecutor at the time the motion is filed with the court. The district attorney or city prosecutor
2 may contest the motion.

3 (3) The court shall hold a hearing on a petition filed in accordance with subsection (1) of this
4 section. In determining whether to grant the petition, the court shall consider:

5 (a) The nature of the underlying crime for which driving privileges were suspended.

6 (b) The blood alcohol content of the defendant at the time of the arrest.

7 (c) Any other relevant factors.

8 (4) The court may vacate a defendant's requirement to install and use an ignition interlock de-
9 vice under ORS 813.602 (3) if, after a hearing described in subsection (3) of this section, the court
10 finds by a preponderance of the evidence that the petitioner:

11 (a) Has complied with the condition of the diversion agreement described in ORS 813.602 (3) for
12 at least six consecutive months with no negative reports; and

13 (b) Has entered into and is in compliance with any treatment program required as a condition
14 of diversion.

15 (5) When a court vacates a defendant's requirement to install and use an ignition interlock de-
16 vice under ORS 813.602 (3), the court shall notify the Department of Transportation.

17 **SECTION 8.** ORS 813.603 is amended to read:

18 813.603. (1) Except as provided in subsection (2) of this section, if an ignition interlock device
19 is ordered or required under ORS 813.602, the person so ordered or required shall pay to the [*service*
20 *center*] **manufacturer's representative** the reasonable costs of leasing, installing and maintaining
21 the device. A payment schedule may be established for the person by the Department of Transpor-
22 tation.

23 (2) The department may waive, in whole or in part, or defer the person's responsibility to pay
24 all or part of the costs under subsection (1) of this section if the person meets the criteria for
25 indigence established for waiving or deferring such costs under subsection (3) of this section. If the
26 person's responsibility for costs is waived, then notwithstanding ORS 813.270, the costs described in
27 subsection (1) of this section must be paid from the Intoxicated Driver Program Fund.

28 (3) The department, by rule, shall establish criteria and procedures for qualification to waive
29 or defer costs described under subsection (1) of this section for indigence. The criteria must be
30 consistent with the standards for indigence adopted by the federal government for purposes of the
31 Supplemental Nutrition Assistance Program.

32 **SECTION 9.** ORS 813.603, as amended by section 20, chapter 655, Oregon Laws 2017, is
33 amended to read:

34 813.603. (1) Except as provided in subsection (2) of this section, if an ignition interlock device
35 is ordered or required under ORS 813.602, the person so ordered or required shall pay to the [*service*
36 *center*] **manufacturer's representative** the reasonable costs of leasing, installing and maintaining
37 the device. A payment schedule may be established for the person by the Department of State Police,
38 in consultation with the Transportation Safety Committee.

39 (2) The department may waive, in whole or in part, or defer the person's responsibility to pay
40 all or part of the costs under subsection (1) of this section if the person meets the criteria for
41 indigence established for waiving or deferring such costs under subsection (3) of this section. If the
42 person's responsibility for costs is waived, then notwithstanding ORS 813.270, the costs described in
43 subsection (1) of this section must be paid from the Intoxicated Driver Program Fund.

44 (3) The department, by rule, shall establish criteria and procedures for qualification to waive
45 or defer costs described under subsection (1) of this section for indigence. The criteria must be

1 consistent with the standards for indigence adopted by the federal government for purposes of the
2 Supplemental Nutrition Assistance Program.

3 **SECTION 10.** ORS 813.630 is amended to read:

4 813.630. (1) This section applies only to a person who has had an ignition interlock device in-
5 stalled as a condition of a driving while under the influence of intoxicants diversion agreement un-
6 der ORS 813.602 (3).

7 (2) After an ignition interlock device is installed, the [*service center*] **manufacturer's repre-**
8 **sentative** that installed the device shall notify:

9 (a) The court that required the device to be installed or the court's designee, including but not
10 limited to an agency or organization certified by the Oregon Health Authority under ORS 813.025;
11 and

12 (b) The district attorney or city prosecutor.

13 (3) Notice of the installation must be given within seven business days of installing the ignition
14 interlock device.

15 (4) Each time a [*service center*] **manufacturer's representative** has access to an ignition
16 interlock device that the [*service center*] **manufacturer's representative** installed, the [*service*
17 *center*] **manufacturer's representative** shall download all reports recorded on the device. If the
18 [*service center*] **manufacturer's representative** downloads a negative report, the [*service center*]
19 **manufacturer's representative** shall submit the negative report, in a form prescribed by rule by
20 the department, to:

21 (a) The court that required the device to be installed or the court's designee, including but not
22 limited to an agency or organization certified by the Oregon Health Authority under ORS 813.025;

23 (b) The district attorney or city prosecutor; and

24 (c) The Department of State Police.

25 (5) The [*service center*] **manufacturer's representative** shall submit a negative report as pro-
26 vided in subsection (4) of this section within seven business days of downloading the report.

27 **SECTION 11.** ORS 813.670 is amended to read:

28 813.670. The Department of Transportation shall adopt a procedure for a person to file a com-
29 plaint with the department concerning [*a service center's failure*] **the failure of a service center**
