

HOUSE AMENDMENTS TO HOUSE BILL 3085

1 On page 1 of the printed bill, line 8, delete “Oregon Business Development Department” and
2 insert “State Department of Agriculture”.

3 In line 9, delete “State Department of Agriculture” and insert “Oregon Business Development
4 Department”.

5 In line 22, delete “Oregon Business Development Department” and insert “State Department of
6 Agriculture”.

7 On page 2, line 29, delete “Oregon Business Development Department” and insert “State De-
8 partment of Agriculture”.

9 On page 3, delete lines 35 through 45.

10 On page 4, delete lines 1 through 7 and insert:

11 “**SECTION 4.** ORS 285A.435 is amended to read:

12 “285A.435. (1) There is created the [*Beginning and Expanding*] Farmer Loan Program Fund,
13 separate and distinct from the General Fund. Interest earned by the [*Beginning and Expanding*]
14 Farmer Loan Program Fund shall be credited to the fund.

15 “(2)(a) All moneys credited to the fund **for the purpose of implementing and operating the**
16 **Beginning and Expanding Farmer Loan Program under ORS 285A.420 to 285A.435** are contin-
17 uously appropriated to the Oregon Business Development Department for [*the purpose of imple-*
18 *menting and operating the Beginning and Expanding Farmer Loan Program under ORS 285A.420 to*
19 *285A.435*] **that purpose.**

20 “(b) **All moneys credited to the fund for the purpose of implementing and operating the**
21 **Family Farmer Loan Program created under section 2 of this 2019 Act are continuously ap-**
22 **propriated to the State Department of Agriculture for that purpose.**

23 “[2] (3) The fund shall consist of all moneys credited to the fund, including:

24 “(a) Moneys appropriated to the fund by the Legislative Assembly; [*or*]

25 “(b) **Moneys transferred to the fund by the Oregon Business Development Department and the**
26 **State Department of Agriculture;**

27 “[*b*] (c) Earnings on moneys in the fund;

28 “[*c*] (d) Fees paid to the [*department by beginning*] **departments by farmers and lenders under**
29 **the Beginning and Expanding Farmer Loan Program and the Family Farmer Loan Program;**
30 and

31 “[*d*] (e) Moneys from any other source, including but not limited to grants and gifts.

32 “[3] (4) Moneys in the fund may be invested as provided by ORS 293.701 to 293.857 and the
33 earnings from investments shall be credited to the fund.

34 “[4] (5) [*The department*] **The Oregon Business Development Department and the State**
35 **Department of Agriculture may establish accounts within the fund to carry out the provisions**

1 **of the Beginning and Expanding Farmer Loan Program and the Family Farmer Loan Pro-**
2 **gram, respectively, under ORS 285A.420 to 285A.435.”.**

3 In line 10, delete “Oregon Business Development Department and the”.

4 In line 11, after “culture” insert “and the Oregon Business Development Department”.
