

## HOUSE AMENDMENTS TO HOUSE BILL 3180

By COMMITTEE ON HUMAN SERVICES AND HOUSING

April 1

1 In line 2 of the printed bill, after the semicolon insert “creating new provisions; amending ORS  
2 147.391, 418.746, 418.786, 418.788 and 418.796;”.

3 After line 3, insert:

4 **“SECTION 1. Section 2 of this 2019 Act is added to and made a part of ORS 418.746 to**  
5 **418.796.**

6 **“SECTION 2. The Child Abuse Assessment Account is established in the State Treasury,**  
7 **separate and distinct from the General Fund. Interest earned by the account shall be cred-**  
8 **ited to the account. The account consists of moneys deposited into the account under ORS**  
9 **418.796 and may include moneys appropriated, allocated, deposited or transferred to the ac-**  
10 **count by the Legislative Assembly or otherwise. The moneys in the account are continuously**  
11 **appropriated to the Department of Justice for the purposes specified in ORS 418.786.**

12 **“SECTION 3.** ORS 418.746 is amended to read:

13 **“418.746. (1) The Child Abuse Multidisciplinary Intervention Account is established separate and**  
14 **distinct from the General Fund. Interest earned, if any, shall inure to the benefit of the account.**  
15 **The account consists of moneys deposited into the account under ORS 418.796 and may in-**  
16 **clude moneys appropriated, allocated, deposited or transferred to the account by the Legis-**  
17 **lative Assembly or otherwise.** All moneys deposited in the account are continuously appropriated  
18 to the Department of Justice for the purposes of ORS 418.751 and this section.

19 **“(2) The Child Abuse Multidisciplinary Intervention Program, with the advice of the Advisory**  
20 **Council on Child Abuse Assessment, created by ORS 418.784, shall allocate moneys from the Child**  
21 **Abuse Multidisciplinary Intervention Account to eligible county multidisciplinary child abuse teams**  
22 **formed under ORS 418.747, or entities designated by the teams, serving the counties from which the**  
23 **moneys were collected. The program may award only one grant per county. The moneys shall be**  
24 **allocated by the same formula as, or a formula similar to, the formula used by the Attorney General**  
25 **for equitable distribution of the fund for victim’s assistance programs under ORS 147.227 (1). Moneys**  
26 **allocated under this subsection may not be used as replacement revenues for currently available**  
27 **funds previously allocated by the county for child abuse intervention.**

28 **“(3) The Child Abuse Multidisciplinary Intervention Program shall determine eligibility of the**  
29 **applicants and:**

30 **“(a) Allocate funds if the applicant is deemed eligible;**

31 **“(b) Conditionally allocate funds, with appropriate conditions, when necessary to establish el-**  
32 **igibility; or**

33 **“(c) Deny funding.**

34 **“(4) In making the eligibility determination, the Child Abuse Multidisciplinary Intervention**  
35 **Program shall consider the following nonexclusive list of factors:**

1 “(a) Whether the services offered by an applicant substantially further the goals and purposes  
2 of ORS 418.747, 418.790 and 418.792;

3 “(b) Whether the county multidisciplinary child abuse team or the entity designated by the team  
4 has properly allocated other available funds;

5 “(c) Any evaluations of previously funded services as required by subsection (7) of this section;

6 “(d) The extent to which the county’s coordinated child abuse multidisciplinary intervention  
7 plan provides for comprehensive services to the victims of child abuse;

8 “(e) Whether the funds are being used as replacement revenues as prohibited by subsection (2)  
9 of this section;

10 “(f) Whether there is a community assessment center or advocacy center in existence or planned  
11 in the county; and

12 “(g) The extent to which funding a community assessment center is given priority in the inter-  
13 vention plan as required under subsection (5) of this section.

14 “(5)(a) At least once a biennium, the county multidisciplinary child abuse team shall submit to  
15 the Child Abuse Multidisciplinary Intervention Program a coordinated child abuse multidisciplinary  
16 intervention plan. The intervention plan must:

17 “(A) Describe all sources of funding, other than moneys that may be allocated from the Child  
18 Abuse Multidisciplinary Intervention Account, including in-kind contributions that are available for  
19 the intervention plan;

20 “(B) Describe the critical needs of victims of child abuse in the county, including but not limited  
21 to assessment, advocacy and treatment, and how the intervention plan addresses those needs in a  
22 comprehensive manner;

23 “(C) Include the county’s written protocol and agreements required by ORS 418.747 (2) and  
24 418.785; and

25 “(D) Describe how the intervention plan gives priority to funding a community assessment cen-  
26 ter and how the funding supports the center.

27 “(b) When submitting the intervention plan, the county multidisciplinary child abuse team shall  
28 also submit:

29 “(A) Those applications for funding received from entities under subsection (6) of this section  
30 that the team determines best meet the needs of the county’s intervention plan and a recommen-  
31 dation that the applications for funding be granted; and

32 “(B) If the team is seeking funding from the Child Abuse Multidisciplinary Intervention Program,  
33 an application setting forth the information required by rule of the program.

34 “(6) An entity wishing to apply for funding from the Child Abuse Multidisciplinary Intervention  
35 Program shall submit an application to the county multidisciplinary child abuse team for the county  
36 in which the entity proposes to provide services. The application shall:

37 “(a) Describe the services to be funded with moneys from the Child Abuse Multidisciplinary  
38 Intervention Program according to the coordinated child abuse multidisciplinary intervention plan  
39 and the anticipated outcomes in terms of benefits to children and families; and

40 “(b) Describe how the services further the goals and purposes of ORS 418.747, 418.790 and  
41 418.792.

42 “(7)(a) A designated entity providing services according to a coordinated child abuse multidis-  
43 ciplinary intervention plan funded with moneys from the Child Abuse Multidisciplinary Intervention  
44 Program shall submit an annual report to the county multidisciplinary child abuse team. A multi-  
45 disciplinary child abuse team shall submit an annual report to the Child Abuse Multidisciplinary

1 Intervention Program.

2 “(b) The annual report filed by the county multidisciplinary child abuse team must:

3 “(A) Document how the moneys were utilized and describe to what extent the services were able  
4 to meet anticipated outcomes in terms of benefits to children and families.

5 “(B) Include local and state issues and recommendations relating to the prevention of child  
6 fatalities identified in the fatality review process under ORS 418.785.

7 “(c) A county multidisciplinary child abuse team receiving a report from a designated entity  
8 shall review the report and take into account success of the entity at meeting service outcomes  
9 before making future recommendations regarding allocation of moneys.

10 “(d) The Child Abuse Multidisciplinary Intervention Program shall review reports received un-  
11 der this section before making future eligibility and allocation decisions and when evaluating ser-  
12 vices funded under this section.

13 “(8) Two or more county multidisciplinary child abuse teams may join together to develop joint  
14 child abuse multidisciplinary intervention plans. The joint intervention plans shall be submitted as  
15 provided in subsection (5) of this section.

16 “(9) The Child Abuse Multidisciplinary Intervention Program may adopt rules to carry out the  
17 provisions of ORS 418.751 and this section including, but not limited to, the following:

18 “(a) Notices and time limits for applications;

19 “(b) Method of review and the role of advisory bodies; and

20 “(c) Reallocation of moneys not applied for or disbursed.

21 “**SECTION 4.** ORS 418.786 is amended to read:

22 “418.786. (1) To accomplish the purpose described in ORS 418.780, with the assistance of the  
23 Advisory Council on Child Abuse Assessment, the administrator of the Child Abuse Multidiscipli-  
24 nary Intervention Program shall develop and administer a grant program, **separate from the grant**  
25 **program described in ORS 418.746**, to establish and maintain regional assessment centers and  
26 community assessment centers under ORS 418.746 to 418.796.

27 “(2) **The Child Abuse Multidisciplinary Intervention Program, with the advice of the Ad-**  
28 **visory Council on Child Abuse Assessment created by ORS 418.784, shall allocate moneys**  
29 **from the Child Abuse Assessment Account established in section 2 of this 2019 Act to eligible**  
30 **community assessment centers under ORS 418.746 to 418.796. The moneys shall be allocated**  
31 **by the same formula as, or a formula similar to, the formula used by the Attorney General**  
32 **for equitable distribution of the account for victims’ assistance programs under ORS 147.227**  
33 **(1). Moneys allocated under this subsection may not be used as replacement revenues for**  
34 **currently available funds previously allocated by the county for child abuse assessments.**

35 “**SECTION 5.** ORS 418.788 is amended to read:

36 “418.788. (1) Subject to the availability of funds under the provisions of ORS **418.786 and**  
37 **418.796**, The administrator of the Child Abuse Multidisciplinary Intervention Program shall make  
38 grants for the establishment and maintenance of regional assessment centers or community assess-  
39 ment centers.

40 “(2) A public or private agency may apply to the administrator for a grant to establish and  
41 maintain a regional assessment center or community assessment center under ORS 418.746 to  
42 418.796. The administrator may consolidate applications from more than one public or private  
43 agency or may return the application with the recommendation that the application be consolidated.

44 “(3) The administrator shall by rule establish criteria for awarding grants to establish and  
45 maintain regional assessment centers or community assessment centers under ORS 418.746 to

1 418.796, including but not limited to:

2 “(a) Expenses eligible for reimbursement from funds under ORS **418.786 and** 418.796;

3 “(b) The extent to which the applicant’s proposed assessment center will best accomplish the  
4 purposes of ORS 418.746 to 418.796;

5 “(c) The extent to which an applicant meets criteria for receiving a grant to establish and  
6 maintain a regional assessment center or community assessment center; and

7 “(d) For a regional assessment center, the extent to which the applicant’s proposed assessment  
8 center meets the documented needs of the communities, community assessment centers and county  
9 multidisciplinary child abuse teams in the region or regions to be served by the center.

10 “(4) The administrator is not required to fund any grant in the total amount requested in the  
11 application.

12 “**SECTION 6.** ORS 418.796 is amended to read:

13 “418.796. The Advisory Council on Child Abuse Assessment may solicit and accept contributions  
14 of funds and assistance from the United States, its agencies or from other sources, public or private,  
15 and agree to conditions not inconsistent with the purposes of ORS 418.746 to 418.796. All funds re-  
16 ceived are to aid in financing the functions of the advisory council and the purposes of ORS 418.746  
17 to 418.796 [*and shall be deposited in the General Fund of the State Treasury to the credit of a separate*  
18 *account and are continuously appropriated to the Child Abuse Multidisciplinary Intervention Program*  
19 *established by ORS 418.783 for the purposes of ORS 418.746 to 418.796*]. **The advisory council may**  
20 **deposit moneys the advisory council collects under this section into the Child Abuse Multi-**  
21 **disciplinary Intervention Account under ORS 418.746 or the Child Abuse Assessment Account**  
22 **under section 2 of this 2019 Act.**

23 “**SECTION 7.** ORS 147.391 is amended to read:

24 “147.391. Notwithstanding ORS 147.390, when the moneys provided from the Criminal Injuries  
25 Compensation Account for the purposes of ORS 147.390 are expended for any cumulative time period  
26 within any biennium, the Criminal Injuries Compensation Account shall have no further obligations  
27 under ORS 147.390 for that time period. However, if [*the Criminal Injuries Compensation Account has*  
28 *unexpended moneys provided for at the end of any biennium, the balance shall be transferred to the*  
29 *account created by*] **at the end of the biennium there are unexpended moneys in the account**  
30 **and those unexpended moneys were allocated to the account for the purposes of ORS 147.390,**  
31 **the balance of those unexpended moneys may be deposited as provided by ORS 418.796.**

32 “**SECTION 8.** In addition to and not in lieu of any other appropriation, there is appro-  
33 priated to the Department of Justice, for the biennium beginning July 1, 2019, out of the  
34 General Fund, the amount of \$6,000,000 for deposit in the Child Abuse Assessment Account  
35 established in section 2 of this 2019 Act.

36 “**SECTION 9.** (1) The Department of Human Services shall distribute to the Center for  
37 the Prevention of Abuse and Neglect \$600,000 between July 1, 2019, and June 30, 2020, and  
38 \$400,000 between July 1, 2020, and June 30, 2021, for the Oregon Child Abuse Prevalence  
39 Study.

40 “(2) The Department of Human Services shall require the Center for the Prevention of  
41 Abuse and Neglect to spend not more than 10 percent of the funds distributed under sub-  
42 section (1) of this section to pay the University of Oregon for facilities and administrative  
43 costs.

44 “**SECTION 10.** There is appropriated to the Department of Human Services, for the  
45 biennium beginning July 1, 2019, out of the General Fund, the amount of \$1,000,000 for dis-

1 **tribution as specified in section 9 of this 2019 Act.”.**

2 In line 4, delete “1” and insert “11”.

3 In line 9, delete “2” and insert “12”.
