

House Bill 3439

Sponsored by Representative EVANS

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Renames Office of Emergency Management as Oregon Department of Emergency Management. Establishes department as state agency independent from Oregon Military Department. Establishes emergency authority regarding public health emergencies, emergency quarantines and conflagrations in department. Transfers rule making authority regarding nuclear emergencies from State Department of Energy to Oregon Department of Emergency Management.

Transfers Oregon Emergency Response System from Department of State Police to Oregon Department of Emergency Management.

Renames office of State Fire Marshal as Department of the State Fire Marshal and establishes department as independent state agency. Transfers search and rescue functions to department.

Transfers Oregon Homeland Security Council from Office of Emergency Management to Office of the Governor. Establishes additional members and duties of council.

Establishes Emergency Preparedness Advisory Council to advise and make policy recommendations to Oregon Homeland Security Council regarding emergency preparedness and resilience.

Establishes Local Government Emergency Management Advisory Council to provide advice and recommendations to Oregon Department of Emergency Management.

Becomes operative on July 1, 2022.

Be It Enacted by the People of the State of Oregon:

RENAMING AND REORGANIZATION OF THE OFFICE OF EMERGENCY MANAGEMENT

SECTION 1. (1) The amendments to ORS 401.052, 401.054, 401.062, 401.072, 401.076, 401.082, 401.088 and 401.092 by sections 2 to 9 of this 2019 Act are intended to change the name of the "Office of Emergency Management" to the "Oregon Department of Emergency Management" and to establish that entity as a state agency independent from the Oregon Military Department.

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 **(2) For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel**
2 **may substitute for words designating the “Office of Emergency Management,” wherever they**
3 **occur in statutory law, other words designating the “Oregon Department of Emergency**
4 **Management.”**

5 **SECTION 2.** ORS 401.052 is amended to read:

6 401.052. (1) The [*Office*] **Oregon Department** of Emergency Management is established [*in the*
7 *Oregon Military Department*].

8 (2) The [*office*] **department** shall be responsible for:

9 (a) Coordinating and facilitating private sector and governmental efforts to prevent, prepare for,
10 respond to and recover from emergencies; and

11 (b) Coordinating exercises and training, planning, preparedness, response, mitigation and recov-
12 ery activities with state and local emergency services agencies and organizations.

13 (3) The [*office*] **department** shall prepare a statewide emergency management plan and update
14 the plan from time to time as necessary.

15 **SECTION 3.** ORS 401.054 is amended to read:

16 401.054. (1) Each of the following agencies, entities and officials shall designate an individual to
17 act as a liaison with the [*Office*] **Oregon Department** of Emergency Management:

18 (a) The Department of Consumer and Business Services;

19 (b) The Department of Corrections;

20 (c) The Department of Education;

21 (d) The Department of Environmental Quality;

22 (e) The Department of Human Services;

23 (f) The Department of Justice;

24 (g) The Department of Land Conservation and Development;

25 (h) The Department of Public Safety Standards and Training;

26 (i) The Department of State Lands;

27 (j) The Department of State Police;

28 (k) The Department of Transportation;

6 (2) Each agency, entity and official required to designate a liaison under this section shall des-
 7 ignate an individual who has authority during an emergency to allocate resources and assets of the
 8 agency, entity or official.

9 (3) Each individual designated as a liaison under subsection (1) of this section shall assist in the
 10 coordination of the functions of the agency, entity or official that designated the individual that
 11 relate to emergency preparedness and response with similar functions of the [Office] **Oregon De-**
 12 **partment** of Emergency Management.

13 **SECTION 4.** ORS 401.062 is amended to read:

14 401.062. (1) The [Office] **Oregon Department** of Emergency Management is under the super-
 15 vision and control of a director, who is responsible for the performance of the duties, functions and
 16 powers of the [office] **department**.

17 (2) The [Adjutant General, with the approval of the Governor,] **Governor** shall appoint the Di-
 18 rector of the [Office] **Oregon Department** of Emergency Management, who holds office at the
 19 pleasure of the [Adjutant General] **Governor**.

20 (3) The director shall be paid a salary as provided by law or, if not so provided, as prescribed
 21 by [the Adjutant General, with the approval of] the Governor.

22 (4) For purposes of administration, subject to the approval of the [Adjutant General] **Governor**,
 23 the director may organize and reorganize the [office] **department** as the director considers neces-
 24 sary to properly conduct the work of the [office] **department**.

25 (5) The director may divide the functions of the [office] **department** into administrative divi-
 26 sions. Subject to the approval of the [Adjutant General] **Governor**, the director may appoint an in-
 27 dividual to administer each division. The administrator of each division serves at the pleasure of the
 28 director and is not subject to the provisions of ORS chapter 240. Each individual appointed under
 29 this subsection must be well qualified by technical training and experience in the functions to be
 30 performed by the individual.

31 **(6) The appointment of the director is subject to confirmation by the Senate in the**
 32 **manner prescribed by ORS 171.562 and 171.565.**

33 **SECTION 5.** ORS 401.072 is amended to read:

34 401.072. (1) The Director of the [Office] **Oregon Department** of Emergency Management may,
 35 by written order filed with the Secretary of State, appoint a deputy director. The deputy director
 36 serves at the pleasure of the director, has authority to act for the director in the absence of the
 37 director and is subject to the control of the director at all times.

38 (2) Subject to any applicable provisions of ORS chapter 240, the director shall appoint all sub-
 39 ordinate officers and employees of the [Office] **Oregon Department** of Emergency Management,
 40 prescribe their duties and fix their compensation.

41 **SECTION 6.** ORS 401.076 is amended to read:

42 401.076. In accordance with applicable provisions of ORS chapter 183, the Director of the
 43 [Office] **Oregon Department** of Emergency Management may adopt rules necessary for the admin-
 44 istration of the laws that the [Office] **Oregon Department** of Emergency Management is charged
 45 with administering.

SECTION 7. ORS 401.092 is amended to read:

401.092. (1) The Director of the [Office] **Oregon Department** of Emergency Management is responsible for coordinating and facilitating exercises and training, emergency planning, preparedness, response, mitigation and recovery activities with the state and local emergency services agencies and organizations, and shall[, *with the approval of the Adjutant General or as directed by the Governor*]:

(a) Make rules that are necessary and proper for the administration and implementation of this chapter;

(b) Coordinate the activities of all public and private organizations specifically related to providing emergency services within this state;

(c) Maintain a cooperative liaison with emergency management agencies and organizations of local governments, other states and the federal government;

(d) Have such additional authority, duties and responsibilities authorized by this chapter or as may be directed by the Governor;

(e) Administer grants relating to emergency program management under ORS 401.305, emergency services for the state and the statewide 2-1-1 system as provided in ORS 403.430;

(f) Provide for and staff a State Emergency Operations Center to aid the Governor and the [Office] **Oregon Department** of Emergency Management in the performance of duties under this chapter;

(g) Serve as the Governor's authorized representative for coordination of certain response activities and managing the recovery process;

(h) Establish training and professional standards for local emergency program management personnel;

(i) Establish task forces and advisory groups to assist the [office] **department** in achieving mandated responsibilities;

(j) Enforce compliance requirements of federal and state agencies for receiving funds and conducting designated emergency functions;

(k) Oversee the design, implementation and support of a statewide 2-1-1 system as provided under ORS 403.415; and

(L) Coordinate the activities of state and local governments to enable state and local governments to work together during domestic incidents as provided in the National Incident Management System established by the Homeland Security Presidential Directive 5 of February 28, 2003.

(2) Notwithstanding subsection (1) of this section, the State Forester shall serve as the Governor's authorized representative for the purpose of initiating the fire management assistance declaration process with the Federal Emergency Management Agency and administering Federal Emergency Management Agency fire management assistance grants.

SECTION 8. ORS 401.082 is amended to read:

401.082. (1) To aid and advise the Director of the [Office] **Oregon Department** of Emergency Management in the performance of the functions of the [Office] **Oregon Department** of Emergency Management, the director may establish such advisory and technical committees as the director considers necessary. The committees may be continuing or temporary. The director shall determine the representation, membership, terms and organization of the committees and shall appoint their members. The director is an ex officio member of each committee.

(2) Members of the committees are not entitled to compensation, but in the discretion of the director may be reimbursed from funds available to the [office] **department** for actual and necessary

1 travel and other expenses incurred by them in the performance of their official duties in the manner
2 and amount provided in ORS 292.495.

3 **SECTION 9.** ORS 401.088 is amended to read:

4 401.088. The Director of the [*Office*] **Oregon Department** of Emergency Management may enter
5 into interagency agreements with other state agencies that the director determines are necessary
6 to carry out the duties of the [*Office*] **Oregon Department** of Emergency Management.

10 **SECTION 10.** (1) **The unexpended balances of amounts authorized to be expended by the**
11 **Oregon Military Department for purposes of the Office of Emergency Management for the**
12 **biennium beginning July 1, 2021, from revenues dedicated, continuously appropriated, appro-**
13 **priated or otherwise made available to the department, are transferred to and are available**
14 **for expenditure by the Oregon Department of Emergency Management for the biennium be-**
15 **ginning July 1, 2021.**

16 (2) **The expenditure classifications, if any, established by Acts authorizing or limiting**
17 **expenditures by the Office of Emergency Management remain applicable to expenditures by**
18 **the Oregon Department of Emergency Management under this section.**

22 **SECTION 11.** **The amendments to ORS 401.052, 401.054, 401.062, 401.072, 401.076, 401.082,**
23 **401.088 and 401.092 by sections 2 to 9 of this 2019 Act do not affect any action, proceeding or**
24 **prosecution involving or with respect to any duties, functions and powers of the Office of**
25 **Emergency Management begun before and pending as of the operative date specified in sec-**
26 **tion 143 of this 2019 Act, except that the Oregon Department of Emergency Management is**
27 **substituted for the Office of Emergency Management in any such action, proceeding or**
28 **prosecution.**

32 **SECTION 12.** (1) **Nothing in the amendments to ORS 401.052, 401.054, 401.062, 401.072,**
33 **401.076, 401.082, 401.088 and 401.092 by sections 2 to 9 of this 2019 Act relieves a person of a**
34 **liability, duty or obligation accruing under or with respect to the duties, functions and pow-**
35 **ers conferred by those statutes prior to the operative date specified in section 143 of this 2019**
36 **Act. The Oregon Department of Emergency Management may undertake the collection or**
37 **enforcement of any such liability, duty or obligation.**

38 (2) **The rights and obligations of the Office of Emergency Management legally incurred**
39 **under contracts, leases and business transactions executed, entered into or begun before the**
40 **operative date specified in section 143 of this 2019 Act are transferred to the Oregon De-**
41 **partment of Emergency Management. For the purpose of succession to these rights and ob-**
42 **ligations, the Oregon Department of Emergency Management is a continuation of the Office**

SECTION 17. ORS 433.441 is amended to read:

433.441. (1) Upon the occurrence of a public health emergency, the Governor may declare a state of public health emergency as authorized by ORS 433.441 to 433.452 to protect the public health.

(2) A *[proclamation]* **declaration** of a state of public health emergency must specify:

(a) The nature of the public health emergency;

(b) The political subdivision or geographic area subject to the *[proclamation]* **declaration**;

(c) The conditions that have brought about the public health emergency; and

(d) The duration of the state of public health emergency, if the duration is less than 14 days.

(3) During a **declared** public health emergency, the Governor **or the Director of the Oregon Department of Emergency Management** may:

(a) Close, order the evacuation of or **order** the decontamination of any facility the Governor **or the director** has reasonable cause to believe may endanger the public health.

(b) Regulate or restrict by any means necessary the use, sale or distribution of food, fuel, medical supplies, medicines or other goods and services.

(c) Prescribe modes of transportation, routes and destinations required for the evacuation of individuals or the provision of emergency services.

(d) Control or limit entry into, exit from, movement within and the occupancy of premises in any public area subject to or threatened by a public health emergency if such actions are reasonable and necessary to respond to the public health emergency.

(e) Authorize pharmacists licensed under ORS chapter 689 to administer vaccines to persons who are three years of age or older.

(f) Take any other action that may be necessary for the management of resources, or to protect the public during a public health emergency, including any actions *[authorized]* **the Governor may take** under ORS 401.168, 401.185, 401.188 and 401.192.

(4) Nothing in ORS 433.441 to 433.452 limits the authority of the Governor to declare a state of emergency under ORS 401.165. If a state of emergency is declared as authorized under ORS 401.165, the Governor may implement any action authorized by ORS 433.441 to 433.452.

(5) A *[proclamation]* **declaration** of a state of public health emergency expires when terminated by a declaration of the Governor or no more than 14 days after the date the public health emergency is *[proclaimed]* **declared** unless the Governor expressly extends the *[proclamation]* **declaration** for an additional 14-day period.

(6) When real or personal property is taken under power granted by this section, the owner of the property shall be entitled to reasonable compensation from the state.

SECTION 18. ORS 433.443 is amended to read:

433.443. (1) As used in this section:

(a) “Covered entity” means:

(A) The Children’s Health Insurance Program;

(B) A health insurer that is an insurer as defined in ORS 731.106 and that issues health insurance as defined in ORS 731.162;

(C) The state medical assistance program; and

(D) A health care provider.

(b) “Health care provider” includes but is not limited to:

(A) A psychologist, occupational therapist, regulated social worker, professional counselor or marriage and family therapist licensed or otherwise authorized to practice under ORS chapter 675

1 or an employee of the psychologist, occupational therapist, regulated social worker, professional
2 counselor or marriage and family therapist;

17 physician;

18 (K) A massage therapist licensed under ORS 687.011 to 687.250 or an employee of the massage
19 therapist;

20 (L) A direct entry midwife licensed under ORS 687.405 to 687.495 or an employee of the direct
21 entry midwife;

22 (M) A physical therapist licensed under ORS 688.010 to 688.201 or an employee of the physical
23 therapist;

24 (N) A medical imaging licensee under ORS 688.405 to 688.605 or an employee of the medical
25 imaging licensee;

26 (O) A respiratory care practitioner licensed under ORS 688.815 or an employee of the respir-
27 atory care practitioner;

28 (P) A polysomnographic technologist licensed under ORS 688.819 or an employee of the poly-
29 somnographic technologist;

30 (Q) A pharmacist licensed under ORS chapter 689 or an employee of the pharmacist;

31 (R) A dietitian licensed under ORS 691.405 to 691.485 or an employee of the dietitian;

32 (S) A funeral service practitioner licensed under ORS chapter 692 or an employee of the funeral
33 service practitioner;

34 (T) A health care facility as defined in ORS 442.015;

35 (U) A home health agency as defined in ORS 443.014;

36 (V) A hospice program as defined in ORS 443.850;

37 (W) A clinical laboratory as defined in ORS 438.010;

38 (X) A pharmacy as defined in ORS 689.005; and

39 (Y) Any other person or entity that furnishes, bills for or is paid for health care in the normal
40 course of business.

41 (c) "Individual" means a natural person.

42 (d) "Individually identifiable health information" means any oral or written health information
43 in any form or medium that is:

44 (A) Created or received by a covered entity, an employer or a health care provider that is not
45 a covered entity; and

1 (B) Identifiable to an individual, including demographic information that identifies the individual,
 2 or for which there is a reasonable basis to believe the information can be used to identify an indi-
 3 vidual, and that relates to:

- 4 (i) The past, present or future physical or mental health or condition of an individual;
- 5 (ii) The provision of health care to an individual; or
- 6 (iii) The past, present or future payment for the provision of health care to an individual.

7 (e) “Legal representative” means attorney at law, person holding a general power of attorney,
 8 guardian, conservator or any person appointed by a court to manage the personal or financial affairs
 9 of a person, or agency legally responsible for the welfare or support of a person.

10 (2)(a) During a public health emergency declared under ORS 433.441, the Public Health
 11 Director, **after consultation with the Director of the Oregon Department of Emergency**
 12 **Management**, may, as necessary to appropriately respond to the public health emergency:

13 (A) Adopt reporting requirements for and provide notice of those requirements to health care
 14 providers, institutions and facilities for the purpose of obtaining information directly related to the
 15 public health emergency;

16 (B) After consultation with appropriate medical experts, create and require the use of diagnostic
 17 and treatment protocols to respond to the public health emergency and provide notice of those
 18 protocols to health care providers, institutions and facilities;

19 (C) Order, or authorize local public health administrators to order, public health measures ap-
 20 propriate to the public health threat presented;

21 (D) Authorize pharmacists licensed under ORS chapter 689 to administer vaccines to persons
 22 who are three years of age or older;

23 (E) Upon approval of the [*Governor*] **Director of the Oregon Department of Emergency**
 24 **Management**, take other actions necessary to address the public health emergency and provide
 25 notice of those actions to health care providers, institutions and facilities, including public health
 26 actions authorized by ORS 431A.015;

27 (F) Take any enforcement action authorized by ORS 431A.010, including the imposition of civil
 28 penalties of up to \$500 per day against individuals, institutions or facilities that knowingly fail to
 29 comply with requirements resulting from actions taken in accordance with the powers granted to
 30 the Public Health Director under subparagraphs (A), (B) and (E) of this paragraph; and

31 (G) The authority granted to the Public Health Director under this section:

32 (i) Supersedes any authority granted to a local public health authority if the local public health
 33 authority acts in a manner inconsistent with guidelines established or rules adopted by the director
 34 under this section; and

35 (ii) Does not supersede the general authority granted to a local public health authority or a
 36 local public health administrator except as authorized by law or necessary to respond to a public
 37 health emergency.

38 (b) The authority of the Public Health Director to take administrative action, and the effec-
 39 tiveness of any action taken, under paragraph (a)(A), (B) and (D) to (G) of this subsection terminates
 40 upon the expiration of the declared state of public health emergency, unless the actions are con-
 41 tinued under other applicable law.

42 (3) Civil penalties under subsection (2) of this section shall be imposed in the manner provided
 43 in ORS 183.745. The Public Health Director must establish that the individual, institution or facility
 44 subject to the civil penalty had actual notice of the action taken that is the basis for the penalty.
 45 The maximum aggregate total for penalties that may be imposed against an individual, institution

1 or facility under subsection (2) of this section is \$500 for each day of violation, regardless of the
 2 number of violations of subsection (2) of this section that occurred on each day of violation.

3 (4)(a) During a declared state of public health emergency, **the Director of the Oregon De-**
 4 **partment of Emergency Management**, the Public Health Director and local public health admin-
 5 istrators shall be given immediate access to individually identifiable health information necessary
 6 to:

- 7 (A) Determine the causes of an illness related to the public health emergency;
- 8 (B) Identify persons at risk;
- 9 (C) Identify patterns of transmission;
- 10 (D) Provide treatment; and
- 11 (E) Take steps to control the disease.

12 (b) Individually identifiable health information accessed as provided by paragraph (a) of this
 13 subsection may not be used for conducting nonemergency epidemiologic research or to identify
 14 persons at risk for post-traumatic mental health problems, or for any other purpose except the pur-
 15 poses listed in paragraph (a) of this subsection.

16 (c) Individually identifiable health information obtained by **the Director of the Oregon De-**
 17 **partment of Emergency Management**, the Public Health Director or local public health adminis-
 18 trators under this subsection may not be disclosed without written authorization of the identified
 19 individual except:

- 20 (A) Directly to the individual who is the subject of the information or to the legal representative
 21 of that individual;
- 22 (B) To state, local or federal agencies authorized to receive such information by state or federal
 23 law;
- 24 (C) To identify or to determine the cause or manner of death of a deceased individual; or
- 25 (D) Directly to a health care provider for the evaluation or treatment of a condition that is the
 26 subject of a declaration of a state of public health emergency issued under ORS 433.441.

27 (d) Upon expiration of the state of public health emergency, **the Director of the Oregon De-**
 28 **partment of Emergency Management**, the Public Health Director or local public health adminis-
 29 trators may not use or disclose any individually identifiable health information that has been
 30 obtained under this section. If a state of emergency that is related to the state of public health
 31 emergency has been declared under ORS 401.165, **the Director of the Oregon Department of**
 32 **Emergency Management**, the Public Health Director and local public health administrators may
 33 continue to use any individually identifiable information obtained as provided under this section
 34 until termination of the state of emergency.

35 (5) All civil penalties recovered under this section shall be paid into the State Treasury and
 36 credited to the General Fund and are available for general governmental expenses.

37 (6) The Public Health Director may request assistance in enforcing orders issued pursuant to
 38 this section from state or local law enforcement authorities. If so requested by the Public Health
 39 Director, state and local law enforcement authorities, to the extent resources are available, shall
 40 assist in enforcing orders issued pursuant to this section.

41 (7) If the Oregon Health Authority adopts temporary rules to implement the provisions of this
 42 section, the rules adopted are not subject to the provisions of ORS 183.335 (6)(a). The authority may

29 measures to public and private entities.

30 (d) Coordinate cybersecurity information sharing and promote shared and real-time situational
31 awareness between the public and private sectors in this state.

32 (e) Encourage the development of the cybersecurity workforce through measures including, but
33 not limited to, competitions aimed at building workforce skills, disseminating best practices, facili-
34 tating cybersecurity research and encouraging industry investment and partnership with post-
35 secondary institutions of education and other career readiness programs.

36 (5) The council may adopt rules necessary for the operation of the council.

37 (6)(a) A majority of the voting members of the council constitutes a quorum for the transaction
38 of business.

39 (b) Official action by the council requires the approval of a majority of the voting members of
40 the council.

41 (7) The State Chief Information Officer shall appoint one member of the council to serve as
42 chairperson and one member of the council to serve as vice chairperson.

43 (8)(a) The term of office of each voting member of the council is four years, but a member serves
44 at the pleasure of the State Chief Information Officer.

45 (b) Before the expiration of the term of a voting member, the State Chief Information Officer,

1 in consultation with the Governor, shall appoint a successor whose term begins on July 1 following

 16 Force are not, by virtue of volunteering in the force, considered:

20 (D) Agents of a public body under ORS 30.260 to 30.300 (Oregon Tort Claims Act) for the pur-

 41 30 days of written notice of the dispute given by the participant asserting noncompliance to the
 42 other participant.

43 (6) If the participants cannot resolve the dispute within 90 days after receipt of the notice of
 44 alleged noncompliance, either participant in the dispute may submit the dispute to arbitration under
 45 the commercial arbitration rules of the American Arbitration Association.

1 (G) One member who is an information technology officer of an Oregon city;

2 (H) One member who is an information technology officer of an Oregon county;

3 (I) One member who represents a nonprofit professional organization interested in the enhance-
4 ment of public safety communications systems; and

5 (J) One member of the public who works or resides in Federal Communications Commission
6 Region 35.

7 (2) Each agency or organization identified in subsection (1)(b)(A) to (I) and (1)(c)(A) to (H) of this
8 section shall recommend an individual from the agency or organization for membership on the
9 council.

10 (3) Members of the council are not entitled to compensation, but in the discretion of the State
11 Chief Information Officer may be reimbursed from funds available to the office of the State Chief
12 Information Officer for actual and necessary travel and other expenses the members incur in per-
13 forming the members' official duties in the manner and amount provided in ORS 292.495.

14 (4) Members of the Legislative Assembly appointed to the council are nonvoting members and
15 may act in an advisory capacity only.

16 **SECTION 75.** ORS 465.505 is amended to read:

17 465.505. (1) In addition to any other applicable federal or state law and regulation, the following
18 waste minimization requirements shall apply to dry cleaning facilities:

19 (a) All wastes meeting the state and federal criteria for hazardous waste, excluding wastewater,

36 condensers, or an equivalent;

31 **SECTION 91.** ORS 476.020 is amended to read:

32 476.020. (1) The [office of] **Department of the** State Fire Marshal is established. [in the De-
 33 partment of State Police. The State Fire Marshal shall be appointed by and be administratively re-
 34 sponsible to the Superintendent of State Police, and shall serve at the pleasure of the superintendent.
 35 The State Fire Marshal shall retain all current authority of the office and shall be responsible for the
 36 implementation of its mission and programs.] **The department is under the supervision of the**
 37 **State Fire Marshal. The Governor shall appoint the State Fire Marshal, who holds the office**

 20 of disclosing the information shall be paid by the agency or university requesting the information.

21 (b) As part of a geographic information system. Points on a map may be used to represent eco-
 22 nomic data, including the location, employment size class and industrial classification of businesses
 23 in Oregon. Information presented as part of a geographic information system may not give specific
 24 details regarding a business's address, actual employment or proprietary information. If the infor-
 25 mation disclosed under this paragraph is not prepared for the use of the Employment Department,
 26 the costs of disclosing the information shall be paid by the party requesting the information.

27 (c) In accordance with ORS 657.673.

28 (4) The Employment Department may:

5 658.503 or ORS chapter 652, 653 or 659A. The information disclosed may include the names and ad-
6 dresses of employers and employees and payroll data of employers and employees. The information
7 disclosed is confidential and may not be used for any other purpose. If the information disclosed
8 under this paragraph is not prepared for the use of the Employment Department, the costs of dis-
9 closing the information shall be paid by the bureau.

10 (g) Disclose information required under ORS 657.660 (3) and (4) to the Public Employees Re-
11 tirement System for the purpose of determining the eligibility of members of the retirement system
12 for disability under ORS chapters 238 and 238A. The information disclosed is confidential and may
13 not be used for any other purpose. The costs of disclosing information under this paragraph shall
14 be paid by the Public Employees Retirement System.

15 (h) Disclose to the Oregon Business Development Commission and the Oregon Business Devel-
16 opment Department information required by the commission and the department in performing their
17 duties under ORS 285A.050 and 285B.630 to verify changes in employment levels following direct
18 employer participation in department programs or indirect participation through municipalities un-
19 der ORS 285B.410 to 285B.482. The information disclosed to the commission and the department may
20 include an employer's employment level, total subject wages payroll and whole hours worked. The
21 information disclosed is confidential and may not be used for any other purpose. The commission
22 and the department may not disclose the information in any manner that would identify an employ-
23 ing unit or employee except to the extent necessary to carry out the commission's and the
24 department's duties under ORS 285A.050 and 285B.630. If the information disclosed under this para-
25 graph is not prepared for the use of the Employment Department, the costs of disclosing the infor-
26 mation shall be paid by the commission or the Oregon Business Development Department.

27 (i) Disclose information to the Department of Revenue for the purpose of performing its duties
28 under ORS 293.250 or under the revenue and tax laws of this state. The information disclosed may
29 include the names and addresses of employers and employees and payroll data of employers and
30 employees. The information disclosed is confidential and may not be disclosed by the Department
31 of Revenue in any manner that would identify an employing unit or employee except to the extent
32 necessary to carry out the department's duties under ORS 293.250 or in auditing or reviewing any
33 report or return required or permitted to be filed under the revenue and tax laws administered by
34 the department. The Department of Revenue may not disclose any information received to any pri-
35 vate collection agency or for any other purpose. If the information disclosed under this paragraph
36 is not prepared for the use of the Employment Department, the costs of disclosing the information
37 shall be paid by the Department of Revenue.

12 commission may not disclose the information in any manner that would identify an employing unit
13 or employee except to the extent necessary to carry out the commission's duties under ORS 430.242.
14 If the information disclosed under this paragraph is not prepared for the use of the Employment
15 Department, the costs of disclosing the information shall be paid by the commission.

16 (q) Disclose to any person establishment level information secured pursuant to this chapter from
17 federal, state and local government agencies, public universities listed in ORS 352.002 or the Oregon
18 Health and Science University established under ORS 353.020. If the information disclosed under this
19 paragraph is not prepared for the use of the Employment Department, the costs of disclosing the
20 information shall be paid by the person requesting the information.

21 (r) Disclose to any person the industrial classification code assigned to an employing unit. If the
22 information disclosed under this paragraph is not prepared for the use of the Employment Depart-
23 ment, the costs of disclosing the information shall be paid by the person requesting the information.

24 (5) The Employment Department may make public all decisions of the Employment Appeals
25 Board.

26 (6) Any officer appointed by or any employee of the Director of the Employment Department
27 who discloses confidential information, except with the authority of the director, pursuant to rules
28 or as otherwise required by law, may be disqualified from holding any appointment or employment
29 with the Employment Department.

30 (7) Any person or any officer or employee of an entity to whom information is disclosed by the
31 Employment Department under this section who divulges or uses the information for any purpose
32 other than that specified in the provision of law or agreement authorizing the use or disclosure may
33 be disqualified from performing any service under contract or disqualified from holding any ap-
34 pointment or employment with the state agency that engaged or employed that person, officer or
35 employee. The Employment Department may immediately cancel or modify any information sharing
36 agreement with an entity when a person or an officer or employee of that entity discloses confi-

(A) Catastrophic disasters declared by the Governor pursuant to Article X-A, section 1, of the Oregon Constitution;

(B) States of emergency declared by the Governor pursuant to ORS 401.165;

(C) Public health emergencies declared by the Governor pursuant to ORS 433.441;

(D) The exercise of the Governor’s authority under ORS 476.520; and

(E) Emergency quarantines ordered by the Director of the Oregon Department of Emergency Management pursuant to ORS 561.560.

[(b)] **(c) Advise state agencies with responsibility for security matters [on the future direction of the office’s planning, preparedness, response and recovery activities.] to facilitate the coordination of the agencies’ emergency preparedness and response functions.**

(2) The membership of the council consists of:

(a) Four members from the Legislative Assembly appointed as follows:

(A) Two members from the Senate appointed by the President of the Senate; and

(B) Two members from the House of Representatives appointed by the Speaker of the House of Representatives;

(b) The Governor;

(c) The Adjutant General;

(d) The Superintendent of State Police; [and]

(e) The Director of the [Office] **Oregon Department** of Emergency Management[.];

(f) The State Resilience Officer;

(g) The State Fire Marshal;

(h) The Director of the Department of Public Safety Standards and Training;

(i) The Director of the Oregon Health Authority;

(j) The Director of Transportation;

(k) The Attorney General;

1 (L) The State Forester; and

2 (m) One member appointed by the Governor to act as a senior policy advisor for emer-
3 gency operations.

4 (3) Each member appointed to the council under subsection (2)[(a)] of this section serves at the
5 pleasure of the appointing authority. The membership of a public official ceases upon termination
6 of the office held by the official at the time of appointment to the council.

7 (4) The Governor is the chairperson of the council.

8 (5) The [Adjutant General] Director of the Oregon Department of Emergency Management
9 is the vice chairperson of the council and serves as the chairperson in the absence of the Governor.

9 **SECTION 141.** The Governor or the following agencies may take any action before the
10 operative date specified in section 143 of this 2019 Act that is necessary for the Governor or
11 agency to exercise, on or after the operative date specified in section 143 of this 2019 Act,
12 all of the duties, functions and powers conferred on the Governor or the agency by sections
13 10 to 15, 92 to 98, 105 to 108 and 136 to 140 of this 2019 Act and the amendments to statutes
14 and session law by sections 2 to 9, 16 to 89, 91, 99 to 104 and 109 to 135 of this 2019 Act:

- 15 (1) The Office of Emergency Management;
- 16 (2) The Oregon Military Department;
- 17 (3) The State Fire Marshal;
- 18 (4) The Department of State Police; or
- 19 (5) The Oregon Homeland Security Council.

20 **SECTION 142.** The Governor and the following agencies shall report to the appropriate
21 interim committees of the Legislative Assembly no later than September 15 of each year
22 before the operative date specified in section 143 of this 2019 Act on the actions taken that
23 are necessary for the Governor or agency to exercise, on or after the operative date specified
24 in section 143 of this 2019 Act, all of the duties, functions and powers conferred on the
25 Governor or the agency by sections 10 to 15, 92 to 98, 105 to 108 and 136 to 140 of this 2019
26 Act and the amendments to statutes and session law by sections 2 to 9, 16 to 89, 91, 99 to
27 104 and 109 to 135 of this 2019 Act:

- 28 (1) The Office of Emergency Management;
- 29 (2) The Oregon Military Department;
- 30 (3) The State Fire Marshal;
- 31 (4) The Department of State Police; and
- 32 (5) The Oregon Homeland Security Council.
