"SECTION 1. (1) On or before December 31, 2021, the State Department of Fish and

Wildlife shall produce a survey of bay clam populations in priority areas in Tillamook Bay.

17	"(d) Establishing physical boundaries for, or seasonal restrictions on, the take of bay
18	clams in Tillamook Bay for commercial purposes, to reduce conflicts between persons who
19	take bay clams in Tillamook Bay for commercial purposes and salmon anglers in and around
20	the Ghost Hole fishing area in Tillamook Bay;
21	"(e) Establishing areas in Tillamook Bay that are closed to the take of bay clams for
22	commercial purposes and open to the take of bay clams for noncommercial purposes;
23	"(f) Monitoring the take of bay clams;
24	"(g) Establishing additional restrictions on the annual take of bay clams in intertidal and
25	subtidal areas in Oregon bays;
26	"(h) Limiting the take of bay clams in Oregon bays for commercial purposes; and
27	"(i) Assessing bay clam populations in Oregon bays.
28	"(4) The department shall consider the recommendations of the committee.
29	"(5) The committee shall assist the department in preparing any funding requests related
30	to bay clams.
