

A-Engrossed Senate Bill 1049

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Directs Public Employees Retirement Board to study issues relating to Public Employees Retirement System and report to appropriate committee or interim committee of Legislative Assembly no later than September 15, 2020.]

Redirects portion of employee contributions of member of Public Employees Retirement System to employee pension stability account. Directs Public Employees Retirement Board to apply amounts in account to pay costs of pension or other retirement benefits payable to member that accrue on or after July 1, 2020.

Allows certain participating public employer making lump sum payment of employer contributions to choose year in which to begin using lump sum payment to offset employer contributions required of employer.

Modifies provisions relating to pension obligation bonds.

Directs board, in year 2019, to determine liabilities attributable to benefits to be provided to Tier 1 and 2 members and set employer contribution rates to ensure that liabilities will be funded 22 years after determination.

Modifies provisions relating to investment options available under individual account program.

Eliminates restrictions on reemployment of retired members of system until December 31, 2024. Requires employer of retired member to make additional employer contribution to system.

Beginning in 2020, caps at \$195,000 annual salary used to calculate final average salary for purposes of system.

Transfers proceeds of sports betting games to Employer Incentive Fund.

Modifies provisions relating to Employer Incentive Fund, School Districts Unfunded Liability Fund and Unfunded Actuarial Liability Resolution Program.

Requires board to report to Joint Committee on Ways and Means or Joint Interim Committee on Ways and Means on proposed changes to actuarial methods and assumptions.

Appropriates moneys for deposit in Employer Incentive Fund to match certain employer contributions.

Provides for expedited review of Act by Supreme Court upon petition by adversely affected party.

Declares emergency, effective on passage.

A BILL FOR AN ACT

Relating to public employee retirement; creating new provisions; amending ORS 238.005, 238.105, 238.115, 238.265, 238.300, 238.305, 238.320, 238.325, 238.395, 238.580, 238.694, 238.695, 238.698, 238A.005, 238A.110, 238A.120, 238A.320, 238A.330, 238A.335, 238A.375, 238A.410, 243.800, 341.551 and 461.010 and sections 1, 2, 3, 3b, 13, 15, 24, 26 and 29, chapter 105, Oregon Laws 2018, and sections 2 and 3, chapter 118, Oregon Laws 2018; repealing section 4, chapter 118, Oregon Laws 2018; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

EMPLOYEE CONTRIBUTIONS

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

SECTION 1. ORS 238A.330 is amended to read:

238A.330. (1) A member of the individual account program must make employee contributions to the individual account program of six percent of the member's salary.

(2) Employee contributions made by a member of the individual account program under this section shall be credited by the **Public Employees Retirement** Board *[to the employee account established for the member under ORS 238A.350 (2).]* **as follows:**

(a) Except as provided in paragraph (c) of this subsection, for a member who established membership in the Public Employees Retirement System before August 29, 2003, as described in ORS 238A.025:

(A) If the member's salary does not exceed \$2,500 in a calendar month, the board shall credit all employee contributions made by the member under this section to the employee account established for the member under ORS 238A.350 (2).

(B) If the member's salary exceeds \$2,500 in a calendar month, the board shall credit:

(i) 3.5 percent of the member's salary to the employee account established for the member under ORS 238A.350 (2); and

(ii) 2.5 percent of the member's salary to the employee pension stability account established for the member under section 3 of this 2019 Act.

(b) Except as provided in paragraph (c) of this subsection, for a member who established membership in the system on or after August 29, 2003, as described in ORS 238A.025:

(A) If the member's salary does not exceed \$2,500 in a calendar month, the board shall credit all employee contributions made by the member under this section to the employee account established for the member under ORS 238A.350 (2).

(B) If the member's salary exceeds \$2,500 in a calendar month, the board shall credit:

(i) 5.25 percent of the member's salary to the employee account established for the member under ORS 238A.350 (2); and

(ii) 0.75 percent of the member's salary to the employee pension stability account established for the member under section 3 of this 2019 Act.

(c) During a biennium following a rate setting valuation prepared by the actuary under ORS 238.605 that shows that the funded status of the system, including any lump sum payments made under ORS 238.229, is 90 percent or greater, the board shall credit all employee contributions made by a member of the individual account program to the employee account established for the member under ORS 238A.350 (2).

(3) If any contributions made by a member of the individual account program are credited to the employee pension stability account under subsection (2) of this section, the member may make additional employee contributions to the individual account program in the amount credited to the employee pension stability account. The board shall credit employee contributions made under this subsection to the employee account established for the member under ORS 238A.350 (2). Contributions under this subsection may not be paid by the employer under ORS 238A.335.

[(3)] (4) A new member of the individual account program shall first make contributions under this section for those wages that are attributable to services performed by the employee during the first full pay period following the six-month probationary period required under ORS 238A.300, without regard to when those wages are considered earned for other purposes under this chapter.

(5) On January 1 of each year, the board shall adjust the dollar amounts provided in subsection (2) of this section to reflect any percentage increase in the cost of living for the

1 previous calendar year, based on changes in the Consumer Price Index for All Urban Con-
2 sumers, West Region (All Items), as published by the Bureau of Labor Statistics of the
3 United States Department of Labor.

4 **SECTION 2.** Section 3 of this 2019 Act is added to and made a part of ORS chapter 238A.

5 **SECTION 3. Employee pension stability accounts established.** (1) The Public Employees
6 Retirement Board shall establish an employee pension stability account for each active
7 member of the Public Employees Retirement System.

8 (2) Each account established under this section shall be adjusted at least annually in ac-
9 cordance with rules adopted by the board to reflect any net earnings or losses on the
10 amounts in the account. The adjustments described in this subsection shall continue until
11 the amounts in the account are withdrawn or applied against the costs of the pension or
12 other retirement benefits that are payable to the member or the member's beneficiary under
13 this chapter or ORS chapter 238.

14 (3)(a) Unless the amounts in an account established under this section are withdrawn
15 under ORS 238A.375, the amounts in the account established under this section shall be ap-
16 plied by the board to pay the costs of the pension or other retirement benefits that are
17 payable to the member or the member's beneficiary under this chapter or ORS chapter 238
18 and that accrue on or after July 1, 2020.

19 (b) If the amounts in the account established under this section exceed the costs of the
20 pension or other retirement benefits that are payable to the member or the member's ben-
21 efiary under this chapter or ORS chapter 238 and that accrue on or after July 1, 2020, the
22 board shall refund the excess amounts in a lump sum to the member or the member's ben-
23 efiary.

24 **SECTION 4.** ORS 238A.110 is amended to read:

25 238A.110. Membership under the pension program terminates when:

- 26 (1) A member dies;
27 (2) A member withdraws under ORS [238A.120] **238A.375**; or
28 (3) A member forfeits retirement credit under ORS 238A.145.

29 **SECTION 5.** ORS 238A.120 is amended to read:

30 238A.120. [(1) A vested inactive member may withdraw from the pension program if:]

31 [(a) The actuarial equivalent of the member's benefit under the pension program at the time of
32 withdrawal is \$5,000 or less; and]

33 [(b) The inactive member has separated from all service with participating public employers and
34 with employers who are treated as part of a participating public employer's controlled group under the
35 federal laws and rules governing the status of the system and the fund as a qualified governmental
36 retirement plan and trust.]

37 [(2) Upon withdrawal under this section, the Public Employees Retirement Board shall pay the
38 withdrawing member the actuarial equivalent of the member's benefit in a lump sum.]

39 [(3) If a vested inactive member withdraws from the pension program under this section and is
40 thereafter reemployed by a participating public employer:] **A vested inactive member who with-
41 draws from the individual account program under ORS 238A.375 cancels the person's mem-
42 bership in the Public Employees Retirement System. If the person is thereafter reemployed
43 by a participating public employer:**

44 [(a)] (1) The person may reestablish membership in the pension program only for the purpose
45 of service performed after the person is reemployed; and

1 *[(b)]* (2) Any service performed before the withdrawal may not be credited toward the period of
2 service required by ORS 238A.100 or 238A.115 or toward the accrual of retirement credit under ORS
3 238A.140, 238A.150 or 238A.155.

4 *[(4) A member who has an individual account or accounts in the individual account program es-*
5 *tablished under ORS 238A.025 may withdraw from the pension program under this section only if the*
6 *member also withdraws all individual accounts pursuant to ORS 238A.375. A member who has a*
7 *member account established under ORS chapter 238 may withdraw from the pension program under*
8 *this section only if the member also withdraws that member account in the manner provided by ORS*
9 *238.265. A member who has an account established under ORS 238.440 may withdraw from the pension*
10 *program under this section only if the member also withdraws the account established under ORS*
11 *238.440.]*

12 *[(5) For the purposes of this section, the actuarial equivalent of a member's benefit does not include*
13 *any value attributable to adjustments to the benefit under ORS 238A.210.]*

14 **SECTION 6.** ORS 238A.320 is amended to read:

15 238A.320. (1) A member of the individual account program becomes vested in the employee ac-
16 count established for the member under ORS 238A.350 (2) on the date the employee account is es-
17 tablished.

18 (2) A member who makes rollover contributions becomes vested in the rollover account estab-
19 lished for the member under ORS 238A.350 (4) on the date the rollover account is established.

20 (3) Except as provided in subsection (4) of this section, if an employer makes employer contri-
21 butions for a member under ORS 238A.340 the member becomes vested in the employer account es-
22 tablished under ORS 238A.350 (3) on the earliest of the following dates:

23 (a) The date on which the member completes at least 600 hours of service in each of five cal-
24 endar years. The five calendar years need not be consecutive, but are subject to the provisions of
25 subsection (5) of this section.

26 (b) The date on which an active member reaches the normal retirement age for the member
27 under ORS 238A.160.

28 (c) If the individual account program is terminated, the date on which termination becomes ef-
29 fective, but only to the extent the account is then funded.

30 (d) The date on which an active member becomes disabled, as described in ORS 238A.155 (5).

31 (e) The date on which an active member dies.

32 (4) If on the date that a person becomes an active member the person has already reached the
33 normal retirement age for the person under ORS 238A.160, and the employer makes employer con-
34 tributions for the member under ORS 238A.340, the person is vested in the employer account es-
35 tablished under ORS 238A.350 (3) on that date.

36 (5) If a member of the individual account program who is not vested in the employer account
37 performs fewer than 600 hours of service in each of five consecutive calendar years, hours of service
38 performed before the first calendar year of the period of five consecutive calendar years shall be
39 disregarded for purposes of determining whether the member is vested under subsection (3)(a) of this
40 section.

41 (6) Solely for purposes of determining whether a member is vested under subsection (3)(a) of this
42 section, hours of service include creditable service, as defined in ORS 238.005, performed by the
43 person before the person became an eligible employee, as long as the membership of the person
44 under ORS chapter 238 has not been terminated under the provisions of ORS 238.095 on the date
45 the person becomes an eligible employee.

1 **(7) A member becomes vested in the employee pension stability account established for**
2 **the member under section 3 of this 2019 Act on the date the employee pension stability ac-**
3 **count is established.**

4 **SECTION 7.** ORS 238A.335 is amended to read:

5 238A.335. (1) A participating public employer may agree, by a written employment policy or by
6 a collective bargaining agreement, to pay the employee contribution required under ORS 238A.330
7 (1). The policy or agreement need not include all members of the individual account program em-
8 ployed by the employer.

9 (2) An agreement under this section [*to pay the required employee contribution*] may provide that:

10 (a) **Amounts be deducted from** employee compensation [*be reduced*] to generate the funds
11 needed to make [*the*] employee contributions; or

12 (b) Additional amounts be paid by the employer for the purpose of making [*the*] employee
13 contributions[, *and employee compensation not be reduced for the purpose of generating the funds*
14 *needed to make the employee contributions*].

15 (3) A participating public employer must give written notice to the Public Employees Retirement
16 Board at the time that [*a written employment policy or collective bargaining agreement described in*]
17 **an agreement under** subsection (1) of this section is adopted or changed. The notice must specif-
18 ically indicate whether the agreement is as described in subsection (2)(a) or (b) of this section. [*Any*
19 *change in the manner in which employee contributions are to be paid applies only to employee contri-*
20 *butions made on and after the date the notice is received by the board.*] **An agreement under this**
21 **section, and any change to an agreement under this section, applies only to employee con-**
22 **tributions for pay periods beginning on or after the date that the notice is received by the**
23 **board.**

24 **SECTION 8.** ORS 238A.375 is amended to read:

25 238A.375. (1) An inactive member of the individual account program may elect to receive a dis-
26 tribution of the amounts in the member's employee account, rollover account, [*and*] employer ac-
27 count **and employee pension stability account** to the extent the member is vested in those
28 accounts under ORS 238A.320 if the inactive member has separated from all service with partic-
29 ipating public employers and with employers who are treated as part of a participating public
30 employer's controlled group under the federal laws and rules governing the status of the **Public**
31 **Employees Retirement** System and the **Public Employees Retirement** Fund as a qualified gov-
32 nmental retirement plan and trust.

33 (2) If an inactive member of the individual account program who is not vested in the employer
34 account receives a distribution under subsection (1) of this section, the employer account of the
35 member is permanently forfeited as of the date of the distribution.

36 (3) A member may not make an election under this section for less than all of the member's in-
37 dividual accounts described in ORS 238A.350, **and the member's employee pension stability ac-**
38 **count described in section 3 of this 2019 Act**, in which the member is vested.

39 (4) A member who is vested in the pension program established under this chapter and who [*is*
40 *eligible to withdraw from the pension program under ORS 238A.120 may make an election under this*
41 *section only if the member also withdraws from the pension program*] **withdraws the member's ac-**
42 **counts under this section cancels all membership rights in the system.**

43 (5) A member who has a member account established under ORS chapter 238 may make an
44 election under this section only if the member also withdraws that member account in the manner
45 provided by ORS 238.265. A member who has an account established under ORS 238.440 may make

1 an election under this section only if the member also withdraws the account established under ORS
2 238.440.

3 [(5)] (6) If an inactive member receives a distribution under subsection (1) of this section and is
4 subsequently reemployed by a participating public employer, any service performed before the date
5 the member became an inactive member may not be used toward the period of service required for
6 vesting in the employer account under ORS 238A.320.

7 **SECTION 9.** ORS 238A.410, as amended by section 9, chapter 101, Oregon Laws 2018, is
8 amended to read:

9 238A.410. (1)(a) If a member of the individual account program dies before retirement, the
10 amounts in the member's employee account, rollover account and employer account, to the extent
11 the member is vested in those accounts under ORS 238A.320, shall be paid in a lump sum to the
12 beneficiary or beneficiaries designated by the member for the purposes of this section.

13 **(b) If a member of the individual account program dies before retirement, the amounts**
14 **in the employee pension stability account established for the member under section 3 of this**
15 **2019 Act shall be applied by the Public Employees Retirement Board to pay the costs of any**
16 **benefit payable under ORS 238.395 or 238A.230 that accrues on or after July 1, 2020. If the**
17 **amounts in the employee pension stability account exceed the costs of the benefit payable**
18 **under ORS 238.395 or 238A.230 that accrues on or after July 1, 2020, the excess amounts shall**
19 **be paid in a lump sum to the beneficiary or beneficiaries designated by the member for the**
20 **purposes of this section.**

21 (2) If a member of the individual account program is married at the time of death, or there exists
22 at the time of death any other person who is constitutionally required to be treated in the same
23 manner as a spouse for the purpose of retirement benefits, the spouse or other person shall be the
24 beneficiary for purposes of the death benefit payable under this section unless the spouse or other
25 person consents to the designation of a different beneficiary or beneficiaries before the designation
26 has been made and the consent has not been revoked by the spouse or other person as of the time
27 of the member's death. Consent and revocation of consent must be in writing, acknowledged by a
28 notary public, and submitted to the Public Employees Retirement Board in accordance with rules
29 adopted by the board. If the member's spouse is designated as the member's beneficiary and the
30 marriage of the member and spouse is subsequently dissolved, the former spouse shall be treated as
31 predeceasing the member for purposes of this section, unless the member expressly designates the
32 former spouse as beneficiary after the effective date of the dissolution or the former spouse is re-
33 quired to be designated as a beneficiary under the provisions of ORS 238.465.

34 (3) For purposes of this section and ORS 238A.400 (3), if a member fails to designate a benefi-
35 ciary, or if the person or persons designated do not survive the member, the death benefit provided
36 for in this section shall be paid to the following person or persons, in the following order of priority:

37 (a) The member's surviving spouse or other person who is constitutionally required to be treated
38 in the same manner as a spouse;

39 (b) The member's surviving children, in equal shares; or

40 (c) The member's estate.

41 (4) The entire amount of a deceased member's vested accounts must be distributed by December
42 31 of the fifth calendar year after the year in which the member died. Notwithstanding any other
43 provision of this chapter, distributions of death benefits under the individual account program must
44 comply with the minimum distribution requirements of 26 U.S.C. 401(a)(9) and the regulations im-
45 plementing that section, as in effect on December 31, 2017. The Public Employees Retirement Board

1 shall adopt rules implementing those minimum distribution requirements.

2 **SECTION 10.** ORS 238.105 is amended to read:

3 238.105. (1) Whenever, within five years after the employee is separated from all service entitling
4 the employee to membership in the **Public Employees Retirement** System, an employee who has
5 withdrawn the amount credited to the member account of the member reenters the service of an
6 employer participating in the system, the employee's rights in the system that were forfeited by the
7 withdrawal shall be restored upon repaying to the **Public Employees Retirement** Board within one
8 year after reentering the service of the employer, the full amount so withdrawn together with the
9 interest that would have been accumulated on the sum had the amount not been withdrawn.

10 (2) Restoration of rights under this section does not affect any forfeiture of rights of a person
11 by reason of:

12 (a) Withdrawal of an account established under ORS 238.440; **or**

13 *[(b) Withdrawal from the pension program under ORS 238A.120; or]*

14 *[(c)]* (b) Withdrawal of individual accounts pursuant to ORS 238A.375.

15 **SECTION 11.** ORS 238.115 is amended to read:

16 238.115. (1)(a) A member of the **Public Employees Retirement** System who, after separation
17 from all service entitling the employee to membership in the system and withdrawal of the amount
18 credited to the member account of the member, reenters the service of an employer participating in
19 the system and serves as an active member of the system for 10 years after that reentry, and who
20 has not otherwise obtained restoration of creditable service forfeited by the withdrawal, shall obtain
21 restoration of one full month of creditable service forfeited by the withdrawal for each three full
22 months of service as an active member after that reentry if the member, within 90 days before the
23 effective date of retirement of the member:

24 (A) Applies in writing to the **Public Employees Retirement** Board for restoration of creditable
25 service; and

26 (B) Pays to the board in a lump sum for credit to the member account of the member the amount
27 withdrawn and interest on the amount withdrawn compounded annually for each year or portion of
28 a year after the date of the withdrawal and before the effective date of retirement of the member.
29 The interest shall be computed at the annual rate of 7.5 percent.

30 (b) If a member who obtains restoration of creditable service as provided in this subsection does
31 not obtain restoration of all creditable service forfeited by the withdrawal pursuant to service after
32 reentry, the payment under paragraph (a) of this subsection shall be reduced proportionately to re-
33 flect the percentage of creditable service restored.

34 (c) A member who obtains restoration of creditable service as provided in this subsection is not
35 entitled to elect to receive the service retirement benefit described in ORS 238.305 (2) or (3).

36 (2) A member who forfeited creditable service rendered to a public employer before March 27,
37 1953, because under ORS 237.976 (2) the employee withdrew contributions of the employee to the
38 Public Employees Retirement System established by chapter 401, Oregon Laws 1945, and who did
39 not obtain restoration of creditable service so forfeited as provided in chapter 857, Oregon Laws
40 1977, shall, upon retirement, receive restoration of creditable service so forfeited, if the member,
41 before the effective date of retirement of the member:

42 (a) Applies in writing to the board for the restoration of the creditable service; and

43 (b) Pays to the board in a lump sum for credit to the member account of the member an amount
44 determined by the board to be equal to the full amount of contributions so withdrawn and the in-
45 terest that would have accumulated to the regular account of the member had those contributions

1 not been withdrawn.

2 (3)(a) A member of the Public Employees Retirement System who was a member of an associ-
3 ation established pursuant to ORS chapter 239 (1997 Edition), but separated from all service entitl-
4 ing the employee to membership in the system of the association and withdrew the amount credited
5 to the member account of the employee in the retirement fund of the association, and who, after that
6 separation, entered the service of an employer in the field of education participating in the Public
7 Employees Retirement System and served as an active member of that system for 10 years after that
8 entry, and who has not otherwise obtained restoration of all creditable service forfeited by the
9 withdrawal, shall obtain creditable service as a member of the Public Employees Retirement System
10 equal to all creditable service forfeited by the withdrawal if the member within 90 days before the
11 effective date of retirement of the member:

12 (A) Applies in writing to the Public Employees Retirement Board for that creditable service; and

13 (B) Pays to the board in a lump sum for credit to the member account of the member the amount
14 withdrawn and interest on the amount withdrawn compounded annually for each year or portion of
15 a year after the date of the withdrawal and before the effective date of retirement or effective date
16 of application of the member. The interest shall be computed at the rate actually credited to regular
17 accounts for that period.

18 (b) This subsection provides a method of obtaining creditable service for forfeited creditable
19 service described in this subsection that is in lieu of any application of subsection (1) of this section
20 for that purpose.

21 (4) Restoration of creditable service under this section does not affect any forfeiture of rights
22 of a person by reason of:

23 (a) Withdrawal of an account established under ORS 238.440; **or**

24 [(b) *Withdrawal from the pension program under ORS 238A.120; or*]

25 [(c)] (b) Withdrawal of individual accounts pursuant to ORS 238A.375.

26 **SECTION 12.** ORS 238.265 is amended to read:

27 238.265. (1) Except as otherwise provided in this section, a member of the Public Employees
28 Retirement System may withdraw from the Public Employees Retirement Fund the amount credited
29 to the member account, if any, for the member if:

30 (a) The member is separated from all service with participating public employers;

31 (b) The member is separated from all service with employers who are treated as part of a par-
32 ticipating public employer's controlled group under the federal laws and rules governing the status
33 of the system and the fund as a qualified governmental retirement plan and trust;

34 (c) The member has not attained earliest service retirement age; and

35 (d) The separation from service is not by reason of death or disability.

36 (2) If a member wishes to withdraw the member account, if any, of the member under this sec-
37 tion, the member must transmit to the Public Employees Retirement Board a withdrawal request.
38 The board shall deny the withdrawal, or shall take all reasonable steps to recover withdrawn
39 amounts, if:

40 (a) The board determines that the separation is not a bona fide separation; or

41 (b) The member fails to remain absent from the service of all employers described in subsection
42 (1) of this section for at least one calendar month following the month in which the member sepa-
43 rates from service.

44 (3) If a member has contributed to the fund in each of five calendar years and has separated
45 from all service in the manner described in subsection (1) of this section before reaching earliest

1 service retirement age, the member may elect to withdraw the member account of the member under
 2 this section at any time before reaching earliest service retirement age. If the inactive member does
 3 not make an election to withdraw under this section, the member shall be paid the benefits or re-
 4 tirement allowances described in ORS 238.425.

5 (4) *[A member who is vested in the pension program established under ORS chapter 238A and*
 6 *who is eligible to withdraw from the pension program under ORS 238A.120 may withdraw a member*
 7 *account under this section only if the member also withdraws from the pension program.]* A member
 8 who has an individual account or accounts in the individual account program established under ORS
 9 chapter 238A may withdraw a member account under this section only if the member also withdraws
 10 all individual accounts pursuant to ORS 238A.375. A member who has an account established under
 11 ORS 238.440 may withdraw a member account under this section only if the member also withdraws
 12 the account established under ORS 238.440.

13 (5) Withdrawal of a member account under this section cancels all membership rights in the
 14 system, including the right to claim credit for any employment before withdrawal.

15 **SECTION 13.** ORS 238.300 is amended to read:

16 238.300. Upon retiring from service at normal retirement age or thereafter, a member of the
 17 **Public Employees Retirement** System shall receive a service retirement allowance which shall
 18 consist of the following annuity and pensions:

19 (1) A refund annuity which shall be the actuarial equivalent of accumulated contributions, if
 20 any, by the member **under this chapter** and interest thereon credited at the time of retirement,
 21 which annuity shall provide an allowance payable during the life of the member and at death a lump
 22 sum equal in amount to the difference between accumulated contributions at the time of retirement
 23 and the sum of the annuity payments actually made to the member during life shall be paid to such
 24 person, if any, as the member nominates by written designation duly acknowledged and filed with
 25 the board or shall otherwise be paid according to the provisions of this chapter for disposal of an
 26 amount credited to the member account of a member at the time of death in the event the member
 27 designates no beneficiary to receive the amount or no such beneficiary is able to receive the
 28 amount. If death of the member occurs before the first payment is due, the member account of the
 29 member shall be treated as though death had occurred before retirement.

30 (2)(a) A life pension (nonrefund) for current service provided by the contributions of employers
 31 **and, for pension benefits that accrue on or after July 1, 2020, amounts in the employee pen-**
 32 **sion stability account established for the member under section 3 of this 2019 Act**, which
 33 pension, subject to paragraph (b) of this subsection, shall be an amount which, when added to the
 34 sum of the annuity, if any, under subsection (1) of this section and the annuity, if any, provided on
 35 the same basis and payable from the Variable Annuity Account, both annuities considered on a re-
 36 fund basis, results in a total of:

37 (A) For service as a police officer or firefighter, two percent of final average salary multiplied
 38 by the number of years of membership in the system as a police officer or firefighter before the ef-
 39 fective date of retirement.

40 (B) For service as other than a police officer or firefighter, including service as a member of the
 41 Legislative Assembly, 1.67 percent of final average salary multiplied by the number of years of
 42 membership in the system as other than a police officer or firefighter before the effective date of
 43 retirement.

44 (b) A pension under this subsection shall be at least:

45 (A) For a member who first establishes membership in the system before July 1, 2003, the

1 actuarial equivalent of the annuity provided by the accumulated contributions of the member. A
 2 person establishes membership in the system before July 1, 2003, for the purposes of this subpara-
 3 graph if:

4 (i) The person is a member of the system, or a judge member of the system, on the day imme-
 5 diately before July 1, 2003; or

6 (ii) The person performed any period of service for a participating public employer before July
 7 1, 2003, that is credited to the six-month period of employment required of an employee under ORS
 8 238.015 before an employee may become a member of the system.

9 (B) For a member who made contributions before August 21, 1981, the equivalent of a pension
 10 computed pursuant to this subsection as it existed immediately before that date.

11 (c) As used in this subsection, "number of years of membership" means the number of full years
 12 of creditable service plus any remaining fraction of a year of creditable service. Except as other-
 13 wise provided in this paragraph, in determining a remaining fraction a full month shall be consid-
 14 ered as one-twelfth of a year and a major fraction of a month shall be considered as a full month.
 15 Membership of a school district employee, an employee of an institution of higher education engaged
 16 in teaching or other school activity or an employee of the Department of Human Services, the
 17 Oregon Youth Authority, the Department of Corrections or the State Board of Education engaged
 18 in teaching or other school activity at an institution supervised by the authority, board or depart-
 19 ment, for all portions of a school year in a calendar year in which the district school, institution

30 (3) An additional life pension (nonrefund) for prior service credit, including military service,
 31 credited to the member at the time of first becoming a member of the system, as elsewhere provided
 32 in this chapter, which pension shall be provided by the contributions of the employer.

33 **SECTION 14.** ORS 238.305 is amended to read:

34 238.305. (1) Not later than 60 days after the first benefit payment is made to a retired member
 35 of the Public Employees Retirement System, the member may elect to convert the allowance de-
 36 scribed by ORS 238.300 as payable after retirement into a service retirement annuity of equivalent
 37 actuarial value of one of the optional forms named below. The election of Option 2, 2A, 3 or 3A shall

 43 (nonrefund) provided by the contributions of employers as provided in ORS 238.300 (2) **and, for**
 44 **pension benefits that accrue on or after July 1, 2020, amounts in the employee pension sta-**
 45 **bility account established for the member under section 3 of this 2019 Act;** (c) an additional

1 nonrefund pension for prior service credit, including military service, credited to the member at the
2 time of first becoming a member of the system, as elsewhere provided in this chapter, which pension
3 shall be provided by the contributions of the employer; or

4 Option 2. A reduced service retirement allowance payable during the member's life, with the
5 provision that it continue after death for the life of the beneficiary the member nominates by written
6 designation duly acknowledged and filed with the Public Employees Retirement Board at the time
7 of election, should the beneficiary survive the member; or

8 Option 2A. A reduced service retirement allowance payable during the member's life which,
9 unless modified under subsection (6) of this section, continues after death for the life of the benefi-
10 ciary the member nominates by written designation duly acknowledged and filed with the board at
11 the time of election, should the beneficiary survive the member; or

12 Option 3. A reduced service retirement allowance payable during the member's life, with the
13 provision that it continue after death at one-half the rate paid to the member and be paid for the
14 life of the beneficiary the member nominates by written designation duly acknowledged and filed
15 with the board at the time of election, should the beneficiary survive the member; or

16 Option 3A. A reduced service retirement allowance payable during the member's life which,
17 unless modified under subsection (6) of this section, continues after death at one-half the rate paid
18 to the member and is paid for the life of the beneficiary the member nominates by written desig-
19 nation duly acknowledged and filed with the board at the time of election, should the beneficiary
20 survive the member; or

21 Option 4. A reduced service retirement allowance payable during the member's life, with the
22 provisions that if the member dies before a total of 180 monthly payments is made, the remainder
23 of the 180 monthly payments shall be paid monthly to the beneficiary the member nominates by
24 written designation duly acknowledged and filed with the board at any time before the member's
25 death; and that if the member designates no beneficiary to receive the monthly payments or no such
26 beneficiary is able to receive the monthly payments, an amount equal to the actuarial value, on the
27 date of the member's death, of the total of the monthly payments not made to the member shall be
28 paid according to ORS 238.390 for disposal of an amount credited to the member account of a
29 member at the time of death; and that if the beneficiary receiving monthly payments dies before the
30 total number of monthly payments to which the beneficiary is entitled is made, an amount equal to
31 the actuarial value, on the date of the beneficiary's death, of the total of the monthly payments not
32 made to the member and beneficiary shall be paid according to ORS 238.390 for disposal of an
33 amount credited to the member account of a member at the time of death and as if the beneficiary
34 had been a member.

35 (2) Not later than 60 days after the first benefit payment is made to a retired member of the
36 system, the member may elect, in lieu of the allowance described by ORS 238.300 as payable after
37 retirement, a service retirement benefit consisting of:

38 (a) A refund of accumulated contributions by the member **under this chapter** and interest
39 thereon credited at the time of refund; and

40 (b) A life pension (nonrefund) provided by the contributions of employers as provided in ORS
41 237.147 (2) (1979 Replacement Part) **and, for pension benefits that accrue on or after July 1,**

3 (3) Not later than 60 days after the first benefit payment is made to a retired member of the
4 system, the member may elect in lieu of the allowance described by ORS 238.300 a refund service
5 retirement benefit consisting of:

6 (a) A refund of accumulated contributions by the member **under this chapter** and interest
7 thereon credited at the time of retirement;

8 (b) An amount that matches the amount of accumulated contributions by the member and inter-
9 est thereon, provided by the contributions of employers **and, for pension benefits that accrue**
10 **on or after July 1, 2020, amounts in the employee pension stability account established for**
11 **the member under section 3 of this 2019 Act;** and

12 (c) Interest on the amounts described in paragraphs (a) and (b) of this subsection from the ef-

42 subsection. If a member elects to receive the refund service retirement benefit described in sub-

1 (c) A member who elects to receive the refund service retirement benefit described in subsection
2 (3) of this section, and any eligible spouse or dependent of the member, shall continue to be eligible
3 for insurance under ORS 238.410, and for any premium payments the member may be entitled to
4 under ORS 238.415 and 238.420.

5 (5) The designation of a beneficiary, the election of an option or any other election or desig-
6 nation under subsection (1), (2), (3) or (4) of this section may be changed by the member within 60
7 days after the date of the first benefit payment, except that the designation of a beneficiary under
8 Option 4 may be changed by the member at any time before the member's death.

9 (6) If a retired member has elected to receive a service retirement allowance under Option 2A
10 or Option 3A as provided in subsection (1) of this section, and if the beneficiary under that option
11 dies after the expiration of the time within which the member could change the election of an option
12 or if the beneficiary is the spouse of the member and the marriage relationship is terminated as
13 provided by law after the expiration of the time within which the member could change the election
14 of an option, the member may elect to receive, in lieu of the optional form of allowance previously
15 elected, the allowance that the member would have received on the effective date of retirement
16 under Option 1 as provided in subsection (1) of this section and adjusted by the actual amount of
17 any cost-of-living or other post-retirement adjustments made to the original allowance since the ef-
18 fective date of retirement. Notice of election under this subsection must be in a form approved by
19 the board. If an election is made under this subsection, the Option 1 payment amount is applicable
20 to the first full month after the death of the beneficiary, or the first full month after entry of the
21 judgment of divorce, and payable the first day of the month thereafter. If the increased amount is
22 not paid in any month in which the increased amount is due, the board shall make a lump sum
23 payment to the retired member that is equal to the difference between the amount paid to the
24 member for that month and the amount that should have been paid under the provisions of this
25 subsection.

26 (7) Notwithstanding any other provision of this section, any member of the system who retired
27 before October 3, 1989, and elected to receive a service retirement allowance under either Option
28 2 or 3 as provided in subsection (1) of this section shall be entitled to receive a service retirement
29 allowance equal to that which the member would have received on the effective date of retirement
30 under Option 1 as provided in subsection (1) of this section and adjusted by the actual amount of
31 any cost-of-living or other post-retirement adjustments made to the original allowance since the ef-
32 fective date of retirement if:

33 (a) The member has attained 80 years of age;

34 (b) The person designated by the member as the member's beneficiary has predeceased the

37 (8) Notwithstanding any other provision of this section, any member of the system who retired
38 before October 3, 1989, who elected to receive a refund of accumulated employee contributions and
39 a life pension or pensions under subsection (2) of this section, and who elected to convert the life
40 pension or pensions provided for in subsection (2) of this section into a service retirement annuity
41 under Option 2 or 3 under subsection (1) of this section, shall be entitled to receive a life pension
42 or pensions equal to that which the member would have received on the effective date of retirement
43 under subsection (2) of this section and adjusted by the actual amount of any cost-of-living or other
44 post-retirement adjustments made to the original life pension or pensions since the effective date of
45 retirement if:

1 (a) The member has attained 80 years of age;

2 (b) The person designated by the member as the member's beneficiary has predeceased the

4 (c) The member gives written notice to the board of the death of the member's beneficiary.

5 (9) The service retirement allowance provided in subsection (7) or (8) of this section shall be
6 applicable to the first full month after the death of the member's beneficiary, or the first full month
7 after the member attains 80 years of age, whichever is later.

8 (10) The board may deny an election to convert a service retirement allowance under this sec-
9 tion, a change of beneficiary under this section or a change in benefit options under this section if
10 that denial is required to maintain the status of the system and the Public Employees Retirement
11 Fund as a qualified governmental retirement plan and trust under the Internal Revenue Code and
12 under regulations adopted pursuant to the Internal Revenue Code.

13 **SECTION 15.** ORS 238.320 is amended to read:

14 238.320. (1) Whenever an employee who is a member of the **Public Employees Retirement**
15 System is found, after being examined by one or more physicians selected by the **Public Employees**
16 **Retirement** Board, to be mentally or physically incapacitated for an extended duration, as deter-
17 mined by medical examination, and thereby unable to perform any work for which qualified, by in-

26 if the member had worked continuously until attaining the age of 55, or if the member has attained
27 the age of 55, the pension which the member would receive were the member to retire for service,
28 as provided in this chapter.

29 (B) For a member other than a police officer or firefighter, the pension to which the member
30 would have been entitled if the member had worked continuously until attaining the age of 58, or
31 if the member has attained the age of 58, the pension which the member would receive were the
32 member to retire for service, as provided in this chapter.

33 (c) The same prior service pension the member would have received had the member worked
34 until normal retirement age.

35 (2) As used in subsection (1) of this section, "injury" means bodily injury causing the disability
36 directly and independently of all other causes and effected solely through accidental means.

37 (3) Whenever an employee who is a member of the system and who has been an employee for
38 10 years or more of an employer participating in the system is found, after being examined by one
39 or more physicians selected by the board, to be mentally or physically incapacitated for an extended
40 duration, as determined by medical examination, and thereby unable to perform any work for which
41 qualified, from cause other than injury or disease sustained while in actual performance of duty or
42 intentionally self-inflicted, the member shall receive a disability retirement allowance as provided
43 in subsection (1) of this section.

44 (4) Payments under a disability retirement allowance provided for in subsection (1) or (3) of this
45 section for the first 90-day period of incapacity shall be withheld until such 90-day period has

2 (5) An inactive member is not eligible for disability benefits referred to in subsection (1) or (3)
3 of this section unless the member applies for such disability benefits within five calendar years after
4 the date of separation from service with a participating public employer if the disability is contin-
5 uous from such separation date or within six months after the date of such separation from service
6 if disability occurs after such separation date.

7 (6) In computing years of employment for the purpose of subsection (3) of this section, the fol-

23 considered to be mentally or physically incapacitated for an extended duration if the mental or
24 physical incapacity can be expected to result in death or has lasted or can be expected to last for

27 238.325. (1) At any time after establishing membership, but before the expiration of 90 days after

42 an additional nonrefund pension for prior service credit, including military service, credited to the
43 member at the time the member first becomes a member of the system, as elsewhere provided in this
44 chapter, which pension shall be provided by the contributions of the employer; or

45 Option 2. A reduced disability retirement allowance payable during the period of incapacity,

1 with the provision that after death, if death shall occur after the effective date of the disability and
2 during the period of incapacity, it shall continue for the life of the beneficiary whom the member
3 has designated in writing duly acknowledged and filed with the board at the time of election, should
4 the beneficiary survive the member; or

5 Option 2A. A reduced disability retirement allowance payable during the period of incapacity
6 which, unless modified under subsection (3) of this section, continues after death, if death shall occur
7 after the effective date of the disability and during the period of incapacity, for the life of the ben-
8 eficiary whom the member nominates by written designation duly acknowledged and filed with the
9 board at the time of election, should the beneficiary survive the member; or

10 Option 3. A reduced disability retirement allowance payable during the period of incapacity,
11 with the provision that after death, if death shall occur after the effective date of the disability and
12 during the period of incapacity, such allowance shall continue at one-half the rate paid to the

16 Option 3A. A reduced disability retirement allowance payable during the period of incapacity

22 Option 4. A reduced disability retirement allowance payable during the period of incapacity,

24 monthly payments is made, the remainder of the 180 monthly payments shall be paid monthly to the

26 board at any time before the member's death; and that if the member designates no beneficiary to
27 receive the monthly payments or no such beneficiary is able to receive the monthly payments, an

30 (b) If not eligible for benefits under ORS 238.395, elect to receive benefits under ORS 238.390 (1);

32 (c) Elect Option 2 or 3 under subsection (1) of this section and designate the surviving spouse
 33 as beneficiary thereunder with the same force and effect as if the election and designation had been
 34 properly made by the deceased member.

35 (7) The board may deny an election to convert a disability retirement allowance under this
 36 section, a change of beneficiary under this section or a change in benefit options under this section
 37 if that denial is required to maintain the status of the system and the Public Employees Retirement

24 pension liabilities may reduce the cost of public pensions to taxpayers and that the reduction of
25 those costs to taxpayers is a matter of statewide concern.

26 (2) Notwithstanding the limitation on indebtedness in ORS 287A.105 or any other limitation on
27 indebtedness or borrowing under state or local law, for the purpose of obtaining funds to pay the

AMORTIZATION OF UNFUNDED ACTUARIAL LIABILITY

SECTION 27. In the year 2019, the Public Employees Retirement Board shall determine the liabilities of the Public Employees Retirement System attributable to the benefits to be provided to members who established membership in the system before August 29, 2003, and shall set the amount of contributions to be made by participating public employers, and by other public employers that are required to make contributions on behalf of members, to ensure that those liabilities will be funded 22 years after the date on which the determination is made.

28 (3) "Board" means the Public Employees Retirement Board.

44 and shall be added to all full years. "Creditable service" includes all retirement credit received by
45 a member.

1 (7) "Earliest service retirement age" means the age attained by a member when the member
2 could first make application for retirement under the provisions of ORS 238.280.

3 (8) "Employee" includes, in addition to employees, public officers, but does not include:

4 (a) Persons engaged as independent contractors.

5 (b) Seasonal, emergency or casual workers whose periods of employment with any public em-
6 ployer or public employers do not total 600 hours in any calendar year.

7 (c) Persons provided sheltered employment or made-work by a public employer in an employment

17 versity listed in ORS 352.002, or by the Oregon Health and Science University, under ORS 350.370.

18 (9) "Final average salary" means whichever of the following is greater:

19 (a) The average salary per calendar year paid by one or more participating public employers to
20 an employee who is an active member of the system in three of the calendar years of membership
21 before the effective date of retirement of the employee, in which three years the employee was paid
22 the highest salary. The three calendar years in which the employee was paid the largest total salary
23 may include calendar years in which the employee was employed for less than a full calendar year.
24 If the number of calendar years of active membership before the effective date of retirement of the
25 employee is three or fewer, the final average salary for the employee is the average salary per cal-
26 endar year paid by one or more participating public employers to the employee in all of those years,
27 without regard to whether the employee was employed for the full calendar year.

38 (12) "Fund" means the Public Employees Retirement Fund.

39 (13) "Inactive member" means a member who is not employed in a qualifying position, whose
40 membership has not been terminated in the manner described by ORS 238.095 and who is not retired
41 for service or disability.

42 (14) "Institution of higher education" means a public university listed in ORS 352.002, the
43 Oregon Health and Science University and a community college, as defined in ORS 341.005.

44 (15) "Member" means a person who has established membership in the system and whose mem-
45 bership has not been terminated as described in ORS 238.095. "Member" includes active, inactive

1 and retired members.

2 (16) "Member account" means the regular account and the variable account.

3 (17) "Normal retirement age" means:

4 (a) For a person who establishes membership in the system before January 1, 1996, as described
5 in ORS 238.430, 55 years of age if the employee retires at that age as a police officer or firefighter
6 or 58 years of age if the employee retires at that age as other than a police officer or firefighter.

7 (b) For a person who establishes membership in the system on or after January 1, 1996, as de-
8 scribed in ORS 238.430, 55 years of age if the employee retires at that age as a police officer or
9 firefighter or 60 years of age if the employee retires at that age as other than a police officer or
10 firefighter.

11 (18) "Pension" means annual payments for life derived from contributions by one or more public
12 employers.

13 (19) "Police officer" includes:

14 (a) Employees of institutions defined in ORS 421.005 as Department of Corrections institutions
15 whose duties, as assigned by the Director of the Department of Corrections, include the custody of
16 persons committed to the custody of or transferred to the Department of Corrections and employees
17 of the Department of Corrections who were classified as police officers on or before July 27, 1989,
18 whether or not such classification was authorized by law.

19 (b) Employees of the Department of State Police who are classified as police officers by the
20 Superintendent of State Police.

21 (c) Employees of the Oregon Liquor Control Commission who are classified as regulatory spe-
22 cialists by the administrator of the commission.

23 (d) Sheriffs and those deputy sheriffs or other employees of a sheriff whose duties, as classified
24 by the sheriff, are the regular duties of police officers or corrections officers.

25 (e) Police chiefs and police personnel of a city who are classified as police officers by the
26 council or other governing body of the city.

27 (f) Police officers who are commissioned by a university under ORS 352.121 or 353.125 and who
28 are classified as police officers by the university.

29 (g) Parole and probation officers employed by the Department of Corrections, parole and pro-
30 bation officers who are transferred to county employment under ORS 423.549 and adult parole and
31 probation officers, as defined in ORS 181A.355, who are classified as police officers for the purposes
32 of this chapter by the county governing body. If a county classifies adult parole and probation offi-
33 cers as police officers for the purposes of this chapter, and the employees so classified are repres-
34 ented by a labor organization, any proposal by the county to change that classification or to cease
35 to classify adult parole and probation officers as police officers for the purposes of this chapter is
36 a mandatory subject of bargaining.

37 (h) Police officers appointed under ORS 276.021 or 276.023.

38 (i) Employees of the Port of Portland who are classified as airport police by the Board of Com-
39 missioners of the Port of Portland.

40 (j) Employees of the State Department of Agriculture who are classified as livestock police of-
41 ficers by the Director of Agriculture.

42 (k) Employees of the Department of Public Safety Standards and Training who are classified by
43 the department as other than secretarial or clerical personnel.

44 (L) Investigators of the Criminal Justice Division of the Department of Justice.

45 (m) Corrections officers as defined in ORS 181A.355.

1 (n) Employees of the Oregon State Lottery Commission who are classified by the Director of the
2 Oregon State Lottery as enforcement agents pursuant to ORS 461.110.

3 (o) The Director of the Department of Corrections.

4 (p) An employee who for seven consecutive years has been classified as a police officer as de-
5 fined by this section, and who is employed or transferred by the Department of Corrections to fill
6 a position designated by the Director of the Department of Corrections as being eligible for police
7 officer status.

8 (q) An employee of the Department of Corrections classified as a police officer on or prior to
9 July 27, 1989, whether or not that classification was authorized by law, as long as the employee
10 remains in the position held on July 27, 1989. The initial classification of an employee under a sys-
11 tem implemented pursuant to ORS 240.190 does not affect police officer status.

12 (r) Employees of a school district who are appointed and duly sworn members of a law
13 enforcement agency of the district as provided in ORS 332.531 or otherwise employed full-time as
14 police officers commissioned by the district.

15 (s) Employees at youth correction facilities and juvenile detention facilities under ORS 419A.050,
16 419A.052 and 420.005 to 420.915 who are required to hold valid Oregon teaching licenses and who
17 have supervisory, control or teaching responsibilities over juveniles committed to the custody of the
18 Department of Corrections or the Oregon Youth Authority.

19 (t) Employees at youth correction facilities as defined in ORS 420.005 whose primary job de-
20 scription involves the custody, control, treatment, investigation or supervision of juveniles placed
21 in such facilities.

22 (u) Employees of the Oregon Youth Authority who are classified as juvenile parole and pro-
23 bation officers.

24 (v) Employees of the Department of Human Services who are prohibited from striking under ORS
25 243.726 and whose duties include the care of residents of residential facilities, as defined in ORS
26 443.400, that house individuals with intellectual or developmental disabilities.

27 (20) "Prior service credit" means credit provided under ORS 238.442 or under ORS 238.225 (2)
28 to (6) (1999 Edition).

29 (21) "Public employer" means the state, one of its agencies, any city, county, or municipal or
30 public corporation, any political subdivision of the state or any instrumentality thereof, or an agency
31 created by one or more such governmental organizations to provide governmental services. For
32 purposes of this chapter, such agency created by one or more governmental organizations is a gov-
33 ernmental instrumentality and a legal entity with power to enter into contracts, hold property and
34 sue and be sued.

35 (22) "Qualifying position" means one or more jobs with one or more participating public em-
36 ployers in which an employee performs 600 or more hours of service in a calendar year, excluding
37 any service in a job for which a participating public employer does not provide benefits under this
38 chapter pursuant to an application made under ORS 238.035.

39 (23) "Regular account" means the account established for each active and inactive member un-
40 der ORS 238.250.

41 (24) "Retired member" means a member who is retired for service or disability.

42 (25) "Retirement credit" means a period of time that is treated as creditable service for the
43 purposes of this chapter.

44 (26)(a) "Salary" means the remuneration paid an employee in cash out of the funds of a public
45 employer in return for services to the employer, plus the monetary value, as determined by the

1 Public Employees Retirement Board, of whatever living quarters, board, lodging, fuel, laundry and
2 other advantages the employer furnishes the employee in return for services.

3 (b) "Salary" includes but is not limited to:

4 (A) Payments of employee and employer money into a deferred compensation plan, which are
5 deemed salary paid in each month of deferral;

6 (B) The amount of participation in a tax-sheltered or deferred annuity, which is deemed salary
7 paid in each month of participation;

8 (C) Retroactive payments described in ORS 238.008; and

9 (D) Wages of a deceased member paid to a surviving spouse or dependent children under ORS
10 652.190.

11 (c) "Salary" or "other advantages" does not include:

12 (A) Travel or any other expenses incidental to employer's business which is reimbursed by the
13 employer;

14 (B) Payments for insurance coverage by an employer on behalf of employee or employee and
15 dependents, for which the employee has no cash option;

16 (C) Payments made on account of an employee's death;

17 (D) Any lump sum payment for accumulated unused sick leave;

18 (E) Any accelerated payment of an employment contract for a future period or an advance
19 against future wages;

20 (F) Any retirement incentive, retirement severance pay, retirement bonus or retirement
21 gratuitous payment;

22 (G) Payments for periods of leave of absence after the date the employer and employee have
23 agreed that no future services qualifying pursuant to ORS 238.015 (3) will be performed, except for
24 sick leave and vacation;

25 (H) Payments for instructional services rendered to public universities listed in ORS 352.002 or
26 the Oregon Health and Science University when such services are in excess of full-time employment
27 subject to this chapter. A person employed under a contract for less than 12 months is subject to
28 this subparagraph only for the months to which the contract pertains;

29 (I) Payments made by an employer for insurance coverage provided to a domestic partner of an
30 employee;

31 (J) Compensation described and authorized under ORS 341.556 that is not paid by the community
32 college employing the faculty member;

33 (K) Compensation described and authorized under ORS 352.232 that is not paid by the public
34 university employing the officer or employee; [or]

35 (L) Compensation described and authorized under ORS 353.270 that is not paid by Oregon Health
36 and Science University[.]; or

37 **(M) For years beginning on or after January 1, 2020, any amount in excess of \$195,000 for**
38 **a calendar year. If any period over which salary is determined is less than 12 months, the**
39 **\$195,000 limitation for that period shall be multiplied by a fraction, the numerator of which**
40 **is the number of months in the determination period and the denominator of which is 12.**
41 **On January 1 of each year, the board shall adjust the dollar limit provided by this subpara-**

40 (2) **A participating public employer shall participate in the program.**

41 [(2)] (3) The board may use moneys in the Employer Incentive Fund established in section 1 [of
42 this 2018 Act], **chapter 105, Oregon Laws 2018,** for reasonable administrative costs incurred under
43 this section.

44 **SECTION 55.** Section 26, chapter 105, Oregon Laws 2018, as amended by section 54 of this 2019
45 Act, is amended to read:

1 **ments.** (1) The amendments to section 3b, chapter 105, Oregon Laws 2018, by section 20 of
2 this 2019 Act apply to lump sum payments made before January 1, 2024.

3 (2) The amendments to section 3b, chapter 105, Oregon Laws 2018, by section 21 of this
4 2019 Act become operative on January 1, 2024.

5 **SECTION 62. Operative date for provisions relating to final average salary.** (1) The

20 **REVIEW BY SUPREME COURT**

21
22 **SECTION 65.** (1) Jurisdiction is conferred upon the Supreme Court to determine in the
23 manner provided by this section whether this 2019 Act breaches any contract between
24 members of the Public Employees Retirement System and their employers or violates any
25 provision of the Oregon Constitution or of the United States Constitution, including but not
26 limited to impairment of contract rights of members of the Public Employees Retirement
27 System under Article I, section 21, of the Oregon Constitution, or Article I, section 10, clause
28 1, of the United States Constitution.

29 (2) A person who is adversely affected by this 2019 Act or who will be adversely affected
30 by this 2019 Act may institute a proceeding for review by filing with the Supreme Court a
31 petition that meets the following requirements:

32 (a) The petition must be filed within 60 days after the effective date of this 2019 Act.

33 (b) The petition must include the following:

34 (A) A statement of the basis of the challenge; and

35 (B) A statement and supporting affidavit showing how the petitioner is adversely af-
36 fected.

37 (3) The petitioner shall serve a copy of the petition by registered or certified mail upon
38 the Public Employees Retirement Board, the Attorney General and the Governor.

39 (4) Proceedings for review under this section shall be given priority over all other mat-
40 ters before the Supreme Court.

41 (5) The Supreme Court shall allow public employers participating in the Public Employees
42 Retirement System to intervene in any proceeding under this section.

43 (6)(a) The Supreme Court shall allow members of the Legislative Assembly to intervene
44 in any proceeding relating to this 2019 Act. After a member intervenes in a proceeding re-
45 lating to this 2019 Act, the member has standing to participate in the proceeding even if the

1 member ceases to be a member of the Legislative Assembly.

2 (b) A member of the Senate or the House of Representatives who intervenes in a pro-
3 ceeding under this subsection may not use public funds to pay legal expenses incurred in
4 intervening in or participating in the proceeding.

5 (7) In the event the Supreme Court determines that there are factual issues in the peti-
6 tion, the Supreme Court may appoint a special master to hear evidence and to prepare re-
7 commended findings of fact.

8 (8) The Supreme Court may not award attorney fees to a petitioner in a proceeding under
9 this section.

13 **SECTION 66.** The unit and section captions used in this 2019 Act are provided only for
14 the convenience of the reader and do not become part of the statutory law of this state or
15 express any legislative intent in the enactment of this 2019 Act.

17 **EMERGENCY CLAUSE**

19 **SECTION 67.** This 2019 Act being necessary for the immediate preservation of the public
20 peace, health and safety, an emergency is declared to exist, and this 2019 Act takes effect
21 on its passage.
