SENATE AMENDMENTS TO SENATE BILL 130

Delete lines 4 through 23 of the printed bill and insert: 1 2 "SECTION 1. (1) As used in this section: 3 "(a) 'Distant site' means the site where a physician licensed under ORS chapter 677, or other licensed health care practitioner, who provides health care services through telehealth 4 is located at the time the physician or licensed health care practitioner provides the health $\mathbf{5}$ care service through telehealth. 6 "(b) 'Originating site' means the site where the patient is located at the time the patient 7 receives health care services provided through telehealth. 8 9 "(c) 'School-based health center' has the meaning given that term in ORS 413.225. 10 "(d) 'School nurse' means: "(A) A school nurse as defined in ORS 342.455; or 11 12"(B) A registered nurse who is an employee or contractor of a school district and who 13 practices nursing in a school setting. 14 "(e) 'Telehealth' means the use of electronic and telecommunication technologies to de-15liver health care services to a patient. "(2)(a) The Oregon Health Authority shall award grant moneys to an eligible school-based 16 17 health center pilot project to expand student access to mental and physical health care ser-18 vices and to improve the health and education outcomes of students through the use of 19 telehealth. 20 (b) To be eligible for a grant under this subsection, a school-based health center shall 21enter into a pilot project agreement with a school district. The pilot project agreement must 22provide that: 23 "(A) The school-based health center is the distant site that provides telehealth in con-24 junction with a school nurse located at the originating site; and 25"(B) The school-based health center will allocate to the school district a portion of funds 26received under this subsection to increase school nurse capacity and assist in offsetting costs 27incurred by the school district as a result of the school district's participation in the pilot 28project. 29"(c) Funds described in this subsection may be used to: "(A) Compensate the following individuals for services provided pursuant to a pilot 30 31 project: 32"(i) A school nurse; 33 "(ii) A licensed health care practitioner located at a school-based health center; and "(iii) Administrative or technical staff at a school-based health center; 34 35 "(B) Cover the costs of:

1 "(i) Technical equipment necessary to provide telehealth; and

2 "(ii) Technical assistance related to the use and function of equipment necessary to 3 provide telehealth; and

"(C) Cover other costs related to the pilot project's provision of telehealth.

"(3) The authority:

6 "(a) Shall assist school-based health centers and school districts that enter into pilot 7 project agreements in the efficient use of funds distributed under subsection (2) of this sec-8 tion.

9 "(b) May coordinate with one or more statewide nonprofit organizations that have expe10 rience in supporting school-based health centers and school nurses to carry out this section.
11 "(4) A school-based health center that operates a pilot project shall report, on an interval

determined by the authority, to the authority on the progress of the pilot project in a manner that allows the authority to determine the effectiveness of the pilot project.

14 "(5) The authority shall establish a process to evaluate at least the following information 15 regarding a pilot project established under this section:

- 16 "(a) Billing practices and reimbursements;
- 17 "(b) Access to health care services;

18 "(c) Impact on student absence from schools; and

19 "(d) Workflow practices.

"(6) Not later than December 31, 2023, the authority shall submit a report, in the manner provided in ORS 192.245, to an interim committee of the Legislative Assembly related to health care, on the effectiveness and success of pilot projects established under this section. The authority may include in the report submitted under this subsection recommendations for legislation.

25 "<u>SECTION 2.</u> There is appropriated to the Oregon Health Authority, for the biennium 26 beginning July 1, 2019, out of the General Fund, the amount of \$950,000 for the purpose of 27 carrying out the provisions of section 1 of this 2019 Act.

28 "SECTION 3. Section 1 of this 2019 Act is repealed on January 2, 2024.

²⁹ "<u>SECTION 4.</u> (1) Section 1 of this 2019 Act becomes operative on January 1, 2020.

"(2) The Oregon Health Authority may take any action before the operative date specified in subsection (1) of this section that is necessary to enable the authority to exercise, on and after the operative date specified in subsection (1) of this section, all of the duties, functions and powers conferred on the authority by section 1 of this 2019 Act.

"<u>SECTION 5.</u> This 2019 Act takes effect on the 91st day after the date on which the 2019
 regular session of the Eightieth Legislative Assembly adjourns sine die.".
