On page 25 of the printed A-engrossed bill, delete lines 28 through 31 and insert:

"SECTION 21. Notwithstanding any other provision of law, the General Fund appropriation made to the Department of Human Services by section 1 (1), chapter ____, Oregon Laws 2019 (Enrolled House Bill 5026), for central services and state assessments and enterprise-wide costs, for the biennium beginning July 1, 2019, is increased by \$1,344,780 for the purpose of complying with the requirements of this 2019 Act.

"SECTION 21a. Notwithstanding any other provision of law, the General Fund appropriation made to the Department of Human Services by section 1 (3), chapter ____, Oregon Laws 2019 (Enrolled House Bill 5026), for child welfare, for the biennium beginning July 1, 2019, is increased by \$1,116,115 for the purpose of complying with the requirements of this 2019 Act.

"SECTION 21b. Notwithstanding any other law limiting expenditures, the limitation on expenditures established by section 2 (5), chapter ____, Oregon Laws 2019 (Enrolled House Bill 5026), for the biennium beginning July 1, 2019, as the maximum limit for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts and Medicare receipts and including federal funds for indirect cost recovery, Social Security Supplemental Security Income recoveries and the Child Care and Development Fund, but excluding lottery funds and federal funds not described in this section, collected or received by the Department of Human Services, for shared services, is increased by \$820,749 for the purpose of complying with the requirements of this 2019 Act.

"SECTION 21c. Notwithstanding any other law limiting expenditures, the limitation on expenditures established by section 3 (1), chapter ___, Oregon Laws 2019 (Enrolled House Bill 5026), for the biennium beginning July 1, 2019, as the maximum limit for payment of expenses from federal funds, excluding federal funds described in section 2, chapter ___, Oregon Laws 2019 (Enrolled House Bill 5026), collected or received by the Department of Human Services, for central services and state assessments and enterprise-wide costs, is increased by \$392,329 for the purpose of complying with the requirements of this 2019 Act.".

On page 31, delete lines 22 through 26 and insert:

"SECTION 30. Notwithstanding any other law limiting expenditures, the limitation on expenditures established by section 1, chapter ____, Oregon Laws 2019 (Enrolled Senate Bill 5537), for the biennium beginning July 1, 2019, as the maximum limit for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Teacher Standards and Practices Commission, is increased by \$525,000 for the purpose of complying with the requirements of section 23 of this 2019 Act."

On page 33, delete lines 28 through 31 and insert:
