SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Includes federally recognized Indian tribes located in this state among parties to whom Oregon Business Development Department may provide grants from Regional Infrastructure Fund.]

Requires that moneys in Regional Infrastructure Fund be used for disbursements to federally recognized Indian tribes in this state for specified purposes.

2 Relating to the Regional Infrastructure Fund; amending section 3, chapter 786, Oregon Laws 2013.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** Section 3, chapter 786, Oregon Laws 2013, as amended by section 3, chapter 812,
5 Oregon Laws 2015, and section 4, chapter 748, Oregon Laws 2017, is amended to read:

6 **Sec. 3.** (1) The Regional Infrastructure Fund is established in the State Treasury, separate and
7 distinct from the General Fund. Interest earned on the moneys in the Regional Infrastructure Fund
8 shall be credited to the fund. The Regional Infrastructure Fund consists of moneys deposited in the
9 fund under section 2, chapter 786, Oregon Laws 2013, *[and]* section 2, chapter 812, Oregon Laws
10 2015, and section 3 *[of this 2017 Act]*, **chapter 748, Oregon Laws 2017**, and may include fees, re-
11 venues or other income deposited into the fund by the Legislative Assembly.

12 (2) Moneys in the fund are continuously appropriated to the Oregon Business Development De-
13 partment for disbursement to local governments **and federally recognized Indian tribes located**
14 **in this state** for the purposes set forth in section 2, chapter 786, Oregon Laws 2013, *[and]* section
15 2, chapter 812, Oregon Laws 2015, and section 3 *[of this 2017 Act]*, **chapter 748, Oregon Laws**
16 **2017.**
