

Senate Bill 26

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Governor Kate Brown for Oregon Health Authority)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Directs Director of the Oregon Health Authority or director's designee to discharge employee at facility under jurisdiction of authority if it has been substantiated that employee physically or sexually abused patient or client.

Declares emergency, effective on passage.

A BILL FOR AN ACT

2 Relating to employees at facilities under the jurisdiction of the Oregon Health Authority; creating
3 new provisions; amending ORS 179.390; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 179.390 is amended to read:

6 179.390. (1) The superintendent of an institution within the jurisdiction of the Department of
7 Corrections shall, subject to the approval of the Director of the Department of Corrections, appoint
8 in the manner provided by law all assistants, officers and other employees at the institution under
9 the jurisdiction of the superintendent. The superintendent may suspend or remove an assistant, of-
10 ficer or other employee in the manner provided by law, reporting all acts of suspension or removal
11 to the Director of the Department of Corrections for approval or disapproval.

12 **(2) The Director of the Oregon Health Authority or a designee at a facility under the**
13 **jurisdiction of the Oregon Health Authority shall, as provided by law, appoint, suspend or**
14 **discharge an employee of the authority. The director or a designee shall discharge an em-**
15 **ployee at a facility under the jurisdiction of the authority if it has been substantiated that**
16 **the employee physically or sexually abused a patient or client.**

17 [(2)] **(3)** The Director of the Department of Corrections and the Director of the Oregon Health
18 Authority shall:

19 (a) Fix the salaries of assistants, officers and employees where their salary is not fixed by law.

20 (b) Suspend or discharge any subordinate of a superintendent when public service requires such
21 action, except when suspending or discharging the subordinate violates the State Personnel Re-
22 lations Law **under ORS chapter 240**.

23 [(3)] **(4)** [*The Director of the Oregon Health Authority or a designee at a facility under jurisdiction*
24 *of the Oregon Health Authority shall, as provided by law, appoint, suspend or discharge an employee*
25 *of the authority.*] The Director **of the Oregon Health Authority** may designate up to three em-
26 ployees at each facility **under the jurisdiction of the Oregon Health Authority** to act in the name
27 of the director in accordance with ORS 240.400.

28 [(4)] **(5)** In addition to or in lieu of employing physicians, the Director of the Department of
29 Corrections or the designee of the director may contract for the personal services of physicians li-

1 censed to practice medicine by the Oregon Medical Board or naturopathic physicians licensed under
2 ORS chapter 685 to serve as medical advisors for the Oregon Health Authority. Advisors under
3 contracts entered into under this subsection shall be directly responsible for administration of
4 medical treatment programs at penal and correctional institutions, as defined in ORS 421.005.

5 **SECTION 2. The amendments to ORS 179.390 by section 1 of this 2019 Act apply only to**
6 **incidents of physical and sexual abuse occurring on or after the effective date of this 2019**
7 **Act.**

8 **SECTION 3. This 2019 Act being necessary for the immediate preservation of the public**
9 **peace, health and safety, an emergency is declared to exist, and this 2019 Act takes effect**
10 **on its passage.**
