SUMMARY

3 **SECTION 2.** ORCP 69 C is amended to read:

4 C Motion for order of default.

5 C(1) The party seeking default must file a motion for order of default. That motion must be ac-
6 companied by an affidavit or declaration to support that default is appropriate and contain facts
7 sufficient to establish the following:

8 C(1)(a) that the party to be defaulted has been served with summons pursuant to Rule 7 or is
9 otherwise subject to the jurisdiction of the court;

10 C(1)(b) that the party against whom the order of default is sought has failed to appear by filing
11 a motion or answer, or otherwise to defend as provided by these rules or applicable statute;

12 C(1)(c) whether written notice of intent to appear has been received by the movant and, if so,
13 whether written notice of intent to apply for an order of default was filed and served at least 10
14 days, or any shortened period of time ordered by the court, prior to filing the motion;

15 C(1)(d) whether, to the best knowledge and belief of the party seeking an order of default, the
16 party against whom judgment is sought is or is not incapacitated as defined in ORS 125.005, a minor,

34 18.358. (1) As used in this section:

35 (a) “Beneficiary” means a person for whom retirement plan benefits are provided or their
36 spouse.

37 (b) “Internal Revenue Code” means the federal Internal Revenue Code as amended and in effect
38 on December 31, 1998.

39 (c) “Permitted contribution” means:

40 (A) A contribution that, at the time of the contribution, is not taxable income to the beneficiary
41 and, if the sponsor is a taxable entity, is tax deductible to the sponsor;

42 (B) A nondeductible contribution by a beneficiary to a retirement plan to the extent that the
43 contribution is permitted to be made under the Internal Revenue Code;

44 (C) A deductible or nondeductible contribution to an individual retirement account to the extent
45 the contribution is not subject to federal excise tax as an excess contribution;

1 (D) A contribution, pursuant to a rollover or transfer, from one retirement plan to another, to
2 the extent the federal tax deferred status is preserved at such time;

3 (E) A rollover from an individual retirement account described in section 408 of the Internal
4 Revenue Code to an individual retirement account described in section 408A of the Internal Revenue
5 Code; and

6 (F) Any earnings under a retirement plan *[which]* **that** are attributable to a contribution de-

12 (B) An individual retirement account or annuity, including one that is pursuant to a simplified

23 other process, mesne or final.

35 18.600. As used in ORS 18.600 to 18.850:

36 (1) "Account" means an account at a financial institution, including a master account or sub-
37 account, to which an electronic payment may be directly routed.

38 (2) "Check" has the meaning given that term in ORS 73.0104.

39 (3) "Creditor" means a person to whom a debt is owed by a debtor.

40 (4) "Debt" means any monetary obligation for which a garnishment may be issued under ORS
41 18.605.

42 (5) "Debtor" means a person whose property is being garnished for the purpose of paying a debt
43 owed to a creditor.

44 (6) "Federal benefit payment" means:

45 (a) A benefit payment from the United States Social Security Administration that is protected

1 under 42 U.S.C. 407 and 1383(d)(1);

2 (b) A benefit payment from the United States Department of Veterans Affairs that is protected
3 under 38 U.S.C. 5301(a);

4 (c) A benefit payment from the Railroad Retirement Board that is protected under 45 U.S.C.
5 231m(a) and 352(e); or

6 (d) A benefit payment from the United States Office of Personnel Management that is protected
7 under 5 U.S.C. 8346 and 8470.

8 (7) "Financial institution" means a financial institution or trust company as those terms are
9 defined in ORS 706.008.

10 (8) "Garnishable property" means all property described in ORS 18.615, but does not include:

11 (a) Any property that is not subject to garnishment under ORS 18.618; and

12 (b) Any property that is applied as a setoff under ORS 18.620 or 18.795.

13 (9) "Garnishee" means a person to whom a writ of garnishment has been delivered.

14 (10) "Garnishment account review" means the process of examining deposits to an account to
15 determine whether benefit payments described in ORS 18.784 (3) have been deposited in the account
16 during the lookback period.

17 (11) "Garnishor" means:

18 (a) The creditor, if the writ is issued by the court administrator on behalf of the creditor under
19 ORS 18.635 (2); or

20 (b) The issuer, if the writ is issued under ORS 18.635 by any person other than the court ad-
21 ministrator.

22 (12) "Past due support" means the amount of child or spousal support, or both, determined under
23 a court or administrative order in a proceeding under **ORS 416.400 to 416.465** or ORS chapter 107,
24 108, 109, 110, [416,] 419B or 419C that has not been paid or is certified to be owed by another state
25 under ORS 25.083.

26 (13) "Wages" includes all amounts paid for the services of an employee by an employer, includ-
27 ing amounts paid as a commission or bonus.

31 **SECTION 5.** ORS 25.010 is amended to read:

32 25.010. As used in **ORS 416.400 to 416.465** and ORS chapters 25, 107[,] **and** 109 [*and 416*] and
33 any other statutes providing for support payments or support enforcement procedures, unless the
34 context requires otherwise:

35 (1) "Administrator" means either the Administrator of the Division of Child Support of the De-
36 partment of Justice or a district attorney, or the administrator's or a district attorney's authorized
37 representative.

38 (2) "Child" has the meaning given that term in ORS 110.503.

39 (3) "Child support rights" means the right to establish or enforce an obligation imposed or
40 imposable by law to provide support, including but not limited to medical support as defined in ORS
41 25.321 and an unsatisfied obligation to provide support.

42 (4) "Department" means the Department of Justice.

43 (5) "Disposable income" means that part of the income of an individual remaining after the de-
44 duction from the income of any amounts required to be withheld by law except laws enforcing
45 spousal or child support and any amounts withheld to pay medical or dental insurance premiums.

1 (6) "Employer" means any entity or individual who engages an individual to perform work or
2 services for which compensation is given in periodic payments or otherwise.

3 (7) "Income" is any monetary obligation in excess of \$4.99 after the fee described in ORS 25.414
4 (6) has been deducted that is in the possession of a third party owed to an obligor and includes but
5 is not limited to:

6 (a) Compensation paid or payable for personal services whether denominated as wages, salary,
7 commission, bonus or otherwise;

8 (b) Periodic payments pursuant to a pension or retirement program;

9 (c) Cash dividends arising from stocks, bonds or mutual funds;

10 (d) Interest payments;

11 (e) Periodic payments from a trust account;

12 (f) Any program or contract to provide substitute wages during times of unemployment or disa-
13 bility;

14 (g) Any payment pursuant to ORS chapter 657; or

15 (h) Amounts payable to independent contractors.

16 (8) "Obligee" has the meaning given that term in ORS 110.503.

17 (9) "Obligor" has the meaning given that term in ORS 110.503.

18 (10) "Order to withhold" means an order or other legal process that requires a withholder to
19 withhold support from the income of an obligor.

20 (11) "Public assistance" has the meaning given that term in ORS 416.400.

21 (12) "Withholder" means any person who disburses income and includes but is not limited to an
22 employer, conservator, trustee or insurer of the obligor.

23 **NOTE:** Eliminates inappropriate chapter reference and substitutes appropriate series reference
24 in lead-in.

25 **SECTION 6.** ORS 25.011 is amended to read:

26 25.011. As used in **ORS 416.400 to 416.465** and ORS chapters 25, 106, 107, 108, 109[,] **and** 110
27 [*and 416*], when a person is required to provide an address, "address" means a residence, mailing
28 or contact address in the same state as the person's home.

30 **SECTION 7.** ORS 25.020 is amended to read:

31 25.020. (1) Support payments for or on behalf of any person that are ordered, registered or filed
32 under **ORS 416.400 to 416.465** or this chapter or ORS chapter 107, 108, 109, 110, [*416,*] 419B or 419C,
33 unless otherwise authorized by ORS 25.030, shall be made to the Department of Justice as the state
34 disbursement unit:

35 (a) During periods for which support is assigned under ORS 412.024, 418.032, 419B.406 or
36 419C.597;

37 (b) As provided by rules adopted under ORS 180.345, when public assistance is provided to a
38 person who receives or has a right to receive support payments on the person's own behalf or on
39 behalf of another person;

40 (c) After the assignment of support terminates for as long as amounts assigned remain owing;

41 (d) For any period during which support enforcement services are provided under ORS 25.080;

42 (e) When ordered by the court under ORS 419B.400;

43 (f) When a support order that is entered or modified on or after January 1, 1994, includes a
44 provision requiring the obligor to pay support by income withholding; or

45 (g) When ordered by the court under any other applicable provision of law.

1 (2)(a) The Department of Justice shall disburse payments, after lawful deduction of fees and in
2 accordance with applicable statutes and rules, to those persons and entities that are lawfully enti-
3 tled to receive such payments.

4 (b) During a period for which support is assigned under ORS 412.024, for an obligee described
5 in subsection (1)(b) of this section, the department shall disburse to the obligee, from child support
6 collected each month, \$50 for each child up to a maximum of \$200 per family.

7 (3)(a) When the administrator is providing support enforcement services under ORS 25.080, the
8 obligee may enter into an agreement with a collection agency, as defined in ORS 697.005, for as-
9 sistance in collecting child support payments.

10 (b) The collection agency:

11 (A) May provide investigative and location services to the obligee and disclose relevant infor-
12 mation from those services to the administrator for purposes of providing support enforcement ser-
13 vices under ORS 25.080;

14 (B) May not charge interest or a fee for its services exceeding 29 percent of each support pay-
15 ment received unless the collection agency, if allowed by the terms of the agreement between the
16 collection agency and the obligee, hires an attorney to perform legal services on behalf of the
17 obligee;

18 (C) May not initiate, without written authorization from the administrator, any enforcement
19 action relating to support payments on which support enforcement services are provided by the ad-
20 ministrator under ORS 25.080; and

21 (D) Shall include in the agreement with the obligee a notice printed in type size equal to at least
22 12-point type that provides information on the fees, penalties, termination and duration of the
23 agreement.

24 (c) The administrator may use information disclosed by the collection agency to provide support
25 enforcement services under ORS 25.080.

26 (4) The Department of Justice may immediately transmit to the obligee payments received from
27 any obligor without waiting for payment or clearance of the check or instrument received if the
28 obligor has not previously tendered any payment by a check or instrument that was not paid or was
29 dishonored.

30 (5) The Department of Justice shall notify each obligor and obligee by mail when support pay-
31 ments shall be made to the department and when the obligation to make payments in this manner
32 shall cease.

33 (6)(a) The administrator shall provide information about a child support account directly to a
34 party to the support order regardless of whether the party is represented by an attorney. As used
35 in this subsection, "information about a child support account" means the:

36 (A) Date of issuance of the support order.

37 (B) Amount of the support order.

38 (C) Dates and amounts of payments.

39 (D) Dates and amounts of disbursements.

40 (E) Payee of any disbursements.

41 (F) Amount of any arrearage.

42 (G) Source of any collection, to the extent allowed by federal law.

43 (b) Nothing in this subsection limits the information the administrator may provide by law to a
44 party who is not represented by an attorney.

45 (7) Any pleading for the entry or modification of a support order must contain a statement that

1 payment of support under a new or modified order will be by income withholding unless an excep-
2 tion to payment by income withholding is granted under ORS 25.396.

3 (8)(a) Except as provided in paragraphs (d) and (e) of this subsection, a judgment or order es-
4 tablishing parentage or including a provision concerning support must contain:

5 (A) The residence, mailing or contact address, final four digits of the Social Security number,
6 telephone number and final four digits of the driver license number of each party;

7 (B) The name, address and telephone number of all employers of each party;

8 (C) The names and dates of birth of the joint children of the parties; and

9 (D) Any other information required by rule adopted by the Chief Justice of the Supreme Court
10 under ORS 1.002.

11 (b) The judgment or order shall also include notice that the obligor and obligee:

12 (A) Must inform the court and the administrator in writing of any change in the information
13 required by this subsection within 10 days after the change; and

14 (B) May request that the administrator review the amount of support ordered after three years,
15 or such shorter cycle as determined by rule of the Department of Justice, or at any time upon a
16 substantial change of circumstances.

17 (c) The administrator may require of the parties any additional information that is necessary for
18 the provision of support enforcement services under ORS 25.080.

19 (d)(A) Upon a finding, which may be made ex parte, that the health, safety or liberty of a party
20 or child would unreasonably be put at risk by the disclosure of information specified in this sub-
21 section or by the disclosure of other information concerning a child or party to a parentage or
22 support proceeding or if an existing order so requires, a court or administrator or administrative
23 law judge, when the proceeding is administrative, shall order that the information not be contained
24 in any document provided to another party or otherwise disclosed to a party other than the state.

25 (B) The Department of Justice shall adopt rules providing for similar confidentiality for infor-
26 mation described in subparagraph (A) of this paragraph that is maintained by an entity providing
27 support enforcement services under ORS 25.080.

28 (e) The Chief Justice of the Supreme Court may, in consultation with the Department of Justice,
29 adopt rules under ORS 1.002 to designate information specified in this subsection as confidential and
30 require that the information be submitted through an alternate procedure to ensure that the infor-
31 mation is exempt from public disclosure under ORS 192.355.

32 (9)(a) Except as otherwise provided in paragraph (b) of this subsection, in any subsequent child
33 support enforcement action, the court or administrator, upon a showing of diligent effort made to
34 locate the obligor or obligee, may deem due process requirements to be met by mailing notice to the
35 last-known residential, mailing or employer address or contact address as provided in ORS 25.085.

36 (b) Service of an order directing an obligor to appear in a contempt proceeding is subject to
37 ORS 33.015 to 33.155.

38 (10) Subject to ORS 25.030, this section, to the extent it imposes any duty or function upon the
39 Department of Justice, shall be deemed to supersede any provisions of **ORS 416.400 to 416.465 and**
40 **ORS chapters 107, 108, 109, 110, [416,] 419A, 419B and 419C** that would otherwise impose the same
41 duties or functions upon the county clerk or the Department of Human Services.

42 (11) Except as provided for in subsections (12), (13) and (14) of this section, credit may not be
43 given for payments not made to the Department of Justice as required under subsection (1) of this
44 section.

45 (12) The Department of Justice shall give credit for payments not made to the department:

1 (a) When payments are not assigned to this or another state and the obligee and obligor agree
2 in writing that specific payments were made and should be credited, limited to the current balance
3 owed to the obligee;

4 (b) When payments are assigned to another state and that state verifies that payments not paid
5 to the department were received by the other state; or

6 (c) As provided by rule adopted under ORS 180.345.

7 (13) An obligor may apply to the Department of Justice for credit for payments made other than
8 to the Department of Justice. If the obligee or other state does not provide the agreement or ver-
9 ification required by subsection (12) of this section, credit may be given pursuant to order of an
10 administrative law judge assigned from the Office of Administrative Hearings after notice and op-
11 portunity to object and be heard are given to both obligor and obligee. Notice shall be served upon
12 the obligee as provided by ORS 25.085. Notice to the obligor may be by regular mail at the address
13 provided in the application for credit. A hearing conducted under this subsection is a contested case
14 hearing and ORS 183.413 to 183.470 apply. Any party may seek a hearing de novo in the circuit
15 court.

16 (14) Nothing in this section precludes the Department of Justice from giving credit for payments
17 not made to the department when there has been a judicially determined credit or satisfaction or
18 when there has been a satisfaction of support executed by the person to whom support is owed.

19 (15) The Department of Justice shall adopt rules that:

20 (a) Direct how support payments that are made through or credited by the department are to
21 be applied and, if applicable, disbursed; and

22 (b) Are consistent with federal regulations.

23 **NOTE:** Eliminates inappropriate chapter reference and substitutes appropriate series reference
24 in (1) and (10).

25 **SECTION 8.** ORS 25.080 is amended to read:

26 25.080. (1) The following entity is primarily responsible for providing the support enforcement
27 services described in subsection (4) of this section when an application as described in ORS 25.084
28 is made, or when an assignment of support rights is made to the state:

29 (a) The Division of Child Support of the Department of Justice:

30 (A) If support rights are, or were within the past five months, assigned to this or another state;
31 or

32 (B) In any case where arrearage under a support order is assigned or owed to or the right to
33 recover back support or state debt is held by this state or another state.

34 (b) Except as provided in subsection (6) of this section, the district attorney in cases other than
35 those described in paragraph (a) of this subsection if an application as described in ORS 25.084 is
36 made by the obligee, by the obligor, by a person having physical custody of a minor child or by a
37 child attending school, as defined in ORS 107.108.

38 (2) The provisions of this section apply to support enforcement services for any order or judg-
39 ment that is or could be entered under ORS **416.400 to 416.465**, 419B.400 or 419C.590 or ORS
40 chapter 107, 108, 109[,] **or** 110 [*or 416*]. The entity specified in subsection (1) of this section shall
41 provide the support enforcement services on behalf of the State of Oregon and not on behalf of any
42 other party or on behalf of a parent. The Department of Justice shall adopt rules addressing the
43 provision of support enforcement services when the purposes of the state in providing those services
44 may be contradictory in individual cases.

45 (3) Notwithstanding the division of responsibility for providing support enforcement services

1 between the Division of Child Support and the district attorney as described in subsection (1) of this
2 section, provision of support enforcement services may not be challenged on the basis that the entity
3 providing the services in a particular case is not the entity responsible for the case under subsection
4 (1) of this section.

5 (4) When responsible for providing support enforcement services and there is sufficient evidence
6 available to support the action to be taken, the entity described in subsection (1) of this section:

7 (a) Shall establish and enforce any child support obligation;

8 (b) Shall establish paternity;

10 support enforcement services are being provided and those services are funded in part by federal
11 moneys;

12 (d) May enforce any other order or judgment for spousal support;

13 (e) Shall, on behalf of the state, initiate and respond to child support modification proceedings
14 based upon a substantial change of circumstances;

15 (f) Shall, on behalf of the state, initiate and respond to child support modification proceedings
16 based upon a modification conducted under ORS 25.287 concerning existing child support orders;

17 (g) Shall establish and enforce obligations to provide medical insurance coverage for dependent
18 children;

19 (h) Shall ensure compliance with the provisions of 42 U.S.C. 651 to 669 and 45 C.F.R. Chapter
20 III as authorized by state law;

21 (i) Shall carry out the policy of the State of Oregon regarding child support obligations as ex-

23 (j) Shall ensure that child support orders are in compliance with the formula established by this

25 (5) In any proceeding under subsection (4) of this section, the parties are those described in ORS

27 (6) The district attorney of any county and the department may provide by agreement for as-
28 sumption by the Division of Child Support of the functions of the district attorney under subsection

41 (d) If the provisions of this subsection are determined by a court to be invalid or ineffective with
42 respect to any person or claim for any reason, the association shall reduce the amount payable by
43 the association with respect to the related covered obligations by the amount realized by any other
44 person with respect to the person or claim that is attributable to the policies or contracts covered
45 by the association.

1 (e) If the association provides benefits with respect to a covered obligation and a person re-
 2 covers amounts to which the association has rights as described in this subsection, the person shall
 3 pay to the association the portion of the recovery attributable to the policies or contracts covered
 4 by the association.

5 (11) The contractual obligations of the impaired or insolvent insurer for which the association
 6 becomes or may become liable may not exceed the [lesser] least of:

7 (a) The contractual obligations for which the impaired or insolvent insurer is liable or would
 8 have been liable if it were not an impaired or insolvent insurer, unless such obligations are reduced
 9 as permitted by subsection (6) of this section;

10 (b) With respect to any one life, regardless of the number of policies or contracts:

11 (A) \$300,000 in life insurance death benefits, but not more than \$100,000 in net cash surrender
 12 and net cash withdrawal values for life insurance.

13 (B) \$100,000 in health insurance benefits other than basic hospital, medical and surgical insur-
 14 ance, major medical insurance, disability insurance or long term care insurance, including any net
 15 cash surrender and net cash withdrawal values.

16 (C) \$300,000 in disability insurance benefits.

17 (D) \$300,000 in long term care insurance benefits.

18 (E) \$500,000 in basic hospital, medical and surgical insurance or major medical insurance.

19 (F) \$250,000 in the present value of annuity benefits, including any net cash surrender and net
 20 cash withdrawal values;

21 (c) With respect to each payee of a structured settlement annuity or the beneficiary of the payee
 22 if deceased, \$250,000 in the present value of annuity benefits, in the aggregate, including any net
 23 cash surrender and net cash withdrawal values; or

24 (d) \$250,000 in the present value of annuity benefits, in the aggregate, including any net cash
 25 surrender and net cash withdrawal values, with respect to each individual participating in a gov-
 26 ernmental retirement plan established under section 401, 403(b) or 457 of the United States Internal
 27 Revenue Code covered by an unallocated annuity contract or the beneficiaries of each such indi-
 28 vidual if deceased.

29 (12) The association may not be liable for more than:

30 (a) \$300,000 in benefits, in the aggregate, with respect to any one life under subsection (11)(b),
 31 (c) and (d) of this section, with the exception of benefits under subsection (11)(b)(E) of this section,
 32 in which case the aggregate liability of the association may not exceed \$500,000 with respect to any
 33 one life.

34 (b) With respect to one policyholder of multiple nongroup policies of life insurance, regardless
 35 of whether the policyholder is an individual, firm, corporation or other person, and whether the
 36 persons insured are officers, managers, employees or other persons, \$5 million in benefits, regardless
 37 of the number of policies and contracts held by the policyholder.

38 (13) The limitations set forth in subsections (11) and (12) of this section are limitations on the

 40 assignment rights or the extent to which those benefits could be provided out of the assets of the

4 (15) The association may:

5 (a) Enter into such contracts as are necessary or proper to carry out the provisions and pur-

7 (b) Sue or be sued, including taking any legal actions necessary or proper for recovery of any
8 unpaid assessments under ORS 734.815 and to settle claims or potential claims against the associ-
9 ation.

10 (c) Borrow money to effect the purposes of ORS 734.750 to 734.890. Any notes or other evidence
11 of indebtedness of the association not in default shall be legal investments for member insurers and
12 may be carried as admitted assets.

13 (d) Employ or retain such persons as are necessary to handle the financial transactions of the
14 association, and to perform such other functions as become necessary or proper under ORS 734.750
15 to 734.890.

16 (e) Negotiate and contract with any liquidator, rehabilitator, conservator or ancillary receiver
17 to carry out the powers and duties of the association.

18 (f) Take such legal action as may be necessary to avoid payment of improper claims.

19 (g) Exercise, for the purposes of ORS 734.750 to 734.890 and to the extent approved by the di-
20 rector, the powers of a member life or health insurer, but in no case may the association issue pol-
21 icies other than those issued to perform the contractual obligations of the impaired or insolvent

23 (h) Organize itself as a corporation or other legal form permitted by the laws of this state.

24 (i) Request information from a person seeking coverage from the association to aid the associ-
25 ation in determining its obligations under ORS 734.750 to 734.890 with respect to that person.

26 (j) Take any other necessary or appropriate action to discharge its duties and obligations and
27 to exercise its powers under ORS 734.750 to 734.890.

28 (16) The duties and powers of the association described in this section are in addition to any
29 other duties and powers of the association described in ORS 734.750 to 734.890.

30 (17)(a) Within 180 days after the date of the order of liquidation, the association may succeed
31 to the rights and obligations of the ceding member insurer that relate to policies or annuities cov-
32 ered, in whole or in part, by the association, in each case under any one or more reinsurance con-
33 tracts entered into by the insolvent insurer and its reinsurers and selected by the association. Any
34 such assumption shall be effective as of the date of the order of liquidation. The election shall be
35 effected by the association sending written notice, return receipt requested, to the affected reinsur-

42 should be assumed, and notices of any defaults under the reinsurance contracts or any known event

44 (c) For any reinsurance contracts assumed by the association under paragraphs (a) and (b) of
45 this subsection:

1 (A) The association is responsible for all unpaid premiums due under the reinsurance contracts
2 for periods both before and after the date of the order of liquidation, and shall be responsible for
3 the performance of all other obligations to be performed after the date of the order of liquidation,
4 related to policies or annuities covered by the reinsurance contract, in whole or in part, by the as-
5 sociation. The association may charge policies or annuities covered in part by the association,
6 through reasonable allocation methods, the costs for reinsurance in excess of the obligations of the
7 association and shall provide notice and an accounting of those charges to the liquidator.

11 receipt of any such amounts, the association shall pay the beneficiary under the policy or annuity
12 on account of which the amounts were paid a portion of the amount equal to the lesser of:

13 (i) The amount received by the association; or

14 (ii) The amount received by the association that is in excess of the amount equal to the benefits
15 paid by the association on account of the policy or annuity minus the amount retained by the
16 insurer applicable to the loss or event.

17 (C) Within 30 days following the association's election, the association and each reinsurer shall
18 calculate the net balance due to or from the association under each reinsurance contract as of the
19 election date with respect to policies or annuities covered, in whole or in part, by the association.
20 The calculation shall give full credit to all items paid by the insurer or its receiver or by the re-
21 insurer prior to the election date. The reinsurer shall pay the receiver any amounts due for losses
22 or events prior to the date of the order of liquidation, subject to any setoff for premiums unpaid for
23 periods prior to that date, and the association or the reinsurer shall pay any remaining balance due
24 to one another. The reinsurer and the association shall make such payments within five days after
25 the completion of the calculation of the net balance due under each reinsurance contract. Any dis-
26 putes over the amounts due to the association or the reinsurer shall be resolved by arbitration ac-
27 cording to the terms of the affected reinsurance contracts or, if the contract contains no arbitration
28 clause, as otherwise provided by law. If the receiver has received any amounts due the association
29 under subparagraph (B) of this paragraph, the receiver shall remit the amounts to the association
30 as promptly as practicable.
