## **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Modifies oil spill prevention fees. Applies to fees assessed on or after effective date. Takes effect on 91st day following adjournment sine die.

## A BILL FOR AN ACT 1 Relating to oil spill prevention fees; creating new provisions; amending ORS 468B.405; and pre-2 3 scribing an effective date. Be It Enacted by the People of the State of Oregon: 4 SECTION 1. ORS 468B.405 is amended to read: 5 6 468B.405. (1) The Department of Environmental Quality shall assess the following fees on cov-7 ered vessels and offshore and onshore facilities to recover the costs of reviewing the plans and conducting the inspections, exercises, training and activities required under ORS 468B.345 to 8 468B.400: 9 10 (a) Cargo and passenger vessels, [\$105] \ per trip. (b) Nonself-propelled tank vessels: 11 12 (A) Having a capacity of fewer than 25,000 barrels, [\$85] \$\_\_\_\_\_ per trip. (B) Having a capacity of 25,000 to 99,999 barrels, [\$110] **\$\_\_\_\_\_** per trip. 13 (C) Having a capacity of 100,000 or more barrels, [\$250] \$\_\_\_\_\_ per trip. 14 (c) Self-propelled tank vessels of 300 gross tons or less, [\$85] \$\_\_\_\_\_ per trip. 15 (d) Self-propelled tank vessels over 300 gross tons, [\$2,100] \$\_\_\_\_\_ per trip. 16 (e) Offshore and onshore facilities that are not pipelines, [\$9,250] \$\_\_\_ 17 (f) Pipelines with a diameter of six inches or less, \$\_\_\_\_\_ per year. 18 (g) Pipelines with a diameter greater than six inches, \$\_\_\_\_\_ per year. 19 [(f)] (h) Dredge vessels, [\$50] \$\_\_\_\_\_ per day when operating in the navigable waters of the 20 21 state. 22 (2) Moneys collected under this section shall be deposited in the State Treasury to the credit of the Oil Spill Prevention Fund established under ORS 468B.410. 23 24 (3) As used in this section, "trip" means travel to the appointed destination and return travel to the point of origin within the navigable waters of this state. For the purpose of assessing trip fees 25 26 under this section, self-propelled tank vessels transiting the navigable waters of this state in ballast 27 shall be considered cargo vessels.
