

# Senate Bill 527

Sponsored by Senator JOHNSON (at the request of Joel Wangle) (Pre-session filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Modifies definition of "fixed load vehicle" to exclude bucket trucks.

## A BILL FOR AN ACT

2 Relating to fixed load vehicles; amending ORS 801.285.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 801.285 is amended to read:

5 801.285. "Fixed load vehicle" means all of the following apply to the vehicle:

6 (1) It is a vehicle with or without motive power that is designed and used primarily:

7 (a) To support and move a permanent load in the form of equipment or appliances constructed  
8 as part of or permanently attached to the body of the vehicle;

9 (b) For transportation of equipment or appliances that are ordinarily kept on or in the vehicle  
10 in order that the vehicle may be used for its primary purpose; and

11 (c) Except for the transportation of permanent load, appliances and equipment described in  
12 paragraphs (a) and (b) of this subsection, for purposes other than for the transportation of persons  
13 or property over public highways or streets.

14 (2) It is a vehicle other than the following:

15 (a) A travel trailer.

16 (b) A tow vehicle, including a tow vehicle with cranes, hoists or dollies.

17 (c) A truck-mounted transit mixer or volumetric mixer.

18 (d) A self-propelled mobile crane.

19 **(e) A bucket truck.**

20 (3) It is a vehicle that may include, but is not limited to, the following vehicles:

21 (a) Air compressors, air drills, asphalt plants, asphalt spreaders, bituminous plants, bituminous  
22 mixers, bituminous spreaders and bucket loaders;

23 (b) Concrete batch plants, concrete mixers other than transit mixers or volumetric mixers, ce-  
24 ment spreaders, carryalls, crawler cranes, crushers and crushing plants, diggers and ditchers, power  
25 units and plants;

26 (c) Earthmoving scrapers, electric generating equipment, electric load-bank and wiring equip-  
27 ment, front-end loaders, leveling graders, lighting plants and portable wiring, motor graders,  
28 payloaders, power hoists, road graders, scoopmobiles, skip hoists, stackers and hoists;

29 (d) Athey wheels, backhoes, bituminous and concrete pavement finishers, drag lines, fork lift  
30 trucks, log loaders, portable bins, portable parts and storage bins, portable shops, portable storage  
31 tanks, power shovels, road rollers, sheepfoot rollers and paving mixers, towermobiles, welders,  
32 yarders;

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 (e) Bituminous and concrete finishing machines, elevator equipment, scarifiers and rooters,  
2 traction engines, vibro screens and rotary screens, wheeled and crawler tractors other than truck  
3 tractors; and

4 (f) Apron feeders, grain grinders, grain rollers, sand classifiers and drags, sawmills and special  
5 construction equipment, scrap metal balers, scrubber screens and plate feeders.
