

Senate Bill 5507

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Oregon Department of Administrative Services)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Appropriates moneys from General Fund to Emergency Board for allocations during biennium.
Declares emergency, effective July 1, 2019.

A BILL FOR AN ACT

2 Relating to state financial administration; and declaring an emergency.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. In addition to and not in lieu of any other appropriation, there is appropri-**
5 **ated to the Emergency Board, for the biennium beginning July 1, 2019, out of the General**
6 **Fund, the amount of \$40,000,000 for the purposes for which the Emergency Board lawfully**
7 **may allocate funds.**

8 **SECTION 2. (1) In addition to and not in lieu of any other appropriation, there is appro-**
9 **priated to the Emergency Board, for the biennium beginning July 1, 2019, out of the General**
10 **Fund, the amount of \$200,000,000, to be allocated to state agencies for state employee com-**
11 **penensation changes for the biennium beginning July 1, 2019.**

12 **(2) If any of the moneys appropriated by subsection (1) of this section are not allocated**
13 **by the Emergency Board prior to December 1, 2020, the moneys remaining on that date be-**
14 **come available for any purpose for which the Emergency Board lawfully may allocate funds.**

15 **SECTION 3. (1) In addition to and not in lieu of any other appropriation, there is appro-**
16 **priated to the Emergency Board, for the biennium beginning July 1, 2019, out of the General**
17 **Fund, the amount of \$12,000,000, to be allocated to state agencies for compensation changes**
18 **driven by collective bargaining for workers who are not state employees.**

19 **(2) If any of the moneys appropriated by subsection (1) of this section are not allocated**
20 **by the Emergency Board prior to December 1, 2020, the moneys remaining on that date be-**
21 **come available for any purpose for which the Emergency Board lawfully may allocate funds.**

22 **SECTION 4. (1) In addition to and not in lieu of any other appropriation, there is appro-**
23 **priated to the Emergency Board, for the biennium beginning July 1, 2019, out of the General**
24 **Fund, the amount of \$10,000,000, to be allocated to the Judicial Department for judicial**
25 **compensation and family treatment courts.**

26 **(2) If any of the moneys appropriated by subsection (1) of this section are not allocated**
27 **by the Emergency Board prior to December 1, 2020, the moneys remaining on that date be-**
28 **come available for any purpose for which the Emergency Board lawfully may allocate funds.**

29 **SECTION 5. (1) In addition to and not in lieu of any other appropriation, there is appro-**
30 **priated to the Emergency Board, for the biennium beginning July 1, 2019, out of the General**

1 Fund, the amount of \$2,000,000, to be allocated to the Judicial Department for immigration
2 defense services.

3 (2) If any of the moneys appropriated by subsection (1) of this section are not allocated
4 by the Emergency Board prior to December 1, 2020, the moneys remaining on that date be-
5 come available for any purpose for which the Emergency Board lawfully may allocate funds.

6 **SECTION 6.** (1) In addition to and not in lieu of any other appropriation, there is appro-
7 priated to the Emergency Board, for the biennium beginning July 1, 2019, out of the General
8 Fund, the amount of \$25,000,000, to be allocated to the Public Defense Services Commission
9 for trial level sustainability and employee compensation.

10 (2) If any of the moneys appropriated by subsection (1) of this section are not allocated
11 by the Emergency Board prior to December 1, 2020, the moneys remaining on that date be-
12 come available for any purpose for which the Emergency Board lawfully may allocate funds.

13 **SECTION 7.** (1) In addition to and not in lieu of any other appropriation, there is appro-
14 priated to the Emergency Board, for the biennium beginning July 1, 2019, out of the General
15 Fund, the amount of \$12,800,000, to be allocated to the Public Defense Services Commission
16 for the Parent Child Representation Program.

17 (2) If any of the moneys appropriated by subsection (1) of this section are not allocated
18 by the Emergency Board prior to December 1, 2020, the moneys remaining on that date be-
19 come available for any purpose for which the Emergency Board lawfully may allocate funds.

20 **SECTION 8.** (1) In addition to and not in lieu of any other appropriation, there is appro-
21 priated to the Emergency Board, for the biennium beginning July 1, 2019, out of the General
22 Fund, the amount of \$2,700,000, to be allocated to the Secretary of State for paid return
23 postage on ballots.

24 (2) If any of the moneys appropriated by subsection (1) of this section are not allocated
25 by the Emergency Board prior to December 1, 2020, the moneys remaining on that date be-
26 come available for any purpose for which the Emergency Board lawfully may allocate funds.

27 **SECTION 9.** In addition to and not in lieu of any other appropriation, there is appropri-
28 ated to the Emergency Board, for the biennium beginning July 1, 2019, out of the General
29 Fund, the amount of \$15,000,000, to be allocated to state agencies for state employee com-
30 pensation changes related to pay equity.

31 **SECTION 10.** This 2019 Act being necessary for the immediate preservation of the public
32 peace, health and safety, an emergency is declared to exist, and this 2019 Act takes effect
33 July 1, 2019.
