

## SENATE AMENDMENTS TO SENATE BILL 5513

By JOINT COMMITTEE ON WAYS AND MEANS

June 18

1 On page 1 of the printed bill, delete lines 6 through 13 and insert:

- 2 “(1) Judicial compensation..... \$ 87,141,293  
3 (2) Operations..... \$ 340,873,732  
4 (3) Mandated payments..... \$ 16,606,161  
5 (4) State court technology  
6 systems ..... \$ 3,432,622  
7 (5) Debt service ..... \$ 30,968,960  
8 (6) Third-party debt  
9 collection..... \$15,312,377”.

10 Delete lines 20 through 27.

11 On page 2, delete line 1 and insert:

- 12 “(1) Operations..... \$ 16,339,627  
13 (2) Mandated payments..... \$ 689,109  
14 (3) State Court Facilities and  
15 Security Account..... \$ 6,716,018  
16 (4) State Court Technology Fund..... \$19,410,111”.

17 In line 8, delete “\$567,057” and insert “\$320,442”.

18 In line 11, delete “\$77,324” and insert “\$51,710”.

19 In line 14, delete “\$9,006,499” and insert “\$7,183,170”.

20 In line 22, delete “\$7,406,500” and insert “\$7,183,170”.

21 In line 26, delete “2019-2021” and insert “2017-2019”.

22 Delete lines 28 through 30 and insert:

23 “**SECTION 8. (1) In addition to and not in lieu of any other appropriation, there is ap-**  
24 **propriated to the Judicial Department, for the biennium beginning July 1, 2019, out of the**  
25 **General Fund, the amount of \$12,257,000 for the purpose of funding the Legal Services Pro-**  
26 **gram described in ORS 9.572.**

27 “**(2) The Chief Justice of the Supreme Court shall distribute all moneys appropriated**  
28 **under this section to the Oregon State Bar in eight quarterly installments of equal amount.**

29 “**SECTION 9. (1) Notwithstanding any other provision of law, the General Fund appro-**  
30 **riation made to the Judicial Department by section 1 (1), chapter 575, Oregon Laws 2017, for**  
31 **the biennium ending June 30, 2019, for judicial compensation, is decreased by \$950,000.**

32 “**(2) Notwithstanding any other provision of law, the General Fund appropriation made**  
33 **to the Judicial Department by section 1 (2), chapter 575, Oregon Laws 2017, for the biennium**  
34 **ending June 30, 2019, for operations, is decreased by \$800,000.**

35 “**(3) Notwithstanding any other provision of law, the General Fund appropriation made**

1 to the Judicial Department by section 16, chapter 650, Oregon Laws 2017, for the biennium  
2 ending June 30, 2019, is decreased by \$600,000.

3 “(4) Notwithstanding any other provision of law, the General Fund appropriation made  
4 to the Judicial Department by section 141 (1), chapter 702, Oregon Laws 2017, for the  
5 biennium ending June 30, 2019, is decreased by \$500,000.

6 “(5) Notwithstanding any other provision of law, the General Fund appropriation made  
7 to the Judicial Department by section 1 (3), chapter 575, Oregon Laws 2017, for the biennium  
8 ending June 30, 2019, for mandated payments, is increased by \$950,000.

9 “(6) Notwithstanding any other provision of law, the General Fund appropriation made  
10 to the Judicial Department by section 1 (6), chapter 575, Oregon Laws 2017, for the biennium  
11 ending June 30, 2019, for third-party debt collection, is increased by \$1,900,000.

12 “SECTION 10. This 2019 Act being necessary for the immediate preservation of the public  
13 peace, health and safety, an emergency is declared to exist, and this 2019 Act takes effect  
14 on its passage.”.
