

Senate Bill 74

Printed pursuant to Senate Interim Rule 213.28 by order of the President of the Senate in conformance with pre-session filing rules, indicating neither advocacy nor opposition on the part of the President (at the request of Governor Kate Brown for Oregon State Lottery Commission)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Defines "video lottery terminal" for purposes of lottery chapter and amusement device excise tax provision.

Provides that claimed prize is valid if ticket or share is mailed and postmarked by claim deadline.

Provides that potential vendors must make certain disclosures when given notice of intent to award contract, instead of at time that bid, proposal or offer is submitted.

Provides that Oregon State Lottery may include costs of entering into agreements with third parties to research problem gambling in costs of administration.

Directs Oregon State Lottery Commission to adopt rules to protect, secure and maintain confidentiality of personally identifiable player data.

Makes various statutory changes to clarify statutes and align statutes with current terminology and practice.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1.** ORS 461.010 is amended to read:

8 461.010. Unless the context requires otherwise, the definitions contained in this [*chapter*] **section**
9 shall govern the construction of this chapter.

10 (1) "Commissioner" means one of the members of the lottery commission appointed by the Gov-
11 ernor pursuant to the Constitution of the State of Oregon and this chapter to oversee the state
12 lottery.

13 (2) "Director" means the Director of the Oregon State Lottery appointed by the Governor pur-
14 suant to the Constitution of the State of Oregon and this chapter as the chief administrator of the
15 Oregon State Lottery.

16 (3) "Lottery" or "state lottery" means the Oregon State Lottery established and operated pur-
17 suant to the Constitution of the State of Oregon and this chapter.

18 (4) "Lottery commission" or "commission" means the five-member body appointed by the Gov-
19 ernor pursuant to the Constitution of the State of Oregon and this chapter to oversee the lottery
20 and the director.

21 (5) "Lottery contractor" means a person with whom the state lottery has contracted for the
22 purpose of providing goods and services for the state lottery.

23 (6) "Lottery game" or "game" means any procedure authorized by the commission whereby
24 prizes are distributed among **natural** persons who have paid, or unconditionally agreed to pay, for

1 tickets or shares that provide the opportunity to win such prizes.

2 (7) "Lottery game retailer" means a person with whom the lottery commission has contracted
3 for the purpose of selling tickets or shares in lottery games to the public.

4 (8) "Lottery vendor" or "vendor" means any person who submits a bid, proposal or offer to
5 provide goods or services to the commission or lottery.

6 (9) "Person" means any natural person or corporation, trust, association, partnership, joint
7 venture, subsidiary or other business entity.

8 (10)(a) "Personally identifiable player data" means:

9 (A) Information associated with an individual that contains personal financial informa-
10 tion, including information relating to payment cards or accounts held by the individual at
11 a financial institution;

12 (B) Information associated with an individual that relates to the individual's playing of
13 lottery games, including frequency of play and amounts paid for tickets or shares; and

14 (C) Other information associated with an individual that the individual reasonably would
15 not want publicly disclosed.

16 (b) "Personally identifiable player data" does not include information pertaining to indi-
17 viduals that is collected, accumulated or analyzed in the aggregate or otherwise
18 anonymously.

19 (11) "Video lottery game" means a lottery game played on a video lottery terminal.

20 (12) "Video lottery game retailer" means a lottery game retailer with whom the lottery
21 has contracted for the purpose of placing video lottery terminals and offering video lottery
22 games, either exclusively or in addition to other lottery games.

23 (13) "Video lottery terminal" means a device for playing lottery games that:

24 (a) Is owned, operated, controlled or maintained by the commission;

25 (b) Is placed in a fixed location for an extended duration;

26 (c) Consists of a console that includes a video display and a random number generator;

27 (d) Is connected to and monitored by a central system; and

28 (e) Accepts payment that enables an individual to play the lottery games offered on the
29 device.

30 **SECTION 2.** ORS 320.005 is amended to read:

31 320.005. As used in ORS 320.005 to 320.150, unless the context requires otherwise:

32 (1) "Amusement device" means a video lottery [game] terminal[, including but not limited to any
33 electronic, mechanical-electronic or nonmechanical device that:]

34 [(a) Displays a ticket through the use of a video display screen;]

35 [(b) Is available for consumer play upon the payment of consideration;]

36 [(c) Determines winners through the element of chance; and]

37 [(d) Displays possible prizes on the device.] **as defined in ORS 461.010.**

38 (2) "Department" means the Department of Revenue.

39 (3) "Net receipts" has the meaning given the term "net receipts from video lottery games" under
40 ORS 461.547.

41 (4) "Operate" means to make an amusement device available for use by the public for gain,
42 benefit or advantage.

43 (5)(a) "Person" means every individual, partnership (limited or not), corporation (for-profit or
44 not-for-profit), company, cooperative, joint stock company, joint venture, firm, business trust, asso-
45 ciation, organization, institution, club, society, receiver, assignee, trustee in bankruptcy, auctioneer,

1 syndicate, trust, trustee, estate, personal representative or any group of individuals acting as a unit,
 2 whether mutual, cooperative, fraternal, nonprofit or otherwise.

3 (b) "Person" includes this or another state, a municipal corporation, quasi-municipal corporation
 4 or political subdivision of this or another state, and the agencies, departments and institutions of
 5 this or another state, irrespective of the nature of the activities engaged in or functions performed,
 6 but does not include the United States or a foreign government or any agency, department or
 7 instrumentality of the United States or of any foreign government.

8 (6) "Tax year" means a period of 12 months beginning July 1 and ending the following June 30.

9 **SECTION 3.** ORS 461.050 is amended to read:

10 461.050. The Oregon State Lottery shall have its [*principal offices*] **headquarters** in the capital
 11 city.

12 **SECTION 4.** ORS 461.100 is amended to read:

13 461.100. (1) The Oregon State Lottery Commission is hereby created in state government.

14 (2)(a) The Oregon State Lottery Commission shall consist of five members appointed by the
 15 Governor and confirmed by the Senate who shall serve at the pleasure of the Governor.

16 (b) The members shall be appointed for terms of four years.

17 (c) Vacancies shall be filled [*within 30 days*] **as soon as practicable** by the Governor, subject
 18 to confirmation by the Senate, for the unexpired portion of the term in which they occur.

19 (3) At least one of the commissioners shall have a minimum of five years' experience in law
 20 enforcement and at least one of the commissioners shall be a certified public accountant. No person
 21 shall be appointed as a lottery commissioner who has been convicted of a felony or a gambling re-
 22 lated offense. No more than three members of the commission shall be members of the same political
 23 party.

24 (4) The commission shall exercise all powers necessary to effectuate the purpose of this chapter.
 25 In all decisions, the commission shall take into account the particularly sensitive nature of the lot-
 26 tery and shall act to promote and [*insure*] **ensure fairness**, integrity, security[,] **and** honesty [*and*
 27 *fairness*] in the operation and administration of the state lottery.

28 (5) Lottery commissioners shall be eligible for compensation and expenses under ORS 292.495.

29 (6) Lottery commissioners shall file a verified statement of economic interest with the Oregon
 30 Government Ethics Commission and shall be subject to the provisions of ORS chapter 244.

31 (7) The Governor shall select annually from the membership of the commission a chairperson
 32 who serves at the pleasure of the Governor. The chairperson or a majority of the members of the
 33 commission then in office shall have the power to call special meetings of the commission.

34 (8) Meetings of the commission shall be open and public in accordance with state law. Records
 35 of the commission shall be open and available to the public in accordance with state law. The
 36 commission shall meet with the Director of the Oregon State Lottery not less than monthly to make
 37 recommendations and set policy, to approve or reject reports of the director, to adopt rules and to
 38 transact other business.

39 (9) A quorum of the commission shall consist of a majority of the members of the commission
 40 then in office. All decisions of the commission shall be made by a majority vote of all of the com-
 41 missioners then in office.

42 (10) The commission shall prepare quarterly and annual reports of the operation of the state
 43 lottery. Such reports shall include a full and complete statement of state lottery revenues, prize
 44 disbursements, expenses, net revenues and all other financial transactions involving state lottery
 45 funds. The commission shall, not less than annually, contact interested parties, including those

1 named in ORS 461.180 (3), and provide them with such quarterly and annual reports as they may
2 request.

3 **SECTION 5.** ORS 461.110 is amended to read:

4 461.110. (1) Upon the request of the Oregon State Lottery Commission or the Director of the
5 Oregon State Lottery, the office of the Attorney General and the Oregon State Police shall furnish
6 to the director and to the Assistant Director for Security such information as may tend to ensure
7 [security] **fairness**, integrity, **security and** honesty [and fairness] in the operation and adminis-
8 tration of the Oregon State Lottery as the office of the Attorney General and the Oregon State
9 Police may have in their possession, including, but not limited to, manual or computerized informa-
10 tion and data.

11 (2) In order to determine an applicant's suitability to enter into a contract with or to be em-
12 ployed by the Oregon State Lottery, each applicant identified in this subsection shall be finger-
13 printed. The Assistant Director for Security may submit to the Department of State Police and to
14 the Federal Bureau of Investigation, for the purpose of verifying the identity of the following per-
15 sons and obtaining records of their arrests and criminal convictions, fingerprints of:

16 (a) With respect to video **lottery** game retailers, each person for whom ORS 461.300 or an ad-
17 ministrative rule of the Oregon State Lottery Commission requires disclosure of the person's name
18 and address;

19 (b) With respect to lottery vendors and lottery contractors, each person for whom ORS 461.410
20 or an administrative rule of the Oregon State Lottery Commission requires disclosure of the person's
21 name and address;

22 (c) Applicants for employment with the Oregon State Lottery; and

23 (d) With respect to other persons and entities that apply for contracts or have contracts with
24 the Oregon State Lottery, each person for whom ORS 461.300 requires disclosure of the person's
25 name and address and for whom the Assistant Director for Security has prepared written reasons,
26 approved in writing by the director, for requiring the confirmation of the person's identity and re-
27 cords.

28 (3) For the purpose of requesting and receiving the information described in subsections (1) and
29 (2) of this section, the Oregon State Lottery Commission is a state agency and a criminal justice
30 agency and its enforcement agents are peace officers pursuant to ORS 181A.355 to 181A.670 and
31 rules adopted thereunder.

32 (4) Enforcement agents, designated as such by the commission, shall have the same authority
33 with respect to service and execution of warrants of arrest and search warrants as is conferred upon
34 peace officers of this state.

35 **SECTION 6.** ORS 461.150 is amended to read:

36 461.150. (1) The Governor shall appoint a Director of the Oregon State Lottery, subject to con-
37 firmation by the Senate, who shall serve at the pleasure of the Governor. The director shall imple-
38 ment and operate a state lottery pursuant to the rules, and under the guidance, of the commission.

39 (2) The director shall be qualified by training and experience to direct the operations of a
40 state-operated lottery. No [person shall] **individual may** be appointed as lottery director who has
41 been convicted of a felony or any gambling related offense.

42 (3) The director shall receive such salary as may be set by the commission with the approval
43 of the Governor, and shall be reimbursed for all expenses actually and necessarily incurred in the
44 performance of official duties. The director shall render full-time service to the duties of office.

45 (4) The director shall, subject to the approval of the commission, perform all duties, exercise all

1 powers and jurisdiction, assume and discharge all responsibilities and carry out and effect the pur-
 2 poses of this chapter. The director shall act as secretary and executive officer of the commission.
 3 The director shall supervise and administer the operation of the Oregon State Lottery in accordance
 4 with this chapter, and the rules adopted by the commission. In all decisions, the director shall take
 5 into account the particularly sensitive nature of the state lottery, and shall act to promote and [*in-*
 6 *sure*] **ensure fairness**, integrity, security[,] **and** honesty [*and fairness of*] **in** the operation and ad-
 7 ministration of the state lottery.

8 (5) The director shall recommend to the commission the establishment of rules pertaining to the
 9 employment, termination and compensation of all commission staff. The rules shall conform to gen-
 10 erally accepted personnel practices based upon merit principles. Under the rules so established, the
 11 director may set the compensation, prescribe the duties and supervise [*persons*] **individuals** so hired.
 12 The director may terminate or otherwise discipline [*persons*] **individuals** so hired. No [*person*
 13 *shall*] **individual may** be employed by the state lottery who has been convicted of a felony or any
 14 gambling related offense.

15 (6) If a lottery employee transfers to a state agency that is subject to ORS chapter 240, the
 16 employee is entitled to transfer accrued sick leave, adjusted if necessary to reflect the accrual rate
 17 in use for management and unrepresented employees under rules of the Personnel Division.

18 (7) Subject to approval of the commission, the director may appoint, prescribe the duties of and
 19 terminate or otherwise discipline no more than four assistant directors as the director deems nec-
 20 essary. The compensation of each assistant director shall be established by the director subject to
 21 approval of the commission. The director shall supervise the assistant directors.

22 (8) The director and each assistant director shall file a verified statement of economic interest
 23 with the Oregon Government Ethics Commission and shall be subject to the provisions of ORS
 24 chapter 244.

25 **SECTION 7.** ORS 461.190 is amended to read:

26 461.190. The Assistant Director for Security appointed pursuant to the Constitution of the State
 27 of Oregon and this chapter shall be responsible for a security division to [*assure*] **ensure fairness**,
 28 integrity, security[,] **and** honesty [*and fairness*] in the operation and administration of the Oregon
 29 State Lottery, including but not limited to[,] an examination of the background of all prospective
 30 employees, lottery game retailers, lottery vendors and lottery contractors. The Assistant Director
 31 for Security shall be qualified by training and experience, including at least five years of law
 32 enforcement experience, and knowledge and experience in [*computer*] **information technology and**
 33 **digital** security, to fulfill these responsibilities. The Assistant Director for Security shall, in con-
 34 junction with the Director of the Oregon State Lottery, confer with the Attorney General or
 35 designee as the Assistant Director for Security deems necessary and advisable to promote and [*in-*
 36 *sure*] **ensure fairness**, integrity, security[,] **and** honesty [*and fairness of*] **in** the operation and ad-
 37 ministration of the state lottery. The Assistant Director for Security, in conjunction with the
 38 director, shall report any alleged violation of law to the Attorney General and any other appropriate
 39 law enforcement authority for further investigation and action.

40 **SECTION 8.** ORS 461.202 is amended to read:

41 461.202. Devices for playing lottery games, including video lottery [*game*] terminals, operated
 42 under the authority of the Oregon State Lottery Commission are exempted from the provisions of
 43 15 U.S.C. 1172.

44 **SECTION 9.** ORS 461.215 is amended to read:

45 461.215. (1) The Oregon State Lottery Commission may initiate [*a game or games using video*

1 *devices*] **video lottery games**, the proceeds from which shall be transferred to the Administrative
2 Services Economic Development Fund for allocation as provided by law.

3 (2) In the approval and purchase of video lottery games, [*game terminals and equipment*] **video**
4 **lottery terminals and other devices and equipment for video lottery games**, the lottery com-
5 mission and any game operator, distributor, retailer or owner shall prefer goods or services that
6 have been manufactured in this state if price, fitness and quality are otherwise equal.

7 (3) The lottery commission shall separately record and account for the costs and net proceeds
8 of games operated under this section. At such time as the lottery commission makes the quarterly
9 transfer of net proceeds provided for by ORS 461.540, it shall certify to the Oregon Department of
10 Administrative Services the amount of such transfer which represents the net proceeds of **video**
11 **lottery games** [*provided for in subsection (1) of this section*].

12 **SECTION 10. Nothing in this chapter prohibits the Oregon State Lottery Commission**
13 **from initiating or offering lottery games that may be accessed or played on devices or**
14 **equipment other than video lottery terminals.**

15 **SECTION 11.** ORS 461.217 is amended to read:

16 461.217. [(1) As used in this section, "video lottery game retailer" means a contractor under con-
17 tract with the Oregon State Lottery to place video lottery game terminals on premises authorized by the
18 contract.]

19 [(2)] (1) A video lottery [*game*] terminal [*that offers a video lottery game authorized by the Di-*
20 *rector of the Oregon State Lottery*]:

21 (a) May be placed for operation only in or on the premises of an establishment that has a con-
22 tract with the Oregon State Lottery as a video lottery game retailer.

23 (b) Must be within the control of an employee of the video lottery game retailer.

24 (c) May not be placed in any other business or location.

25 [(3)] (2) A video lottery [*game*] terminal may be placed only on the premises of an establishment
26 licensed by the Oregon Liquor Control Commission with a full on-premises sales license, a limited
27 on-premises sales license or a brewery-public house license. A video lottery [*game*] terminal may be
28 placed only in that part of the premises that is posted by the Oregon Liquor Control Commission
29 as being closed to minors. In addition to the requirements of this subsection, the director may by
30 rule establish other criteria and conditions as the director determines appropriate for the placement
31 of video lottery [*game*] terminals in establishments.

32 [(4)] (3) No more than six video lottery [*game*] terminals may be placed in or on premises de-
33 scribed in subsection [(3)] (2) of this section.

34 [(5)] (4) No more than 10 video lottery [*game*] terminals may be placed in or on the premises
35 of a race meet licensee licensed under ORS 462.020 that qualifies as a video lottery game retailer.

36 **SECTION 12.** ORS 461.220 is amended to read:

37 461.220. (1) Upon recommendation of the Director of the Oregon State Lottery, the Oregon State
38 Lottery Commission shall adopt rules that specify the number and value of prizes for winning tickets
39 or shares in each lottery game including, without limitation, cash prizes, merchandise prizes, prizes
40 consisting of deferred payments or annuities and prizes of tickets or shares in the same lottery game
41 or other lottery games [*conducted by the Oregon State Lottery*].

42 (2) In each lottery game utilizing tickets, the following information shall be printed on each
43 ticket:

44 (a) A close approximation of the odds of winning some prize or some cash prize, as appropriate
45 for the lottery game.

1 (b) An approximation of a payout percentage that will be returned to players in the form of
2 prizes for the lottery game. For online games, the approximation may be based on the average
3 payout percentage over several prior years.

4 (c) The statement that “Lottery games are based on chance, should be played for entertainment
5 only and should not be played for investment purposes.”

6 (3) A detailed tabulation of the estimated number of prizes of each particular prize denomination
7 that are expected to be awarded in each lottery game and the close approximation of the odds of
8 winning such prizes shall be [*available at each location at which tickets or shares in such lottery*
9 *games are offered for sale to the public*] **made available by the commission to the public in a**
10 **manner determined by the commission by rule.**

11 (4) Notwithstanding subsection (1) of this section[,]:

12 (a) The commission [*may*] **shall either** specify by rule the number and value of prizes for **video**
13 lottery games [*that use video devices or that use tickets or shares that allow a player to manually re-*
14 *veal covered play symbols, or the commission may*] **or** make such information available at each lo-
15 cation [*that offers such games using video devices, tickets or shares for sale to the public*] **at which**
16 **video lottery terminals are placed for operation.**

17 (b) **The commission shall either specify by rule the number and value of prizes for games**
18 **that use tickets or shares that allow a player to manually reveal covered play symbols or**
19 **make such information available at each location where such tickets or shares are offered**
20 **for sale to the public.**

21 (5) All television, radio and newspaper advertising of a lottery game shall include a disclaimer
22 representing a close approximation of the odds of winning some prize and an approximation of the
23 amount that will be returned to the players in the form of prizes for the game in the following
24 words: “The odds of winning some prize are one in (some number). The prize payout percentage is
25 (some number).” where the numbers stated represent a close approximation of the odds of winning
26 some prize and the prize payout percentage. However, this subsection does not apply to advertising
27 the purpose of which is to advertise the location where tickets may be purchased or to provide in-
28 formation about the winners.

29 (6) All television, radio and newspaper advertising of lottery games funded by the lottery com-
30 mission, including advertising that is intended to indicate where tickets may be purchased or to
31 provide information about prize winners, shall include the disclaimer that “Lottery games are based
32 on chance, should be played for entertainment only and should not be played for investment pur-
33 poses.”

34 (7) All television, radio and newspaper advertising intended to publicize projects or programs
35 funded by lottery dollars shall include the disclaimer that “Lottery games are based on chance and
36 should be played for entertainment only.” However, this subsection does not apply to any such ad-
37 vertising that has the sole purpose of educating the public about gambling addiction or available
38 treatments.

39 (8) All billboard advertising intended to promote a lottery game, to indicate where tickets may
40 be purchased or to provide information about prize winners shall include the disclaimer that “Lot-
41 tery games should not be played for investment purposes.”

42 (9) All billboard advertising intended to publicize projects or programs funded by lottery dollars
43 shall include the disclaimer that “Lottery games should be played for entertainment only.”

44 (10) A disclaimer required by this section to be included in a written advertisement shall be of
45 a size and in a form that allows an individual to readily notice and read the statement. A disclaimer

1 required by this section to be included in a television or radio advertisement shall be spoken aloud
 2 and, in the case of television, must also be displayed visually in a form that allows an individual to
 3 readily notice and read the statement.

4 **SECTION 13.** ORS 461.230 is amended to read:

5 461.230. (1) Upon recommendation of the Director of the Oregon State Lottery, the Oregon State
 6 Lottery Commission shall adopt rules that specify the method for determining winners in each lot-
 7 tery game.

8 (2) If a lottery game utilizes a manual drawing of winning numbers, a manual drawing among
 9 entries or a manual drawing among finalists:

10 (a) The drawing must be open to the public;

11 (b) The drawing must be witnessed by an independent certified public accountant or a profes-
 12 sional representative of an independent certified public accountancy organization;

13 (c) Any equipment used in the drawing must be inspected by the independent certified public
 14 accountant or the professional representative of an independent certified public accountancy or-
 15 ganization and an employee of the lottery both before and after the drawing; and

16 (d) The drawing and such inspections shall be recorded on both video and audio tape.

17 (3)(a) [*When*] **If** a drawing is held out of this state in conjunction with other state lotteries, the
 18 Oregon State Lottery shall conduct periodic studies of the drawing's security procedures. Any
 19 equipment used in a manual drawing must be inspected both before and after the drawing by a
 20 professional representative of an independent certified public accountancy organization and a rep-
 21 resentative of the [*state lottery*] **Oregon State Lottery** designated by the director.

22 (b) Any manual drawing and such inspections shall be recorded on both video and audio tape.

23 (4) The lottery may use any of a variety of existing or future methods or technologies in deter-
 24 mining winners.

25 **SECTION 14.** ORS 461.250 is amended to read:

26 461.250. Upon recommendation of the Director of the Oregon State Lottery, the Oregon State
 27 Lottery Commission shall adopt rules to establish a system of verifying the validity of tickets or
 28 shares claimed to win prizes and to effect payment of such prizes, provided:

29 (1) For the convenience of the public, lottery game retailers may be authorized by the commis-
 30 sion to pay winners of up to \$5,000 after performing validation procedures on their premises appro-
 31 priate to the lottery game involved.

32 (2) A prize may not be paid to a person under 18 years of age.

33 (3) A video lottery game prize may not be paid to a person under 21 years of age.

34 (4) A prize may not be paid arising from claimed tickets or shares that are stolen, counterfeit,
 35 altered, fraudulent, unissued, produced or issued in error, unreadable, not received or not recorded
 36 by the Oregon State Lottery by applicable deadlines, lacking in captions that confirm and agree with
 37 the lottery play symbols as appropriate to the lottery game involved or not in compliance with such
 38 additional specific rules or with public or confidential validation and security tests of the lottery
 39 appropriate to the particular lottery game involved. However, the commission may adopt rules to
 40 establish a system of verifying the validity of claims to prizes greater than \$600 that are otherwise
 41 not payable under this subsection due to a lottery game retailer's losing, damaging or destroying the
 42 winning ticket or share while performing validation procedures thereon, and to effect payment of
 43 verified claims. A verification system established by the commission shall include appropriate public
 44 or confidential validation and security tests.

45 (5) A particular prize in any lottery game may not be paid more than once, and in the event of

1 a binding determination that more than one claimant is entitled to a particular prize, the sole rem-
2 edy of such claimants is the award to each of them of an equal share in the prize.

3 (6) The commission may specify that winners of less than \$25 claim such prizes from either the
4 same lottery game retailer who sold the winning ticket or share or from the lottery itself and may
5 also specify that the lottery game retailer who sold the winning ticket or share be responsible for
6 directly paying that prize.

7 (7)(a) Holders of tickets or shares shall have the right to claim prizes for one year after the
8 drawing or the end of the lottery game or play in which the prize was won, **subject to ORS**
9 **187.010**. The commission may define shorter time periods to claim prizes and for eligibility for entry
10 into drawings involving entries or finalists. If a valid claim is not made for a prize payable directly
11 by the lottery commission within the applicable period, the unclaimed prize shall remain the prop-
12 erty of the commission and shall be allocated to the benefit of the public purpose **described in**
13 **Article XV, section 4, of the Oregon Constitution**.

14 (b) **A ticket or share that is transmitted through the United States mail or by private**
15 **express carrier is deemed to be claimed on the date shown by the cancellation mark or other**
16 **record of transmittal, or on the date the ticket or share was mailed or deposited for trans-**
17 **mittal if proof satisfactory to the director establishes that the mailing or deposit occurred**
18 **on a date earlier than the date shown by the record of transmittal.**

19 (8)(a) The right of any person to a prize shall not be assignable, except that:

20 (A) Payment of any prize may be made according to the terms of a deceased prize winner's
21 signed beneficiary designation form filed with the commission or, if no such form has been filed, to
22 the estate of the deceased prize winner.

23 (B) Payment of any prize shall be made to a person designated pursuant to an appropriate ju-
24 dicial order or pursuant to a judicial order approving the assignment of the prize in accordance with
25 ORS 461.253.

26 (b) The director, commission and state shall be discharged of all further liability with respect
27 to a specific prize payment upon making that prize payment in accordance with this subsection or
28 ORS 461.253.

29 (9) A ticket or share may not be purchased by, and a prize may not be paid to, a member of the
30 commission, the director, the assistant directors or any employee of the state lottery or to any
31 spouse, child, brother, sister or parent of such person.

32 (10) Payments made according to the terms of a deceased prize winner's signed beneficiary des-
33 ignation form filed with the commission are effective by reason of the contract involved and this
34 statute and are not to be considered as testamentary devices or subject to ORS chapter 112. The
35 director, commission and state shall be discharged of all liability upon payment of a prize.

36 (11) In accordance with the provisions of the Soldiers' and Sailors' Civil Relief Act of 1940 (50
37 U.S.C.A. app. 525), a person while in active military service may claim exemption from the one-year
38 ticket redemption requirement under subsection (7) of this section. However, the person must notify
39 the commission by providing satisfactory evidence of possession of the winning ticket within the
40 one-year period, and must claim the prize or share no later than one year after discharge from ac-
41 tive military service.

42 **SECTION 15.** ORS 461.257 is amended to read:

43 461.257. Notwithstanding ORS 461.250 (8) [or] **and** 461.253, if it is ever determined that prize
44 winners who do not seek to assign their prize payments are subject to immediate income taxes on
45 the prize payments just as if those prize winners had so assigned their prizes, the Oregon State

1 Lottery Commission may intervene in a proceeding commenced under ORS 461.253 in order to raise
2 the issue of adverse tax consequences in the proceeding. If the court determines that ORS 461.250
3 (8) and 461.253 or the issuance of an order approving an assignment of prize payments subjects prize
4 winners who do not seek assignment of prize payments to immediate income taxes on their prize

33 of the voting stock and each stockholder who owns 10 percent or more of the outstanding stock in

35 [(B)] (ii) If the **potential** lottery game retailer is a trust, the trustee and all persons entitled to
36 receive income or benefit from the trust.

37 [(C)] (iii) If the **potential** lottery game retailer is an association but not a nonprofit private club
38 as described in ORS 471.175, the members, officers and directors.

39 [(D)] (iv) If the **potential** lottery game retailer is a subsidiary but not a nonprofit private club
40 as described in ORS 471.175, the officers, each director who owns or controls three percent or more
41 of the voting stock and each stockholder who owns 10 percent or more of the outstanding stock of
42 the parent corporation thereof.

43 [(E)] (v) If the **potential** lottery game retailer is a partnership, joint venture or limited liability
44 company, all of the general partners, limited partners, joint venturers, members of a limited liability
45 company whose investment commitment or membership interest is 10 percent or more, and managers

1 of a limited liability company.

2 [(F) *If the parent company, general partner, limited partner, joint venturer, stockholder, member*
 3 *or manager of a limited liability company is itself a corporation, trust, association, subsidiary, part-*
 4 *nership, joint venture or limited liability company, then the director may require that all of the infor-*
 5 *mation required by this paragraph be disclosed for such other entity as if it were itself a lottery game*
 6 *retailer to the end that full disclosure of ultimate ownership be achieved.*]

7 [(G) *If any member, 18 years of age or older, of the immediate family of any video lottery game*
 8 *retailer, or any member, 18 years of age or older, of the immediate family of any individual whose name*
 9 *is required to be disclosed under this paragraph, is involved in the video lottery game retailer's busi-*
 10 *ness in any capacity, then all of the information required in this paragraph shall be disclosed for such*
 11 *immediate family member as if the family member were a video lottery game retailer.*]

12 [(H) *If any immediate family member, 18 years of age or older, of any lottery game retailer, other*
 13 *than a video lottery game retailer, or of any person whose name is required to be disclosed under this*

25 [(J) (vii) Any other person required by rule of the commission.

26 **(B)(i) If the potential lottery game retailer is a limited liability company whose parent**
 27 **company, general partner, limited partner, joint venturer, stockholder, member or manager**
 28 **is itself a corporation, trust, association, subsidiary, partnership, joint venture or limited li-**
 29 **ability company, then the director may require that all of the information required by this**
 30 **paragraph be disclosed for such other entity as if it were itself a potential lottery game**
 31 **retailer to the end that full disclosure of ultimate ownership be achieved.**

32 **(ii) If any member, 18 years of age or older, of the immediate family of any potential**
 33 **video lottery game retailer, or any member, 18 years of age or older, of the immediate family**
 34 **of any individual whose name is required to be disclosed under this paragraph, is involved in**
 35 **the potential video lottery game retailer's business in any capacity, then all of the informa-**
 36 **tion required in this paragraph shall be disclosed for such immediate family member as if the**

6 (d) The commission may refuse to grant a lottery game [retail] **retailer** contract to any **poten-**
 7 **tial** lottery game retailer or any natural person whose name is required to be disclosed under par-
 8 agraph (b) of this subsection, who has been convicted of violating any of the gambling laws of this
 9 state, general or local, or has been convicted at any time of any crime. The lottery may require
 10 payment by each lottery game retailer to the lottery of an initial nonrefundable application fee or
 11 an annual fee, or both, to maintain the contract to be a lottery game retailer.

12 (e) A person who is a lottery game retailer may not be engaged exclusively in the business of
 13 selling lottery tickets or shares. A person lawfully engaged in nongovernmental business on state

 18 corporation, only the names and addresses of those known to the corporation to beneficially own
 19 15 percent or more of such securities need be disclosed.

20 (B) If the vendor is a trust, the trustee and all persons entitled to receive income or benefit from
 21 the trust.

22 (C) If the vendor is an association, the members, officers and directors.

23 (D) If the vendor is a subsidiary, the officers, directors and each stockholder of the parent cor-
 24 poration thereof; except that, in the case of stockholders of publicly held equity securities of a
 25 publicly traded corporation, only the names and addresses of those known to the corporation to
 26 beneficially own 15 percent or more of such securities need be disclosed.

27 (E) If the vendor is a partnership or joint venture, all of the general partners, limited partners
 28 or joint venturers.

29 (F) If the parent company, general partner, limited partner or joint venturer of any vendor is
 30 itself a corporation, trust, association, subsidiary, partnership or joint venture, then all of the in-
 31 formation required in this section shall be disclosed for such other entity as if it were itself a vendor
 32 to the end that full disclosure of ultimate ownership be achieved.

33 (G) If any member of the immediate family of any vendor is involved in the vendor's business in
 34 any capacity, then all of the information required in this section shall be disclosed for such imme-
 35 diate family member as if the family member were a vendor.

36 (H) If the vendor subcontracts any substantial portion of the work to be performed to a sub-
 37 contractor, then all of the information required in this section shall be disclosed for such subcon-
 38 tractor as if it were itself a vendor.

39 (I) The persons or entities in subparagraphs (A) to (H) of this paragraph, along with the vendor
 40 itself, shall be referred to as control persons.

41 (b) A disclosure of all the states and jurisdictions in which each control person does business,
 42 and the nature of that business for each such state or jurisdiction.

43 (c) A disclosure of all the states and jurisdictions in which each control person has contracts
 44 to supply gaming goods or services, including, but not limited to, lottery goods and services and the
 45 nature of the goods or services involved for each such state or jurisdiction.

1 (d) A disclosure of all the states and jurisdictions in which each control person has applied for,
 2 has sought renewal of, has received, has been denied, has pending or has had revoked a gaming li-

30 earnings credited to this fund and other moneys authorized to be transferred to this fund from
31 whatever source are appropriated continuously for any of the following public purposes:

32 (a) Creating jobs;

33 (b) Furthering economic development in Oregon; or

34 (c) Financing public education.

35 (2) Moneys shall be transferred from the Administrative Services Economic Development Fund
36 to:

37 (a) The Education Stability Fund established under ORS 348.696 as described in section 4, Arti-
38 cle XV of the Oregon Constitution; and

39 (b) The School Capital Matching Fund established under ORS 286A.806 as described in section
40 4, Article XI-P of the Oregon Constitution.

41 (3) As used in this section [*and section 4, Article XV of the Oregon Constitution*]:

42 (a) "Creating jobs" includes, but is not limited to:

43 (A) Supporting the creation of new jobs in Oregon;

44 (B) Helping prevent the loss of existing jobs in Oregon;

45 (C) Assisting with work transition to new jobs in Oregon; [*or*] **and**

1 (D) Training or retraining workers.

2 (b) “Education” includes, but is not limited to, the Education Stability Fund established under
3 ORS 348.696 and specific programs that support the following:

4 (A) Prekindergartens;

5 (B) Elementary and secondary schools;

6 (C) Community colleges;

7 (D) Higher education;

8 (E) Continuing education;

9 (F) Workforce training and education programs; or

10 (G) Financial assistance to Oregon students.

11 (c) “Furthering economic development” includes, but is not limited to, providing:

12 (A) Services or financial assistance to for-profit and nonprofit businesses located or to be lo-
13 cated in Oregon;

14 (B) Services or financial assistance to business or industry associations to promote, expand or
15 prevent the decline of their businesses; or

16 (C) Services or financial assistance for facilities, physical environments or development projects,
17 as defined in ORS 285B.410, that benefit Oregon’s economy.

18 **SECTION 25.** ORS 461.547 is amended to read:

19 461.547. (1) The Oregon State Lottery Commission shall transfer an amount equal to 2.5 percent
20 of the net receipts from video lottery games allocated to the Administrative Services Economic De-
21 velopment Fund to counties for economic development activities. Ninety percent of the moneys shall
22 be distributed to each county in proportion to the gross receipts from video lottery games from each
23 county. Ten percent of the moneys shall be distributed in equal amounts to each county.

24 (2) As used in this section:

25 (a) “Gross receipts from video lottery games” means the amount of money inserted into video
26 lottery [games] **terminals** plus the value of any free game prizes used by players for subsequent
27 games.

28 (b) “Net receipts from video lottery games” means the amount of money that is received from
29 the operation of video lottery games after the payment of prizes but prior to any other payment.

30 **SECTION 26.** ORS 461.548 is amended to read:

31 461.548. Notwithstanding any other provision of law, the Oregon State Lottery Commission shall
32 meet the constitutional requirements for prizes and administrative costs separately for video **lottery**
33 **games** and all other lottery games. The lottery commission shall not intermingle the results of video
34 lottery games for the purpose of calculating the allowable limit on administrative expenses of other
35 lottery games.

36 **SECTION 27.** ORS 461.600 is amended to read:

37 461.600. (1) Tickets or shares in lottery games, including tickets or shares sold from vending
38 machines or other devices, may not be sold to a person under 18 years of age.

39 (2) Video lottery [game] terminals may not be operated by a person under 21 years of age.

40 (3) The Oregon State Lottery Commission shall establish safeguards to ensure that lottery game
41 retailers comply with the requirements of this section.

42 **SECTION 28.** (1) **The Legislative Assembly finds that:**

43 (a) **Personally identifiable player data submitted by players of lottery games, particularly**
44 **information submitted through mobile or Internet-enabled devices, may, if disclosed, expose**
45 **players to identity theft, financial risk or invasion of personal privacy;**

1 **(b) Players of lottery games voluntarily submit personally identifiable player data to the**
2 **Oregon State Lottery and reasonably expect that such information will be protected and se-**
3 **cured by the Oregon State Lottery;**

4 **(c) The inability or failure of the Oregon State Lottery to ensure the confidentiality of**
5 **personally identifiable player data will result in a decreased willingness of individuals to play**
6 **lottery games and a resultant decrease in lottery revenue; and**

7 **(d) The Oregon State Lottery Commission is responsible for the protection and security**
8 **of personally identifiable player data and should make every reasonable effort to maintain**
9 **the confidentiality of such information.**

10 **(2) The commission shall adopt rules to ensure that the systems, standards and proce-**
11 **dures of the Oregon State Lottery protect, secure and maintain the confidentiality of per-**
12 **sonally identifiable player data. The commission may, by rule, designate categories of**
13 **information to be protected as personally identifiable player data.**

14 **SECTION 29.** **ORS 461.257, 461.445, 461.512, 461.544, 461.547, 461.548, 461.549, 461.553,**
15 **461.555, 461.557, 461.559, 461.725 and 461.740 and sections 10 and 28 of this 2019 Act are added**
16 **to and made a part of ORS chapter 461.**

17 **SECTION 30.** **Sections 1 to 4, chapter 2, Oregon Laws 2017, are added to and made a part**
18 **of ORS chapter 327.**

19 **SECTION 31.** **The amendments to ORS 320.005 by section 2 of this 2019 Act apply to tax**
20 **years beginning on or after January 1, 2019.**

21
