

SENATE AMENDMENTS TO SENATE BILL 755

1 On page 1 of the printed bill, delete lines 5 through 31 and delete page 2 and insert:

2 **“SECTION 1. Section 2 of this 2019 Act is added to and made a part of ORS 250.137 to**
3 **250.149.**

4 **“SECTION 2. (1) The Citizens’ Initiative Review Commission Endowment Fund is estab-**
5 **lished in the State Treasury, separate and distinct from the General Fund. The Operating**
6 **Subaccount is created as a subaccount of the Citizens’ Initiative Review Commission**
7 **Endowment Fund. Moneys in the fund and the subaccount may be invested as provided in**
8 **ORS 293.701 to 293.857. Interest and investment earnings earned by either the fund or the**
9 **subaccount shall be credited to the subaccount.**

10 **“(2) Moneys in the subaccount are continuously appropriated to the Oregon Department**
11 **of Administrative Services for distribution to the Citizens’ Initiative Review Commission for**
12 **the purpose of carrying out the duties, functions and powers of the commission pursuant to**
13 **ORS 250.137 to 250.149. The department may not distribute to the commission moneys in the**
14 **fund that are not in the subaccount.**

15 **“(3) The department may accept contributions of moneys and assistance to the fund and**
16 **the subaccount from the United States Government or its agencies or from any other source,**
17 **public or private, and may agree to conditions placed on the moneys not inconsistent with**
18 **the duties of the commission.**

19 **“(4) Notwithstanding subsection (3) of this section, the fund and the subaccount may not**
20 **receive contributions of moneys or assistance from any entity described in ORS 250.147 (2).**

21 **“(5) If a person contributes to the fund or the subaccount an aggregate total of more**
22 **than \$100 in a calendar year, not later than 14 calendar days after the receipt of the contri-**
23 **bution that causes the \$100 threshold to be exceeded, the commission shall make available**
24 **to the public on the Internet:**

25 **“(a) The name and address of the person who made the contribution; and**

26 **“(b) The aggregate total of the contribution or contributions.**

27 **“SECTION 3. ORS 250.149 is amended to read:**

28 **“250.149. (1) Not later than the date that is four months before the date of the general election**
29 **in an even-numbered year, the Citizens’ Initiative Review Commission, in consultation with the**
30 **Oregon Department of Administrative Services, shall determine whether moneys in sufficient**
31 **amount are available in the Operating Subaccount created under section 2 of this 2019 Act and**
32 **the account established under ORS 182.470 to carry out all the duties, functions and powers of the**
33 **commission, implement ORS 250.139 to 250.143 and pay for any statements to be printed in the**
34 **voters’ pamphlet under ORS 251.185.**

35 **“(2)(a) If the commission determines that the subaccount and the account [has] have sufficient**

1 moneys under subsection (1) of this section, the commission shall carry out all the duties, functions
2 and powers of the commission, implement ORS 250.139 to 250.143 and may submit statements to be
3 printed in the voters' pamphlet under ORS 251.185.

4 “(b) If the commission determines that the **subaccount and the** account [*has*] **have** insufficient
5 moneys under subsection (1) of this section, for the general election in that even-numbered year, the
6 commission may not carry out all the duties, functions and powers of the commission, implement
7 ORS 250.139 to 250.143 or submit statements to be printed in the voters' pamphlet under ORS
8 251.185.”.
