SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Establishes Health Care for All Oregon Board to be responsible for planning and oversight of Health Care for All Oregon Plan to be administered by Oregon Health Authority. Provides com-prehensive health care coverage to all individuals residing or working in Oregon. Repeals health insurance exchange upon implementation of Health Care for All Oregon Plan.

Supplants coverage by private insurers for health services covered by plan. Authorizes Public Employees' Benefit Board and Oregon Educators Benefit Board to offer supplemental health benefit plans to employees. Requires public employees to be covered by Health Care for All Oregon Plan. Establishes Health Care for All Oregon Fund. Continuously appropriates moneys in fund to

Health Care for All Oregon Board.

Establishes office of Health Care for All Oregon Ombudsman in office of Governor. Requires Health Care for All Oregon Board to establish Regional Planning Boards to oversee allocation of health resources in geographic regions prescribed by Health Care for All Oregon Board. Requires submission to Regional Planning Board of plans for addition, alteration or con-struction of health care facility except long term care facility. Authorizes Health Care for All Oregon Board to provide public funding upon request if addition, alteration or construction ap-proved Transform to Department of Humper Services authority to approve actificate of need for long proved. Transfers to Department of Human Services authority to approve certificate of need for long term care facility.

Appropriates moneys from General Fund to Health Care for All Oregon Board for purposes of Health Care for All Oregon Plan.

Declares emergency, effective on passage.

ESTABLISHMENT OF THE HEALTH CARE FOR ALL OREGON PLAN

1	SECTION 1. (1) The Health Care for All Oregon Plan is established to:
2	(a) Ensure access to comprehensive, quality, patient-centered, equitable and affordable
3	publicly funded health care for all individuals living or working in Oregon;
4	(b) Improve the public's health; and
5	(c) Control the cost of health care for the benefit of individuals, families, businesses and
6	society.
7	(2) An individual is eligible to participate in the plan if the individual:
8	(a) Resides in Oregon;
9	(b) Is employed in Oregon full-time and pays any personal income tax dedicated to the
10	plan;
11	(c) Is a dependent, as defined by rule by the Health Care for All Oregon Board, of an in-
12	dividual described in paragraph (a) or (b) of this subsection; or
13	(d) Meets other criteria established by the board.
14	SECTION 2. (1) The Health Care for All Oregon Board shall design the delivery and fi-
15	nancing of health care funded by the Health Care for All Oregon Plan in order to:
16	(a) Provide universal access to comprehensive care at the appropriate time.
17	(b) Ensure transparency and accountability.
18	(c) Enhance primary care.
19	(d) Allow the choice of health care provider.
20	(e) Respect the primacy of the patient-provider relationship.
21	(f) Provide for continuous improvement of health care quality and safety.
22	(g) Reduce administrative costs.
23	(h) Have financing that is sufficient, fair and sustainable.
24	(i) Ensure adequate compensation of health care providers.
25	(j) Incorporate community-based systems.
26	(k) Include effective cost controls.
27	(L) Provide universal access to care even if the participant is outside of this state.
28	(m) Provide seamless birth-to-death access to care.
29	(n) Minimize medical errors.
30	(o) Focus on preventive health care.
31	(p) Integrate physical, dental, vision and mental health care.
32	(q) Include long term care.
33	(r) Provide equitable access to health care, according to a participant's needs.
34	(s) Be affordable for individuals, families, businesses and society.
35	(2) The board shall administer the plan according to all of the following principles:
36	(a) Health care, as a human right, must be accessible to everyone without exception.
37	(b) Health care resources and services must be distributed and accessed according to
38	people's needs. Health, income, employment, age, race, gender, immigration status and other
39	factors should not create any barriers to health care or disparities in health outcomes.
40	(c) The health care system must be accountable to the people it serves. It must ensure
41	effective delivery of care and stewardship of resources that improve individual and overall
42	population health and provide the means to maintain human rights standards in the distrib-
43	ution and delivery of health care.
44	(d) The health care system must be open to the public with regard to information,

45 decision-making and management.

(e) The health care system must enable meaningful public participation in all decisions 1 2 affecting people's right to health care. (f) Health care, as a fundamental element of a just society, must not be rationed by cost 3 as a commodity in private markets, but must be secured to the people on an equitable basis 4 by public means, similar to public education, public safety and public utilities. 5 (3) The plan shall pay the costs of health services that are medically necessary or med-6 ically appropriate for the maintenance of health, the prevention of health problems and the 7 diagnosis, treatment or rehabilitation of health conditions, within the scope of coverage 8 9 prescribed by the board, including but not limited to the following categories of health ser-10 vices: 11 (a) Primary and preventive care, including health education; 12(b) Specialty care; 13 (c) Inpatient and outpatient hospital care and emergency care; (d) Home health care; 14 (e) Prescription drugs according to a drug formulary; 15 (f) Durable medical equipment, including prosthetics; 16 (g) Mental and behavioral health services; 17 (h) Substance abuse treatment; 18 (i) Dental services; 19 (j) Chiropractic and naturopathic services; 20 (k) Women's health services: 21 (L) Ophthalmic services, as well as basic vision and vision correction; 22(m) Diagnostic imaging, laboratory services and other diagnostic and evaluation services; 23(n) Inpatient and outpatient rehabilitative services, including physical, speech and occu-94 pational therapy; 25(o) Emergency transportation; 2627(p) Translation of spoken and written language; (q) Palliative and hospice care; 28(r) Podiatry; 2930 (s) Acupuncture; 31 (t) Dialysis; and (u) Telemedicine, as it becomes available and effective. 32(4) The board shall determine the details for the plan's coverage of health services, in-33 34 cluding schedules for preventive, diagnostic and health maintenance services and prescription drugs, in accordance with the following criteria: 35(a) The plan must cover all services required by Medicare, Medicaid or the Patient Pro-36 37 tection and Affordable Care Act (P.L. 111-148), as amended by the Health Care and Education Reconciliation Act (P.L. 111-152), and by any other federal program that provides funds for 38 the plan. 39 (b) The plan must cover all services that were covered by the health benefit plans offered 40 by the Oregon Educators Benefit Board and the Public Employees' Benefit Board on the ef-41 fective date of this 2019 Act, unless there is strong medical evidence that coverage of specific 42 services should be discontinued. 43 (c) The board shall consider: 44 (A) The short-term clinical effectiveness and cost-effectiveness of a service, based upon 45

2 (B) Safety;

3 (C) In addition to symptoms and the immediate causes of symptoms, the underlying fac 4 tors that result in the need for care; and

5 (D) The importance of a patient's comfort with, and acceptance of, a service as clinically 6 valuable.

7 (d) The plan must cover health services that:

8 (A) Are evidence-based and cost-effective in promoting health; and

9 (B) Emphasize disease prevention and health promotion.

(e) Subject to the requirements to provide comprehensive care and all medically neces-10 sary and medically appropriate care, the board may set limits on the reimbursement paid for 11 12 medical equipment and devices in order to encourage the use of the most economical equipment and devices. If the board limits the reimbursement paid for medical equipment and 13 devices, the board shall have a procedure that allows a plan participant to apply the re-14 15 imbursement amount toward the cost of a more costly type of equipment or device if, in the 16 discretion of the participant's health care provider, the equipment or device is medically necessary or medically appropriate for the participant's health needs. 17

(f) Health care services that are cosmetic may be covered if necessary for the participant
 to obtain employment, to improve mental health or to function in society.

(5) Copayments, deductibles or other forms of cost-sharing may not be imposed on par ticipants under the plan.

(6) Participants in the plan may choose any health care provider licensed, certified or
registered in this state or in another state for services within the scope of the provider's
license, certification or registration.

(7) Within the scope of services covered within each category, participants and their
 health care providers shall determine whether a treatment is medically necessary or med ically appropriate.

(8) The plan and any health care provider reimbursed by the plan may not discriminate
 against any participant on the basis of race, religion, sex, sexual orientation, gender identity,
 national origin, age, income or any basis prohibited by the civil rights laws of this state.

(9) The plan may not discriminate against any health care provider who is licensed, cer tified or registered in this state and who is acting within the provider's scope of practice.

(10) A health care provider reimbursed by the plan may not be required to offer any
 particular service unless denial of the service amounts to discrimination against a partic ipant or class of participants.

(11) Except as provided in subsection (4)(e) of this section, a health care provider shall
 accept payment from the plan for services covered by the plan as payment in full and may
 not bill a patient for an amount exceeding the reimbursement amount under the plan.

39 (12)(a) Administrative costs of the plan may not exceed:

40 (A) Twelve percent of the total costs of the plan during the first two years of plan op-41 eration.

42 (B) Eight percent of the total costs of the plan during the third and fourth years of plan
43 operation.

44 (C) Five percent of the total costs of the plan during the fifth and subsequent years of 45 plan operation.

1	(b) During the first four years of plan operation, total costs include transition costs and
2	the costs of retraining provided to workers displaced by the plan, as described in section 10
3	of this 2019 Act.
4	(13) A participant's loss of eligibility due to no longer meeting the criteria specified in
5	section 1 of this 2019 Act is a qualifying event for the purpose of continuation coverage re-
6	quired by 29 U.S.C. 1161. The Oregon Health Authority shall be considered to be a plan
7	sponsor of a group health plan and shall notify the participant losing coverage and the de-
8	pendents of the participant losing coverage of the option to continue coverage at the
9	participant's own expense.
10	SECTION 3. No later than October 1, 2023, the Health Care for All Oregon Board estab-
11	lished under section 7 of this 2019 Act shall develop and submit to the Legislative Assembly
12	a recommendation for the coverage of long term care services by the Health Care for All
13	Oregon Plan.
14	SECTION 4. Sections 5 and 6 of this 2019 Act are added to and made a part of the In-
15	surance Code.
16	SECTION 5. Notwithstanding any other provision of law, an insurer with a certificate of
17	authority to transact insurance in this state may not offer in this state a policy or certificate
18	of health insurance that reimburses the costs of health services covered under the Health
19	Care for All Oregon Plan.
20	SECTION 6. Actions taken by insurers may not be considered to be the transaction of
21	insurance for purposes of the Insurance Code if the actions are:

27	SECTION 7. (1) There is established the Health Care for All Oregon Board, consisting of
28	nine members appointed by the Governor and subject to confirmation by the Senate in the

30 21	manner prescribed by ORS 171.562 and 171.565. The membership must represent every con- gressional district in this state and include:
31 32	(a) Two licensed health care providers, one of whom is not a physician licensed under

42	nancial or pecuniary interest or investment in, or be employed by, a pharmaceutical com-
43	pany, health insurer or medical supply company.
44	(b) This subsection does not prohibit a person from having a financial interest resulting
45	from investments made by a pension fund or through mutual funds, blind trusts or similar

investments where the person does not exercise control over the nature, amount or timing

2 of the investment.

3 (c) A board member shall sign an agreement that the member will not be employed by,
4 or have voting or decision-making power for, a pharmaceutical company, health insurer or
5 medical supply company for a period of five years after tenure as a board member ceases.

6 (3) The term of office of each member is four years and begins on the January 2 next 7 following appointment. A new term begins on the expiration of the previous term. A member 8 is eligible for reappointment for a new term. The Governor shall appoint a person to fill any 9 vacancy, subject to confirmation by the Senate. Any appointment to a vacant position shall 10 become immediately effective for the unexpired term.

(4) The board shall select one of its members as chairperson and another as vice chair person, for such terms and with duties and powers necessary for the performance of the
 functions of such offices as the board determines.

(5) A majority of the members of the board constitutes a quorum for the transaction of
 business.

(6) The board shall meet at a place, day and hour determined by the chairperson or a
 majority of the members of the board.

(7) Consistent with ORS chapter 244, the board shall adopt rules of ethics and definitions
 of conflicts of interest for determining the circumstances under which members of the board
 must recuse themselves from voting.

(8) A member of the board is entitled to compensation and expenses as provided in ORS
292.495 for participation in board, committee and subcommittee meetings.

(9)(a) The board may establish such advisory and technical committees as the board
 considers necessary. The committees may be continuing or temporary. The board shall de termine the representation, membership, terms and organization of the committees and shall
 appoint their members.

(b) Members of advisory and technical committees, other than board members, are not entitled to compensation, but in the discretion of the board may be reimbursed from funds available to the board for actual and necessary travel and other expenses incurred by them in the performance of their official duties in the manner and amount provided in ORS 292.495. (10) In accordance with applicable provisions of ORS chapter 183, the board may adopt

rules necessary for the administration of the laws that the board is charged with administering.

(11) The Oregon Health Authority shall provide staff support for the board and its com mittees and subcommittees until the board hires an executive director under section 9 of this
 2019 Act. The executive director and the executive director's subordinates shall provide staff
 support once the executive director and subordinates are in place.

(c) Determining the package of benefits covered in the plan in accordance with section 14 15 2 of this 2019 Act. 16 (d) Managing the Health Care for All Oregon Fund established under section 13 of this 2019 Act. 17 18 (e) Determining policies and adopting rules to guide the operation of the plan, including but not limited to: 19 20(A) Establishing eligibility standards for participation, including standards for presumptive eligibility determinations; 2122(B) Developing quality of care indicators; 23(C) Ensuring meaningful access by plan participants to quality health services; (D) Establishing policies regarding conflicts of interest for health care providers and 94 health care facilities providing health services to plan participants; 25(E) Regularly soliciting input from the public, including individuals with special health 2627care needs, through regional advisory committees appointed under section 17 of this 2019 Act and other means; and 28(F) Ensuring that the plan is implemented in accordance with section 2 of this 2019 Act. 2930 (f) Hiring an executive director who serves at the pleasure of the board and who, subject 31 to approval by the board, shall appoint all subordinate officers and employees that the executive director deems necessary and shall prescribe their duties and fix their compensation. 32(g) Approving contracts for items and services provided by health care providers to plan 33 34 participants. 35(h) Partnering with public health agencies to take steps to improve the health of the 36 overall population. 37 (i) Reporting, at least annually, to the Legislative Assembly during a regular session on 38 the performance of the plan, and recommending needed legislative changes. 1	SECTION 10. (1) The Health Care for All Oregon Board, in consultation with the Transi-
2	tion Commission established under section 23 of this 2019 Act, shall establish a program to
3	be operated for a four-year period beginning on the operative date specified in section 115
4	of this 2019 Act, to pay or reimburse the costs of retraining for workers displaced by the
5	implementation of the Health Care for All Oregon Plan. The Oregon Health Authority shall

25	accessible to all Oregonians, and propose major policy changes to the board;
26	(5) Establish systems to monitor and evaluate the access to, and the quality and cost of,
27	health services provided to Oregonians;
28	(6) Make recommendations to the board for ensuring equity in the delivery of culturally
29	appropriate health services to all Oregonians;
30	(7) Assist the board in negotiations with the federal government, with local governments
31	and with other state agencies as necessary to implement the plan;
32	(8) Direct research to improve health and health services;
33	(9) Identify legislation needed to improve the health services covered under the plan;
34	(10) Establish collaborative partnerships with other public health agencies;
35	(11) Develop a biennial budget to recommend to the board;
36	(12) Administer the legislatively approved budget for the plan;
37	(13) Report periodically to the board, the Governor and the Legislative Assembly on the
38	progress of implementing the plan and on the financial status of the plan;
39	(14) Arrange for appropriate and timely support that allows the board to carry out the
40	board's functions;
41	(15) Ensure prompt payment for all plan expenditures;
42	(16) Subject to the board's approval, enter into contracts with entities to process health
43	care claims and payments;
44	(17) Contract for actuarial, legal, technical or other professional services as needed;
45	(18) Enter into contracts with health care providers to provide health services on favor-

able terms and prices;

2	(19) Establish a system for monitoring the health services covered by the plan to ensure
3	that the health services are medically necessary or medically appropriate, and take remedial
