## **A-Engrossed** Senate Bill 800

Ordered by the Senate April 10 Including Senate Amendments dated April 10

Sponsored by COMMITTEE ON EDUCATION (at the request of Senator Rob Wagner)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Directs Higher Education Coordinating Commission to develop standards for partnership based in high school for purpose of providing dual credit program.] Directs Higher Education Coordinating Commission to convene specified persons for purpose of assisting in alignment of credits earned through dual credit programs with re-quirements of foundational curricula. Requires reports to interim committees of Legislative **Assembly related to education.** 

Directs commission to collect data related to acceptance of credits from foundational curriculum.

Declares emergency, effective on passage.
