SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Directs certifying agencies to certify to United States Citizenship and Immigration Services, within specified time, victim helpfulness in detecting, investigating or prosecuting qualifying criminal activity. Specifies certification procedures.

Directs certifying agencies to report annually to Oregon Criminal Justice Commission beginning June 1, [2020] **2021**. [Directs staff of interim committees related to judiciary to compile reports and provide to Oregon Criminal Justice Commission within 90 days.] Directs commission to prepare comprehensive report within 90 days and submit report to interim committees related to judiciary. Sunsets reporting requirement on January 2, [2022] **2023**.

(b) Nothing in this section prohibits the district attorney or assistant attorney general representing a party in a juvenile court proceeding, the juvenile department, the Department of Human Services, the Oregon Youth Authority or other parties in the proceeding or their attorneys from disclosing to each other reports, materials or documents described in subsections (1) and (2) of this section if the disclosure is reasonably necessary to perform official duties related to the involvement

(9) Nothing in this section limits access to any juvenile court records by an appellate court re-

viewing a juvenile court order or judgment. Appellate court rules may establish procedures for appellate court access to juvenile records.

3 (10) Nothing in this section prohibits the court from providing to the administrator as defined 4 in ORS 25.010 the date of entry of a judgment terminating parental rights or the date of entry of a 5 judgment terminating wardship following entry of a judgment of adoption together with the names 6 and dates of birth of the parents and children subject to the judgment.

(14) The court shall cooperate in the sharing of information with a court in another state tofacilitate an interstate placement of a child or ward.

(16) Subject to subsection (11) of this section, the office of public defense services shall be permitted access to juvenile court records for the purposes of performing the office's duties as set forth in ORS 151.219 to audit or investigate attorney appointment or representation of a party in a juvenile court proceeding in order to ensure adequate representation of parties in juvenile court proceedings consistent with the child welfare state plan related to Title IV-E of the Social Security Act.

7 (17) Subject to subsection (11) of this section, the Oregon State Bar shall be permitted access 8 to juvenile court records maintained in the record of the case for the purpose of performing the 9 bar's duties as set forth in ORS 9.005 to 9.757 to investigate attorney representation of a party in 10 a juvenile court proceeding and in order to ensure adequate representation of parties in juvenile 11 court proceedings consistent with the child welfare state plan related to Title IV-E of the Social 12 Security Act.

(18)(a) A child, ward, youth or youth offender, or the parent or guardian of a child, ward, youth or youth offender who is a party to the juvenile court proceeding, who is entitled to inspect or copy the record of the case under subsection (1)(b) and (c) of this section maintains the right to inspect or copy the record of the case after jurisdiction of the court over the child, ward, youth or youth offender terminates and after the child, ward, youth or youth offender has reached the age of majority.

(b) Notwithstanding ORS 419B.524, a parent of a child, ward, youth or youth offender whose parental rights have been terminated maintains the right that existed under subsection (1)(b) and (c) of this section to inspect or copy the record of the case as the record of the case existed up until the time of entry of the judgment terminating the parent's parental rights and may obtain a copy of the judgment terminating the parent's parental rights.

(19) When inspection or copying of the record of the case or of the supplemental confidential file is allowed pursuant to this section, and unless otherwise required by law, the court that maintains the record of the case or the supplemental confidential file is not required to redact the names of, or information about, siblings or other persons contained in the record of the case or the supplemental confidential file.

(20) Nothing in this section prohibits the court, acting as a certifying agency or official
as defined in section 1 of this 2019 Act, from certifying a request under section 1 of this 2019
Act and including in the certification document any information obtained from the record
of the case or the confidential supplemental file that is necessary to complete the certification.
