# B-Engrossed Senate Bill 999

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies provisions requiring person to be informed about rights and consequences relating to driving under the influence of intoxicants.

## A BILL FOR AN ACT

2 Relating to traffic offenses; amending ORS 135.815, 813.100, 813.120, 813.130, 813.131, 813.132,  
3 813.135, 813.136, 813.140, 813.310, 813.320 and 813.602.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 813.100 is amended to read:

6 813.100. (1) Any person who operates a motor vehicle upon premises open to the public or the  
7 highways of this state shall be deemed to have given consent, subject to the implied consent law,  
8 to a chemical test of the person's breath, or of the person's blood if the person is receiving medical  
9 care in a health care facility immediately after a motor vehicle accident, for the purpose of deter-  
10 mining the alcoholic content of the person's blood if the person is arrested for driving a motor ve-  
11 hicle while under the influence of intoxicants in violation of ORS 813.010 or of a municipal  
12 ordinance. A test shall be administered upon the request of a police officer having reasonable  
13 grounds to believe the person arrested to have been driving while under the influence of intoxicants  
14 in violation of ORS 813.010 or of a municipal ordinance. Before the test is administered the person  
15 requested to take the test shall be informed of consequences and rights as described under ORS  
16 813.130.

17 *[(2) No chemical test of the person's breath or blood shall be given, under subsection (1) of this*  
18 *section, to a person under arrest for driving a motor vehicle while under the influence of intoxicants*  
19 *in violation of ORS 813.010 or of a municipal ordinance, if the person refuses the request of a police*  
20 *officer to submit to the chemical test after the person has been informed of consequences and rights as*  
21 *described under ORS 813.130.]*

22 *[(3)]* **(2)** If a person refuses to *[take]* **submit to** a test under this section or if a breath test under  
23 this section discloses that the person, at the time of the test, had a level of alcohol in the person's  
24 blood that constitutes being under the influence of intoxicating liquor under ORS 813.300 **and the**  
25 **person has been informed of rights and consequences as provided under ORS 813.130,** the  
26 person's driving privileges are subject to suspension under ORS 813.410 and the police officer shall

1 do all of the following:

2 (a) Immediately take custody of any driver license or permit issued by this state to the person  
3 to grant driving privileges.

4 (b) Provide the person with a written notice of intent to suspend, on forms prepared and pro-  
5 vided by the Department of Transportation. The written notice shall inform the person of conse-  
6 quences and rights as described under ORS 813.130.

7 (c) If the person qualifies under ORS 813.110, issue to the person, on behalf of the department,  
8 a temporary driving permit described under ORS 813.110.

9 (d) Within a period of time required by the department by rule, report action taken under this  
10 section to the department and prepare and cause to be delivered to the department a report as de-  
11 scribed in ORS 813.120, along with the confiscated license or permit and a copy of the notice of in-  
12 tent to suspend.

13 [(4)] (3) If a blood test under this section discloses that the person, at the time of the test, had  
14 a level of alcohol in the person's blood that constitutes being under the influence of intoxicating  
15 liquor under ORS 813.300, the person's driving privileges are subject to suspension under ORS  
16 813.410 and the police officer shall report to the department within 45 days of the date of arrest that  
17 the person failed the blood test.

18 [(5)] (4) Nothing in this section precludes a police officer from obtaining a chemical test of the  
19 person's breath or blood through any lawful means for use as evidence in a criminal or civil pro-  
20 ceeding including, but not limited to, obtaining a search warrant.

21 **SECTION 2.** ORS 813.130 is amended to read:

22 813.130. This section establishes the requirements for information about rights and consequences  
23 for purposes of ORS 813.100 and 813.410. The following apply to the information about rights and  
24 consequences:

25 (1) The information about rights and consequences shall be substantially in the form prepared  
26 by the Department of Transportation. The department may establish any form it determines appro-  
27 priate and convenient.

28 (2) **Except as provided in subsection (3) of this section,** the information about rights and  
29 consequences shall be substantially as follows:

30 (a) Driving under the influence of intoxicants is a crime in Oregon, and the person is subject  
31 to criminal penalties if a test under ORS 813.100 shows that the person is under the influence of  
32 intoxicants. If the person [*refuses a test or*] fails a **test**, evidence of the [*refusal or*] failure may also  
33 be offered against the person.

34 (b) The person will fail a test under ORS 813.100 for purposes of criminal penalties if the test  
35 discloses a blood alcohol content of 0.08 percent or more by weight **of alcohol in the blood of the**  
36 **person as shown by chemical analysis of the breath or blood.** The person will fail a test for  
37 purposes of the Motorist Implied Consent Law if the test discloses a blood alcohol content of:

38 (A) 0.08 percent or more by weight **of alcohol in the blood of the person as shown by**  
39 **chemical analysis of the breath or blood** if the person was not driving a commercial motor vehi-  
40 cle;

41 (B) 0.04 percent or more by weight **of alcohol in the blood of the person as shown by**  
42 **chemical analysis of the breath or blood** if the person was driving a commercial motor vehicle;

43 or

44 (C) Any amount if the person was under 21 years of age.

45 (c) If the person [*refuses or*] fails a test under ORS 813.100, the person's driving privileges will

1 be suspended. The outcome of a criminal charge for driving under the influence of intoxicants will  
2 not affect the suspension. [*The suspension will be substantially longer if the person refuses a test.*]

3 (d) If the person [*refuses a test or*] fails a breath test under ORS 813.100 and has an Oregon  
4 driver license or permit, the license or permit will be taken immediately and, unless the person does  
5 not currently have full valid driving privileges, a temporary driving permit will be issued to the  
6 person.

7 [(e) *If the person refuses a test under ORS 813.100, the person is not eligible for a hardship permit*  
8 *for at least 90 days, and possibly for three years, depending on the following factors set forth in ORS*  
9 *813.430:*]

10 [(A) *Whether the person is presently participating in a driving while under the influence of*  
11 *intoxicants diversion program in this state or in any similar alcohol or drug rehabilitation program in*  
12 *this or another jurisdiction; or*]

13 [(B) *Whether within the five years preceding the date of arrest any of the following occurred:*]

14 [(i) *A suspension of the person's driving privileges under ORS 813.410 or 482.540 (1981 Replace-*  
15 *ment Part) became effective;*]

16 [(ii) *The person was convicted of driving while under the influence of intoxicants in violation of*  
17 *ORS 813.010 or the statutory counterpart to ORS 813.010 in another jurisdiction, as described in ORS*  
18 *813.430;*]

19 [(iii) *The person was convicted of driving while under the influence of intoxicants in violation of*  
20 *a municipal ordinance in this state or another jurisdiction, as described in ORS 813.430; or*]

21 [(iv) *The person commenced participating in a driving while under the influence of intoxicants di-*  
22 *version program in this state or in any similar alcohol or drug rehabilitation program in this or an-*  
23 *other jurisdiction, as described in ORS 813.430.*]

24 [(f) *If the person refuses a breath test under ORS 813.100, or refuses a urine test under ORS*  
25 *813.131 and 813.132, the person is subject to a fine of at least \$500 and not more than \$1,000.*]

26 [(g) (e) After taking a test under ORS 813.100, the person will have a reasonable opportunity,  
27 upon request, for an additional chemical test for blood alcohol content to be performed at the  
28 person's own expense by a qualified individual of the person's choosing.

29 [(h) (f) The person has a right to a hearing to challenge the validity of the suspension before  
30 the suspension becomes effective. The person must make a written request to the department for  
31 such a hearing. If the person wins at the hearing, the person's driving privileges will not be sus-  
32 pended. If the person loses at the hearing, the suspension will remain in effect during any court  
33 review of the hearing.

34 [(i) (g) If the person is issued a temporary driving permit under ORS 813.100, the information  
35 provided to the person shall include the number of hours before the driving permit will be effective  
36 and the number of days the permit will be effective.

37 [(j) (h) The information provided to the person shall include the number of days within which  
38 a person must request a hearing under ORS 813.410.

39 [(k) (i) The information provided to the person shall include the number of days within which  
40 a hearing under ORS 813.410 will be held.

41 [(L) (j) The person may possibly qualify for a hardship permit in 30 days if the person fails a  
42 test, depending on the person's driving record.

43 [(3) *If the person is driving a commercial motor vehicle, the information about rights and conse-*  
44 *quences shall include, in addition to the provisions of subsection (2) of this section, substantially the*  
45 *following:*]

1        *[(a) If the person refuses a test under ORS 813.100 or submits to a breath or blood test and the*  
2 *level of alcohol in the person's blood is 0.04 percent or more by weight, the person's commercial driving*  
3 *privileges or right to apply for commercial driving privileges will be suspended and no hardship permit*  
4 *authorizing the person to drive a commercial motor vehicle will be issued. The suspension will be*  
5 *substantially longer if the person refuses a test.]*

6        *[(b) The suspension of the person's commercial driving privileges or right to apply for commercial*  
7 *driving privileges will be for the person's lifetime if the person refuses a test under ORS 813.100 or*  
8 *submits to a breath or blood test and the level of alcohol in the person's blood is 0.04 percent or more*  
9 *by weight and:]*

10        *[(A) The person previously has been convicted of failure to perform the duties of a driver;]*

11        *[(B) The person previously has been convicted of a crime punishable as a felony and the person*  
12 *was driving a motor vehicle at the time the offense was committed;]*

13        *[(C) The person previously has been convicted of driving a commercial motor vehicle while the*  
14 *person's commercial driving privileges or right to apply for commercial driving privileges was sus-*  
15 *pending or revoked for offenses committed while operating a commercial motor vehicle;]*

16        *[(D) The person previously has been convicted of any degree of murder, manslaughter or criminally*  
17 *negligent homicide resulting from the operation of a commercial motor vehicle or assault in the first*  
18 *degree resulting from the operation of a commercial motor vehicle;]*

19        *[(E) The person previously has been convicted of driving while under the influence of*  
20 *intoxicants;]*

21        *[(F) The person's commercial driving privileges previously have been suspended or revoked for*  
22 *refusal to submit to, or failure of, a breath or blood test under ORS 813.100; or]*

23        *[(G) The person's right to apply for commercial driving privileges previously has been suspended*  
24 *or revoked for refusal to submit to, or failure of, a breath or blood test under ORS 813.100 resulting*  
25 *from the operation of a commercial motor vehicle.]*

26        **(k) If the person is driving a commercial motor vehicle, and takes a breath or blood test**  
27 **under ORS 813.100 after being informed of the rights and consequences under paragraphs (a)**  
28 **to (j) of this subsection, the following additional information shall be provided:**

29        **(A) If the level of alcohol in the person's blood is 0.04 percent or more by weight of al-**  
30 **cohol in the blood of the person as shown by chemical analysis of the breath or blood, the**  
31 **person's commercial driving privileges or right to apply for commercial driving privileges**  
32 **will be suspended and no hardship permit authorizing the person to drive a commercial mo-**  
33 **tor vehicle will be issued.**

34        **(B) The suspension of the person's commercial driving privileges or right to apply for**  
35 **commercial driving privileges will be for the person's lifetime if the person takes a breath**  
36 **or blood test and the level of alcohol in the person's blood is 0.04 percent or more by weight**  
37 **of alcohol in the blood of the person as shown by chemical analysis of the breath or blood**  
38 **and:**

39        **(i) The person previously has been convicted of failure to perform the duties of a driver;**

40        **(ii) The person previously has been convicted of a crime punishable as a felony and the**  
41 **person was driving a motor vehicle at the time the offense was committed;**

42        **(iii) The person previously has been convicted of driving a commercial motor vehicle**  
43 **while the person's commercial driving privileges or right to apply for commercial driving**  
44 **privileges was suspended or revoked for offenses committed while operating a commercial**  
45 **motor vehicle;**

1 (iv) The person previously has been convicted of any degree of murder, manslaughter or  
2 criminally negligent homicide resulting from the operation of a commercial motor vehicle  
3 or assault in the first degree resulting from the operation of a commercial motor vehicle;

4 (v) The person previously has been convicted of driving while under the influence of  
5 intoxicants;

6 (vi) The person's commercial driving privileges previously have been suspended or re-  
7 voked for refusal to submit to, or failure of, a breath or blood test under ORS 813.100; or

8 (vii) The person's right to apply for commercial driving privileges previously has been  
9 suspended or revoked for refusal to submit to, or failure of, a breath or blood test under ORS  
10 813.100 resulting from the operation of a commercial motor vehicle.

11 (3) A person who refuses to submit to a chemical test after being informed of the rights  
12 and consequences in subsection (2) of this section shall be provided additional information,  
13 substantially as follows:

14 (a) If the person refuses to provide consent to a breath or blood test, and is thereafter  
15 requested to provide only physical cooperation to submit to a breath or blood test, and the  
16 person refuses to physically submit to a test, evidence of that refusal may be offered against  
17 the person.

18 (b) If the person refuses to submit to a test under ORS 813.100, the person's driving  
19 privileges will be suspended. The outcome of a criminal charge for driving under the influ-  
20 ence of intoxicants will not affect the suspension. The suspension will be substantially longer  
21 if a person refuses a test.

22 (c) If the person refuses to submit to a breath test under ORS 813.100 and has an Oregon  
23 driver license or permit, the license or permit will be taken immediately and, unless the  
24 person does not currently have full valid driving privileges, a temporary driving permit will  
25 be issued to the person.

26 (d) If the person refuses to submit to a test under ORS 813.100, the person is not eligible  
27 for a hardship permit for at least 90 days, and possibly for three years, depending on the  
28 following factors set forth in ORS 813.430:

29 (A) Whether the person is presently participating in a driving while under the influence

37 lation of ORS 813.010 or the statutory counterpart to ORS 813.010 in another jurisdiction, as  
38 described in ORS 813.430;

39 (iii) The person was convicted of driving while under the influence of intoxicants in vio-  
40 lation of a municipal ordinance in this state or another jurisdiction, as described in ORS  
41 813.430; or

42 (iv) The person commenced participating in a driving while under the influence of  
43 intoxicants diversion program in this state or in any similar alcohol or drug rehabilitation  
44 program in this or another jurisdiction, as described in ORS 813.430.

45 (e) If the person refuses to submit to a breath test under ORS 813.100, or refuses to

1 provide a urine sample under ORS 813.131 and 813.132, the person is subject to a fine of at  
2 least \$500 and not more than \$1,000.

3 (f) The person has a right to a hearing to challenge the validity of the suspension before  
4 the suspension becomes effective. The person must make a written request to the depart-  
5 ment for such a hearing. If the person wins at the hearing, the person's driving privileges  
6 will not be suspended. If the person loses at the hearing, the suspension will remain in effect  
7 during any court review of the hearing.

8 (g) If the person is issued a temporary driving permit under ORS 813.100, the number of  
9 hours before the driving permit will be effective and the number of days the permit will be  
10 effective.

11 (h) The number of days within which a person must request a hearing under ORS 813.410.

12 (i) The number of days within which a hearing under ORS 813.410 will be held.

13 (j) The person may possibly qualify for a hardship permit in 30 days if the person fails a  
14 test, depending on the person's driving record.

15 (k) If the person is driving a commercial motor vehicle, further information as follows:

16 (A) If the person refuses to submit to a test under ORS 813.100, the person's commercial  
17 driving privileges or right to apply for commercial driving privileges will be suspended and  
18 no hardship permit authorizing the person to drive a commercial motor vehicle will be is-  
19 sued. The suspension will be substantially longer if the person refuses the test.

20 (B) The suspension of the person's commercial driving privileges or right to apply for  
21 commercial driving privileges will be for the person's lifetime if the person refuses to submit  
22 to a test under ORS 813.100 and:

23 (i) The person previously has been convicted of failure to perform the duties of a driver;

24 (ii) The person previously has been convicted of a crime punishable as a felony and the  
25 person was driving a motor vehicle at the time the offense was committed;

26 (iii) The person previously has been convicted of driving a commercial motor vehicle  
27 while the person's commercial driving privileges or right to apply for commercial driving  
28 privileges was suspended or revoked for offenses committed while operating a commercial  
29 motor vehicle;

30 (iv) The person previously has been convicted of any degree of murder, manslaughter or  
31 criminally negligent homicide resulting from the operation of a commercial motor vehicle  
32 or assault in the first degree resulting from the operation of a commercial motor vehicle;

33 (v) The person previously has been convicted of driving while under the influence of  
34 intoxicants;

35 (vi) The person's commercial driving privileges previously have been suspended or re-  
36 voked for refusal to submit to, or failure of, a breath or blood test under ORS 813.100; or

37 (vii) The person's right to apply for commercial driving privileges previously has been  
38 suspended or revoked for refusal to submit to, or failure of, a breath or blood test under ORS  
39 813.100 resulting from the operation of a commercial motor vehicle.

40 (4) Nothing in this section prohibits the department from providing additional information con-  
41 cerning rights and consequences that the department considers convenient or appropriate.

42 **SECTION 3.** ORS 813.131 is amended to read:

43 813.131. (1) A person may be asked to provide a urine sample under ORS 813.140 or sub-  
44 section (2) of this section.

45 [(1)] (2) Any person who operates a motor vehicle upon premises open to the public or the

1 highways of this state shall be deemed to have given consent, subject to the Motorist Implied Con-  
2 sent Law, to a chemical test of the person's urine for the purpose of determining the presence of  
3 cannabis, a controlled substance or an inhalant in the person's body if the person is arrested for  
4 driving while under the influence of intoxicants in violation of ORS 813.010 or of a municipal ordi-  
5 nance and either:

6 (a) The person takes the breath test described in ORS 813.100 and the test discloses a blood  
7 alcohol content of less than 0.08 percent; or

8 (b) The person is involved in an accident resulting in injury or property damage. A urine test  
9 may be requested under this paragraph regardless of whether a breath test has been requested and  
10 regardless of the results of a breath test, if one is taken.

11 [(2)] (3) A police officer may not request a urine test unless the officer is certified by the De-  
12 partment of Public Safety Standards and Training as having completed at least eight hours of  
13 training in recognition of drug impaired driving and the officer has a reasonable suspicion that the  
14 person arrested has been driving while under the influence of cannabis, a controlled substance, an  
15 inhalant or any combination of cannabis, a controlled substance, an inhalant and intoxicating liquor.

16 [(3)] (4) A person asked to give a urine sample shall be given privacy and may not be observed  
17 by a police officer when producing the sample.

18 [(4)(a)] (5)(a) At the trial of any civil or criminal action, suit or proceeding arising out of the  
19 acts committed by a person driving a motor vehicle while under the influence of intoxicants, a valid  
20 chemical analysis of a person's urine is admissible as evidence and may be used with other evidence,  
21 if any, to determine whether the person was driving while under the influence of intoxicants.

22 (b) A chemical analysis of a person's urine is valid [*under this subsection*] if analysis is per-  
23 formed in an accredited or licensed toxicology laboratory.

24 **SECTION 4.** ORS 813.132 is amended to read:

25 813.132. (1) Except as otherwise provided in this section, a refusal to [*take*] **submit to** a urine  
26 test requested under ORS 813.131 shall be treated for all purposes as a refusal to [*take*] **submit to**  
27 a breath test. A suspension imposed for refusal to [*take*] **submit to** a urine test **under ORS 813.131**  
28 (2) shall be consecutive to any other suspension imposed under the Motorist Implied Consent Law.  
29 If a person is subject to consecutive suspensions, the length of time that must elapse before the  
30 Department of Transportation may reinstate driving privileges or issue a hardship permit under ORS  
31 813.520 shall be doubled.

32 (2) [*Before any test of urine may be administered*] **If a person refuses to submit to a urine test**  
33 under ORS 813.131 (2), in addition to information described in ORS 813.130, the person asked to take  
34 the test shall be informed that if the person refuses **to submit to** the test, the person's driving  
35 privileges will be suspended for the same time period and with the same consequences as if the  
36 person had refused **to submit to** the breath test and that a suspension for refusal [*of*] **to submit**  
37 **to** the urine test will be consecutive to any other suspension under the Motorist Implied Consent  
38 Law.

39 (3) Notwithstanding subsection (1) of this section, no suspension of driving privileges shall be  
40 imposed for refusal to [*provide a urine sample*] **submit to a urine test** if the person provides doc-  
41 umentation from a physician licensed by this state showing that the person has a medical condition  
42 that makes it impossible for the person to provide a sample.

43 **SECTION 5.** ORS 813.135 is amended to read:

44 813.135. Any person who operates a vehicle upon premises open to the public or the highways  
45 of the state shall be deemed to have given consent to submit to field sobriety tests upon the request

1 of a police officer for the purpose of determining if the person is under the influence of intoxicants  
2 if the police officer reasonably suspects that the person has committed the offense of driving while  
3 under the influence of intoxicants in violation of ORS 813.010 or a municipal ordinance. *[Before the*  
4 *tests are administered, the person requested to take the tests shall be informed of the consequences of*  
5 *refusing to take or failing to submit to the tests under ORS 813.136]* **If the person refuses to con-**  
6 **sent to field sobriety tests, the person shall be asked to provide only physical cooperation to**  
7 **submit to nontestimonial field sobriety tests, and the person shall be informed of the con-**  
8 **sequences of failing to physically submit to those tests under ORS 813.136.**

9 **SECTION 6.** ORS 813.136 is amended to read:

10 813.136. If a person refuses or fails to **physically** submit to field sobriety tests as required by  
11 ORS 813.135 **after the person has been informed of the consequences of refusing to submit,**  
12 evidence of the person's refusal or failure to **physically** submit is admissible in any criminal or civil  
13 action or proceeding arising out of allegations that the person was driving while under the influence  
14 of intoxicants.

15 **SECTION 7.** ORS 813.140 is amended to read:

16 813.140. Nothing in ORS 813.100, **813.131 or 813.132** is intended to preclude the administration  
17 of a chemical test described in this section. A police officer may obtain a chemical test of the breath  
18 or blood to determine the amount of alcohol in any person's blood or a test of the person's blood  
19 or urine, or both, to determine the presence of cannabis, a controlled substance or an inhalant in  
20 the person as provided in the following:

21 (1) If, when requested by a police officer, the person expressly consents to such a test.

22 (2) Notwithstanding subsection (1) of this section, from a person without the person's consent  
23 if:

24 (a) The police officer has probable cause to believe that the person was driving while under the  
25 influence of intoxicants and that evidence of the offense will be found in the person's blood or urine;  
26 and

27 (b) The person is unconscious or otherwise in a condition rendering the person incapable of  
28 expressly consenting to the test or tests requested.

29 **SECTION 8.** ORS 813.310 is amended to read:

30 813.310. If a person refuses to **physically** submit to a chemical test under ORS 813.100 **or**  
31 **813.131** *[or refuses to consent to chemical tests under ORS 813.140]*, evidence of the person's refusal  
32 is admissible in any civil or criminal action, suit or proceeding arising out of acts alleged to have  
33 been committed while the person was driving a motor vehicle on premises open to the public or the  
34 highways while under the influence of intoxicants.

35 **SECTION 9.** ORS 813.320 is amended to read:

36 813.320. (1) The provisions of the implied consent law, except ORS 813.300, shall not be con-  
37 strued by any court to limit the introduction of otherwise competent, relevant evidence in any civil  
38 action, suit or proceedings or in any criminal action other than a violation of ORS 813.010 or a  
39 similar municipal ordinance in proceedings under ORS 813.410.

40 (2) The provisions of the implied consent law shall not be construed by any court to limit the  
41 introduction of otherwise competent, relevant evidence of the amount of alcohol in the blood of a  
42 defendant in a prosecution for driving while under the influence of intoxicants. *[if:]*

43 *[(a) The evidence results from a test of blood taken from the defendant while the defendant was*  
44 *hospitalized or otherwise receiving medical care, whether or not the defendant consented to the drawing*  
45 *of blood or to the test; or]*



1        *[(b) The evidence is obtained pursuant to a search warrant.]*

3 (a) The names and addresses of persons whom the district attorney intends to call as witnesses  
4 at any stage of the trial, together with their relevant written or recorded statements or memoranda  
5 of any oral statements of such persons.

6 (b) Any written or recorded statements or memoranda of any oral statements made by the de-  
7 fendant, or made by a codefendant if the trial is to be a joint one.

8 (c) Any reports or statements of experts, made in connection with the particular case, including  
9 results of physical or mental examinations and of scientific tests, experiments or comparisons which  
10 the district attorney intends to offer in evidence at the trial.

11 (d) Any books, papers, documents, photographs or tangible objects:

12 (A) Which the district attorney intends to offer in evidence at the trial; or

13 (B) Which were obtained from or belong to the defendant.

14 (e) If actually known to the district attorney, any record of prior criminal convictions of persons  
15 whom the district attorney intends to call as witnesses at the trial; and the district attorney shall  
16 make a good faith effort to determine if such convictions have occurred.

17 (f) All prior convictions of the defendant known to the state that would affect the determination

40 (a) Any report prepared by a police officer relating to field tests, interviews, observations and

42 (b) Any report relating to the test results;

43 (c) A copy of the form provided to the defendant under ORS 813.100 [(3)(b)] **(2)(b)**; and

44 (d) Any checklist prepared by the operator of the instrument for the test.

45 (4)(a) If a defendant is not represented by a lawyer, the district attorney shall disclose to the

1 defendant all of the information described in subsections (1) and (3) of this section except for the  
2 personal identifiers of the victim and any witnesses.

3 (b) Notwithstanding paragraph (a) of this subsection, the district attorney shall disclose the  
4 personal identifiers of the victim and any witnesses if the trial court orders the disclosure. A trial  
5 court shall order the district attorney to disclose the personal identifiers of the victim and any  
6 witnesses if the trial court finds that:

7 (A) The defendant has requested the information; and

8 (B)(i) The victim or witness is a business or institution and disclosure of the information would  
9 not represent a risk of harm to the victim or witness; or

10 (ii) The need for the information cannot reasonably be met by other means.

11 (5)(a) Unless authorized by the trial court to disclose the information, a lawyer representing a  
12 defendant, or a representative of the lawyer, may not disclose to the defendant personal identifiers  
13 of a victim or witness obtained under subsections (1) and (3) of this section.

14 (b) The trial court shall order the lawyer, or representative of the lawyer, to disclose to the  
15 defendant the personal identifiers of a victim or witness if the court finds that:

16 (A) The defendant's lawyer has requested the district attorney to disclose the information to the  
17 defendant;

18 (B) The district attorney has refused to disclose the information to the defendant; and

19 (C) The need for the information cannot reasonably be met by other means.

20 (6) As used in this section:

21 (a) "Personal identifiers" means:

22 (A) In relation to a witness, the witness's address, telephone number, Social Security number  
23 and date of birth and the identifying number of the witness's depository account at a financial in-  
24 stitution, as defined in ORS 706.008, or credit card account.

25 (B) In relation to a victim, the victim's address, electronic mail address, telephone number, So-  
26 cial Security number, date of birth, any user names or other identifying information associated with  
27 the victim's social media accounts and the identifying number of the victim's depository account at  
28 a financial institution, as defined in ORS 706.008, or credit card account.

29 (b) "Representative of the lawyer" has the meaning given that term in ORS 40.225.

30 (c) "Represented defendant" means a defendant who is represented by a lawyer in a criminal  
31 action.

32 (d) "Social media" has the meaning given that term in ORS 659A.330.

33 **SECTION 12.** ORS 813.120 is amended to read:

34 813.120. (1) A report required by ORS 813.100 shall disclose substantially all of the following  
35 information:

36 (a) Whether the person, at the time the person was requested to submit to a test, was under  
37 arrest for driving a motor vehicle while under the influence of intoxicants in violation of ORS  
38 813.010 or of a municipal ordinance.

39 (b) Whether the police officer had reasonable grounds to believe, at the time the request was  
40 made, that the person arrested had been driving under the influence of intoxicants in violation of  
41 ORS 813.010 or of a municipal ordinance.

42 (c) Whether the person refused to submit to a test or if the person submitted to a breath or  
43 blood test whether the level of alcohol in the person's blood, as shown by the test, was sufficient  
44 to constitute being under the influence of intoxicating liquor under ORS 813.300.

45 (d) Whether the person was driving a commercial motor vehicle and refused to submit to a test

1 or if the person submitted to a breath or blood test whether the level of alcohol in the person's  
2 blood, as shown by the test, was 0.04 percent or more by weight.

3 (e) Whether the person was informed of consequences and rights as described under ORS  
4 813.130.

5 (f) Whether the person was given written notice of intent to suspend required by ORS 813.100  
6 [(3)(b)] **(2)(b)**.

7 (g) If the arrested person took a test, a statement that the person conducting the test was ap-  
8 propriately qualified.

9 (h) If the arrested person took a test, a statement that any methods, procedures and equipment  
10 used in the test comply with any requirements under ORS 813.160.

11 (2) A report required by ORS 813.100 may be made in one or more forms specified by the De-  
12 partment of Transportation.
