**PROPOSED AMENDMENTS TO
SENATE BILL 52**

1 On page 1 of the printed bill, delete lines 4 through 28.

2 On page 2, delete lines 1 through 19 and insert:

3 **“SECTION 1. (1) This section shall be known and may be cited as**
4 **Adi’s Act.**

5 **“(2) In accordance with rules adopted by the State Board of Edu-**
6 **cation in consultation with the Oregon Health Authority, each school**
7 **district shall adopt a policy requiring a comprehensive district plan**
8 **on student suicide prevention for students in kindergarten through**
9 **grade 12.**

10 **“(3) A plan required under this section must include:**

11 **“(a) Procedures relating to suicide prevention, intervention and**
12 **activities that reduce risk and promote healing after a suicide;**

13 **“(b) Identification of the school officials responsible for responding**
14 **to reports of suicidal risk;**

15 **“(c) A procedure by which a person may request a school district**
16 **to review the actions of a school in responding to suicidal risk;**

17 **“(d) Methods to address the needs of high-risk groups, including:**

18 **“(A) Youth bereaved by suicide;**

19 **“(B) Youth with disabilities, mental illness or substance use disor-**
20 **ders;**

21 **“(C) Youth experiencing homelessness or out-of-home settings, such**

1 as foster care; and

2 “(D) Lesbian, gay, bisexual, transgender, queer and other minority
3 gender identities and sexual orientations;

4 “(e) A description of, and materials for, any training to be provided
5 to school employees as part of the plan, which must include:

6 “(A) When and how to refer youth and their families to appropriate
7 mental health services; and

8 “(B) Programs that can be completed through self-review of suit-
9 able suicide prevention materials; and

10 “(f) Any other requirement prescribed by the State Board of Edu-
11 cation by rule, based on consultations with state and national suicide
12 prevention organizations, suicide experts and school-based mental
13 health providers, and based on reviews of national models.

14 “(4) A school district may consult with state or national suicide
15 prevention organizations, the Department of Education, school-based
16 mental health professionals, parents, guardians, school employees,
17 students, administrators and school board associations when develop-
18 ing the plan required under this section.

19 “(5) The plan required under this section:

20 “(a) Must be written to ensure that a school employee acts only
21 within the authorization and scope of the employee’s credentials or
22 licenses. Nothing in this section shall be construed as authorizing or
23 encouraging a school employee to diagnose or treat mental illness
24 unless the employee is specifically licensed and employed to do so.

25 “(b) Must be:

26 “(A) Made available annually to the community of the school dis-
27 trict, including students of the school district, parents and guardians
28 of students of the school district, and employees and volunteers of the
29 school district.

30 “(B) Readily available at the school district office and on the school

2 **“(6) A school district that does not comply with the requirements**
3 **of this section is considered to be nonstandard under ORS 327.103.”.**
