**PROPOSED AMENDMENTS TO
SENATE BILL 135**

1 In line 2 of the printed bill, after “analysis;” insert “creating new pro-
2 visions; amending ORS 676.820;”.

3 Delete lines 16 through 24 and insert:

4 **“SECTION 3.** ORS 676.820 is amended to read:

5 “676.820. (1) An individual licensed under ORS 676.810 or registered under
6 ORS 676.815 may practice applied behavior analysis.

7 **“(2) An individual may not practice applied behavior analysis for the**
8 **purpose of treating a mental, emotional or behavioral disorder unless**
9 **the individual is licensed under ORS 676.810 or registered under ORS**
10 **676.815. This subsection does not apply to:**

11 **“(a) A licensed health care professional; or**

12 **“(b) A family member of a patient if the family member is acting**
13 **at the direction of an individual licensed under ORS 676.810 or a li-**
14 **censed health care professional.**

15 “[2] **(3)** Only an individual who is licensed under ORS 676.810 or regis-
16 tered under ORS 676.815 may use the title ‘licensed behavior analyst,’ ‘li-
17 censed assistant behavior analyst’ or ‘registered behavior analysis
18 interventionist.’

19 **“(4) A penalty for a violation of subsection (2) of this section may**
20 **be imposed in addition to other applicable disciplinary actions that**
21 **may be imposed by a board listed in ORS 676.802.**

1 **“SECTION 4. Section 2 of this 2019 Act and the amendments to ORS**
2 **676.820 by section 3 of this 2019 Act apply to acts performed on or after**
3 **the operative date specified in section 5 of this 2019 Act.**

4 **“SECTION 5. (1) Section 2 of this 2019 Act and the amendments to**
5 **ORS 676.820 by section 3 of this 2019 Act become operative on January**
6 **1, 2020.**

7 **“(2) The Health Licensing Office and the boards listed in ORS**
8 **676.802 may take any action before the operative date specified in**
9 **subsection (1) of this section that is necessary to enable the office and**
10 **the boards to exercise, on and after the operative date specified in**
11 **subsection (1) of this section, all of the duties, functions and powers**
12 **conferred on the office and the boards by section 2 of this 2019 Act and**
13 **the amendments to ORS 676.820 by section 3 of this 2019 Act.**

14 **“SECTION 6. This 2019 Act takes effect on the 91st day after the**
15 **date on which the 2019 regular session of the Eightieth Legislative**
16 **Assembly adjourns sine die.”.**
