PROPOSED AMENDMENTS TO HOUSE BILL 2025

1 On page 1 of the printed bill, delete lines 24 through 27 and delete pages 2 2 through 4.

3 On page 5, delete lines 1 through 16 and insert:

4 "SECTION 2. ORS 329.172 is amended to read:

5 "329.172. (1)(a) The Preschool Promise Program is established. The 6 Early Learning Division shall administer [a preschool program] the Pre-7 school Promise Program as provided by this section. The [preschool pro-8 gram] Preschool Promise Program shall expand preschool options 9 available to the children of this state.

10 "(b) In administering the Preschool Promise Program, the Early 11 Learning Division shall identify local entities as provided under sub-12 section (3) of this section within the region served by each Early 13 Learning Hub to serve as a preschool provider or as a fiscal agent for 14 multiple preschool providers that meet the eligibility criteria estab-15 lished under subsections (4) and (5) this section.

"[(2)(a)] (2) For the purpose of expanding and coordinating preschool
 options under the Preschool Promise Program, Early Learning Hubs
 shall:

"(a) Once every two years, in consultation with resource and re ferral entities established under ORS 329A.100 to 329A.135, complete a
 community plan to identify priority populations of children and fami-

lies to enroll in preschool, to assess the availability of high-quality
 preschool programs and to identify existing preschool providers and
 other related services within the region served by the Early Learning
 Hub.

5 "[(A) Coordinate the providers of preschool programs under this section.] 6 "[(B) Convene annual meetings between representatives of the Oregon 7 prekindergarten program and the preschool program described in this section 8 to coordinate the enrollment of eligible children in the programs before the 9 eligible children are enrolled. The representatives shall collaborate to deter-10 mine the program that best meets the needs of eligible children and their 11 families within the Early Learning Hub.]

"[(b) The Early Learning Hubs shall apply for state funding, coordinate
 local planning and enter into contracts with preschool providers.]

"(b) Based on the results of the most recent community plan, an nually coordinate and collaborate with preschool providers to:

"(A) Determine the preschool program that best meets the needs
 of eligible children and their families within the Early Learning Hub;
 and

"[(3)] (4) A preschool provider that meets the requirements of this subsection may apply to participate in the [preschool program described in this
section] Preschool Promise Program to receive grants or contracts under the program. The preschool provider:

6 "(a) Must be establishing a new preschool program or expanding an ex-7 isting preschool program.

8 "(b) Must meet or exceed the requirements of subsection [(4)] (5) of this
9 section.

"(c) May be a **federal** Head Start program, an Oregon prekindergarten [*program*], a child care provider, a relief nursery, a private preschool, a public school, a public charter school, an education service district or a community-based organization that provides a preschool program.

"[(4)] (5) A preschool provider may participate in the [preschool program described in this section] **Preschool Promise Program** if the provider's preschool program:

"(a) Provides, at a minimum, the annual number of instructional hours
 required for full-day kindergarten.

"(b) Takes into consideration the scheduling needs of families who needfull-time child care.

"(A) Are at least three years of age but not older than five years of age,
as determined by the date used to determine kindergarten eligibility; and

"(B)(i) Are members of families whose incomes, at the time of enrollment,

"(d) Provides continuity from infant and toddler services to early elementary grades.

2 "[(e)] (f) Demonstrates quality through meeting standards, including:

"(A) [Attaining one of the top two ratings of] Participating in the quality
rating and improvement system for early childhood programs.

5 "(B) Adopting culturally responsive teaching methods and practices.

6 "(C) Providing a high-quality, culturally responsive family engagement 7 environment that supports parents as partners in a child's learning and de-8 velopment.

9 "(D) Providing high-quality, culturally responsive curricula, assessments 10 and professional development that are linked to one another and to the 11 state's comprehensive early learning standards.

"(E) Providing a classroom environment that is inclusive of all
 children, regardless of ability or family income.

14 "((E))] (F) Providing highly trained lead preschool teachers who have:

15 "(i) At least a bachelor's degree in:

"(I) Early childhood education or a field related to early childhood edu cation; or

"(II) A field not related to early childhood education if the Early Learning Division, based on rules adopted by the Early Learning Council, determines that the teacher has completed coursework that is equivalent to a major in early childhood education and has sufficient training in early childhood education;

"(ii) An associate degree with additional training or additional certification in early childhood education or a field related to early childhood education, as determined by the Early Learning Division based on rules adopted
by the Early Learning Council; or

"(iii) Sufficient alternative credentialing to indicate that the teacher is
highly trained, as determined by the Early Learning Division based on rules
adopted by the Early Learning Council.

(F) (G) Providing lead preschool teachers and teaching assistants

with a salary that meets the minimum salary requirements established by theEarly Learning Council.

"[(G)] (H) Providing at least one **teaching** assistant in each classroom who provides support for academic instruction and who meets the state's personnel qualification requirements of one of the top two tiers for the quality rating and improvement system for early childhood programs.

"[(H)] (I) Providing children and families with additional health and
child development supports [for children and families], such as screening,
referrals and coordination with health care providers.

"[(f)] (g) Incorporates best practices in outreach, enrollment and programming for diverse cultural and linguistic populations and children who have been historically underserved in preschool programs.

"[(g)] (h) Works in collaboration with community programs to ensure that families have knowledge of, and are connected to, community resources and supports to meet the needs of children and families served by the preschool program.

"[(h)] (i) Participates in an ongoing monitoring and program evaluation
 system that is used for continuous program improvement.

"[(5)(a)] (6)(a) While any moneys received under a grant received or a contract entered into as provided by this section must be used to serve children described in subsection [(4)(c)] (5)(c) of this section, nothing in subsection [(4)(c)] (5)(c) of this section prevents a preschool provider from serving additional children, including children who:

"(A) Pay tuition for the preschool program and whose family [*incomes*]
 income at the time of enrollment exceeds 200 percent of federal poverty
 guidelines.

"(B) Are funded by the Oregon prekindergarten program, a federal Head
Start program or another source of funding.

"(b) If a preschool [*program*] provider participating in the Preschool
Promise Program serves children described in paragraph (a) of this sub-

section, moneys received under a grant or contract as provided by this sec tion may not be used to pay for expenses incurred for the children described
 in paragraph (a) of this subsection.

"[(6)] (7) A preschool [program] provider participating in the Preschool
Promise Program may receive a waiver of any of the requirements described in subsection [(4)] (5) of this section if the waiver:

"(a) Is for a preschool program that is maintaining progress toward
quality; and

9 "(b) Is anticipated for the first years of the preschool program only. [; 10 and]

11 "[(c) Is granted for only one year at a time.]

"[(7)] (8) To assist the Early Learning Division in administering this
 section, the Early Learning Council shall:

"(a) Identify resources necessary for the Early Learning Division to de velop, support and sustain the implementation of a high-quality preschool
 program, including evaluations, professional development opportunities,
 technical assistance, monitoring guidance and administrative assistance.

"(b) Ensure that pathways and supports are available to teaching staff to
 increase culturally and linguistically diverse staff to teach and assist in
 preschool classrooms.

"(c) Establish minimum salary requirements and target salary guidelines 21for lead preschool teachers and teaching assistants at preschool provid-22ers participating in the Preschool Promise Program [as required under 23subsection (4)(e)(F) of this section]. Minimum salary requirements may be 24differentiated by program type. Target salary guidelines shall be, to the ex-25tent practicable, comparable to lead kindergarten teacher and teaching as-26sistant salaries in public schools. The Early Learning Division shall provide 27guidelines and technical assistance to [programs] preschool providers par-28ticipating in the Preschool Promise Program to address salary disparities 29 among preschool teachers and preschool staff. 30

20 "(E) Who are eligible for early childhood special education.

"[(9)] (10) The Early Learning Division shall coordinate with the Department of Education and other state agencies in support of the [preschool
program described in this section] Preschool Promise Program.

"[(10)] (11) The Early Learning Division shall prescribe the form and
timeline for applications to participate in the [preschool program as provided
