## PROPOSED AMENDMENTS TO SENATE BILL 994

In line 2 of the printed bill, after "juveniles" insert "; creating new provisions; and amending ORS 419B.021, 419B.055 and 419B.165".

3 Delete lines 4 through 7 and insert:

4 **"SECTION 1.** ORS 419B.165 is amended to read:

5 "419B.165. (1) Subject to subsection (2) of this section, the person 6 taking the child into custody shall release the child to the custody of the 7 child's parent or other responsible person in this state, except in the fol-8 lowing cases:

9 "[(1)] (a) Where the court has issued an order directing that the child be 10 taken into protective custody.

"[(2)] (b) Where the person taking the child into custody has probable cause to believe that the welfare of the child or others may be immediately endangered by the release of the child.

"(2)(a) Prior to releasing a child to the custody of the child's noncustodial parent, a person who has taken a child into custody shall request the Department of Human Services to conduct a criminal records check on:

18 "(A) The noncustodial parent; and

"(b) The department shall conduct a criminal records check under
 ORS 181A.200 (3) based on a request received under paragraph (a) of

"SECTION 2. The amendments to ORS 419B.165 by section 1 of this
2019 Act apply to any release of a child that occurs on or after the
effective date of this 2019 Act.

9 "419B.021. (1) Except as provided in subsection (2) of this section, the 10 following persons must possess a bachelor's, master's or doctoral degree from 11 an accredited institution of higher education:

12 "(a) A person who conducts an investigation under ORS 419B.020; and

13 "(b) A person who makes the following determinations:

"(A) That a child must be taken into protective custody under ORS
 419B.150; and

"(B) That the child should not be released to the child's parent or other
responsible person under ORS 419B.165 [(2)] (1)(b).

18 "(2) Subsection (1) of this section does not apply to:

"(a) A person who was employed or otherwise engaged by the Department of Human Services for the purpose of conducting investigations or making determinations before January 1, 2012, provided the person's employment or engagement for these purposes has been continuous and uninterrupted.
