21 "(C) Applied baccalaureate and other transfer degrees;

<sup>22</sup> "(D) Programs and grants that span multiple institutions; and

<sup>23</sup> "(E) Reciprocity agreements with other states.

"(d) In coordination with the State Board of Education, enhance the use
and quality of dual credit, career and technical pathways and efforts to create a culture of college attendance in this state.

"(e) In coordination with the State Workforce and Talent Development
Board, local workforce development boards, the Oregon Health and Science
University and independent institutions, ensure that the state's colleges and
universities offer programs in high-demand occupations that meet Oregon's

1 workforce needs.

"(f) Improve economies of scale by encouraging and facilitating the use
of the shared services among post-secondary institutions in this state.

"(5) The Higher Education Coordinating Commission, in a manner consistent with ORS chapter 183, may adopt administrative rules.

6 "(6) With the exception of the rulemaking authority granted in subsection 7 (5) of this section, the Higher Education Coordinating Commission may del-8 egate any of its powers, duties or functions to a committee of the commission 9 or to the executive director of the commission.

"(7) The Higher Education Coordinating Commission may, subject to the Public Contracting Code, enter into contracts and agreements, including grant agreements, with public and private entities for those higher education and workforce development activities that are consistent with ORS 350.001 and 350.005, with the policies set forth in ORS chapters 341 and 348 and with statutory policies related to career schools and public universities.

16 "(8) The Higher Education Coordinating Commission may exercise only 17 powers, duties and functions expressly granted by the Legislative Assembly. 18 Except as otherwise expressly provided by law, all other authorities reside 19 at the institutional level with the respective boards of the post-secondary 20 institutions.".
