**PROPOSED AMENDMENTS TO
SENATE BILL 755**

1 On page 1 of the printed bill, delete lines 5 through 31 and delete page
2 2 and insert:

3 **“SECTION 1. Section 2 of this 2019 Act is added to and made a part
4 of ORS 250.137 to 250.149.**

5 **“SECTION 2. (1) The Citizens’ Initiative Review Commission
6 Endowment Fund is established in the State Treasury, separate and
7 distinct from the General Fund. The Operating Subaccount is created
8 as a subaccount of the Citizens’ Initiative Review Commission
9 Endowment Fund. Moneys in the fund and the subaccount may be
10 invested as provided in ORS 293.701 to 293.857. Interest and investment
11 earnings earned by either the fund or the subaccount shall be credited
12 to the subaccount.**

13 **“(2) Moneys in the subaccount are continuously appropriated to the
14 Oregon Department of Administrative Services for distribution to the
15 Citizens’ Initiative Review Commission for the purpose of carrying out
16 the duties, functions and powers of the commission pursuant to ORS
17 250.137 to 250.149. The department may not distribute to the commis-
18 sion moneys in the fund that are not in the subaccount.**

19 **“(3) The department may accept contributions of moneys and as-
20 sistance to the fund and the subaccount from the United States Gov-
21 ernment or its agencies or from any other source, public or private,**

1 **and may agree to conditions placed on the moneys not inconsistent**
2 **with the duties of the commission.**

3 **“(4) Notwithstanding subsection (3) of this section, the fund and the**
4 **subaccount may not receive contributions of moneys or assistance**
5 **from any entity described in ORS 250.147 (2).**

6 **“(5) If a person contributes to the fund or the subaccount an ag-**
7 **gregate total of more than \$100 in a calendar year, not later than 14**
8 **calendar days after the receipt of the contribution that causes the \$100**
9 **threshold to be exceeded, the commission shall make available to the**
10 **public on the Internet:**

11 **“(a) The name and address of the person who made the contribu-**
12 **tion; and**

13 **“(b) The aggregate total of the contribution or contributions.**

14 **“SECTION 3.** ORS 250.149 is amended to read:

15 **“250.149. (1) Not later than the date that is four months before the date**
16 **of the general election in an even-numbered year, the Citizens’ Initiative**
17 **Review Commission, in consultation with the Oregon Department of**
18 **Administrative Services, shall determine whether moneys in sufficient**
19 **amount are available in the Operating Subaccount created under section**
20 **2 of this 2019 Act and the account established under ORS 182.470 to carry**
21 **out all the duties, functions and powers of the commission, implement ORS**
22 **250.139 to 250.143 and pay for any statements to be printed in the voters’**
23 **pamphlet under ORS 251.185.**

24 **“(2)(a) If the commission determines that the subaccount and the ac-**
25 **count [has] have sufficient moneys under subsection (1) of this section, the**
26 **commission shall carry out all the duties, functions and powers of the com-**
27 **mission, implement ORS 250.139 to 250.143 and may submit statements to be**
28 **printed in the voters’ pamphlet under ORS 251.185.**

29 **“(b) If the commission determines that the subaccount and the account**
30 **[has] have insufficient moneys under subsection (1) of this section, for the**

1 general election in that even-numbered year, the commission may not carry
2 out all the duties, functions and powers of the commission, implement ORS
3 250.139 to 250.143 or submit statements to be printed in the voters' pamphlet
4 under ORS 251.185.”
